

## 1. Basic life support

#### **Personal safety**

- Check for your personal safety and that patient surroundings are safe
- Wear gloves and other protective equipment, e.g. apron, eye protection

#### Call for help

Check for signs of life: Loudly ask 'Are you OK?' and gently shake shoulders. If response:

- Call for urgent medical help—use hospital protocol to contact resus/medical team
- Assess using airway, breathing, circulation, disability, exposure (ABCDE) approach
- Give O<sub>2</sub> as guided by pulse oximetry
- Attach monitoring equipment and take vital signs
- Obtain intravenous (IV) access and take bloods as appropriate (e.g. full blood count (FBC), urea and
  electrolytes (U&E), C-reactive protein (CRP), glucose, liver function test (LFT), coagulation test, group and
  save (G&S), lactate)—consider venous/arterial blood gas (ABG)

#### If no response:

- Lie patient on back
- Open airway: Head tilt, chin lift if no trauma/Jaw thrust is suspicion of trauma
- Look, listen, and feel for breathing and assess carotid pulse at same time (<10 s)

If pulse present/other signs of life: ABCDE approach,  $O_2$ , monitoring, IV access, await medical team If no pulse/no sign of life:

• Ask colleague to call the resuscitation team and to collect the resuscitation trolley

#### Start CPR

- Place heel of one hand in the middle of the lower half of sternum and place the other hand on top
- Depth of compressions should be 5–6 cm at rate of 100–120 compressions per minute
- Allow complete recoil of chest between compressions
- Give 30 compressions followed by 2 ventilations (minimize any interruptions in CPR)

#### Ventilation

- Use whatever equipment is available, e.g. bag mask, pocket mask, or supraglottic airway device (SAD)
   (e.g. laryngeal mask airway (LMA)) and self-inflating bag. Consider mouth to mouth ventilation if nothing
   else available. Minimize air leak by forming good seal if using bag mask
- Use inspiratory time of 1 s and ensure visible chest rise
- Give supplementary O₂ when possible

#### Defibrillation

- When available, apply pads to chest (one beneath right clavicle and one in left mid-axillary line)
- Assess rhythm: if indicated (i.e. ventricular fibrillation (VF)/pulseless ventricular tachycardia (VT)) charge
  machine, stand clear, remove O<sub>2</sub>, and deliver shock, minimizing gaps in CPR. (Note: If using automated
  external defibrillator (AED), follow audio-visual prompts)
- When resuscitation team arrives, progress to advanced life support (ALS)


If respiratory arrest (i.e. has a pulse but not breathing):

- Ventilate lungs, checking for pulse and response every 10 breaths
- If any doubt about presence of pulse, start CPR

## 2. Airway protection

#### Introduction

The gold standard in airway protection is the passage of a cuffed tube into the trachea. However, even in cases where this is clearly indicated, and the appropriate staff and equipment are available, it cannot happen instantly. It is essential that all practitioners who are expected to deal with emergency presentations are capable of emergency airway assessment and management. Table 1.1 lists methods of optimizing an airway.

Table 1.1 Methods of optimizing an airway


| Method                                  | Information   |
|---|---|
| Patient position                        | Unconscious patients with no suspicion of spinal injury should be placed in the recovery position with close monitoring.  Ideally the trolley should be capable of being tipped head-down in case of vomiting.  In some cases of facial trauma or foreign body obstruction, for example, patients may present sitting forwards, sometimes even holding their own tongue/mandible to maintain their airway. Invariably they do this better than you can: let them, and request additional help.  Supine patients who it is not appropriate to place in the recovery position should be managed on a trolley which can be tipped head-down, and if spinal injury is not suspected, then the 'sniffing the morning air' position should be achieved; alternatively a jaw thrust can be used.   |
| Suction                                 | Suction should be performed using a Yankauer-type suction catheter under direct vision.<br>Consider using a tongue depressor to facilitate this.  |
| Airway adjuncts                         | Oropharyngeal (OP) airway should be used in the absence of a gag reflex.  Nasopharyngeal (NP) airway is very useful where trismus is present or there is a risk of precipitating vomiting with an OP airway. This should preferentially be avoided in cases of serious head injury; however, if the patient is hypoxic and other methods of airway maintenance have failed, then the risk of worsening secondary brain injury because of hypoxia is likely to outweigh the small risk of inadvertently introducing the NP airway through a base of skull fracture. After placement, position may be confirmed by intraoral palpation or inspection.  SADs are useful in cardiac arrest cases and failed intubation scenarios during RSI as they can be inserted rapidly and offer some degree of (but not complete) airway protection. However, they may precipitate vomiting or laryngospasm and as such are not recommended in the non-anaesthetized patient where other methods are effective. |
| Rapid sequence induction of anaesthesia | The gold standard in airway protection in the passage of a cuffed tube into the trachea. This requires appropriate staff, monitoring, and equipment, and it is essential that an airway is maintained during the preparation time involved.   |
| Surgical airway                         | In the apnoeic peri-arrest or actual cardiac arrest patient with an airway that is unmanageable by any other means, this must be performed immediately.   |

## 3. Rapid sequence induction

#### Introduction

In all cases of RSI, the benefits and risks must be evaluated. This must include consideration of who (patient **and** clinician), when, and where to perform this.

However, in time-critical airway or ventilation problems, transferring a patient to another part of the hospital is not possible. As such, the Emergency Department should be able to facilitate a safe and effective RSI of anaesthesia and manage predictable complications.

#### **Checklist**

In order to do this, a checklist should always be used (Table 1.2) and the '6 Ps' approach followed:


- Pre-oxygenation—should be delivered using tight-fitting mask and circuit with reservoir bag (e.g. bag-valve-mask (BVM) or Mapleson C)
- Preparation—all the items listed in the checklist, along with optimizing the patient's current condition. This
  may include using fluids, sedation, chest decompression, pelvic splintage, etc.
- Premedication—if required, e.g. fentanyl in isolated head injuries
- Paralysis and sedation—appropriate agents include thiopentone (3–5 mg/kg) or ketamine (2 mg/kg) with suxamethonium (1.5 mg/kg) or rocuronium (1.2 mg/kg)
- Passage of the tube—routine use of a bougie is recommended, but this should be passed carefully to avoid airway trauma
- Post-intubation care—appropriate monitoring (minimum of SPO<sub>2</sub>, end-tidal carbon dioxide (ETCO<sub>2</sub>), noninvasive blood pressure (NIBP), 3-lead electrocardiogram (ECG)), ongoing sedation, and paralysis. Consider head-up position in raised intracranial pressure

## 4. Cricothyroidotomy

#### Introduction

- Accounts for ~1% of all secured airways in the Emergency Department
- Needle cricothyroidotomy (success rate 40%) should only be used for 30-45 minutes
- Surgical cricothyroidotomy has a success rate of around 84%

#### Indications

- To save life—a situation where you 'can't intubate and can't ventilate'
  - Other airway techniques should have been attempted first
  - Consider use of bougie if difficult placement
- Likely aetiology:
  - Severe upper airway haemorrhage
  - Maxillofacial injuries or abnormal facial anatomy
  - Airway trauma
    - Inhalational or thermal
    - Foreign body in the upper airway
    - Laryngeal disruption
  - Airway oedema
  - Mass (tumour, haematoma, abscess)
  - Supraglottitis

#### **Contraindications**

There are no absolute contraindications, only relative due to being a life-saving measure:

- Age under 10 years undesirable; under 5 years should be avoided
- Pre-existing laryngeal pathology (epiglottitis, cancer)
- Anatomic barriers (stab wounds, haematoma)
- Coagulopathy

#### **Complications**

- Substantial complication rate (10-40%) for emergency cricothyroidotomy
  - Damage to the thyroid cartilage and vocal chords
  - Subcutaneous emphysema
  - Haemorrhage
  - Extra-tracheal tube placement (false-passage)
  - Pneumothorax
  - Supraglottic or tracheal stenosis
  - Oesophageal perforation and fistulae
  - Infection

#### **Anatomy**

- Vocal chords short distance above thyroid notch (avoid this area)
- Cricoid is a complete cartilaginous ring
- Cricothyroid membrane located between thyroid and cricoid cartilages
- 30% of population have veins lateral to the midline



### 5. Needle thoracocentesis

#### **Definition**

- A procedure where a needle and catheter are inserted through the chest wall into the pleural space
  - The catheter provides a pathway for the release of accumulated pressure within the pleural space

#### **Indications**

- Primary spontaneous pneumothorax
- Tension pneumothorax
  - Any patient with thoracic injury at risk for developing tension pneumothorax
    - Increased risk with penetrating wound or signs of rib fracture
- A needle decompression should also be considered if any of the following indications are present in the trauma patient:
  - Patients with decreased or absent breath sounds, and examination consistent with pneumothorax, or tension pneumothorax
  - Patients with shortness of breath and/or respiratory distress
  - Subcutaneous emphysema
  - Tracheal deviation

#### **Contraindications**

There are no significant contraindications if a penetrating chest trauma. Relative contraindications include:

- Secondary spontaneous pneumothorax (underlying lung disease)
- Traumatic pneumothorax without tension

#### Clinical decision making

- Based on mechanism of injury (MOI) and a noted increase in difficulty breathing
- Inspection—unequal rise and fall of the chest during respirations
- Auscultation—decreased breath sounds
- Percussion—hyper-resonant to percussion
- Palpation—flail segments or crepitus


#### **Complications**

- Local cellulitis
- Local haematoma (2%)
- Pleural infection, empyema
- Pneumothorax
  - 11% chance of causing a pneumothorax if one not present initially
- Haemothorax (0.8%)
- Subcutaneous emphysema
- Cannula needle may not be long enough in up to 1/3 adult males, so prepare for immediate thoracostomy in peri-arrest situation

## 6. Pleural aspiration—pneumothorax

#### Introduction

A pneumothorax can be spontaneous or traumatic. Spontaneous pneumothorax can be subdivided into primary and secondary pneumothorax. Primary pneumothorax occurs in the absence of underlying lung disease. Secondary pneumothorax occurs when there is underlying chest disease (e.g. chronic obstructive pulmonary disease (COPD), asthma, malignancy, tuberculosis (TB)) or evidence of underlying lung disease on examination or chest X-ray (CXR).

#### **Indications**

British Thoracic Society (BTS) guidelines suggest that a pneumothorax should be aspirated in the following circumstances:

- Primary spontaneous pneumothorax with difficulty in breathing and/or a rim of pneumothorax on CXR
   2 cm (measured at the level of the hilum). A >2-cm pneumothorax is by definition a large pneumothorax and a 2-cm radiographic pneumothorax approximates to a 50% pneumothorax by volume
- Secondary spontaneous pneumothorax with no difficulty in breathing and a 1- to 2-cm rim of pneumothorax on CXR

#### **Contraindications**

- Tension pneumothorax should undergo immediate needle decompression
- Traumatic pneumothorax requires intervention
- Bilateral pneumothoraces
- Previous pneumothorax within last 2 weeks
- Haemodynamically unstable patient
- Anticoagulated patient (await internalized normalized ratio (INR) prior to attempted aspiration)
- Spontaneous pneumothoraces suitable for conservative management
- Secondary spontaneous pneumothorax with difficulty in breathing or >2-cm rim of air on CXR should be treated with Seldinger chest drain

#### Patient positioning and the triangle of safety

Whilst performing aspiration of a pneumothorax, the patient should be positioned sitting upright, with the hand of the affected side behind the head. The triangle of safety for aspiration of the pneumothorax lies between the lateral edges of the pectoralis major and latissimus dorsi, above the 5th intercostal space and below the base of the axilla.

### Patient discharge advice

Patients who are suitable for discharge should be referred for follow-up in the chest clinic, and information should be sent to their GP to confirm their diagnosis. Patients should be given the following information:

- Return to the ED immediately if they experience breathlessness or chest pain
- They should avoid diving for life
- They should avoid air travel until given further advice at chest clinic review



## 7. Intercostal drain—seldinger

#### **Indications**

- Pneumothorax
- Malignant pleural effusion

#### **Predrainage**

- Correct coagulopathy or platelet defect if possible
- Explain procedure to patient and record informed consent
- Place patient on monitoring for pulse oximetry, ECG, and blood pressure (BP)
- Premedication (benzodiazepine or opioid) to reduce patient distress unless contraindicated





Figure 1.1 Safe triangle for intercostal drain insertion.

- Position patient slightly recumbent, with ipsilateral hand behind patient's head to expose axillary area and 'triangle of safety' (Figure 1.1)
  - Lateral edge of latissimus dorsi (posteriorly)
  - Lateral border of pectoralis major (anteriorly)
  - Line superior to horizontal level of the nipple or 5th IC space (inferiorly)
  - Base of the axilla (superiorly)
- Alternatively: patient sat upright leaning forwards over adjacent table with a pillow
- Confirm site of drain insertion by reviewing clinical signs and chest radiograph
- Prophylactic antibiotics not routinely indicated

#### **Drainage**

- Common position for insertion is in the mid-axillary line through the 'safe triangle'
  - For apical pneumothoraces, 2nd intercostal space in mid-clavicular line
- · Aseptic technique with skin cleansing using iodine or chlorhexidine
- Local anaesthetic (LA) prior to insertion of drain (up to 3 mg/kg of lidocaine)
- Insertion of a small-bore (8–14 French (Fr)) drain with aid of a guidewire by Seldinger technique does not require blunt dissection
- Position of tube tip should be apically for pneumothorax or basally for pleural effusion
  - However, any tube position can be effective, and a functioning drain should not be repositioned because of its radiographic position
- Secure drain with stay suture to prevent it falling out—such as 1-0 silk
- Connect chest tube to a single flow drainage system (e.g. underwater seal bottle)
  - Position confirmed with swinging and bubbling

## 8. Intercostal drain—open

#### **Indications**

- Traumatic haemothorax
- Traumatic pneumothorax
- Open pneumothorax
- Selected patients with suspected severe lung injury (e.g. multiple rib fractures or pulmonary contusions) who
  need positive-pressure ventilation or transport via road or air
- Traumatic cardiac arrest (either insert bilateral intercostal drains (ICDs) or perform bilateral finger thorocostomies)
- Empyema and complicated parapneumonic effusion
- Postsurgical (e.g. thoracotomy, oesophagectomy, cardiac surgery)

#### **Contraindications**

- Patient unstable: no contraindications
- Patient stable: consider coagulopathy/multiple pleural adhesions

#### **Equipment**

- Personal protective equipment (sterile gloves and gown, consider face shield)
- Skin antiseptic solution (use hospital policy, e.g. iodine/chlorhexidine in alcohol)
- Sterile drapes and swabs
- · A selection of syringes and needles
- LA (e.g. 1% lignocaine +/- adrenaline)
- Scalpel and blade
- Instrument for blunt dissection (e.g. curved clamp)
- A chest tube (size 28–32 Fr in adults) with the trocar discarded
- Connecting tubing
- Underwater seal drain
- Suture (e.g. 0 or 1-0 silk)
- Dressing and tape

#### **Complications**

- Damage to intercostal nerve, artery, or vein
- Infection, e.g. thoracic empyema
- Creation of false track
- Persistent pneumothorax
- Subcutaneous emphysema
- Organ damage, e.g. liver, spleen, lung, heart, diaphragm
- Chronic pain

#### Other considerations

- Antibiotics should be considered in trauma patients having an ICD inserted, especially with penetrating trauma
- Patients should be referred to a thoracic surgeon if the ICD yields >1.5 L of blood immediately OR if there is
  persistent blood loss via the ICD (e.g. >200 mL/hour for 2 hours)
- A ruptured bronchus is suggested by persistent air through the ICD, especially if the lung fails to expand; this
  needs urgent discussion with a thoracic surgeon
- Consider Seldinger drain in non-traumatic pneumothorax
- Consider conservative management for small isolated traumatic pneumothoraces with no haemothorax

#### Algorithm for intercostal drain—open

Identify need for open ICD

#### Preparation:

- Obtain consent: ideally written, but in emergency setting verbal is adequate.
   If patient is unable to give consent, perform procedure if deemed in the best interests of the patient
- · Ensure assistant is present
- Monitoring: ensure patient is attached to full monitoring and has 100% oxygen (unless any contraindications to high flow oxygen)
- Consider parenteral analgesia e.g. IV morphine

#### **Procedure**

- Position patient appropriately—classically supine or at 45° (depending on other injuries) with arm fully abducted or held behind patient's head.
- 2. Determine insertion site: commonly 5th intercostal space, just anterior to the mid-axillary line on the affected side
- 3. Don full personal protective equipment
- 4. Prepare equipment on procedure trolley
- 5. Maintain asepsis
- 6. Clean skin with appropriate antiseptic solution
- 7. Surgically drape the chest
- 8. Insert local anaesthetic to skin and down to rib periosteum
- 9. Make 2- to 3-cm transverse incision on upper border of the rib and bluntly dissect down through tissues
- 10. Puncture the parietal pleura and insert a gloved finger into the pleural cavity to release adhesions and to ensure that you are in the pleural space
- 11. Insert the chest tube into the pleural cavity with the aid of a clamp, and look for fogging of air or passage of blood in the drain tube
- 12. Connect the end of the tube with the underwater seal
- 13. Suture tube in place and apply a dressing
- 14. Ensure tube is secure

Post procedure
Re-evaluate patient
Obtain CXR

# 9. Arterial blood gas sampling

#### **Indications**

Arterial blood gas (ABG) sampling is useful:

- In patients with respiratory disease who are at risk of inadequate ventilation and tissue oxygenation.
- In critically ill patients
- In those with metabolic disease (e.g. diabetic ketoacidosis)
- In poisoning and drug overdose.

#### **Contraindications**

Contraindications are relative and patient risk should be weighed against the importance of sampling.

- Areas of infected skin/cellulitis overlying the sample site (due to the risk of inoculation with bacteria)
- Patients with coagulopathy or who are anticoagulated.
- Consideration should also be given to the presence of collateral circulation (see section 'Selection of a suitable artery') due to the risk of thrombus formation.

#### **Complications**

- The commonest complication is local haematoma at the site of sampling.
- Other complications include intra-arterial thrombus and infection at the sampling site.

#### Selection of a suitable artery

ABG sampling can be performed using the radial, brachial, or femoral arteries. If the radial artery is to be used, a modified Allen test should ideally be performed to assess and confirm good collateral circulation. To do this, ask the patient to make a fist and apply occlusive pressure to both radial and ulnar arteries with your thumbs. Ask the patient to clench their fist until the palmar skin is blanched. Release the pressure over the ulnar artery only and watch to ensure the palm becomes pink. Repeat the process again, this time releasing pressure on the radial artery only to ensure the palm becomes pink. If pressure release over either artery fails to allow blood flow to the palm and colour to return within 15 seconds, consider a different site for ABG sampling.

To access the radial artery the patient should be positioned supine, with the forearm supinated and the wrist dorsiflexed to approx. 40° if possible.

To access the brachial artery the patient is positioned supine, with the shoulder in slight abduction, the elbow extended, and the forearm fully supinated.

To access the femoral artery the patient is positioned supine, with the legs in the anatomical position.

#### Use of local anaesthetic

LA does not tend to be used routinely as the insertion of LA is itself painful. If LA is to be utilized 0.5–1.0 mL of 1% lignocaine can be injected subcutaneously using an orange needle over the intended site of arterial puncture. Care should be taken to aspirate prior to instilling the anaesthetic agent to ensure that the artery has not been punctured and so avoid intra-arterial administration of the LA.

#### **ABG** normal values

pH 7.35-7.45

PaO<sub>2</sub> 10.0–13.0 kPa on room air


PaCO<sub>2</sub> 4.7–6.0 kPa HCO<sub>3</sub> 22–26 mmol/L BE -2 to +2 SaO<sub>2</sub> >95%

(As a rule of thumb,  $PaO_2$  should usually be around 10 kPa less than inspired partial pressure. Practically, this means  $PaO_2$  should be numerically around 10 less than the inspired  $O_2$  concentration (%).)

# 10. Peripheral venous cannulation

#### **Indications**

Peripheral venous cannulas are used for:

- The administration of IV fluids, blood and blood products, drugs, and parenteral nutrition.
- They are also inserted prophylactically in unstable patients and before certain procedures are commenced.

#### **Contraindications**

Peripheral venous cannulation is contraindicated:

- Where there is evidence of infection over the site of insertion.
- Relative contraindications include avoiding forearm veins in patients with renal failure (who may require
  arteriovenous fistulae) and small veins with low flow rates, especially when irritant drugs are to be used
- Established arteriovenous fistulas should not be cannulated.

### **Complications**

Complications include:

- Infection, phlebitis and thrombophlebitis
- Fmboli
- Pain
- Haematoma or haemorrhage
- Extravasation
- Arterial cannulation.

#### Selection of a suitable vein

In general, peripheral veins in the upper limb are used in preference to those in the lower limb, as they cause less interference with a patient's mobility and are less prone to thrombophlebitis and thrombosis. In the upper limb the dorsal hand veins, cephalic veins, and basilic veins are all commonly used. If a limb is affected by lymphoedema, is infected, or has sustained injuries or burns, then another limb should be cannulated in preference.

If a suitable vein is difficult to identify, a number of techniques may be useful. These include:

- Try a different limb to see if veins are more readily visible
- Ask the patient to open and close their fist when the tourniquet is in situ
- Gently tap or stroke the site
- Enlist the help of gravity, by holding the limb down
- Place the limb in warm water or apply heat pack/warm towel to the site

#### Ultrasound-guided peripheral cannulation

If peripheral veins are not readily visible and the above techniques do not help, US-guided cannulation is a useful technique. The linear/vascular probe can be used to visualize veins and a cannula can then be inserted using the standard technique.

#### Topical anaesthetic

In non-emergent situations, topical anaesthetic creams and gels may be applied to the skin to decrease the pain associated with cannulation. This is particularly useful in paediatric patients, but can also be valuable in adults who are very anxious or have a fear of needles.



## 11. Central venous cannulation

#### **Indications**

- If the patient requires medications that need central access to allow administration such as inotropes or amiodarone
- If a patient has very poor peripheral venous access and needs a more definitive line
- As part of fluid balance monitoring in the critically ill patient
- If a patient requires a rapid infusion of fluid or blood, such as in haemorrhagic shock secondary to trauma

#### **Contraindications**

There are no absolute contraindications for central line insertion, but a risk versus benefit approach should be considered in the following circumstances:

- If the patient has a coagulopathy that hasn't been addressed
- Infection in the tissues around the insertion site
- If there is local thrombosis causing venous obstruction
- Raised intracranial pressure. A femoral line should be considered in this situation
- Local damage such as a burn or a contaminated wound

#### Consent

Consent for this procedure should cover the following risks:

- Bleeding—local or from arterial puncture
- Infection
- Failure of procedure
- Pneumothorax and damage to other local structures
- Pain
- Thrombus formation
- Uncooperative patient

## Ultrasound identification of the internal jugular vein


The following features will help differentiate between the carotid artery and the internal jugular vein:

- It usually lies lateral to the carotid artery within the carotid sheath
- The internal jugular vein should be compressible, whereas the carotid artery will not be
- Valsalva manoeuvre will increase the diameter of the vein
- Doppler flow will show blood flowing away from the probe

## 12. Intraosseous access

## **Important points**

- Any medication or fluid that you would give peripherally can go intraosseous (IO) at the same dose
- Any age patient can have an IO needle inserted
- Each medication given needs to be flushed with 5 mL of normal saline

#### **Indications**

Any situation where IV access is proving difficult/impossible, e.g. burns, circulatory collapse, cardiac arrest

#### **Contraindications**

- Vascular damage or fracture proximal to the intended site of insertion
- Infection in the skin overlying the intended site of insertion
- Osteogenesis imperfecta

### **Equipment**

- Manual IO needle or IO needle with mechanical driver (drill)
- Select the correct IO needle:
  - 15 mm: 3-39 kg
  - 25 mm: >40 kg
  - 45 mm: proximal humeral site, or excessive subcutaneous tissue
- Three-way tap with primed extension set with 0.9% saline

#### **Complications**

- Epiphyseal injury
- Bleeding
- Skin necrosis
- Infection
- Through and through bone penetration
- Subcutaneous infiltration
- latrogenic fracture

#### Possible sites for insertion

- Proximal tibia: approx. 2.5 cm distal to the tibial tuberosity on the antero-medial aspect of the tibia
- Distal tibia: 2.5 cm proximal to the medial malleolus
- Distal femur: 2.5 cm proximal to the lateral femoral condyle on the antero-lateral surface
- Proximal humerus: at the greater trochanter on the antero-lateral aspect

#### **Notes**

- Bone marrow can be tested for BM, cultures, or group and save
- Any fluid inserted through the IO will need to be manually syringed
- Continually assess to ensure patency of IO placement
- Remove IO needle as soon as two IV accesses have been obtained and within 24 hours of insertion

## Algorithm for intraosseous access

#### Preparation

- Explain the procedure to patient/relative and obtain consent if appropriate
- Identify the insertion site
- Sterilize the skin
- Support the limb on a blanket

#### Manual IO insertion

- Insert local anaesthetic (e.g. 1% lignocaine) subcutaneously if needed
- Firmly grasp the handle and use a twisting motion to insert the needle at a 90° angle to the bone. Stop when you feel the give of breaching the medullary cavity
- Remove stylet and confirm placement by aspiration of bone marrow (Note: failure to aspirate bone marrow does not necessarily signify incorrect IO placement)

#### Mechanical IO insertion (with drill)

- Local anaesthetic to the skin is not needed
- Select correct IO needle size and place needle into drill
- 3. Insert the needle at 90° to the skin up to the 5-mm black line on the shaft of the needle
- Remove the drill and the stylet of the IO needle, leaving the needle itself in the medullary cavity
- 5. Confirm placement by aspiration of bone marrow
- Note: failure to aspirate bone marrow does not necessarily signify incorrect IO placement

Attach the 3-way tap and extension set, and flush the IO with 0.9% saline Look for soft tissue swelling around the IO site—this may suggest incorrect IO positioning

Secure IO needle to leg with tape or consider a plaster of Paris back slab to ensure leg immobilization  $% \left( 1\right) =\left( 1\right) \left( 1\right$ 

# 13. Urinary catheterization

## Important safety notes

- Adult urinary catheters are manufactured in two lengths: female length (20–26 cm) and standard length (40–45 cm). The use of standard-length catheters in females poses no safety issues. However, if a female-length catheter is accidentally used for a male, the 'balloon' inflated with sterile water to retain the catheter will be within the urethra, rather than the bladder, and can then cause severe trauma
- Most widely used types of catheter contain latex. If the patient is allergic to latex, an all-silicone catheter must be used

## **Technique for insertion**

- 1. Obtain an assistant/chaperon
- 2. Choose an appropriate size catheter (e.g. 12–14 Fr) and appropriate length (see above) and prepare your equipment
- 3. Position the patient in supine with legs slightly apart
- 4. Wash and dry your hands, then put on sterile gloves
- Clean thoroughly around the urethral meatus (retract the foreskin if applicable) using an antiseptic solution like chlorhexidine
- 6. Insert LA gel and hold the meatus close; wait for 5 minutes for it to work
- a) Hold the penis vertically with one hand and gently advance the catheter with the other hand, until all is inserted
  - b) Part the labia with one hand and gently advance the catheter with the other hand, until all is inserted
- 8. Wait until urine starts flowing through the catheter
- 9. Inflate the balloon using 10 mL of sterile water, ensuring that it does not cause any pain, and attach a catheter bag
- 10. Gently pull on the catheter until resistance is felt
- 11. Reposition the foreskin if applicable


#### **Useful tips**

- Instruct the patient to try to void when you feel resistance passing the catheter. This will sometimes open the sphincter, allowing the catheter to pass
- Use forceps to aid advancing and applying gentle pressure to the catheter as it advances; this will provide better grip to the catheter and stops slipping

# 14. Nasogastric tube insertion

#### **Technique for insertion**

- Choose the appropriate tube size, which depends on the reason for the tube insertion (drainage or feeding)
- 2. Place patient in an upright position
- 3. Measure the tube length (it must be measured from the tip of the patient's nose, loop around their ear, and then down to roughly 5 cm below the xiphoid process)
- 4. Lubricate the tube end using water-soluble lubricant like KY gel or LA gel
- 5. Insert it into one of the patient's nostrils
- 6. The tube should be directed straight towards the back of the patient, parallel to the nasal floor
- 7. When the tube enters the oropharynx and glides down the posterior pharyngeal wall, the patient may gag; ask the patient to mimic swallowing or give some water to sip through a straw
- 8. Secure the tube using tape
- 9. Confirm the position of the tube before using it

#### **Confirmation of position**

- pH testing is used as the first-line test method, with pH between 1 and 5.5 as the safe range for right position (pH indicator paper must be used)
- X-ray is used only as a second-line test when no aspirate could be obtained or pH indicator paper has failed to confirm the position of the nasogastric (NG) tube

The following methods **must not** be used to confirm tube position:


- Auscultation of air insufflated through the NG tube ('whoosh' test)
- Testing acidity/alkalinity of aspirate using blue litmus paper—blue litmus paper is not sensitive enough to distinguish between bronchial and gastric secretions
- Interpreting absence of respiratory distress as an indicator of correct positioning
- Monitoring bubbling at the end of the NG tube
- Observing the appearance of NG tube aspirate

# 15. Arterial cannulation and arterial pressure monitoring

#### Indications

- The need for continuous BP monitoring, such as the critically ill or unstable patient
- If recurrent arterial samples are required
- If normal BP monitoring is not possible due to an injury such as burns

#### **Contraindications**

Absolute contraindications include:

- Any vascular impairment to the limb intended for use
- Raynaud syndrome
- Full thickness burns

Relative contraindications include:

- Partial thickness burns
- Local infection
- Previous vascular surgery in the affected area
- Inadequate collateral flow, such as ulnar artery insufficiency in the Allen test

#### **Complications**

- Radial artery occlusion secondary to indwelling catheter
- Bleeding
- Local infection
- Limb ischaemia
- Thrombosis
- Air embolism
- Median nerve damage


### Preparing arterial pressure monitoring

- Spike a 500-mL bag of normal saline with the transducer set
- Place saline in a pressure bag and inflate pressure bag up to 300 mmHg
- Attach transducer holder and saline to IV pole
- Connect transducer to transducer holder, ensuring transducer cable is pointing down
- Prime tubing and remove all air bubbles
- Connect transducer cable to monitor port
- Connect distal part of tubing to patient's arterial line
- Expose port on transducer to atmosphere (port closed to the patient) and press zero on monitor
- Close port to atmosphere and open port to the patient
- Arterial tracing should now be present on the monitor

# 16. Lumbar puncture

#### **Consent**

It is important as with any procedure to ensure fully informed consent is obtained prior to performing the procedure. If you are doing the procedure, you should be able to consent the patient.

- Outline the reason the procedure is being done. This might be as a diagnostic test in a suspected central nervous system infection
- Explain the procedure and the steps involved to the patient
- Explain the risks associated with the procedure
- Common risks include back pain at the site of insertion, post spinal headache, shooting pain down the legs
  during the procedure, and bleeding if on anticoagulants
- Less common risks include bleeding at the insertion site, lower limb neurology, and infection at insertion site


#### **Complications**

- Post spinal headache can begin anywhere between 24 and 48 hours after the lumbar puncture has been done.
   It is usually relieved by lying down. Simple analgesia can be given, and it is usually self-limiting. If severe, an anaesthetic review should be sought for consideration of an epidural blood patch
- Infection can occur in any of the anatomical sites involved with the lumbar puncture. These include cellulitis, epidural and spinal abscesses, and potentially discitis. Correct sterile technique will reduce the risk of this occurring
- A bloody spinal tap may occur secondary to trauma to local tissues when performing the lumbar puncture. It will usually result in a false positive for red blood cells in the cerebrospinal fluid (CSF) cell count
- Bleeding in the epidural and subdural space can occur but is rare. It is important to check whether the patient
  is on anticoagulants or is known to have a coagulopathy. If the platelet count is below 50 the procedure should
  be delayed and advice should be sought from the haematologist
- When withdrawing the spinal needle, it is important to ensure that the stylet is replaced in the needle to prevent damage to spinal structures

# 17. Abdominal paracentesis/ascetic tap

#### Introduction

Paracentesis is a method of obtaining a sample of abdominal free fluid either as a diagnostic or as a therapeutic intervention.

#### **Indications**

- In the Emergency Department the most common reason to perform paracentesis is for the diagnosis or exclusion of spontaneous bacterial peritonitis.
- Other indications include:
  - Therapeutic drainage of massive chronic ascites
  - To relieve either abdominal pain or respiratory splinting
  - To aid diagnosis in new-onset ascites.

#### Contraindications

Acute abdomen requiring surgery

The following are relative contraindications and require a senior clinician to assess the perceived risks of carrying out compared to delaying the procedure:

- Thrombocytopenia (platelet count <20 × 10³/μL) or INR >2.0
- Pregnancy
- Distended urinary bladder
- Abdominal wall cellulitis
- Distended bowel
- Intra-abdominal adhesions

#### **Procedure**

Pericardiocentesis packs should be used where available: IV cannulas, a three-way tap, a 50-mL syringe, and a giving set may be fashioned together as an alternative, but this should only be used by someone already familiar with this technique.

With the patient either supine with head of bed raised by 30° or in lateral decubitus position, the left or right lower quadrants are the preferred puncture sites (lower side if in lateral position). Dullness to percussion or confirmation of fluid using US is necessary prior to puncture. To avoid the inferior epigastric artery, aim for 2–4 cm cephalad and medial to the anterior superior iliac spine.

#### **Complications**


- Complications include puncture of bowel or mesentery.
- Rarely there may be spontaneous bleeding from mesenteric varices following large volume drainage.
- Abdominal wall haematomas are uncomfortable but rarely significant.
- Post-paracentesis hypotension may be managed with fluid replacement: commonly, albumin is used in these
  cases; however, other plasma expanders may be used as an alternative.
- A persistent leak should be initially managed with direct pressure, and if continuing, consider horizontal
  mattress suture around the site or alternatively apply a urostomy bag to collect and measure fluid loss.

## 18. DC cardioversion

#### Introduction

Electrical cardioversion is an effective method of restoring sinus rhythm in a variety of cardiac arrhythmias. It is the responsibility of the practitioner delivering the shock to ensure the safety of the team.

#### **Indications**

- Cardiac arrest due to ventricular fibrillation or ventricular tachycardia
- Haemodynamically compromised patient with either a broad or a narrow complex tachycardia
- Stable patient with persistent dysrhythmia (e.g. atrial fibrillation)

#### **Contraindications**

 The only contraindications involve risks to safety of the operator or patient and include water across the chest (e.g. in cases of drowning) and removal or avoidance of glyceryl trinitrate (GTN) medication patch if this lies between the two pads

### **Complications**

- · Failure to restore sinus rhythm
- Post-procedure chest discomfort
- Thromboembolic stroke
- Induction of a different arrhythmia

#### **Notes**

All European defibrillators are marked with the numbers 1–3: 1 selects energy, 2 charges, and 3 delivers the shock. It should be noted that if a synchronized shock is to be delivered, the practitioner must hold the shock button down until the shock has been delivered: this may not be instantaneous.

The energy delivered depends on the machine used; practitioners must be familiar with the equipment they will be using. Values quoted in the algorithm are for a Philips Heartstart biphasic defibrillator.

If sedation is required, a separate clinician is required to deliver this (not the same person who is doing the cardioversion.) This requires an assessment of sedation risk and may need urgent anaesthetic assistance.


Following cardioversion, an immediate pulse check should take place, along with recording BP. An ECG should then be performed.

# 19. Temporary pacing (external)

#### Introduction

External pacing is a potentially life-saving emergency intervention to restore or increase heart rate in order to preserve cardiac output.

#### **Indications**

- Bradycardia resulting in cardiovascular compromise
- Syncope due to bradycardia

#### Contraindications

There are no absolute contraindications.

### Complications

- Failure to respond
- Chest discomfort at site of pads
- Inability to tolerate procedure (sedation is frequently required)

#### **Procedure**

It is essential that practitioners are familiar with the equipment used in their own department.




Figure 1.2 Position of pacing pads.

Note: most pacing machines require the monitor electrodes to be applied as well as the pacing/defibrillator pads. Pacing pads may be applied in either the standard defibrillation or antero-posterior (AP) positions (Figure 1.2).

Sedation of the unwell bradycardic patient is hazardous and should only be undertaken by experienced clinicians. Monitoring in such cases should include SPO<sub>2</sub>, NIBP, ECG, and nasal capnography.

Fist pacing (to the centre of the chest with increasing force until capture is seen on the monitor) is sometimes necessary whilst obtaining help and equipment needed for external electric pacing.


Early cardiology referral is essential: complete heart block may be a finding in acute myocardial infarction. Transvenous pacing is nearly always required, and inotropic support may be needed in some cases.

In cases of failure to capture, consider changing to alternative pad position.

# 20. Knee aspiration

#### Introduction

Table 1.3 shows the characteristics of the three most common causes for a swollen knee.

#### **Causes**

- Acute injuries
  - Blood in the knee, e.g. anterior cruciate ligament (ACL) tears, fractures
  - Synovial fluid accumulation, e.g. meniscal injuries and ligamentous sprains
- Chronic conditions
  - E.g. arthritis or any other condition that can flare up
- Spontaneous
  - Rapid knee swelling, e.g. septic arthritis, gout, and pseudogout

#### **Indications**

- The procedure of knee aspiration is primarily used to identify septic arthritis
- It can be used to symptomatically drain a haemarthrosis or a swollen joint secondary to arthritis,
- It can also confirm gout and pseudogout.


#### **Contraindications**

- Infection over site of planned aspiration
- Patient with known bleeding disorder, e.g. haemophilia—in these patients with a swollen joint, all must be
  discussed with the haematologist on call prior to any intervention
- All cases with a prosthetic knee do not aspirate in the ED—refer to orthopaedics for aspiration in theatre

# 21. Fracture manipulation

#### Introduction

Rapid reduction of a displaced fracture may be required to restore circulation or reduce pressure on affected nerves or skin.

#### **Indications**

- Neurovascular compromise (distal sensation and circulation, but also tight, tented, blanched skin at site of fracture)
- Simple fracture which is angulated or displaced
- Fracture is expected to be straightforward to reduce

#### **Contraindications**

- Current position acceptable
- Open fractures requiring operative debridement (unless neurovascular compromise)

### **Complications**

- Pain
- Failure to reduce the fracture
- Conversion of closed fracture to open fracture
- Nerve or skin damage

#### **Notes**

It is essential that the patient is comfortable throughout the procedure and a number of methods may be considered either in isolation or in combination, including opiate analgesia, inhaled  $O_2$  and nitrous oxide ( $N_2O$ ) gas mixture, regional or local anaesthetic, or sedation.


It should be noted that different fracture patterns require specific techniques for optimum reduction: a list of these is beyond the scope of this book and direct supervision by someone experienced in these techniques is required. One method of Colles fracture reduction is as follows:

- After appropriate analgesia/nerve block, apply traction to the hand with dorsal angulation in order to disimpact the fracture
- Whilst maintaining traction, push the distal fragment distally and flex the wrist along with the application
  of ulna deviation. The wrist position should therefore be 20–30° of flexion, 15° ulna deviation, and 20°
  pronation
- · Hold this position whilst a plaster slab is applied

## 22. Procedural sedation

#### Introduction

This guidance is for adult patients only. Patients <18 years of age should only be sedated by clinicians skilled in paediatric airway management and advanced paediatric resuscitation.

There are different kinds of depths of sedation:

- Minimal sedation. Patients respond normally to voice and command
- Moderate sedation (or 'conscious sedation'). A depression of consciousness where patients respond to voice.
   Spontaneous ventilation is maintained. Their airway remains intact throughout
- Deep sedation. A depression of consciousness where patients respond to painful stimuli. Patients may require
  assistance with their airway and breathing
- General anaesthesia. Patients are unrousable.

Three trained members of staff are needed: one for the sedation, one for the manipulation, and one to monitor the patient.

During reduction of a dislocated joint in the ED, aim for minimal sedation (using Entonox) or moderate sedation. Fasting: this is not required for moderate sedation as the patient's airway reflexes will remain intact.

Medications used: there are various different medications that can be used. One example is morphine (for analgesia) and midazolam (for sedative). Other examples are ketamine (causing 'dissociative sedation') and propofol—these are only to be used in the hands of senior trained anaesthetists or emergency physicians.

**Discharge**: patients should be formally assessed for suitability for discharge from the clinical area where sedation has taken place. Discharge criteria are as follows:


- The patient has returned to their baseline level of consciousness
- Vital signs are within normal limits for that patient
- Respiratory status is not compromised
- Pain and discomfort have been addressed
- Patients meeting discharge criteria following sedation who go on to be discharged home should be discharged
  into the care of a suitable third party
- Patients need to be advised not to drive and not to operate heavy machinery in the next 24 hours
- Verbal and written instructions should be given

# 1. Anaphylaxis

#### Introduction

Anaphylaxis is an acute, severe, life-threatening type 1 hypersensitivity reaction. The clinical manifestations relate to four systems:

- Skin: flushing, pruritus, urticarial, angioedema
- Respiratory: upper and/or lower tract, upper airway swelling, bronchospasm
- Cardiovascular: vasodilatation, hypotension
- Gastrointestinal (GI): abdominal pain, nausea, vomiting, diarrhoea

#### Recognition

Anaphylaxis is likely with any one of the following:

- Acute onset:
  - Skin or mucosal involvement **and** respiratory distress **or** hypotension
- Two or more of:
  - Skin involvement
  - Respiratory distress
  - Hypotension
  - Gl symptoms
- Hypotension after allergen exposure

Most cases occur within 1 hour of exposure but can be delayed up to 12 hours.

#### **Treatment**

- See Algorithm
- Additional treatment: consider IV glucagon (1 mg) for patients on B blockers. B blockers may cause persistent
  hypotension in patients with anaphylaxis
- Fluid: use crystalloid: 500–1000 mL in an adult, 20 mL/kg in a child

#### **Investigations**

- Mast cell degranulation causes an increase in serum tryptase, which can be measured. Ideally take three samples—at 1, 4, and 24 hours—after onset of symptoms
- Consider measuring electrolytes if at risk of renal failure and FBC (may see a raised eosinophil level)


#### Follow-up

- Patients need to be observed for at least 6 hours to monitor for biphasic reaction
- Consider 3 days of oral prednisolone and antihistamines
- Ensure that patient follows up with their GP to consider immunology referral
- Discharge with an EpiPen® with clear instructions of how and when to use it
- Stop any angiotensin-converting enzyme (ACE) inhibitors

# 2. Apnoea, stridor and airway obstruction

## **Apnoea**

Apnoea is defined as the cessation of ventilation. This can be secondary to airway obstruction. Other causes include poisoning, iatrogenic secondary to sedation, raised intracranial pressure, respiratory failure, high spinal trauma, and obstructive sleep apnoea.

#### Partial vs complete airway obstruction

It is important to recognize the difference between partial and complete obstruction (Table 2.1). Complete airway obstruction is an emergency; it needs early recognition and early definitive management to prevent death. When acute complete airway obstruction is recognized, a surgical airway is indicated as the definitive management.

Table 2.1 Clinical features of partial vs. complete airway obstruction

| Partial airway obstruction    | Complete airway obstruction |
|-------------------------------|-----------------------------|
| Ventilation may be maintained | Unable to breathe or talk   |
| Stridor                       | Unable to cough             |
| Use of accessory muscles      | Apnoea                      |
| Drooling                      | Paradoxical chest movements |
| Positional worsening          | Desaturation                |
| Conscious initially           | Cyanosis                    |
|                               | Reduced consciousness/coma  |
|                               | Failed assisted ventilation |

## Causes of airway obstruction

Causes of airway obstruction can be broken down into anatomical location (Table 2.2). This can be within the airway, luminal, intramural, or extramural. This can be further specified by whether the lesion is supraglottic, laryngeal, tracheal, or bronchial.



## 3. Pneumothorax/haemothorax

#### Introduction

- Thoracic trauma has a high morbidity and mortality (25% of traumatic deaths)
- Chest injuries occur in roughly 60% of polytrauma cases
- Pneumothorax (PTX) is a significant global health problem (incidence 18–28 cases/100,000/year for men)
- 12% risk in smokers vs 0.1% risk in non-smokers for PTX

#### **Tension pneumothorax**

- Tension PTX is an emergency and requires immediate treatment by needle thoracocentesis. A formal chest
  drain can then be sited
- Diagnosis is **not** radiological but from clinical signs of respiratory distress:
  - Cyanosis/low SpO<sub>2</sub>/low PaO<sub>2</sub>
  - Hypotension/shock
  - Tracheal deviation away from side of other signs
  - Silent, resonant hemithorax

#### **Spontaneous pneumothorax**

- The size of a pneumothorax is less important than the degree of clinical compromise
  - Patients with significant breathlessness should undergo active intervention
- Large PTX has a visible rim of >2 cm between lung margin and chest wall
- Aspirate in second intercostal space, mid-clavicular line with a 18G cannula
- Stop aspiration if
  - More than 2.5 L aspirated
  - Resistance is felt
  - Excessive coughing

#### **Traumatic pneumothorax**

- Chest drains are required for any history of chest trauma
- A repeat chest radiograph should always be obtained

#### **Haemothorax**

- 400–500 mL of blood required to obliterate costophrenic angle on upright CXR
- All haemothoraces, regardless of size, should be considered for drainage with a tube thoracostomy (usually 36–42 Fr)
- Criteria indicating the necessity to proceed with urgent thoracotomy:
  - >1,500 mL of blood immediately evacuated by tube thoracostomy
  - Persistent bleeding of 150–200 mL/hour for 2–4 hours
  - Persistent blood transfusion is required to maintain haemodynamic stability

#### **Discharge**


- Patients with small primary spontaneous PTX, without breathlessness, with early outpatient (O/P) review
- Clear written advice to return immediately if less well or more breathless
- Air travel should be avoided until full resolution (contact airline)
- Diving contraindicated unless patient undergoes bilateral surgical pleurectomy
- PTX recurrence risk up to 50% within 4 years

# 4. Asthma and chronic obstructive pulmonary disease

#### Introduction

- Both asthma and COPD are obstructive pulmonary diseases
  - If patient is symptomatic, spirometry should show an obstructive pattern with forced expiratory volume (FEV1)/forced vital capacity (FVC) < 70%</li>
- Asthma is inflammation of the airways, leading to reversible airflow obstruction
  - Either FEV1 or FVC improves with the use of a bronchodilator
  - Prevalence of 3.85 million people in the UK
- Some examples of classic triggers of asthma include:
  - Exercise and cold air
  - Upper respiratory tract infections
  - Animal fur/pollen/mould
  - Tobacco smoke
- Asthma is often associated with atopy
- COPD is airflow obstruction that is not fully reversible
  - It accounts for 1 in 8 emergency admissions in the UK
  - Reduction in FEV1/FVC ratio with minimal or no improvement after inhaled bronchodilator
- Diagnosis of COPD should be considered in patients >35 years old with:
  - Risk factors (predominantly smoking)
  - Exertional breathlessness
  - Chronic cough or wheeze and regular sputum production
- Exacerbations requiring hospital admissions carry 3–4% mortality rate

## Diagnosis and evaluation

Factors implying hospital admission:

- Inability to cope at home/confined to bed
- Severe breathlessness
- Cyanosis
- Impaired level of consciousness/acute confusion
- Significant comorbidities

A key aspect of asthma is variability in airflow obstruction.

• A peak flow meter is useful to monitor exacerbations of established disease

#### **Treatment**

- Treat with a combination of quick relief (beta agonist inhaler, such as salbutamol) and controller medications (IV corticosteroids or steroid inhaler)
- Educate patients to avoid triggers and maintain a clean living environment
- Smoking cessation is essential
- Frequent use of systemic corticosteroids, nocturnal symptoms, Emergency Department visits, and previous intubations all suggest poor control and portend a poorer prognosis
- Non-invasive ventilation (NIV) should be used for persistent hypercapnic ventilatory failure not responding to medical therapy



# 5. Pulmonary embolism

#### Introduction

- Major risk factors include the following (relative risk 5–20):
  - Venous stasis or immobilization
     Surgery and trauma
     Pregnancy
  - Malignancy
     Previous proven thromboembolism

#### Signs and symptoms

- Classically, abrupt onset of pleuritic chest pain, shortness of breath, and hypoxia
- PE should be suspected in patients with respiratory symptoms unexplained by an alternative diagnosis

## **Diagnosis**

- ECG: right axis deviation, right bundle branch block (RBBB), S1Q3T3, sinus tachycardia
- Two-level Wells score to aid diagnosis (Box 2.1)
- Negative predictive value (NPV) of D-dimers useful in low-risk patients (89–96%)
- CTPA or V/Q scan if renal failure/contrast allergy

#### Box 2.1 Two-level Wells score

Clinically suspected DVT (3) PE most likely diagnosis (3)

Heart rate >100 (1.5) Immobile >3 days/surgery <4 weeks (1.5) Previous DVT/PE (1.5) Haemoptysis (1)

Malignancy <6 months (1)
Total score >4 = high risk

## **Management**

## Anticoagulation and thrombolysis

- Thrombolysis is the first-line treatment for massive PE, and may be instituted on clinical grounds alone if cardiac arrest is imminent (see Box 2.2 for agents)—may take 90 minutes
- For non-massive PE, low molecular weight heparin (LMWH) is recommended over unfractionated heparin
  - Thrombolysis should not be used as first-line treatment in non-massive PE.

#### Box 2.2 Thrombolytic agents licensed for PE

#### Alteplase

- Accelerated regimen: 50 mg bolus
- 10 mg over 1–2 minutes, followed by 90 mg over 2 hours

#### Streptokinase

- Accelerated regimen: 1.5 million IU over 2 hours
- 250,000 units over 30 minutes, then 100,000 units/hour over 12–72 hours

#### Urokinase

- Accelerated regimen: 3 million IU over 2 hours
- 4400 units/kg over 10–20 minutes, then 4400 units/kg/hour for 12 hours

#### Surgical options


- If thrombolysis has failed or is contraindicated, surgical management options include:
  - Catheter embolectomy and fragmentation
     Surgical embolectomy

## 6. Acute heart failure

#### Introduction

In heart failure the heart does not pump enough blood to meet all the needs of the body. Heart failure may present as a first occurrence or as a consequence of acute decompensation of chronic heart failure.

#### Causes

It may be caused by primary cardiac dysfunction or be precipitated by extrinsic factors. Among the most frequent causes of acute heart failure are:

- Acute myocardial dysfunction (ischaemic, inflammatory, or toxic)
- Acute valve insufficiency
- Pericardial tamponade

Decompensation of chronic heart failure can occur

- Infection
- Uncontrolled hypertension
- Rhythm disturbances
- Non-adherence with drugs/diet.

#### **Clinical manifestations**

- Progressive dypnoea, cough, pink frothy sputum
- Symptoms of peripheral and abdominal congestion—ankle swelling, abdominal fullness
- Abdominal tenderness due to hepatic congestion and patient may complain of nausea and anorexia

## **Physical signs**

- Elevated jugular venous pressure (JVP)/positive hepatojugular reflex
- Reduced air entry at lung bases
- Leg oedema
- · Cardiac examination may be normal or can show displaced apex and third heart sound

#### **Investigations**

- Bloods—U&E, bicarbonate, lactate, troponin T, N-terminal pro B-type natriuretic peptide (NT-pro BNP)
- ABGs—if patient hypoxic and likely to need ventilatory support
- ECG—checking specifically for evidence of ischaemia or dysrhythmia
- CXR—this may (in 20% of cases) be normal; other signs include mild pulmonary vascular redistribution to marked cardiomegaly and extensive bilateral interstitial markings
- Echocardiogram—recommended for patients with new diagnosis of heart failure. The urgency of this depends upon the acuity of presentation

#### **Management**


- Diuresis (choice and dose of diuretic according to local protocols). Furosemide +/
   other diuretics with urine
   output monitoring
- Supplemental oxygen +/- assisted ventilation if needed
- Vasodilator therapy
- Arrhythmia management (if present)

Venous thromboembolism prophylaxis is indicated for all patients hospitalized with acute heart failure.

## 7. Cough

## **Duration of symptoms**

For ease of assessment and management it is best to establish how long a patient has had a cough. A cough of <3 weeks duration is deemed an acute cough, 3–8 weeks is subacute, and >8 weeks is termed a chronic cough. These are arbitrary cut-off points but generally accepted. For the purposes of assessment and investigation in an Emergency Department, an intermediate and a chronic cough are approached in much the same way.

## Clinical features suggesting admission likely

- Respiratory rate (RR) >30
- Heart rate (HR) >130
- Significant hypotension: systolic blood pressure (SBP) <90; diastolic blood pressure (DBP) <60
- Oxygen saturations <92% on air (unless normal for patient, e.g. known COPD)</li>
- Central cyanosis (if no history of chronic hypoxia)
- Peak expiratory flow rate (PEFR) <33% predicted (if asthmatic)</li>
- Reduced Glasgow Coma Scale (GCS)
- Significant respiratory effort/exhaustion
- Clinical features of PE, pneumothorax, or aspirated foreign body (FB)

## Clinical features suggesting admission should be considered

- Tachycardia
- Hypotension
- Fever (temperature >38.5°C)
- Peak expiratory flow rate (PEFR) <50% predicted</li>
- Age >65 years

## Clinical features suggestive of lung cancer

- Haemoptysis
- Any of the following that are unexplained and persist >3 weeks:
  - Chest/shoulder pain
  - Breathlessness
  - Weight loss
  - Hoarseness
  - Finger clubbing
  - Cervical or supraclavicular lymphadenopathy

## Clinical features suggestive of foreign body aspiration

- Sudden onset of cough, possibly associated with history suggestive of inhaled FB
- Stridor if FB in upper airway
- Signs of lung or lobar collapse if FB in lower airways

#### **Pertussis**

Suspect if:

- Cough has lasted more than 14 days, with paroxysms of coughing or vomiting after coughing or cough associated with inspiratory 'whoop'
- Cough develops within 2 weeks of contact with someone with confirmed pertussis


## Clinical features suggestive of TB

- Chronic cough with associated sputum, breathlessness, or haemoptysis
- Weight loss

## 8. Cyanosis

#### Introduction

It is worth noting at the start that there is significant inter-observer variability in the identification of cyanosis. It should also be noted that below approximately 5 g/dL of haemoglobin, cyanosis is not clinically detectable, irrespective of the level of hypoxaemia. Likewise, in less severe cases of anaemia, the level of hypoxaemia required to produce detectable cyanosis is greater that in patients with higher haemoglobin concentrations (i.e. cyanosis appears at a higher oxygen saturation level in patients with normal haemoglobin levels).

#### Causes

- In cyanosis due to acute hypoxaemia (e.g. caused by infection or pulmonary oedema) optimal medical treatment should be started immediately, with supplementary oxygen. Failure to improve warrants consideration of non-invasive or invasive respiratory support.
- Many cases have been reported in the literature of skin staining, e.g. from blue socks, giving the appearance of cyanosis!
- Cyanosis-like skin discoloration may also be seen as a side effect of medications, e.g. amiodarone.
- It is also common to see peripheral vasoconstriction, usually brought on by cold temperatures, resulting in cyanotic changes to the distal limbs. More seriously, this may be seen in peripheral vascular occlusion.
- Patients with congenital cyanotic heart disease or severe COPD or heart failure may be chronically
  hypoxaemic. These patients frequently know their 'normal' oxygen saturations, and if available there are likely
  to be previous PaO₂ results in their medical records for comparison. Further causes of reversible hypoxia
  should still be sought.


#### **Notes**

Methaemoglobinaemia causes interference to normal light absorption utilized by pulse oximetry. As such, in patients with methaemoglobinaemia, pulse oximetry reading typically displays around 85%; however, this does not correlate with their PaO<sub>2</sub>. Most cases occur after drug use such as nitrites. # 1. Cardiorespiratory arrest—adult life support (ALS)

#### Introduction

- VF/VT is the first monitored rhythm in approximately 25% of cardiac arrests
  - Also seen in approximately 25% of cases with initial rhythm of asystole or pulseless electrical activity (PEA)
- Survival following cardiac arrest with asystole or PEA is unlikely unless a reversible cause can be treated
  effectively

## **During CPR**

- Ensure high-quality CPR: rate, depth, recoil
  - Change individual every 2 minutes to prevent tiring
- Plan actions before interrupting CPR
  - Emphasis on minimally interrupted high-quality chest compressions
  - Chest compressions are continued whilst defibrillator is charged
  - Pads are safer and enable a shock to be delivered more rapidly than paddles
- Give oxygen (remove source during defibrillation)
- Consider advanced airway and capnography
  - Continuous chest compressions when advanced airway in place
- Vascular access (IV, IO)
- Give 1 mg adrenaline (1 in 10,000) every 3-5 minutes
  - 1st adrenalin given immediately if non-shockable rhythm
  - 1st adrenalin given just after 3rd shock for VF/pulseless VT
  - 300 mg amiodarone also given just after 3rd shock for VF/pulseless VT
- Correct reversible causes

## Reversible causes (4 Hs and 4 Ts)

- Hypoxia
- Hypovolaemia
- Hyper/hypokalaemia/metabolic
  - IV calcium chloride indicated in presence of hyperkalaemia, hypocalcaemia, and calcium channel-blocking drug overdose
- Hypothermia
  - Use low-reading thermometer, especially in drowning
- Tamponade—cardiac
- Thrombosis—coronary or pulmonary
  - Consider immediate thrombolysis if likely cause (may require 90 minutes of CPR)
- Toxins
- Tension pneumothorax


#### **Management**

- Three stacked shocks are recommended for VF/pulseless VT in witnessed arrest
- Initial shock should be at least 150 | (biphasic) or 360 | (monophasic)
- Delivery of drugs via ET tube is no longer recommended
  - If IV access cannot be achieved, give drugs IO
- Do not interrupt chest compressions if organized rhythm seen within 2-minute period, unless patient shows signs of life
- If any doubt about existence of a pulse, resume CPR

# 2. Cardiorespiratory arrest—advanced paediatric life support (APLS)

#### Introduction

Cardiac arrest should be confirmed in a collapsed child by following the ABC approach:

- Airway (A): Use head tilt/chin lift manoeuvre
  - Infant—head tilt to neutral position
  - Child—head tilt to sniffing position
  - If no improvement—jaw thrust
  - LOOK for chest/abdominal movement
  - LISTEN for breath sounds
  - FFFI for breath
- Breathing (B): If normal breathing starts after airway manoeuvres, place in recovery position
  - If no breathing—give 5 rescue breaths
  - Infant—seal mouth around patient's mouth and nose
  - Child—seal mouth around patient's mouth (whilst pinching nose)
  - Observe the chest rise
- Circulation (C): Check central pulse for 10 seconds:
  - Child—carotid or femoral artery
  - Infant—brachial or femoral artery
  - Start chest compressions if:
    - There are no signs of life
    - There is no pulse or there is a slow pulse (<60 bpm and poor perfusion)

#### Infant

- Hand-encircling technique (two or more rescuers): partially encircle/encircle chest with hands and place thumbs on lower half of sternum
- Two-finger technique (one rescuer): two fingers placed on lower half of sternum
- Compress chest at rate of 100–120 per minute in a ratio of 15 compressions to 2 breaths (15:2)

#### Child

- One-handed technique: place heel of one hand over lower half of sternum. Lift fingers to ensure no pressure
  over ribs. Position yourself vertically above child's chest and compress with arm straight
- Two-handed technique: use both hands with fingers interlocked
- Compress sternum to depress it by one-third of depth of chest
- Compress chest at rate of 100–120 per minute in a ratio of 15 compressions to 2 breaths (15:2)

## **Defibrillation**

Attach defibrillator pads and assess the patient's rhythm. Determine if the rhythm is shockable (VF/pulseless VT) or non-shockable (PEA/asystole).

If in a shockable rhythm, administer shock of 4 J/kg and then immediately resume CPR for 2 minutes. If in a non-shockable rhythm immediately resume CPR for 2 minutes.


Adrenaline is given every 3–5 minutes at a dose of 10 mcg/kg and can be given IV or IO.

The reversible causes (4 Hs and 4 Ts) should be considered and acted upon as appropriate. (Please see appropriate chapters for management.)

#### **During CPR**

- Ensure high-quality CPR: rate, depth, recoil
- Plan actions before interrupting CPR Give oxygen
- Vascular access (intravenous, intraosseous)
- Give adrenaline every 3–5 min
- · Consider advanced airway and capnography
- Continous chest compressions when advanced airway in place
- Correct reversible causes
- Consider amiodarone after 3 and 5 shocks

#### Reversible Causes

- Hypoxia
- Hypovolaemia
- Hyper/hypokalaemia, metabolic
- Hypothermia
- Thrombosis (coronary or pulmonary)
- Tension pneumothorax
- Tamponade (cardiac)
- · Toxic/therapeutic disturbances

# 3. Chest pain

#### Introduction

Table 3.1 shows risk factors, typical presenting features, examination findings and investigations that can help diagnose various causes of chest pain.


#### **Notes**

MI can present with a normal ECG and chest wall tenderness and be relieved by antacids. It can also present in patients aged <30. If in any doubt, admit patients for further tests, including serial troponins, and discussion with senior colleagues.

## 4. Palpitations

#### Introduction

Palpitations are a subjective awareness of one's heartbeat. It is essential to clarify exactly what each patient means by this term: asking them to tap out what they feel can give invaluable information with regard to rate and rhythm.

#### **Causes**

Although many causes of palpitations are benign, more serious causes do exist, and high-risk features should always be looked for (Box 3.1).

#### Box 3.1 High-risk features

Associated syncope

Precipitated by exercise

History of sudden cardiac death

Second or third AV block on ECG

Prolonged QT interval

Heart murmur

Precipitants include caffeine, alcohol, amphetamine, and other illicit drug use, along with a number of commonly prescribed medications (Box 3.2).

#### Box 3.2 Modifiable causes

Alcohol

Caffeine

Anxiety

Prescribed or non-prescribed drug use

Suspected thyroid disease

A group of rare but significant causes are the inherited cardiac diseases: any history of a relative with sudden cardiac death, unexplained death under age 40, or 'epilepsy' (which may be a misdiagnosed arrhythmia) should be taken seriously. A number of non-cardiac causes may present with palpitations, including electrolyte abnormalities, thyroid disease, anaemia, and anxiety.

#### **Management**

All cases of atrial fibrillation (AF) (paroxysmal and permanent) carry a thromboembolic risk, and  $CHA_2DS_2$ -VASc score (Table 3.2) should be recorded and consideration given to long-term anticoagulation if >0. Note: acute-onset AF may be suitable for early cardioversion. Discuss with senior ED clinician.



# 5. Tachyarrhythmias

#### Introduction

Tachyarrhythmias are relatively common in the peri-arrest period. They may precipitate VF.

#### Assessment

Determine two factors:

- Condition of the patient (stable versus unstable)
- Nature of arrhythmia (from 12-lead ECG)
  - Broad complex is QRS duration of >0.12 seconds (three small squares on standard ECG paper speed of 25 mm/s)

#### Adverse features

- Shock
  - Hypotension (BP <90 mmHg systolic), pallor, sweating, cold, confusion</li>
- Syncope
  - Transient loss of consciousness due to global reduction in blood flow to the brain
- MI
  - Typical chest pain and/or evidence on 12-lead ECG
- Heart failure
  - Pulmonary oedema and/or raised IVP

#### **Treatment**

- Dependent on nature and condition, immediate treatment is categorized under four headings:
  - Electrical (cardioversion)
  - Simple clinical interventions (e.g. vagal manoeuvres)
  - Pharmacological
  - No treatment needed
- If tachyarrhythmia is due to an underlying condition, ensure that condition is treated appropriately
- Sinus tachycardia (regular narrow complex) is not an arrhythmia but a physiological response to exercise, anxiety, pain, infection, blood loss, etc.
- Treatment should be directed at underlying cause
- Trying to slow sinus tachycardia may make situation worse

#### Vagal manoeuvres

- Carotid sinus massage
- Valsalva manoeuvre
- Successful in up to 25% of paroxysmal supraventricular tachycardia (SVT)


#### **Cardioversion**

- Perform under general anaesthesia or conscious sedation
- Ensure defibrillator is set to synchronized mode
- Provide increasing increments of energy if fails to convert
  - Commence at 120–150 J biphasic for broad-complex or AF
  - 70–120 J biphasic for atrial flutter or regular narrow complex

# 6. Bradyarrhythmias

#### Introduction

Potential underlying causes must be sought and treated whilst managing cardiovascular compromise using Resuscitation Council UK guidelines. These include heart block, sick sinus syndrome, hypothermia, and toxicity from, for example, beta-blockers.

## **Management**

In the peri-arrest setting, fist pacing is an immediate temporary treatment option which can be used whilst arranging drug or electrical treatment.

Emergency transcutaneous pacing may be performed using a suitable defibrillator with pacing function. You must ensure you are familiar with the equipment used in your place of work. The generic steps to follow are:

- Place pads on chest (AP position recommended)
- Connect ECG leads
- Set pacemaker mode to demand
- Set rate to required value (typically 70–80 bpm)
- Start pacing and increase mA until pacing rate captured on monitor (confirm by palpating peripheral pulse).

Where toxicity (deliberate or accidental) is suspected, appropriate treatment advice should be obtained from the National Poisons Information Service. Common causative agents include beta-blockers, digoxin (especially in the presence of hypokalaemia), and calcium channel blockers.

Early cardiology involvement is required in the following:

- Any case not responding to interventions listed in the algorithm
- Suspected MI
- Complete heart block
- Presence of prolonged PR interval associated with either new bifascicular block (RBBB +LAD or RBBB + RAD) or with complete LBBB: this may suddenly deteriorate to complete heart block.

#### **Notes**


Transcutaneous pacing can be life-saving but is often intolerable for the patient. Analgesia +/– sedation is required. Beware of deterioration to PEA with paced complexes remaining on the monitor.

## 1. Acute abdominal pain

#### **Definition**

Acute abdominal pain is a common clinical presentation in the Emergency Department. The clinician addressing the patient with acute abdominal pain ideally should eliminate acute medical causes of abdominal pain as well as acute surgical causes.

#### Acute versus chronic pain

While a 12-week arbitrary interval can be used to separate acute from chronic abdominal pain, there is no strict time period that will classify the differential diagnosis. A clinical judgement must be made that considers whether this is an accelerating process, one that has reached a plateau, or one that is longstanding but intermittent.

Pain in a sick or unstable patient should generally be managed as acute, since patients with chronic abdominal pain may present with an acute exacerbation of a chronic problem or a new and unrelated problem.


## Important points to consider when managing patients

- A normal WBC count does not rule out appendicitis or other acute inflammatory conditions
- Normal-looking CXR does not rule out the presence of pneumoperitonium (if you see it, it's there; if you
  don't see it, it doesn't mean it's not there)
- Analgesia should not be withheld to patients with abdominal pain for the fear of obscuring clinical findings.
   Oligoanalgesia is not acceptable practice
- Plain abdominal X-ray (AXR) should not be taken unless bowel obstruction is suspected
- Avoid overzealous resuscitation in patients with suspected abdominal aortic aneurysm (AAA) rapture and immediate vascular referral should be made. AAA should be suspected in any patient >65 years of age
- It is hazardous making a diagnosis of renal colic in an elderly patient without considering the diagnosis of a leaking AAA
- Medical causes for abdominal pain should not be overlooked, like MI, basal pneumonia, and diabetic ketoacidosis (DKA)
- The diagnosis of mesenteric ischaemia should be considered, particularly in patients with the classic finding
  of pain out of proportion to physical findings or risk factors such as congestive heart failure, recent MI,
  hypotension, hypovolaemia, sepsis, cardiac surgery, or requirement for dialysis.

# 2. Rectal bleeding

#### **Definition**

Lower gastrointestinal bleeding (LGIB) is defined as bleeding derived from a source distal to the ligament of Treitz. Haematochesia is the passage of fresh or altered blood per rectum usually due to colonic bleeding. Occasionally profuse upper gastrointestinal bleeding (UGIB) or small bowel bleeding can be responsible.

#### Causes

For causes of acute rectal bleeding see Table 4.1.

Table 4.1 Causes of acute rectal bleeding

## Important points in initial management and resuscitation


- Consider a UGIB source in patients with haemodynamic instability, orthostatic hypotension, and an elevated urea-to-creatinine ratio, since 10–15% of patients with severe haematochesia will have a UGIB source
- Nasogastric (NG) aspiration and lavage may help identify patients with upper GI bleeding. Findings that suggest UGIB include the presence of coffee-ground material or bright-red blood in the lavage fluid
- A haemodynamically normal patient with per rectal bleeding which has stopped and normal haemoglobin
  might be considered for discharge with surgical outpatient follow-up
- Colorectal malignancy should be suspected in:
  - Patients aged ≥40 years reporting rectal bleeding with a change of bowel habit towards looser stools and/ or increased stool frequency persisting for ≥6 weeks
  - Patients aged ≥60 years with rectal bleeding persisting for ≥6 weeks without a change in bowel habit and without anal symptoms
  - Patients aged ≥60 years with a change in bowel habit to looser stools and/or more frequent stools
    persisting for ≥6 weeks without rectal bleeding

# 3. Dehydration in children

## **Aetiology**

Occurs with excess loss of water and other body fluids, due to:

- Decreased intake
- Increased output (renal, GI, or insensible losses)
- Shift of fluid (ascites or effusions)
- Capillary leak of fluid (burns or sepsis)

#### **Causes**

- Gastroenteritis or GI obstruction (e.g. pyloric stenosis)
- Pain limiting oral intake (e.g. mouth ulcers or tonsillitis)
- DKA, febrile illness, or burns

#### **Assessment**

Children who are at increased risk of dehydration include the following:

- <1 year of age, especially those younger than 6 months</li>
- · Infants who were of low birth weight
- >5 diarrhoeal stools or >2 vomits in past 24 hours
- Not been offered or not been able to tolerate oral fluids
- Stopped breastfeeding during the illness
- Signs of malnutrition

#### Calculation of deficit

- No significant dehydration (<3%)</li>
  - No signs
- Clinical dehydration (3–8%)
  - Dry mucous membranes, sunken eyes, reduced skin turgor, tachycardia, looks unwell, drowsiness, irritability
- Severe dehydration/shock (>8%)
  - Acidotic respiration, poor perfusion (capillary refill time (CRT) >2 seconds), circulatory collapse, deteriorating conscious level

#### **Treatment**

- Mild to moderate = Oral rehydration (e.g. Dioralyte™) whenever possible
  - 50 mL/kg in small volumes over 4 hours
  - If vomiting persists, try smaller volumes more frequently
  - Consider NG fluids if refusing
- Severe = Replace deficit (50 mL/kg) plus maintenance over 24 hours
  - If signs of shock, give 10–20 mL/kg 0.9% saline as IV bolus and repeat as necessary

#### **Maintenance fluids**

These should be given at a rate of:


- <10 kg: 100 mL/kg/day</li>
- 10-20kg: 1000 mL plus 50 mL/kg/day for every kg >10 kg
- >20 kg: 1500 mL plus 20 mL/kg/day for every kg >20 kg

## 4. Diarrhoea

#### **Definition**

The following definitions have been suggested according to the duration of diarrhoea:

- Acute diarrhoea: ≤14 days in duration
- Persistent diarrhoea: >14 days in duration
- Chronic diarrhoea: >30 days in duration

#### Causes

Most cases of acute diarrhoea are due to infections with viruses and bacteria and are self-limiting. Non-infectious aetiologies become more common as the diarrhoea persists and becomes chronic.

## Important points in patient evaluation

- Duration of illness
- Frequency and characteristics of the stool
- Associated signs and symptoms of systemic illness such as fever, anorexia, weight loss, and volume depletion
- Evaluate for hypovolaemia (e.g. decreased skin turgor, orthostatic hypotension)
- Abdominal pain and presence of peritoneal signs

## Indications for diagnostic evaluation

A diagnostic evaluation is indicated in patients with relatively severe illness, as suggested by one or more of the following:

- Profuse watery diarrhoea with signs of hypovolaemia
- Passage of many small-volume stools containing blood and mucus
- Bloody diarrhoea
- Temperature ≥38.5°C (101.3°F)
- Passage of ≥6 unformed stools per 24 hours or a duration of illness >48 hours
- Severe abdominal pain
- Hospitalized patients or recent use of antibiotics
- Diarrhoea in the elderly (≥70 years of age) or the immunocompromised
- Systemic illness with diarrhoea, especially in pregnant women (in which case listeriosis should be suspected)

#### **Notes**


- Presence of either WBCs or RBCs in stool implies infection with invasive organisms and/or inflammatory bowel disease
- Empiric antibiotic therapy should be avoided, as patient might develop haemolytic-uraemic syndrome if
  infected with enterohaemorrhagic Escherichia coli (increase in the production or release of Shiga toxin)

# 5. Dysuria

#### Introduction

Physical examination in a patient complaining of dysuria should include:

- Temperature
- General well-being
- Urine dipstick
- Examination of lymph nodes
- Consider blood culture if systemically unwell (temperature >38°C)

Patients with risk factors for sexually transmitted infection should be offered or referred for screening, including HIV

## Dysuria in men

Dysuria is common in men and may be a symptom of various conditions including:

- Urethritis
- Prostatitis
- Epididymitis/epididymo-orchitis
- Urinary tract infection (UTI)

## Dysuria in pregnancy

Bacteriuria is very common in pregnancy, especially in the first trimester. If not treated, 30–40% of cases will go on to develop a symptomatic UTI. In the UK, pregnant women are screened at 12–16 weeks—by urine dip (and microscopy, culture, and sensitivity (MC&S) if appropriate). *E. coli* remains the most common organism.

Untreated bacteriuria is associated with:

- Preterm birth
- Low birth weight
- Perinatal mortality

## **Ascending urinary tract infection**

Acute pyelonephritis is usually associated with systemic upset, high temperature, and loin or back pain. Patients often require admission for IV antibiotics, IV fluids, and analgesia.

## **Urine dipstick**

A urine test strip or dipstick is a basic diagnostic tool used to determine pathological changes in a patient's urine. It checks urine acidity, specific gravity, protein, sugar, ketones, bilirubin, WBCs, RBCs, and nitrates. A positive test for nitrates indicates a possible urine infection caused by nitrate-reducing bacteria, and a high number of WBCs indicates urinary infection.



# 6. Ectopic pregnancy

#### Introduction

Ectopic pregnancies occur in approximately 1% of all pregnancies, and 97% occur as a tubal implantation.

It is imperative that a pregnancy test is performed in **all** patients presenting with any of the symptoms or signs shown in Table 4.2. A urine or serum beta-human chorionic gonadotropin ( $\beta$ -HCG) test is needed. It is important to recognize and treat an ectopic pregnancy promptly to improve morbidity and mortality. Early assistance from seniors, the gynaecology team, and anaethetists is recommended.

Table 4.2 Risk factors, symptoms, and signs of ectopic pregnancy

| Risk factors                  | Symptoms              | Signs                          |
|-------------------------------|-----------------------|--------------------------------|
| Pelvic inflammatory disease   | Abdominal/pelvic pain | Pelvic or abdominal tenderness |
| In vitro fertilization (IVF)  | Amenorrhoea           | Adnexal tenderness             |
| Previous pelvic/tubal surgery | Vaginal bleeding      | Cervical excitation            |
| Previous ectopic              | Dizziness/syncope     | Peritonitis                    |
| Intra-uterine device          | Shoulder-tip pain     | Signs of 'shock'               |
|                               | Rectal 'pressure'     | Cervical os usually closed     |

#### Symptoms and Signs

The 'classical' history is one of lower abdominal pain and per vagina (PV) bleeding; however, the symptoms are varied and an open mind is needed to diagnose ectopic pregnancies.

If the patient is haemodynamically unstable, an urgent laparotomy is needed to clamp the bleeding artery. If gynaecology is not on site, immediate discussion with the senior surgeon is required.

## Anti-D immunoglobulin

Anti-D immunoglobulin (Ig) should be given to all rhesus-negative women who need a surgical procedure to manage an ectopic pregnancy. Patients with a medically managed ectopic pregnancy may not need anti-D—discuss this with the gynaecology team.


Anti-D is given IM via the deltoid muscle at 250 IU.

There is no clinical need to perform a Kleihauer test to quantify feto-maternal haemorrhage.

## 7. Haematemesis and melaena

#### Introduction

Haematemesis is the vomiting of blood, either bright red in colour or of coffee-ground material (altered blood). Melaena is the passage of black tarry stools. The tarriness is characteristic and distinguishes melaena from the passage of black stools due to dietary agents, including the ingestion of iron.

#### **Aetiology**

- Peptic ulcer disease (commonest—50% of cases)
   Oesophago-gastric varices
- Gastritis, esophagitis, duodenitis
   Oesophageal (Mallory–Weiss) tear
- Tumour
   Arteriovenous malformation

At the time of first assessment, this should focus on trying to identify the cause of the bleeding, assess the haemodynamic status of the patient, and define factors that predict outcome (risk stratification). A history of previous ulcer disease, aspirin, or NSAID use is common in patients with bleeding peptic ulcer.

#### Risk stratification

The Blatchford score, unlike the Rockall score, does not take endoscopic findings into account and thus can be used when the patient first presents to the Emergency Department (Table 4.3).

## Features of a major bleed

- Tachycardia (be aware of patients on β-blockers)
- Tachypnea Hypotension (SBP <100 mmHg)
- Presence of significant postural drop in BP
   Reduced conscious level
   History of syncope

#### Important points in initial management and resuscitation


- Transfuse patients with massive bleeding with blood, platelets, and clotting factors
- Offer platelet transfusion to patients who are actively bleeding and have a platelet count of <50 × 10° L</li>
- Offer prothrombin complex concentrate (e.g. Beriplex® 30 units/kg) to patients who are taking warfarin with high INR and actively bleeding
- Give terlipressin acetate (2 mg IV qds) to patients with suspected variceal bleeding
- Antibiotic therapy should be commenced in patients with chronic liver disease: e.g. IV aztreonam 2 g bd and IV metronidazole 500 mg tds
- Proton pump inhibitor (PPI) should not routinely be used prior to diagnosis by endoscopy

# 8. Jaundice

#### **Definition**

Jaundice is not a diagnosis per se but rather a physical manifestation of elevated serum bilirubin, usually not clinically apparent unless the serum total bilirubin is  $>50 \mu mol/L$ . It is not a common chief complaint. Instead, the jaundiced patient often presents with a related symptom (e.g. abdominal pain, pruritis, vomiting, or substance ingestion).

#### **Differential diagnosis**

The differential diagnosis of jaundice is broad, and a precise diagnosis is not always possible. For this reason, the emergency physician has two primary responsibilities: to identify and stabilize patients with life-threatening conditions and to provide an appropriate work-up for non-emergency cases.

The critical and emergency causes of jaundice include:

- Massive hemolysis
- Acute cholangitis
- Acute liver failure
- Acute fatty liver of pregnancy
- Neonatal hyperbilirubinaemia

#### Unstable jaundiced patient

Clues to a potentially critical unstable patient with jaundice include:

- Altered mental status
- Hypotension
- Fever
- Abdominal pain
- Coagulopathy, multiple bruises

#### Laboratory tests

Initial laboratory tests for a jaundiced patient should include bilirubin, alkaline phosphatase, aminotransferases (aspartate transaminase (AST), alanine transaminase (ALT)), prothrombin time/INR, and albumin.


- With normal alkaline phosphatase and aminotransferases, jaundice is likely not due to hepatic injury or biliary tract disease. In such patients, haemolysis or inherited disorders of bilirubin metabolism may be responsible for the hyperbilirubinaemia
- Predominant aminotransferase elevation suggests that jaundice is caused by intrinsic hepatocellular disease
- Predominant alkaline phosphatase elevation, out of proportion to serum aminotransferases, suggests biliary obstruction or intrahepatic cholestasis

# 9. Nausea and vomiting

#### **Definition**

Nausea is a subjective unpleasant sensation of being about to vomit.

Vomiting is the physical event that results in rapid, forceful expulsion of gastric contents and it should be differentiated from regurgitation.

Regurgitation is a passive act by which gastric contents are brought back into the mouth without the abdominal and diaphragmatic muscular activity that characterizes vomiting.

#### Causes

In most cases, the cause of nausea and vomiting can be determined from the history and physical examination and additional testing is not required.

#### Salient points in the history

- Abdominal pain with vomiting often indicates an organic etiology (e.g. cholelithiasis)
- Abdominal distension and tenderness suggest bowel obstruction
- Vomiting of food eaten several hours earlier and a succussion splash detected on abdominal examination suggest gastric obstruction or gastroparesis
- Vomiting in the morning is typically related to pregnancy, uraemia, alcohol ingestion, or increased intracranial
  pressure
- The quality of vomiting may be helpful. A feculent odor to the vomitus is a feature of intestinal obstruction suggestive of bacterial degradation of stagnant intestinal contents
- Heartburn with nausea often indicates gastroesophageal reflux disease

#### **Management**


As a general rule, the following four steps should be considered in patients with persistent nausea and vomiting:

- Etiology should be sought, taking into account whether the patient has acute nausea and vomiting or chronic symptoms (at least 1 month in duration)
- The consequences or complications of nausea and vomiting (e.g. fluid depletion, hypokalaemia, and metabolic alkalosis) should be identified and corrected
- Targeted therapy should be provided, when possible (e.g. surgery for bowel obstruction or malignancy). In other cases, the symptoms should be treated
- In women of childbearing age, a pregnancy test must be done

# 1. The unconscious patient

#### Introduction

Conscious level is determined using the GCS. The adult score ranges from a minimum of 3 to a maximum of 15 and is calculated as shown in Table 5.1. 'Unconsciousness' is generally taken to mean no eye response and a GCS  $\leq 8$ .

#### Causes

In the absence of trauma there are a number of different causes of a low GCS:

- Vascular (stroke/subarachnoid haemorrhage (SAH))
- Infection
- Neoplasm
- Seizures
- Metabolic disturbance

#### **History**

A thorough history is vital in determining the cause of 'unconsciousness'. This includes information obtained from paramedics, the patient's relatives and friends, and information from old medical records/Emergency Department attendances.

#### **Examination**


Thorough neurological examination may help to determine the cause:

- Coma without lateralizing signs is often due to poisoning, a postictal state, or hepatic failure
- Tricyclic antidepressant overdose causes coma with dilated pupils, increased tone, jerky limb movements, and ECG abnormalities
- Ocular nerve palsy with coma could indicate Wernicke's encephalopathy and requires treatment with IV thiamine

# 2. Aggressive/disturbed behaviour

#### **Initial approach**

There are many causes of agitation and it is important to use a methodical approach.

The initial priorities are to ensure that any life-threatening problem is identified and treated promptly (e.g. hypoxia, hypovolaemia, hypoglycaemia). The next step is to ensure that a thorough history (including a collateral history) and examination is undertaken. In these situations, good communication and explanation to the patient and relatives are imperative. These verbal and non-verbal skills are often sufficient to de-escalate the situation and help to treat the aggressive behaviour. A calm manner, non-critical approach, and active listening provide patients with reassurance and will reduce the need for pharmacological intervention.

Your personal safety and those of staff and patients around you is paramount. Ask for assistance early from seniors, security staff, or the police if needed.

#### **Treatment options**

- Treat the underlying cause. It is imperative that the cause for this behaviour is found and treated appropriately (e.g. aggressive treatment of sepsis, or treatment of encephalopathy, or correction of hypoxia or hypoglycaemia)
- Nursing techniques. Patients should be nursed in a well-lit, quiet room. It is important that good verbal and non-verbal communication skills are used to explain to the patient and reassure the patient about diagnosis and treatment options. De-escalation techniques can be used to ensure that patients are reassured
- Medication. When de-escalation techniques have failed or if they are inappropriate, medication can be given
  to patients who are at risk of harming themselves or harming others due to their agitated behaviour

Medication is, however, a last resort and should be given in discussion with senior support. Medication must be given with reference to the Mental Health Act and the Mental Capacity Act with respect to those patients who cannot consent to this treatment option. The aim is to minimize the risk of harm to the patient and to others around them.

- Oral therapy is preferred; however, this may not be possible in a violent and aggressive patient
- Ensure that the British National Formulary (BNF) is used prior to administering
- Allow sufficient time in between first dose and subsequent dose
- It is important to be aware of possible complications from lorazepam (e.g. respiratory depression) and haloperidol (e.g. acute dystonia) and know how to treat these (e.g. 5–10 mg IV procyclidine for haloperidolinduced dystonia)
- Avoid IV sedation for agitation if possible
- Care should be taken with the elderly or those with multiple comorbidities, and an appropriate reduced dose should be considered

Table 5.2 offers suggestions for possible choice of medications.

**Table 5.2** Medication options

| Route         | Non-psychotic patient | Psychotic patient                     |
|---------------|-----------------------|---------------------------------------|
| Oral          | Lorazepam 1–2 mg      | Lorazepam 1–2 mg + haloperidol 2.5 mg |
| Intramuscular | Lorazepam 2–4 mg      | Lorazepam 2–4 mg + haloperidol 5 mg   |



## 3. Alcohol and substance abuse

#### Introduction

- Alcohol dependence and withdrawal has significant morbidity and mortality
- People admitting to >10 units/day are likely to have withdrawal symptoms
- Delirium tremens is rare at a consumption of <15 units/day
- Hypoglycaemia, hypokalaemia, hypocalcaemia, and fever may predispose patients to seizures or delirium tremens (DTs)

#### **Presentation**

- Acute intoxication
- Withdrawal DTs
- Seizures: withdrawal or intoxication, or hypoglycaemia
- Associated problem, e.g. pneumonia, rhabdomyolysis

#### **Patient workup**

- History is the key to a diagnosis of alcohol or drug abuse or dependence
- Physical examination should be detailed and thorough
  - Cirrhosis, ascites, oedema, and jaundice characterize end-stage alcoholism
- Laboratory screening can be informative
  - Look for elevations in AST, ALT, and  $\gamma$ -glutamyltransferase (GGT)
  - FBC often shows elevated mean corpuscular volume (MCV) and mean corpuscular haemoglobin (MCHb) with prolonged use of alcohol

## **M**anagement

- Pabrinex® required if nil by mouth (NBM), or actual or incipient Wernicke's encephalopathy
  - Note: risk of anaphylaxis (must give before glucose)
- Signs of possible Wernicke–Korsakov syndrome:
  - Acute confusion
  - Reduced conscious level
  - Memory problems
  - Ataxia
  - Ophthalmoplegia
  - Hypoglycaemia
- Treat any associated problems. Screen for infection including CXR
- Remember spontaneous bacterial peritonitis
  - Tap ascites and send for culture, urgent Gram stain, and cell count
- Common precipitating causes of encephalopathy are infection, GI bleed, electrolyte disturbance, and constipation



# 4. Acute confusion/delirium

#### **Definition of delirium**

This is a clinical syndrome characterized by disturbed consciousness, cognitive function, or perception. It usually has an acute onset and a fluctuating course. It may be hyperactive or hypoactive or occasionally both.

- Hyperactive delirium is a subtype characterized by heightened arousal, restlessness, agitation, and aggression
- Hypoactive delirium is a subtype characterized by withdrawal, quietness, and sleepiness

## History and examination

Table 5.3 shows the key aspects to be covered in the clerking of a patient with acute confusion.

#### Table 5.3 Key Aspects of Medical Clerking

| Salient points to cover in the history  | Important aspects to cover in the examination   |

| Onset and course of confusion   | Usual vital signs   |
| Past medical history and comorbidities  | Cardiovascular, respiratory, and abdominal examination  |

#### **Modifiable risk factors**


- Familiar staff Clear signage/lighting/clocks
- Fluid balance
   Hypoxia
   Encourage mobility
- Search for and treat infections Avoid catheterization Medication reconciliation
- Assess for and manage pain (look for non-verbal clues)
- Resolve any reversible causes of sensory impairment, e.g. impacted ear wax
- Encourage normal sleep patterns (reduce noise levels)

# 5. Dizziness and vertigo

#### **Definition**

Vertigo is a symptom not a diagnosis. It is the sensation that you or the environment around you is moving or spinning in the absence of any physical movement.

#### **Types**

The first important question is: 'Does my dizzy patient have vertigo?' There are three basic forms of dizziness:

- Presyncope or light-headedness—see Chapter 8
- Unsteadiness or the feeling of imbalance or unsteadiness due to ataxia
- Vertigo

This chapter deals primarily with true vertigo.

The second important question is: 'Is the vertigo central or peripheral in origin?'

- Peripheral vertigo is caused by altered activity in the balance organs of the inner ear, from which the brain
  detects a sensation of movement (e.g. benign paroxysmal positional vertigo, vestibular neuronitis, labyrinthitis,
  and Ménière's disease)
- Central vertigo is caused by disturbance of the visual–vestibular interaction centres in the brainstem and cerebellum, or to sensory pathways to and from the thalamus (e.g. migraine, stroke, TIA, posterior fossa tumour, and multiple sclerosis)

Nystagmus in patients with vertigo is usually rotatory. If it is sustained, this is suggestive of a central cause; if it fatigues, it is suggestive of a peripheral cause. If the nystagmus is vertical (rare), this suggests a central cause.

### Salient points in the history

- Duration, onset, frequency, severity, and details of any previous episodes
- Aggravating/precipitating factors
- Hearing loss, tinnitus, discharge from ear, or a feeling of fullness
- Headache, visual disturbance, speech disturbance, weakness, or paraesthesia
- Nausea, vomiting, sweating, or palpitations
- Recent upper respiratory tract infection or ear infection
- Recent head injury/direct trauma to the ear
- Cardiovascular risk factors
- Past medical history including any previous cancers
- Medications taken
- Alcohol intake and illicit drug use
- Family history of Ménière's disease

#### Salient areas for examination


- Facial asymmetry
- · Ears including tympanic membrane and hearing
- Central nervous and cerebellar function
- Eyes including movements, examining for nystagmus, fields, and ophthalmoscopy
- Neurological examination of limbs
- Cardiovascular examination
- Gait
- Hallpike's test
- Consider Romberg's test

## 6. Fits/seizures

#### Introduction

This chapter is concerned with both primary and secondary generalized seizures.

## Salient points in the history

It is imperative to make every effort to capture a witness account of events. Salient points include:

- Does patient have history of previous fits?
- Condition of patient prior to fit, unwell in any way/trauma prior to fit
- Did the patient have any prodrome or warning of the fit?
- Was there any trigger for the fit?
- Was there any focal element prior to development of the tonic clonic fit?
- Was there any headache prior to the fit or prolonged headache after?
- How long did the fit last?
- Was any medication given to terminate the fit?
- Was there any urinary incontinence?
- Was there any tongue biting or buccal mucosa biting?

## Seizure or pseudo seizure?

It can be difficult to distinguish a seizure from a pseudo seizure, and the default position should be to treat a possible seizure if you are unable to distinguish the two. Some possible clues to aid the differentiation are:

- Uncoordinated failing movements of the extremities
- Evidence of consciousness, such as talking during an apparent tonic clonic fit
- Babinski sign is absent in a pseudo seizure
- Tongue biting does not occur (although patients have been known to bite the mucosa of the cheek)

### Drug therapy for seizure control in the emergency situation

First-line: benzodiazepine can be

- Diazepam 10-20 mg per rectum
- Midazolam 10 mg buccal
- Lorazepam 4 mg IV

This can be repeated after 10–15 minutes if seizure continues.

If seizure is more prolonged:

• Second- line: phenytoin 15 mg/kg at 100 mg/minute

If seizure is more prolonged still:

- Third-line: general anaesthetic (GA) with
  - Propofol 1–2 mg/kg bolus, then titrate to effect (2–10 mg/kg/hour)
  - Midazolam 0.1–0.2 mg/kg bolus, then titrate to effect (0.05–0.5 mg/kg/hour)
  - Thiopentone 3–5 mg/kg bolus, then titrate to effect (3–5 mg/kg/hour)

#### Indications for urgent CT following seizure


- Post head injury
- Associated sudden onset or persistent headache
- Associated focal neuro deficit (Todd's paresis)
- Patient has history of (h/o) cancer, HIV, or stroke
- Associated fever
- Focal onset
- Patient is anticoagulated
- Patient will not be compliant with follow-up

## 7. Headache

#### **Primary headache**

Primary headaches are classified according to the symptoms experienced; their diagnosis is reliant upon recognition of a clinical pattern. Most are episodic, but some, especially tension headache and sometimes migraine, can become chronic. Primary headaches can be positively diagnosed and do not require imaging for reassurance purposes alone. In the Emergency Department, primary headache should be a diagnosis of exclusion. As the diagnosis of primary headache is based on recurrence, one should be wary of diagnosing primary headache on a first presentation to the Emergency Department. No primary headache is caused by demonstrable organic disease or structural neurologic abnormality. Most common types of primary headache include:

- Migraine
- Tension-type
- Cluster and other trigeminal autonomic cephalagias

#### Secondary headache

Secondary headaches are classified according to their aetiology. They are usually of recent onset and associated with abnormalities on clinical examination. The diagnosis is confirmed by laboratory testing or imaging. The recognition of secondary headaches is vital, as treatment of the underlying cause will usually eradicate the headache, and more importantly some of the underlying conditions are life threatening. Although some important differential diagnoses are mentioned in the algorithm, these are by no means an exhaustive list.

### Salient points in the history

- Impaired conscious level
- New-onset cognitive dysfunction (delirium)
- Fever
- Photophobia, neck stiffness
- New neurological deficit
- Sudden onset, maximal within 5 minutes
- Severity, worsening
- Recent (within 3 months) head trauma
- Change in personality
- Triggered by cough, valsalva, or sneeze
- Triggered by exercise
- Orthostatic headache (triggered by changes in posture)
- Symptoms suggestive of giant cell arteritis
- Symptoms and signs of acute narrow-angle glaucoma
- Substantial change in characteristic of patient's headache
- Compromised immunity
- Age <20 years and a history of malignancy</li>
- History of malignancy known to metastasize to brain
- Vomiting without obvious cause
- · Early morning headache
- New-onset daily headache (without other symptoms) lasting at least 1 month



# 8. Syncope and pre-syncope

#### **Definition**

Syncope is the spontaneous, transient loss of consciousness with complete recovery.

## Salient points in the history

- Circumstances of event
- Posture immediately before loss of consciousness
- Prodromal symptoms
- Appearance: eyes open/shut, colour of patient
- Presence/absence of movement during event (and duration)
- Tongue biting (side or tip of tongue)
- Injury occurring during event (site and severity)
- Duration of event
- Presence/absence of confusion during recovery (red flag)
- Weakness down one side during recovery (red flag)
- Family history of sudden death (red flag)

#### Abnormalities to look for on ECG

- Inappropriate, persistent bradycardia
- Any ventricular arrhythmia (including ventricular ectopics)
- Long QT (cQT >450 ms) and short QT (cQT <350 ms)</li>
- Brugada syndrome
- Ventricular pre-excitation
- Left or right ventricular hypertrophy
- Abnormal T wave inversion
- Pathological Q waves
- Atrial arrhythmias (sustained)
- Paced rhythm

## Features suggestive of simple vasovagal syncope (the three Ps)

- Posture: prolonged standing or similar episodes that have been prevented by lying down
- Provoking factors (such as pain or medical procedure)
- Prodromal symptoms (e.g. sweating or feeling warm/hot)

#### Features suggestive of seizure activity


- Bitten tongue
- Head or eyes turning to one side during transient loss of consciousness
- No memory of abnormal behaviour that was witnessed before, during, or after the transient loss of consciousness by someone else
- Unusual posturing
- Prolonged limb jerking (note that brief seizure-like activity can often occur during uncomplicated vasovagals)
- Confusion following the event
- Prodromal déjà vu or jamais vu

# 9. Weakness and paralysis

#### Introduction

The algorithm is concerned only with patients with true muscle weakness; it does not cover patients presenting with general malaise or fatigue. In order to assess a patient for true muscle weakness it is necessary to have a system for assessing the strength of the various muscle groups examined (Table 5.4).

Table 5.4 Medical Research Council grading system for muscle weakness

| 0 | No muscle contraction  |
|---|--|
| 1 | Flicker or trace of muscle contraction                                 |
| 2 | Limb or joint movement possible only with gravity eliminated           |
| 3 | Limb or joint movement against gravity only                            |
| 4 | Power decreased but limb or joint movement possible against resistance |
| 5 | Normal power against resistance  |

## **Establishing patterns**

The second step in the assessment of patients with weakness is establishing the pattern of weakness. This may be in terms of site, onset, or signs (Table 5.5).

Table 5.5 Pattern of signs

| Lower motor neurone syndrome           | Upper motor neurone syndrome |
|--|------------------------------|
| Flaccid paralysis                      | Spastic paralysis            |
| Areflexia                              | Hyperreflexia                |
| Later—muscle wasting and fasciculation | Positive Babinski sign       |



## 10. Stroke

#### Introduction

The potentially difficult but vital first step is to identify the person presenting with an acute stroke.

There are various tools available to aid this process, including the well-publicized Face Arm Speech Test (FAST) screen often used by the emergency services. The ROSIER (recognition of stroke in the emergency room) scale is more suitable for hospital use, with a score of >0 indicating that the diagnosis of stroke is likely (Table 5.8).

## **Application**

There is sometimes confusion between a TIA and stroke. For practical purposes, if symptoms and signs have not completely resolved by the time the patient is seen in the Emergency Department, continue down the stroke algorithm. This algorithm deals with patients presenting with stroke, not TIA. If the patient meets the requirements for thrombolysis he/she should be transferred to the nearest hospital with these facilities as soon as possible at the direction of the stroke physician at that hospital.

## Indications for immediate CT in patients presenting with acute stroke

- Indications for thrombolysis or early anticoagulation treatment
- On anticoagulation treatment
- A known bleeding tendency
- Decreased GCS (<13)
- Unexplained progressive or fluctuating symptoms
- Papilloedema, neck stiffness, or fever
- Severe headache at onset of stroke symptoms

#### **Exclusions for thrombolysis**


- ≥4 hours since onset
- GCS <8</li>
- Seizure since onset of symptoms
- Previously reliant on others
- Ischaemic stroke within last 6 weeks
- Haemorrhagic stroke in the past
- GI or genitourinary bleed or major surgery in last 3 weeks
- On warfarin and INR >1.7, or on new anticoagulant
- Blood pressure >185/110 on repeated readings, despite treatment

# 11. Subarachnoid haemorrhage

#### Introduction

- Acute headache is the chief complaint in as many as 5% of patients visiting the Emergency Department
- UK incidence of 8-12 per 100,000 per year
- Three- to seven-fold increased risk in first-degree relatives
- Mortality rate up to 40% in first week; 50% in first 6 months
  - More than 1/3 of survivors have major neurological deficits
- Sudden onset of severe headache ('thunderclap') and no history of head trauma requires a full neurologic evaluation and head CT scan
  - Imaging can be negative in up to 15% of cases, so an LP is often required

#### **Pathology**

- Acute bleed into subarachnoid space; this may also be an intracerebral component
  - 85%: aneurysmal
  - 10%: no known vascular cause (perimesencephalic)
  - 5%: arteriovenous malformations (AVMs), tumours, etc.
- 10-40% of patients get sentinel bleeds (headaches)

#### **Presentation**

- Acute onset (severe) headache (maximal instantly or within a few minutes)
  - 20% of cases of SAH present with headache alone
- Transient or persisting loss of consciousness
- Seizures (roughly 7%) or focal neurological signs
- Vomiting, hypertension, and tachycardia

#### **Management**

- Manage patient 30° head-up if possible
- Laryngoscopy can cause severe hypertension and may precipitate rebleeding
- CT brain should be performed early
  - 93–98% sensitivity on first day, falling to 85% on day 3
  - If negative, LP must be performed (unless contraindicated)
  - Xanthochromia only detected 6–12 hours after symptom onset (used to differentiate from traumatic LP)
- PO nimodipine 60 mg 4-hourly (if hypotension, reduce dose to 30 mg or omit)
  - Aim for <160 mmHg to reduce hypertension, but maintain CPP
- Tight control of temperature, glucose, and fluid balance for better outcomes
- Rebleeding: up to 20% in first 24 hours and 40% in first month if left untreated
  - Definitive treatment is to occlude the aneurysm by endovascular 'coiling', or sometimes neurosurgical 'clipping'



# 1. Primary survey

#### **Assessment**

In trauma, it is essential to undertake a rapid assessment of patients as they arrive to the Emergency Department. This follows ABCDE assessment. In an ideal situation, the trauma team leader should stand at the foot end of the bed and direct the team. If enough clinicians are present, each team member should assess and treat A, B, and C simultaneously (the so-called *horizontal* approach). If there are few clinicians present, the *vertical* approach should be adopted (assess A, *then* B, *then* C).

#### **Identification and treatment**

It is important to identify and treat problems as you find them during the primary survey (Table 6.1).

#### **Assessment**

In cases of major trauma, rapid transfer of the patient to CT is imperative to identify major injuries, even in some cases of haemodynamic instability; the resuscitation team should be prepared to accompany the patient to CT with ongoing resuscitation. The decision when to transfer the patient to CT or straight to theatre is a team decision.

## Adjuncts to primary survey

Consider, ECG monitoring, urinary catheter and gastric catheter.


## **Radiology**

Consider, CXR and pelvis X-ray in resus, USS (extended focused assessment with sonography (eFAST)), Rapid transfer to CT for whole-body CT and interventional radiology.

# 2. Secondary survey

#### Introduction

The secondary survey is a head to toe assessment of the patient for other injuries not found in the primary survey. It is important to ensure the primary survey and any intervention that is required is completed prior to commencing the secondary survey. If at any point during the assessment there is deterioration or change in clinical status, go back to the primary survey and reassess.

## Important points to consider

- The AMPLE history will allow you to gather important information to aid your management. Comorbidities
  will help you to understand physiological response to trauma and the mechanism of injury will help with injury
  prediction
- It is important to assess the eyes thoroughly, as developing periorbital swelling can often inhibit this assessment
  later. Eye examination should include pupillary size and reaction, visual acuity, visual fields, ocular movements,
  fundoscopy, and inspection for hyphema and penetrating globe injury
- Whilst assessing for CSF leakage, it is important to consider other signs of a base of skull fracture. These
  include post-auricular bruising (Battle's sign), panda eyes (bruising around the eyes), bleeding from the ears,
  haemotympanum, and cranial nerve palsy
- Be aware of facial instability when assessing for facial fractures. When assessing for maxillary movement there
  is a risk of provoking haemorrhage, which in turn could affect the patient's airway patency
- If the patient is unconscious, it will be difficult to assess the more subjective aspects of the secondary survey. This is particularly true when assessing for any bony and abdominal tenderness or neurological status of a limb. It is important to consider this when assessing these areas, and therefore injury cannot be ruled out based on the lack of tenderness in an unconscious patient. Equally, the patient cannot have their cervical spine cleared clinically until they are conscious
- Ensure the whole of the patient is visualised to ensure missing posterior injuries. If the patient is immobilised, they must be log rolled to ensure spinal immobilisation remains intact when assessing for posterior injuries
- You should not insert a catheter prior to assessing for urethral injury, as outlined in the genito-urinary and perineum box in the algorithm
- Limb injuries that aren't neurovascularly intact should not take priority over the primary survey. However, once the patient has stabilised it is important to deal with any limb-threatening injuries early

## Algorithm for secondary survey

#### Stable trauma patient post primary survey

#### Take an AMPLE history.

- Allergies
- Medications
- · Past medical history
- Last meal
- Events leading to injury

#### Assess the head and face for:

- Lacerations and bruising
- Feel for any bony tenderness and depressions suggestive of fractures
- · Full eye examination
- · Assess ears for presence of CSF leak, haemotympanum, and active bleeding
- Assess nose for deformity, active bleeding, septal haematoma, and CSF leak
- Full oral inspection for mucosal, tongue, palate, and dental injury

#### Assess the neck for:

- · Cervical spine tenderness
- Subcutaneous emphysema
- Tracheal deviation
- Carotid artery bruit and neck vein distention
- · Bruising and swelling
- Lacerations and penetrating injuries
- Soft tissue tenderness
- · Laryngeal tenderness and crepitus

#### Assess the chest for:

- External evidence of open pneumothorax, flail segment, penetrating injuries, occult blood loss and contusions
- Bony tenderness by palpating all bony structures including clavicles, ribs, and sternum
- Equal air entry by auscultating and percussing both lungs

#### Assess the abdomen and pelvis for:

- Bruising, distention, penetrating injuries or laceration by inspection
- · Tenderness, particularly over the spleen, liver, kidneys, and bladder
- Pelvic tenderness by gentle palpation

#### Assess the genito-urinary system and perineum for:

- Perineum and genitalia contusions, lacerations, and haematomas
- Urethral and vaginal bleeding
- High riding prostate, rectal wall injury and anal tone by PR examination
- Vaginal bleeding, vaginal vault injury and laceration by PV examination.

## Assess the spine, lower and upper limbs for:

- · Bony and soft tissue tenderness and joint instability
- · Deformity, bruising and wounds
- Neurovascular injury

# 3. Head injury

### **Definition**

Head injuries are traumatic injuries which range from superficial skin and soft tissue injuries to skull fractures and intracranial haemorrhage. They are one of the commonest presentations to the Emergency Department.

It is important to remember that a head injury may be part of multisystem trauma and the patient should be assessed in the standard ABCDE approach.

## Mechanism of injury

Understanding the mechanism of an injury can help to predict injury pattern and severity of injury. The mechanisms in Table 6.2 are considered dangerous and are classified as one of the risk factors in the secondary assessment for CT indication.

## Secondary indications for CT

In adult patients who do not meet the initial NICE criteria for CT, if they have had loss of conscious or amnesia since the injury they should be assessed for the following features:

- Age 65 or older
- History of bleeding or clotting disorders
- Dangerous mechanism
- More than 30 minutes' retrograde amnesia of events immediately before the head injury

If any of these are present, the patient should have a CT head scan within 8 hours of the injury. Secondary indications in the paediatric population are outlined in the algorithm.

## **Management**

It is important to promptly refer all patients with acute intracranial pathology to the neurosurgical team as these are potentially time-critical injuries. It is important to minimise secondary brain injury by avoiding hypotension, hypoxia, hypoventilation, and hyperthermia.



# 4. Major trauma—chest injuries

## **Epidemiology**

- Road traffic collisions represent the most common cause of major thoracic injury among Emergency Department patients
- Increased mortality and morbidity is associated with multiple rib fractures, increased age, and higher injury severity scores

#### Initial management

- Clinicians first assess and stabilise the patient's airway, breathing, and circulation, in that order (ABCs; i.e. primary survey)
- The one caveat to this principle in patients with respiratory distress following chest trauma is that breathing
  may take priority over airway

## Immediate life-threatening injuries

- Tension or open pneumothorax
- Cardiac tamponade from myocardial injury
- Aortic injury
- Massive haemothorax
- Tracheobronchial disruption

## **Emergency thoracotomy**

In the setting of blunt trauma, ED thoracotomy rarely results in successful resuscitation:

- Neurologically intact survival in approximately less than 5% of those in shock
- 1% of those without vital signs upon arrival to the Emergency Department
- None of those without signs of life pre-hospital


#### Chest X-ray

- CXR is the initial test for all patients who warrant imaging
- CXR is inexpensive, non-invasive, and easy to obtain, and, in many instances, it reveals useful information
- Although no single finding on CXR possesses high sensitivity or specificity for aortic injury, the following findings on a plain CXR indicate a need for further investigation:
  - Wide mediastinum (supine CXR >8 cm; upright CXR >6 cm)
  - Obscured aortic knob; abnormal aortic contour
  - Left 'apical cap' (i.e. pleural blood above apex of left lung)
  - Large left haemothorax
  - Deviation of nasogastric tube rightward
  - Deviation of trachea rightward and/or right mainstem bronchus downward
- A widened mediastinum is a sensitive but non-specific sign of aortic injury. Such injuries account for about 20% of abnormal mediastinal widening on CXR after blunt trauma

# 5. Major trauma—abdominal trauma

Abdominal injury often co-exists with other significant injuries: as always, a thorough primary survey must be undertaken.

Intravenous access is essential and blood should be taken for urgent FBC, U&E, LFT, amylase, coagulation, lactate, and cross-match.

Pelvic injury should be regarded in the same way as cervical spine injury: a sling should be applied whenever a pelvic fracture is possible from the mechanism of injury, and then only removed following clinical +/- radiological assessment.

Note that in cases of spinal cord injury there may be no abnormal examination features and there should be a low threshold for abdominal imaging.

Note: the use of focused assessment with sonography in trauma (FAST) may rapidly identify free fluid within the abdomen, or other potential sources of major blood loss such as haemothorax. However, it does not exclude significant intra-abdominal injury and will also not identify retroperitoneal injury.

Intra-abdominal bleeding requires urgent surgical or interventional radiological management.

The relative sensitivities of common abdominal investigations are shown in Table 6.3.

Table 6.3 Relative sensitivities of common abdominal investigations


Early CT is advantageous if the patient is stable enough; it may identify the bleeding site and also inform if radiological embolisation is possible.

# 6. Major trauma—spinal injuries

## **Epidemiology**

- Spinal column injury(s) with or without neurological deficit should be considered in patients with multiple injuries
- 1:10 patients with cervical spine facture have a second non-contagious vertebral column fracture
- Spinal column injuries association with spinal cord injury underscores the importance of early recognition and appropriate management

## **Mechanism** of injury

Injury to the vertebral column often occurs secondary to blunt or penetrating trauma.

Injury to the spinal cord might occur due to transection (complete or incomplete), compression (by, for example, bony fragment), or contusion, or by vascular compromise (this should be suspected when there is a discrepancy between a clinically apparent neurologic deficit and the known level of spinal column injury).

#### Classification

Spinal cord injuries can be classified into:

- Complete cord injury: there will be complete sensory and motor loss at the level of the spinal cord injury with no sacral sensation
- Incomplete injury: there are various degrees of motor function in muscles controlled by levels of the spinal
  cord below the injury. Sensation is also partially preserved in dermatomes below the area of injury. Usually,
  sensation is preserved to a greater extent than motor. The bulbocavernosus reflex and anal sensation are
  often present
- Central cord syndrome: characterised by disproportionately greater motor impairment in the upper than
  the lower extremities, with variable degree of sensory loss. Often described after relatively mild trauma in the
  setting of pre-existing cervical spondylosis, e.g. in the elderly
- Anterior cord syndrome: characterised by loss of function of the anterior two-thirds of the spinal cord
  (paraplegia with bilateral loss of pain and temperature sensation with preservation of proprioception and fine
  touch). Caused by ischaemia of the anterior spinal artery, resulting in loss of function of the anterior twothirds of the spinal cord

#### **ASIA** chart



# 7. Major trauma—maxillofacial

#### **Introduction**

As with all cases of major trauma, a primary survey must be carried out in order to identify immediately lifethreatening injuries.

Significant maxillofacial trauma may be associated with catastrophic haemorrhage, airway obstruction, serious head injury, and cervical spine injury, all of which must be addressed.

## Airway management

Any maxillofacial injury may be associated with airway compromise. This may be due to obstruction, bleeding, distorted anatomy, or swelling. Standard airway management techniques should be used initially.

In cases of bilateral mandibular fracture, the tongue loses its anterior anchor and as such will be pulled back, obstructing the airway. This requires anterior traction in order to clear the airway. This may involve simply holding the tongue or lower incisors and chin with gauze in a gloved hand, or inserting a large silk horizontal mattress suture through the tongue and applying traction to this.

## Haemorrhage management


Torrential haemorrhage may occur in maxillofacial injuries from injury to branches of the maxillary artery or ethmoidal arteries. Prompt haemostasis may be necessary for both airway and circulation reasons. In cases of unstable maxilla fractures, inflating unopposed nasal packs may further displace the fracture; as such, nasal packs should only be minimally inflated initially: if bleeding remains uncontrolled the inferior border of the maxilla should be splinted against the mandible using bite blocks, which in turn are splinted by applying a cervical collar to effectively fix the mandible to the sternum. The correct order of application is essential: first collar, then bite blocks, then nasal packs, then inflate. In practice, these patients almost always require intubation prior to these steps.

In cases of posterior impaction of a fractured maxilla, manual disimpaction may be necessary in order to both maintain the airway and reduce bleeding. This is achieved by inserting a gloved index and middle finger into the oropharynx and pulling back from behind the soft palate.

# 8. Major trauma—burns

## **Epidemiology**

In the UK 130,000 people each year visit the Emergency Department with burns injuries

## **Types of burns**

- Thermal: the most common. Caused by hot liquids (scalds), hot objects (contact), and flames
- Chemical: can be caused by acids or alkalis. These continue to burn skin until completely removed. Thus thorough irrigation is essential
- Electrical: tissue burnt along path of electrical current from 'entry' to 'exit' point. Domestic (low-voltage)
  exposure is usually less severe. However, because it is alternating current (AC) this can cause arrhythmias
- Cold: ice crystals form intra- and extracellularly, causing cell death
- Radiation: ionizing radiation causes tissue damage. Most common is sunburn

#### Size of burn

- Burns >15% of body surface area (BSA) in adults and >10% in children can cause circulatory shock due to fluid losses
- Use Lund-Browder chart or the 'Rule of 9s' to assess size of burns. This can be accessed on line


## **Depth of burn**

- Superficial
  - Erythema only (like sunburn)
  - Does not count in % BSA
  - Partial thickness
  - Blistering but blanches. Painful
- Full thickness
- Dry and white or black in colour. Painless

# 9. Traumatic limb and joint injuries

Musculoskeletal injuries presenting to the Emergency Department are common and vary from mild injuries into more severe limb threatening ones. However a mild injury might cause serious life long consequences and the treating physician needs to be vigilant when assessing these injuries.

## Principles in management

The acute management of bone and/or joint injuries involves the following steps:

- Initial clinical assessment: details of the mechanism of injury and an understanding of the injury patterns
  associated with particular mechanisms are important. Evaluation should include neurovascular function (NV)
  and looking for signs of soft tissue damage. Avoid testing passive range of motion or manipulating the affected
  area or limb until radiologic assessment is completed if required in order to prevent exacerbating fracture
  displacement, soft tissue damage, or neurovascular compromise
- Pain management: adequate analgesia is key in managing these patients and regularly assess the need for analgesia
- Immobilisation: initially "splint it where it lies." Unless neurovascular compromise is present where urgent manipulation under appropriate analgesia and sedation is needed.
- Radiographic assessment: obtain at least 2 plain x-ray views at 90 degrees to each other. Bear in mind if you
  don't see a fracture, it does not mean one is not there. E.g. a fractured scaphoid is often not seen on initial
  x-rays and negative hip x-ray does not rule our neck of femur fracture. Computed tomography (CT) and
  magnetic resonance imaging (MRI) reveal such occult fractures
- Manipulation and reduction: once imaging has been obtained, manipulate fractures to obtain best anatomical reduction. Dislocated joints need to be reduced as soon as feasible.


#### Pit falls to avoid

- Always assess and document appropriately the NV status. Both before and after fracture manipulation or joint reduction
- Give early antibiotics in open fractures and consider tetanus status.
- Try to obtain appropriate photos for open fractures before applying a dressing to aid management planning
- Don't use excessive force when manipulating a fracture or reducing a joint. A good understanding of the
  mechanism of injury and anatomy is key
- Refer to speciality when needed and arrange follow up.

# 10. Wound assessment and management

A primary survey should be carried out whenever a significant wound is suspected: beware especially wounds inflicted by narrow sharp implements, which may cause life-threatening internal injuries with only a small skin cut visible externally.

Always take penetrating injuries to the neck, trunk, abdomen, and groin very seriously.

It is essential to be familiar with the relevant anatomy when assessing a wound: if necessary look this up before seeing the patient. This is especially true in the case of hand injuries, where assessment is impossible without knowledge of the underlying tendons, nerves, and vessels.

Wounds that may not be suitable for primary closure include bites, obvious gross contamination, and significant skin loss. *Note*: if these wounds are present on the face they should be discussed with a maxillofacial team: in some circumstances the risk of a disfiguring scar if the wound is not closed may mean primary closure with antibiotic cover is attempted with careful follow-up.

The vast majority of foreign bodies can be safely removed in the Emergency Department following appropriate assessment +/- imaging. **Any** wound caused by broken glass requires a soft-tissue radiograph. All underlying structures require clinical assessment both before and after removal.

Always remember that the most trivial of cuts may leave a significant scar if managed inappropriately.

Antibiotics should be given in all bite wounds and considered in other deep or contaminated wounds. See your local antibiotic policy tetanus immunity status should be checked and tetnus cover given when appropriate.

#### Wound closure

Wound closure can be achieved using the methods outlined in Table 6.4.



## 11. Shoulder examination

## Joint movement

- Flexion (deltoid, pectoralis major, coracobrachialis, biceps)
- Extension (deltoid, latissimus dorsi, teres major and minor, triceps)
- Abduction (deltoid, supraspinatus, infraspinatus, subscapularis, teres minor)
- Adduction (pectoralis major, latissimus dorsi, teres major, subscapularis)
- Internal rotation (subscapularis, pectoralis major, deltoid, latissimus dorsi, teres major)
- External rotation (infraspinatus, deltoid and teres minor)

#### Other muscle tests

- Pectoralis major = shoulder flexion to 90°, push down (lower) and then up (upper)
- Latissimus dorsi = shoulder abduction and external rotation to 90° and elbow flexion at 90°, push elbows down
  - Scapula stabilisers = shrug shoulders (trapezius)
  - Push against wall (serratus anterior), if weak = 'winged scapula'

### **Special tests**

- Lifetime prevalence of 20% for shoulder pain (new incidence of 1% in adults >45 years)
- Neer's test for rotator cuff impingement
  - Patient seated, elbow extended, and scapula stabilised by examiner. Passively internally rotate shoulder and then flexion. Pain on passive flexion = +ve test
- Instability apprehension test
  - Patient supine. Passively abduct shoulder to 90° and externally rotate
  - Look for apprehension and resistance from patient = +ve test
  - Apply pressure on humeral head. Improvement = +ve test (relocation sign)
  - Immediate internal rotation on release = +ve test (release sign)
- Cross-arm/Scarf test (acromioclavicular joint (ACJ))
  - Place hand on other shoulder. Push so reaching further back (forced adduction). Pain in ACJ = +ve test
- **Drop-arm test** (rotator cuff tear—70% of shoulder disorders)
  - Passively abduct arm to 90°. Actively hold arm at 90° and gently lower to side
  - Inability to hold arm up = +ve test
- Rotator cuff tests
  - Apley's scratch test (supraspinatus)
    - Reach between shoulder blades (trying to scratch back)
  - Empty can test (supraspinatus)
    - Abduct shoulder 90° with 30° flexion and full internal rotation (thumb pointing down). Abduct shoulder further (+/– resistance). Pain and weakness = +ve test
  - External rotation lag sign (infraspinatus and teres minor)
    - Passive flex elbow to 90° and externally rotate shoulder to 90°
    - If patient cannot maintain position (swings back forwards) = +ve test
  - **Gerber's lift-off test** (subscapularis)
    - Hand in small of back and lift hand away from back. Pain or limited movement = +ve test

## Algorithm for shoulder examination

#### Indication to perform examination of the shoulder

Consent patient, sit patient at 90°, expose both shoulders, offer analgesia

Inspect patient from front, side, and back whilst pushing against a wall Inspect: skin for erythema, abrasions, contusions, scars, skin colour change, obvious effusions or deformity (compare sides), winging of scapula

Palpate: temperature, swelling, tenderness, crepitus

Palpate: sternoclavicular joint, clavicle, ACJ, acromion, subacromial space, greater tuberosity, bicepital groove, coracoid, spine, and inferior pole of scapula

Movement: Screen - hands behind head & reach up back
Movement: Active (flexion (165°), extension (60°), abduction (170°), adduction,
internal rotation (70°), external rotation (70°))
Movement: Passive (same ranges)

Movement: resisted (to grade power)

Test pectoralis major, latissimus dorsi, and scapula stabilizers

Scarf test for ACJ injury

Instability tests

Screen for rotator cuff injury with drop-arm test

Rotator cuff tests

Axillary and distal nerve sensation and pulse check

Check cervical spine

Request x-ray or MRI or orthopaedic opinion if indicated

## 12. Elbow examination

## **Analgesia**

Options include distraction, entonox, oral analgesia (ibuprofen, paracetamol, codeine, oramorph), IV analgesia (commonly IV morphine), immobilisation (classically a broad arm sling or an above-elbow back slab; these can be used before X-ray for analgesia).

It is important to assess the mechanism of injury, to exclude any other injuries, and to examine the joints above and below (in this case, the shoulder and wrist).

#### Neurovascular assessment

- Vascular assessment: look for pallor and cyanosis of the limb. Feel for radial, ulnar, and brachial pulses, check warmth of the limb, and compare capillary refill with the other arm.
- Nerve assessment: see Table 6.5.

#### **Examination**

- LOOK: scars, any obvious deformity, periarticular swellings
- FEEL: bony contours (medial and lateral epicondyles, olecranon), feel for local tenderness or heat
- MOVE: active and passive:
  - Flexion, extension (0–150°)
  - Pronation (0–90°), supination (0–90°)—best done with elbow at 90° flexion and held by patient's side

Lack of pronation/supination and lack of full extension highly suggests a fracture, commonly the radial head.

#### Discharge of patients


The following is a general guide; it is important to follow local hospital guidelines and orthopaedic advice.

- Non-displaced radial head fractures: collar and cuff and next available fracture clinic
- Supracondylar fractures: above elbow back slab and admit under orthopaedics
- Proximal radial and ulnar fractures: need full ulnar and radius X-rays, an above-elbow back slab, and admission
  under orthopaedics
- If no fracture, consider collar and cuff for analgesia, discharge, and follow-up with GP, physio, or soft tissue injury clinic as appropriate
- Flbow dislocations:
  - If relocated, no fracture and neurovascularly intact, above-elbow back slab and fracture clinic
  - If relocated and fracture present (with or without neurovascular compromise), above-elbow back slab and discuss with orthopaedics
  - If unable to relocate, discuss with orthopaedics


Fractures and dislocations of carpel bones can be subtle to detect on examination and on X-rays. If in any doubt, discuss with colleagues in orthopaedics/plastics and consider further imaging, e.g. CT. Always refer suspected scaphoid fractures to fracture clinic even if initial X-rays are normal.

# 14. Hip examination

#### **Introduction**

The hip joint is commonly painful following trauma or due to conditions such as arthritis and bursitis. Pain in the hip can be referred from the lumbar spine or the knee, so if no obvious cause is found locally at the hip, to explain the symptoms, the knee and spine should be examined.

## Assessment of posture and gait

If the patient is able to stand and walk, the hip examination should begin with an assessment of gait and posture. This enables muscle bulk, symmetry, and gait to be assessed. An antalgic gait, Trendelenburg gait, or other pattern may be seen.

## Trendelenburg test

This test is performed by asking the patient to stand on one leg. The examiner stands behind the patient and observes the pelvis. In a normal test the pelvis should remain level. In an abnormal test the pelvis drops markedly on the side of the raised leg. This indicates weakness of the hip abductors of the supporting leg.

## Inspection

This can be performed with the patient standing or lying. Care should be taken to look for any scars, deformity, or muscle wasting. Erythema may indicate bursitis, cellulitis, or a septic arthritis. The leg may be obviously shortened or rotated, e.g. if there is a fractured neck of femur.

## **Palpation**

The greater trochanters can be easily palpated and tenderness here can indicate trochanteric bursitis. The head of the femur can be palpated in slim patients and lies below the inguinal ligament, lateral to the femoral artery. The temperature of the hip joints and surrounding tissues should be assessed and compared.

#### **Movements**

Range of movement of the hip should be assessed and recorded, and can be compared with the patient's unaffected side. Hip flexion is assessed in a supine patient by flexing the knee to 90° and passively flexing the hip towards the chest. Extension can be examined by positioning the patient prone and lifting each straight leg away from the bed, whilst stabilizing the pelvis. This may not be possible if the hip is very painful, or in elderly patients. An alternative is to put a hand beneath the patient's ankle whilst they lie supine, with straight legs, and ask them to push your hand into the bed. Internal and external rotation can be assessed in the supine position with the knee flexed at 90°, or with the knee extended, by rolling the straight leg medially and laterally. Abduction and adduction are assessed with the leg straight and the examiner's hand positioned over the anterior superior iliac spines to stabilize the pelvis.

## Thomas' test

This is a test of hip extension. The patient lies supine and the examiner's hand is placed under the patient's lumbar spine. One of the hips is then fully flexed. The contralateral hip is observed—if it rises from the bed it suggests a fixed flexion deformity of that hip (i.e. the one that lifts off the bed).


### X-rays

If required, an AP view of the pelvis and hip and a lateral hip view should be requested in the first instance. Oblique or Judet views can be useful to assess the acetabulum, if fracture here is suspected.

## 15. Knee examination

#### **Patella**

- Patella tap test (ballottement): positive when >10-15 mL of intra-articular fluid
  - With slight downward pressure, milk the suprapatellar pouch into the knee joint. Use the other hand to
    push on the patella
- Bulge sign: milk fluid proximally from the medial patella into the suprapatellar pouch and then distally along the lateral patella. Apply pressure to the lateral dimple—the fluid will reappear medially
- Patella apprehension test: apply lateral pressure on the patella with knee extended and slowly flex knee.
   When subluxation is imminent, the patient will respond with quadriceps spasm as a guarding reflex (sensitivity is reported to be 39%)

## Joint stability

- Patient may report acute pain, swelling, hearing a 'pop', and instability
- Collaterals (in 30° (and full extension if +ve))
  - Stabilise the joint by placing one hand along the medial joint line. With the other hand, hold the ankle and apply a valgus force to the knee
  - If medcial collateral ligament is torn, the joint 'opens up' along the medial aspect (this may also elicit pain)
    - Sensitivity of 86–96% is reported for this test
  - Repeat with opposite hands and varus stress to test lateral collateral ligamant
- Cruciates (anterior and posterior draw tests in 90° flexion)
  - Anterior drawer test: flex knee to 90° and sit on the patient's foot. Pull forward on tibia just distal to the knee—movement suggests ACL damage
    - Sensitivity and specificity are 62% and 67% respectively
  - Lachman test: flex the knee only 20–30°, then pull tibia anterior relative to femur. A deficient anterior cruciate ligament demonstrates increased movement forward
    - Sensitivity and specificity are 87% and 93% respectively
  - Posterior sag sign: flex knee to 90° and observe from the side for any posterior lag of the joint; this suggests posterior cruciate ligament damage
    - Sensitivity and specificity are 79% and 100% respectively
  - Posterior drawer test: sit on foot of patient and apply a posterior force to the proximal tibia. Increased
    posterior tibial displacement suggests posterior cruciate ligament tear
    - Sensitivity ranges from 51 to 90%. Specificity is reported to be 99%.
- Menisci: McMurray's test: flex knee to 90°. Slowly extend knee while palpating joint line in external (medial meniscus) + internal (lateral) rotation. Pain or click confirms torn menisci
  - Sensitivity around 52%, but specificity varies ranging from 59 to 97%

#### Ottawa knee rule

This rule can be used to determine whether an X-ray is needed in people over 2 years with suspected knee fractures to exclude a fracture.

Any one of the following indications is sufficient to order an X-ray:

- Age ≥55 years
- Isolated patella tenderness
- Tenderness at head of fibula
- Inability to flex knee 90°
- Inability to weight bear (four steps) immediately after injury and in Emergency Department



## 16. Ankle examination

#### Introduction

Ankle injuries are a common presentation. Examination of the ankle is important to determine the nature of the injury and decide if X-ray or emergent treatment is required.

## **Ankle joint**

The true ankle joint (tibiotalar joint) is the articulation of the distal tibia, medial and lateral malleoli, and the body of the talus. The subtalar joint is the articulation of the talus and calcaneus.

#### **Ankle dislocation**

This requires prompt reduction and immobilisation to prevent neurovascular complications. Dislocation is usually but not always associated with fracture of the ankle. A frankly dislocated ankle should be reduced prior to X-ray. It is important to photograph and document any wounds in the case of an open injury, prior to application of plaster of Paris.

## Inspection

The injured ankle should be checked carefully for swelling, bruising, and any wounds over or around the site of injury. A joint effusion can sometimes be seen as a fullness either side of the Achilles tendon.

## **Palpation**

Bony, ligamentous, and soft tissue structures of the ankle should all be palpated. The distal 6 cm of the tibia should be carefully palpated, along with the entire fibula. The knee and foot may also need to be examined depending on the nature and mechanism of injury.

## **Ankle ligaments**

Ankle sprains are common. The anterior and posterior talofibula, calcaneofibular, and deltoid ligaments should all be carefully palpated.

#### Ottawa Ankle Rules

The Ottawa Ankle Rules are a set of guidelines to assist in deciding which patients should be offered X-ray of their ankle injury. Ankle X-ray is indicated if there is pain in the malleolar zone and any one of the following:

- Bone tenderness along the distal 6 cm of the posterior edge of the tibia or tip of the medial malleolus, or
- Bone tenderness along the distal 6 cm of the posterior edge of the fibula or tip of the lateral malleolus, or
- An inability to weight bear both immediately and in the Emergency Department for four steps

Clinical judgement should be used in patients under 18 years old and in patients who are intoxicated, are uncooperative, have distracting painful injuries, have decreased sensation in legs, or have gross swelling preventing palpation of malleolar bones.


## Simmonds calf squeeze test

This test can be performed in patients where there is a suspicion of Achilles tendon injury. The patient kneels or lies face down on the bed, with the feet hanging over the edge of the bed or chair. The calf muscle is then squeezed to elicit plantar flexion of the foot. The test is abnormal when there is decreased or no plantar flexion of the foot of the injured leg, indicating likely rupture/partial rupture of the Achilles tendon.

## 1. Heat stroke and heat exhaustion

There is a spectrum of heat-related disease, from rashes and cramps through to heat stroke. Heat exhaustion is characterized by non-specific symptoms such as malaise, headache, and nausea and may progress to heat stroke which involves the central nervous system (CNS) and results in altered conscious state.

Heat stroke is defined as a core temperature of >40.6°C due to environmental exposure and lack of thermoregulation. This differentiates it from fever and has a significant mortality associated with it. It can be classified as exertional or non-exertional.

Exertional heat stroke (EHS) results from strenuous activity in hot conditions. Non-exertional heat stroke (NEHS) describes loss of thermoregulation resulting in overheating and particularly affects infants, children, and the elderly. CNS disorder, medications, and endocrine abnormalities (e.g. thyrotoxicosis) may all contribute to NEHS.

## **Clinical presentation**

- Patients may present with a hyperdynamic state, cramps, tachycardia, CNS disturbance including seizures and coma, and coagulopathy sometimes with GI bleeding
- Blood investigations should include FBC, U&E, liver function, Mg, Ca, phosphate, lactate, creatine kinase (CK), arterial gas, coagulation screen, thyroid function, and glucose
- A CT head scan may be required to exclude intracerebral bleeding
- Sinus tachycardia and non-specific ST and T wave changes may be seen on ECG
- Aggressive reduction of temperature to 39°C can be life-saving
- Benzodiazepines may be required for fits or shivering, but antipyretics have no role in the management of heat stroke

### **Cooling methods**

- Immersion in a bath of iced water is rapidly effective but largely impractical
- Evaporative cooling involves removing the patient's clothes and spraying with a fine mist of water at 15°C, followed by fanning
- Ice packing involves placing ice packs in the groin and axillae, and even covering the whole trunk
- Gastric lavage requires intubation with a cuffed ET tube prior to instilling 10 mL/kg iced water via an NG tube, and suctioning out after 1 minute
- Cardiac bypass or haemodialysis may be considered in refractory cases
- Care should be taken with IV fluids to avoid pulmonary oedema



# 2. Drug-related hyperthermias

There are three defined drug-related conditions that include hyperthermia as a feature: malignant hyperthermia, neuroleptic malignant syndrome, and serotonin syndrome. Hyperpyrexia related to stimulant drug use including amphetamines is also increasingly seen and is similar to serotonin syndrome.

## Malignant hyperthermia

This is an inherited disorder resulting in hypermetabolism in skeletal muscle triggered by certain drugs (typically inhaled anaesthetic agents or suxamethonium). Acidosis, rigidity, and hyperkalaemia will be present, and a rapid rise in end tidal carbon dioxide in anaesthetized patients is often the first sign of development. Anaesthetic management guidelines should be followed (see Further reading) and dantrolene may be life-saving.

## Neuroleptic malignant syndrome

This refers to the combination of hyperthermia, rigidity, and autonomic dysfunction associated with antipsychotic mediation. Bradykinesia or akinesia is typical and delirium is common. The onset may be over a number of days. Raised CK and/or WBC count is also commonly found.

## Serotonin syndrome

This has some similar features to neuroleptic malignant syndrome, including altered mental status, autonomic dysfunction, and neuromuscular abnormalities, but may be distinguished by tremor, hyperreflexia, and more rapid onset over a period of hours. Selective serotonin reuptake inhibitor (SSRI) medications are the typical cause.

Blood investigations should include FBC, U&E, liver function, Mg, Ca, lactate, CK, arterial gas, coagulation screen, and glucose. Rhabdomyolysis may be seen with all causes and monitoring of CK and renal function is essential.


The role of pharmacological agents such as dantrolene or bromocriptine is unproven; however, as with any toxicological presentation, advice can be sought from the NPIS. If indicated, the initial dose of dantrolene is 1 mg/kg given intravenously.

# 3. Hypothermia and frostbite

## **Hypothermia**

Hypothermia describes a core body temperature of <35°C. Conventionally it is classified as follows: mild 32–35°, moderate 28–32°, and severe <28°C.

Along with environmental exposure, other causes include impaired thermoregulation (e.g. drug use, Parkinson's disease), sepsis, endocrine dysfunction, and alcohol use.

Symptoms range from mild confusion to ataxia, agitation, and coma. *Note*: below 31° the shivering response ceases. Arrhythmias are common below 30°, and the pupils may become fixed and dilated.

When suspected, a core temperature should be obtained urgently (rectal or oesophageal).

Always check blood glucose, and correct if low.




Figure 7.1 Osborn (J) wave.

ECG may demonstrate prolonged PR, QRS, and QT intervals, and J or Osborn waves (Figure 7.1) may be present when temperature falls below 30°.

Aggressive rewarming may be necessary: bladder irrigation can be performed using a three-way catheter, peritoneal irrigation via a diagnostic peritoneal lavage set, and pleural irrigation via chest drains.

#### **Frostbite**

Frostbite refers to tissue damage as a result of freezing. Although commonly associated with mountaineering or polar exploration, it is seen in urban populations, particularly in people who work outdoors or are homeless. Risk factors include peripheral vascular disease, diabetes, Raynaud's disease, and use of beta-blockers.

Typically it is caused when temperatures are below -10°C and affects exposed areas including ears, nose, fingers, and toes.

Symptoms include pain, paraesthesia or anaesthesia of the affected part, and loss of movement or coordination. Skin may feel cold and, depending on the depth of the damage, the underlying tissues may feel soft (favourable prognosis) or hard (poor prognosis).

When suspected in the Emergency Department, rapid rewarming is appropriate using immersion in water at 37–39°C. *Note*: this may precipitate extreme pain and appropriate analgesia should be given. This should continue until the distal parts are pink/red, then they should be gently dried and padded or splinted for protection. Reperfusion injury, characterized by oedema and sloughing of devitalized tissue, occurs over the following 2–3 days. Consultation should be made with a vascular or burns service, as occasionally thrombolysis or prostaglandin analogues may be considered. Amputation is rarely needed acutely, and a period of observation of up to 3 months may be appropriate before the decision is made.

## 4. Electrical burns/electrocution

There are four described mechanisms of electrical injury:

- True electrical injury: electricity passes through the person as part of a circuit
- Flash injuries: superficial burns from electrical arcing—current does not pass through the person
- Flame injuries: clothing ignited by an electrical arc
- Lightning injuries: extremely high voltage for short duration

When current passes through the body, aside from thermal injury there may also be tetanic muscle contractions prohibiting the person from releasing their grip on the source, and if the current passes through the thorax or head there may be respiratory arrest, cardiac dysrhythmias, seizures, and brain injury. Electrothermal damage includes burns and muscle oedema which may result in compartment syndrome and rhabdomyolysis.

High-voltage injuries may cause considerable internal burns but minimal skin damage.

Care should be taken not to miss associated injuries resulting from falls or severe muscle contraction.

Note that cases of high voltage (including lightning strike) may result in fixed, dilated pupils, but this should not be seen as a marker of futility when considering prolonged resuscitative efforts.

Studies have shown that patients receiving a transthoracic shock with voltage <1000 V, a normal ECG on presentation, and no loss of consciousness (LOC) can safely be discharged without a period of cardiac monitoring.



## 5. Drowning

The World Health Organization (WHO) has defined drowning as 'the process of experiencing respiratory impairment from submersion/immersion in liquid'. If this causes death, this is a fatal drowning: survival becomes non-fatal drowning. This has replaced previous terms such as 'near-drowning'.

## Management of drowning

There are several points to consider when managing cases of drowning:

- Management is the same for salt and fresh water drowning
- Cervical spine injury should be considered in all cases of drowning; however, it is very unlikely in cases where
  a witness confirms the drowning did not occur immediately following diving/jumping in or, for example, after
  collision with rocks or a rapidly moving vehicle such as a jet ski
- Consideration should always be given to potential causative medical conditions such as subarachnoid haemorrhage, poisoning, or MI, and these should be investigated accordingly
- There is no role for the routine administration of steroids. Antibiotics should not be routinely given unless the submersion was in heavily contaminated liquid

## Management of hypothermia

There is some controversy regarding core temperature targets for resuscitation in drowning. It is generally accepted that resuscitation should continue until at least a temperature of 30°C is achieved, using active rewarming strategies up to and including extracorporeal blood rewarming. However, there have been a number of case reports where it was felt that hypothermia provided a degree of neuro-protection during prolonged resuscitation. The WHO has made the following consensus statement: 'Drowning victims with restoration of adequate spontaneous circulation who remain comatose should not be actively warmed to temperature values above 32–34°C. If core temperature exceeds 34°C, hypothermia should be achieved as soon as possible and sustained for 12 to 24 hours.'

#### Stopping resuscitation


This is always a difficult decision as there are very few absolute markers of futility.

- A consensus statement from the UK suggests that after 30 minutes' submersion in waters of >6°C, survival is
  extremely unlikely: in a water temperature of 6°C or less, survival is extremely unlikely if submersion exceeds
  90 minutes
- A serum potassium level >10 mmol/L is incompatible with successful resuscitation
- pH of <7.1 is associated with a poor prognosis; however, successful resuscitation and neurological outcome
  has been reported following drowning with a presenting pH of 6.47</li>

# 1. The septic patient

#### Introduction

Sepsis is a complex syndrome presenting with systemic manifestations of infection and can be defined as life-threatening organ dysfunction caused by a dysregulated host response to infection.

#### **Identification**

It is identified using a compilation of various signs, symptoms, and investigations, although no definitive diagnostic test currently exists.

There is increasing acknowledgment that previous definitions used in this field, such as systemic inflammatory response syndrome (SIRS) (Table 8.1) and severe sepsis, are unhelpful: SIRS is neither sensitive nor specific for infection for sepsis, and sepsis itself carries a high enough mortality and morbidity to be labelled as a 'severe' condition.

The algorithm identifies a place for the SIRS criteria, as this is still used in many hospitals around the world to identify sepsis; however, there is newer evidence suggesting that the Sequential (sepsis-related) Organ Failure Assessment (SOFA) score has a higher accuracy in identifying early those patients with a higher morbidity and mortality and thereby needing more urgent and thorough medical input. The SOFA score examines six areas of physiology (respiratory, coagulation, liver, cardiovascular, CNS, and renal) and the presence of abnormalities. A shorter scoring system—Quick SOFA (qSOFA; Table 8.2)—looks at three aspects of physiology and can be measured rapidly and easily at the bedside.

## Septic shock

Septic shock (previously known as 'severe sepsis') is a state of acute circulatory failure associated with a significantly higher mortality. Its definition is not exact; however, two tests point towards this: a lactate >2 despite adequate fluid resuscitation and the need for vasopressor support to maintain a mean arterial pressure (MAP) >65 mmHg. Including the initial investigations, further investigations may be needed, depending on the clinical picture, including radiological (CXR, abdominal US, CT) and microbiological (urine dip/mid-stream urine (MSU)/catheter specimen urine (CSU), sputum and wound samples, diagnostic pleural or ascetic or joint aspirations).



# 2. The shocked patient

#### Introduction

Shock is a clinical condition characterised by a failure to adequately perfuse vital organs. It is recognised by:

- Hypotension (systolic BP <90 mmHg)</li>
- Tachycardia (HR >100 bpm)
- Altered consciousness
- Poor peripheral perfusion
- Oliguria (urine output (UO) <50 mL/hour)
- Tachypnoea (>20 breaths per minute)

Shock is traditionally classified into five broad groups, although there may be overlap between these.

## **Anaphylactic shock**

This is a generalised immunological condition of sudden onset following exposure to an allergen. Management of anaphylaxis is outlined in the anaphylaxis algorithm in this book (see Section 2, Chapter 1).

## **Cardiogenic shock**

This can have a primary cardiac cause, such as MI, dysrhythmia, or valvular dysfunction. It can be secondary due to cardiac tamponade, pulmonary embolus, or tension pneumothorax. Management depends on the underlying cause. Please refer to the relevant algorithm in this book.

## Hypovolaemic shock

This can be due to blood loss, e.g. following trauma or GI haemorrhage. It can be due to fluid losses following burns or as a consequence of pancreatitis or other disease processes. Please refer to the relevant algorithms within this book.

## **Neurogenic shock**

This is caused by disruption of the autonomic pathways within the spinal cord. It can occur after damage to the CNS such as spinal cord injury. Management of spinal cord injury is outlined in the spinal trauma algorithm in this book (see Section 6, Chapter 6).


## Septic shock

Septic patients have a suspected or proven infection in combination with SIRS. Patients who are immunocompromised may be neutropaenic and should be managed appropriately as neutropaenic sepsis. Please refer to septic shock algorithm in this book.

# 3. Abnormal blood glucose—diabetic ketoacidosis

#### Introduction

- More than 10% of type 1 diabetics have an episode of DKA
- This remains a life-threatening condition, with a mortality rate of approximately 2–5% in the UK

#### **Definition**

- Insulin deficiency state characterised by:
  - Acidosis: venous pH ≤7.3 and/or venous bicarbonate ≤15 mmol/L
  - Dehydration: typical DKA patient has fluid deficit of 6–8 L
  - Ketonuria: urinalysis +++ on dipstick or ≥3 mmol/L blood ketone level
  - Hyperglycaemia: blood glucose level >11 mmol/L
- Severe DKA characterised by:
  - pH <7.1 and/or bicarbonate <5 mmol/L</li>
  - Blood ketones >6 mmol/L
  - Hypokalaemia on admission (<3.5 mmol/L)
  - GCS <12 or abnormal Alert, Voice, Pain, Unresponsive (AVPU)</li>
  - Oxygen saturations <92% on air</li>
  - Shock (systolic BP <90 mmHg, pulse >100 or <60 bpm)

## **Management**

- Restoration of circulatory volume
- Correction of electrolyte imbalance (particularly potassium (K) loss)
- Correction of acid-base balance (reversal of acidosis)
- Suppression of ketogenesis/clearance of ketones
- Correction of hyperglycaemia
- Identification and treatment of precipitating factors (e.g. insulin omission, infection)

#### **Treatment**

- IV fluids
  - Replace total fluid deficit over 24 hours (typically 6–8 L) with 0.9% saline
  - Caution in elderly, pregnant, heart or kidney failure
- IV glucose
  - Start 10% glucose at 50 ml/hour when blood glucose level ≤14 to prevent hypoglycaemia and allow continued IV insulin until acidosis resolved
- Potassium
  - Monitor 2-hourly and replace to maintain normal range
  - Usually required with 2nd or 3rd litre of replacement fluid
- Insulin
  - If delay >30 minutes for IV insulin infusion, give 10 units Actrapid® stat IM or IV
  - Start infusion at 0.1 units/kg/hour and continue until acidosis corrected (bicarbonate >20)


#### **Complications**

- Cerebral oedema—risk can be reduced by correcting acidosis and hydration gradually
- Acute respiratory distress syndrome (ARDS)
- Hypoglycaemia
- Hypokalaemia—leading to cardiac dysrhythmias
- Aspiration—frequently associated with ileus, so consider NG tube if vomiting/low GCS

# 4. Abnormal blood glucose—hyperosmolar hyperglycaemic state

## **Definition and typical features**

There is no precise definition for hyperosmolar hyperglycaemic state (HHS), but there are characteristic features that enable it to be differentiated from other hyperglycaemic states. These features include hypovolaemia, marked hyperglycaemia, and high plasma osmolality without significant ketonuria or acidosis.

- Serum glucose typically >30 mmol/L
- Serum osmolarity typically >320 mmol/L: can be measured or estimated (2Na+ + glucose + urea)

The unwell patient with HHS may represent the first presentation of type 2 diabetes or HHS may occur in a known type 2 diabetic, precipitated by an acute problem such as infection or MI. Classically, HHS occurs in the elderly, but it is increasingly seen in younger adults. Altered mental state occurs in up to 25% of patients. Mild acidosis may occur in patients with concurrent renal failure (pH >7.30) and it is possible for patients to present with a mixed picture of HHS and DKA.

## **Management**

Patients should be investigated by obtaining the following:

- Bloods—U&E, serum glucose, laboratory osmolality, HbA1c, bicarbonate, lactate, and troponin T
- Urinalysis to assess ketonuria and/or plasma ketones and possible UTI
- ECG
- CXR

Further tests may be necessary as clinically indicated and for infection screening.

#### **Treatment**

Once diagnosed, the patient with HHS requires the following treatment (note: fluid replacement is the priority and often very little insulin is required):

- Slow and careful rehydration with correction of any identified electrolyte abnormalities (HHS patients typically
  have fluid deficit of 6–10 L). Take into account pre-existing conditions such as heart or renal failure. Encourage
  patients to drink as soon as it is safe to do so, with accurate fluid balance charts maintained
- Gradual restoration of normal blood glucose. This minimizes the risk of cerebral oedema. Target blood glucose is 10–15 mmol/L at 48–72 hours and is usually achieved using IV Actrapid at 2 units/hour
- Identify and treat any underlying precipitants (e.g. infection/steroid use)
- Patients are hypercoagulable and should receive prophylactic low molecular weight heparin in most cases
- Patients are at high risk of foot and leg ulceration and should receive adequate pressure area protection and daily foot checks
- Patients may require high-dependency/level 2 care, e.g. if significant impairment of conscious level, electrolyte abnormalities, or there is a need for central venous monitoring


#### **Complications**

- Fluid overload
- Cerebral oedema
- Central pontine myelinosis

## 5. Sickle cell crisis

#### Introduction

Sickle cell disease is a group of inherited conditions caused by a mutation in one of the haemoglobin (Hb) chains. In homozygotes, the sickle red blood cells are hard and fragile.

Patients generally have a chronic anaemia and present in situations of acute crisis to the Emergency Department. An acute crisis occurs when the sickling red blood cells block small blood vessels or haemolyse.

#### **Management**

The primary goal in patients with an acute crisis is effective analgesia and to identify any acute complications.

## Causes and diagnosis

There are many causes of an acute crisis, including infection, cold and dehydration.

It is also important to recognize any alternative diagnoses in patients presenting with pain (e.g. pancreatitis or pneumothorax).

## **Complications**

In addition to a crisis, patients can develop acute complications (Table 8.3). These must be recognised early and treated promptly. Other acute symptoms may be swelling of the hands and feet and priapism.

If any acute complications of the crisis occur, the patient needs urgent discussion with the haematologist (and consideration for a blood transfusion) and consideration for transfer to the High Dependency Unit.



## 6. Anaemia

The most common form of anaemia is one of iron deficiency (iron deficiency anaemia (IDA)). Once this diagnosis has been made, it is important to identify the *cause* of the IDA (most commonly from blood loss). The patient will need further investigations (e.g. endoscopy, colonoscopy) and/or specialist referral. This can be organised either through the patient's GP, via an ambulatory care setting, or as an inpatient, depending on the patient's current medical status and local protocols.

Coeliac disease is a common autoimmune condition that can present with malabsorption of iron, or B12/folate, so it may present with a microcytic or a macrocytic anaemia.

#### To transfuse or not to transfuse?

If patients are not bleeding acutely, there is no clinical need to transfuse urgently; blood transfusions come with the risk of severe reactions.

#### Transfusions in IDA

Transfusions are rarely needed in stable patients with IDA and oral/IV iron is usually the preferred treatment option. Transfusions should only be considered if an immediate increase in Hb is essential to improve the clinical situation acutely (e.g. in ACS, severe sepsis, congestive cardiac failure (CCF)). The patient should receive written and verbal advice and give their informed consent.

General recommendations for the level of Hb when a blood transfusion is needed are as follows (however, if possible, treat with oral/IV iron):

- Transfuse if Hb is <70 g/L in patients who are otherwise well
- Transfuse if Hb is <80 g/L in patients with significant comorbidities (e.g. ACS, severe sepsis, CCF)

This recommendation is a guide only. Review the symptoms and signs of the patient, discuss with a senior colleague, refer to local guidelines, and obtain advice from the local haematologists if necessary.

## Transfusions in vitamin B12/folate deficiency

This can present with marked anaemia and the temptation is to transfuse. However, the vast majority of patients improve rapidly with vitamin B12 injections and folate replacement. If a blood transfusion is essential due to critical illness (e.g. heart failure or ACS being caused or exacerbated by the anaemia), a single unit of red cells should be transfused over 4 hours, with close monitoring and diuretic cover—these patients are at high risk of developing heart failure from transfusions.



# 7. Purpura and bruising in children

## **Purpura**

Bleeding under the skin or into mucosal membranes is called purpura. Purpura can be subdivided according to size into small petechiae (<2 mm) or larger confluent areas, called ecchymoses.

#### Causes

- Meningococcal disease
- Henoch–Schönlein purpura
- Thrombocytopaenia
  - Idiopathic thrombocytopaenic purpura
  - Leukaemia
  - Aplastic anaemia
  - Septic shock
- Viral illness
- Trauma
- Forceful coughing or vomiting (usually superior vena cava (SVC) distribution)

## Meningococcal disease

Rash may be a late feature of meningococcal disease. Children presenting with petechial rash and fever who are objectively or subjectively unwell should be treated urgently, as possible meningococcal sepsis. Failure to treat aggressively is associated with a high mortality.

Treatment involves administration of third-generation cephalosporin, such as ceftriaxone or cefotaxime, according to local guidelines. Fluid resuscitation should be commenced and urgent referral to paediatrics should be arranged. Referral to the PICU team should be considered if signs of sepsis are displayed or if there is any ongoing concern.

#### Non-accidental injury

Purpura or unexplained bruising can be a presenting feature of a non-accidental injury (NAI). NAI should be considered for the following:

- Bruising in a non-mobile child
- Bruising at unusual sites
- Linear bruising/petechiae
- History incompatible with injury
- Delayed presentation of significant injury
- Petechiae co-existing with bruising, which should prompt suspicion of NAI


Any lesions suspicious of NAI should be discussed promptly with a senior colleague and referred to paediatrics for further assessment.

# 8. Leukaemia/lymphoma in children

#### Leukaemia

One-third of all childhood cancers are leukaemia, with approximately 400 new cases in the UK each year. Approximately three-quarters of these cases are acute lymphoblastic leukaemia (ALL). ALL can affect children of any age but is more common in children aged 1–4. It is more common in boys than girls.

#### Signs and symptoms of leukaemia

- Persistently enlarged lymph nodes
- Swollen abdomen
- Abdominal pain
- Hepatomegaly/splenomegaly
- Shortness of breath
- Frequent infections
- Bone and joint pain
- Weight loss
- Anaemia

## Lymphoma

The most common lymphoma in children in the UK is non-Hodgkin lymphoma (NHL), although it is still rare. About 80 children of all ages develop NHL in the UK each year. It is more common in boys than girls.

## Signs and symptoms of lymphoma

- Persistent enlarged lymph nodes
- Swollen abdomen
- Early fullness when eating
- Shortness of breath
- Persistent cough
- Fever
- Weight loss
- Night sweats
- Fatigue
- Bleeding or bruising easily


#### **Management**

Patients presenting with signs or symptoms suggestive of leukaemia or lymphoma should have bloods taken, along with a CXR if indicated. They should then be referred to the paediatric team for further investigation and to ensure appropriate follow-up is arranged.

# 9. Bruising and spontaneous bleeding

#### Introduction and definition

This chapter deals solely with adults.

A bruise is a haematoma or diffuse extravasation of blood without rupture of the skin, resulting from injury. The discoloration of a bruise (usually initially red but can be purple or brownish/yellow) does not blanch on pressure. Excessive bruising or bruising occurring due to very minor trauma may be associated with:

- Abnormalities of the blood vessels or dermis
- Abnormalities of platelet function or number
- Abnormalities of coagulation
   Abnormalities caused by drugs
   Non-accidental injury

## Drugs known to cause problems with bruising

The following are known to cause problems with bruising: corticosteroids, amitriptyline, NSAIDs, cephalosporins, chloramphenicol (systemically), cisplatin, clopidogrel, doxorubicin, glycoprotein Ilb/Illa inhibitors, gold, heparin, propranolol, penicillins, quinidine, quinine, sulphonamides, thiazide diuretics, warfarin.

## Examples of skin conditions that may be mistaken for bruising

- Allergic contact dermatitis
- Stretch marks
- Phytophotodermatitis

- Mongolian spots
- Urticarial pigmentosa
- Bullous impetigo

## Salient points in the history

- Symptoms suggesting platelet or coagulation disorder, e.g. nosebleeds, bleeding gums, blood per urine, per rectum or menorrhagia
- Excessive bruising or exessive or prolonged bleeding especially if only after minor trauma or occurring after a
  delay or only of recent onset
- Previous radio- or chemotherapy
- Past medical history of autoimmune disorders, kidney disease, liver disease, or thyroid dysfunction
- Appetite, weight loss, and general nutrition
- Tiredness, night sweats, and joint pains
- Alcohol consumption
- Medications including over-the-counter
- Family history of bleeding disorders, easy bruising, menorrhagia, or Ehlers—Danlos syndrome

#### **Examination**

- Pattern of bruising
   More general examination of skin
   Assess hair and nails
- Examine joints
- Examine abdomen: look especially for hepatomegaly, splenomegaly, and ascites
- Examine gums and eyes including fundoscopy
   Assess for lymphadenopathy
   Perform urinalysis


#### Patterns of bruising

- Dependent areas—suggests thrombocytopenia or stasis factors
- Atypical areas—suggests underlying bleeding diathesis or NAI
- Only on limbs—suggests trauma or changes in the skin or subcutaneous tissues
- Around the eyes—suggests connective tissue disorder
- Extensor surfaces of hands, forearms, and shins—suggests senile purpura in the elderly

## 10. Fever

#### Introduction

There are different definitions regarding fever (pyrexia) and hyperthermia. These involve the distinction between increased temperature due to the body's thermoregulatory centre increasing the set level required (for a variety of reasons) and increased temperature due to the body's thermoregulatory centre losing control (again due to a number of possible causes).

For the purposes of this algorithm we will ignore these distinctions and consider patients presenting with a markedly increased temperature as one group. Body temperature  $\geq 40^{\circ}$ C is generally considered to be dangerous and is the cut-off used for the purposes of this algorithm.

## Signs and symptoms

Possible signs and symptoms of markedly elevated temperature include:

Weakness or fatigue, headache and/or impaired judgement, thirst, nausea and/or vomiting, dizziness/stumbling gait, anxiety/agitation or hysteria, tachypnoea and tachycardia, paraesthesia, myalgia, cramps, or tetany, diarrhea, excessive salivation and swallowing dysfunction, collapse, seizures, or coma Any of these can occur at any time and in any combination.

## Elements suggestive of a thyroid storm

History of thyroid dysfunction or symptoms of hyperthyroidism, tachycardia and palpitations, chest pain or shortness of breath, anxiety and irritability or disorientation, heart failure, increased sweating or high temperature, weakness.

## **Evaporative cooling**

Strip patient to underwear, sponge or spray the patient with cool water, and apply fans to encourage evaporation.

## Malignant hyperthermia

This is a particular presentation with markedly increased temperature (among other signs). Here patients with the genetic predisposition when exposed to suitable triggers, e.g. volatile anaesthetic agents or succinylcholine, can develop an uncontrolled and extreme increase in skeletal muscle oxidative metabolism. This usually occurs when patients receive anaesthetics for surgical procedures within the theatre area; however, there is a possibility that it may occur in the Emergency Department if a patient receives an RSI for the first time. The AAGBI has produced a safety guideline for use when malignant hyperthermia occurs.

## Neuroleptic malignant syndrome

This is another particular type of presentation where, along with increased temperature, muscle rigidity and autonomic hyperactivity predominate. This is caused by various antipsychotics (including haloperidol, olanzapine, and risperidone) and some antiemetics (including droperidol, metoclopramide, and prochlorperazine). These lists are by no means exhaustive; it is vital that any history of the patient having taken antipsychotics or antiemetics is sought.

#### Serotonin syndrome


A very similar picture is seen with serotonin syndrome; this is due to an accumulation of serotonin, which can be caused by a wide variety of drugs including SSRIs, serotonin-norepinephine reuptake inhibitors, tricyclic antidepressants, monoamine oxidase inhibitors, some migraine medications, antiemetics and analgesics, illegal substances (lysergic acid diethylamide (LSD), 3,4-methylenedioxy-methamphetamine (MDMA, commonly known as ecstasy), cocaine, amphetamines), and even some herbal remedies. Again this list is not exhaustive but emphasizes the need for a very careful and thorough drug history.

# 11. The oliguric patient

#### **Definition**

- In infants: <1 mL/kg/hour urine output</li>
- In children and adults: <0.5 mL/kg/hour urine output for 6 consecutive hours
- Anuria—defined in adults as <50 mL of urine/day
- Oliguria is important as it is associated with acute kidney injury (AKI), and in particular AKI is associated with fluid overload if oliguria is present.

#### **Types**

- Pre-renal: functional response of structurally normal kidneys to hypoperfusion. Associated with high-output GI losses, haemorrhage, sepsis, congestive heart failure, or decreased oral intake
- Intrinsic renal problem: associated with structural renal damage. Includes acute tubular necrosis (ATN) (from prolonged ischaemia, drugs, or toxins), primary glomerular disease, or vascular lesions
- Post-renal: consequence of mechanical or functional obstruction of flow of urine. This form of oliguria and renal insufficiency usually responds to release of the obstruction
- Fictitious: if all other causes above are ruled out. Patients may report oliguria in order to avoid supplying a urine sample (e.g. due to fear of exposure of recent illicit drug use)

## Salient points in the history

- Duration of oliguria and if any associated suprapubic pain or discomfort
- Recent urinary symptoms, e.g. dysuria, haematuria, poor flow, hesitancy, urgency, post micturition dribbling
- Recent fevers
- Recent back injury or pain or neurological deficit in lower limbs
- Lethargy or itching
- Peripheral oedema
- Drug history, especially any potentially nephrotoxic drugs, e.g. NSAIDs, ACE inhibitors, diuretics
- Recent renal tract instrumentation
- Previous renal problems
- Systemic review including past medical history (PMH), diabetes mellitus (DM), hypertension, ischaemic heart disease (IHD), stroke, peripheral vascular disease (PVD), and any recent respiratory symptoms
- Any testicular pain or swelling


#### **Examination**

- Any evidence of anaemia
- Excoriation or rashes
- Volume status
- Palpable bladder
- Loin/flank tenderness
- Peripheral oedema
- Prostate examination in males

# 12. Oncology emergencies

## Malignant superior vena cava obstruction

There are several 'oncology emergencies', including symptoms due to a cancer as yet undiagnosed, complications of a known cancer, or complications caused by a cancer treatment. Some of these are covered in other algorithms within this book, e.g. spinal cord compression and neutropaenic sepsis. This chapter deals solely with malignant SVC obstruction.

The majority of cases of SVC obstruction are due to the presence of a malignant tumour in the mediastinum preventing venous drainage from the head, arms, and upper trunk. Lung cancer is the commonest cancer associated with SVC obstruction, but it can occur with lymphoma or cancers that metastasize to the mediastinal lymph nodes.

SVC obstruction usually develops over weeks or even months (chronic presentation is best managed with a phone call to an oncologist for advice), but occasionally it can develop over days and present acutely (patients in this situation may present to the Emergency Department).

## Signs and symptoms

- Facial swelling, redness, headache (worse with stooping), periorbital oedema, engorged conjunctivae, papilloedema (late sign)
- Swelling of the arms, prominent distended veins on neck and upper chest wall
- Breathlessness, increased RR, cough, chest pain, stridor, cyanosis
- Other symptoms, e.g. dysphagia, visual disturbance, dizziness

#### **Treatment**

This depends on the cause of the obstruction, the severity of the symptoms, and the patient's prognosis. This makes obtaining a thorough history, performing a comprehensive examination, and relevant investigations key to decisions regarding management. The acute oncology team will make the decision regarding which treatments will be recommended for each individual patient; options include radiotherapy, chemotherapy, and minimally invasive stent placement.

## **History**

This should include (if known):


- Cancer diagnosis
- Disease stage
- Treatment intent
- Drugs and timings of most recent treatment
- Has patient received treatment within last 6 weeks?
- Is patient for further treatment including resuscitation?
- What is the DNACPR (do not attempt cardiopulmonary resuscitation) status?
- Where is preferred place of care and death?

Note: it may be possible to obtain more detailed information via the cancer treatment centre's triage line or via direct access to oncology case notes.

# 13. Poisoning/self-harm

#### Introduction

There are two obvious aspects to assessment and management of patients who present with overdoses or self-harm. The medical assessment including resuscitation and emergency management must take precedence, but the psychosocial assessment is equally important and should not be delayed until after medical management is complete unless life-saving treatment is required, the patient has reduced conscious level, or there is another reason precluding assessment.

All staff dealing with patients presenting with poisoning must have access to TOXBASE and the NPIS telephone number. It is vital that TOXBASE is consulted for all patients presenting with poisoning at triage so that staff can be alerted early if any urgent treatment or monitoring is required.

All staff dealing with poisoning and self-harm patients should have a good working knowledge of the Mental Capacity Act (MCA), the steps required to assess capacity, the principles underlying the Act, and treating patients under Common Law. They should also be aware of the relevant parts of the Mental Health Act (MHA) that can be invoked in the area in which they work, and understand the limitations and responsibilities involved.

## **Australian Mental Health Triage Tool**

This clinical tool can be used at point of entry to the ED to provide a systematic way of categorising the urgency of clinical presentations, and determining an appropriate service response and an optimal timeframe for intervention. Table 8.4 ... Australian Mental Health Triage Tool

## Medical and traumatic management

This chapter covers a wide variety of presentations; therefore it is extremely important that TOXBASE advice is followed for specific overdoses. Where a patient has self-harmed, advanced trauma life support (ATLS) principles and/or usual wound management (see wound assessment and management in Section 6, Chapter 10) should be employed and surgical advice (where appropriate) should be followed.

## Psychosocial assessment

Psychosocial assessment should include identification of the main clinical and demographic features known to be associated with risk of further self-harm and/or suicide, and identification of the key psychological characteristics associated with risk, in particular depression, hopelessness, and continuing suicidal intent. This assessment should be documented in the patient's notes and communicated to the patient's GP.

Psychosocial assessments done by ED staff will not be as comprehensive as those done by a mental health team; with this in mind it is best if ED staff have a locally agreed proforma to follow, and if there is any doubt as to the level of risk posed by the patient, the mental health team should be contacted.



## 14. Rashes

#### Introduction

This chapter covers rashes occurring in adults, which fall into four basic categories:

- Petechial/purpuric
- Erythematous
- Maculopapular
- Vesiculobullous

For petechial/purpuric rashes see the algorithm for bruising and spontaneous bleeding in this book (Section 8, Chapter 9). Remember, it is not the job of any ED doctor to diagnose every rash, but we should recognize or at least ask for senior review for the more serious and certainly life-threatening rashes, and there may be some more typical rashes that can be easily diagnosed in the Emergency Department.

Nikolsky's sign—With an erythematous rash, try applying lateral pressure to the skin and see if it sloughs

## History and examination

Important guestions to answer within the history and examination include:

- When did the rash appear and how quickly did it progress?
- What is the overall morphology (remember, there can be secondary changes) and did the rash change over time?
- What is the overall pattern, distribution, and percentage of the body affected and where did it start?
- Is the patient sick or not sick?
- Is the rash pruritic?
- Is there any past medical history and any history of recent travel?
- What is the patient's occupation/what are their hobbies?
- What medications is the patient taking?
- Have there been any recent changes in medication or products used?

## Red flags for toxic rash

- Extremes of age
- Adenopathy or arthralgia
- Toxic appearance, hypotension, or high fever
- Severe pain or rapidly progressive rash
- Extensive skin involvement (anything >10% BSA should be concerning)
- Mucosal involvement (never good)
- Immunocompromised
- Positive Nikolsky's sign
- Petechial or purpuric morphology
- Specific lab abnormalities
- Common recognisable patterns of rash

#### Table 8.5 Common recognisable patterns of rash



# 15. Acute red eye

#### **Definition**

The differential diagnosis of acute red eye ranges from benign conditions that can be managed by the emergency physician to serious vision-threatening ones that require emergent ophthalmologic evaluation. Emergency physicians should be adept at recognizing high-risk features from the history and examination that would require urgent ophthalmologic referral and treatment.

# History

The history should address the following essential components:

- Time of onset
- Photophobia
- Any visual disturbances
- Recent illnesses and trauma
- Ophthalmologic history
- Presence or absence of pain, foreign body sensation, and itching
- Presence and type of discharge

#### **Examination**

- Visual acuity
- Extraocular muscle function
- Gross appearance of sclera and conjunctiva
- Palpation for preauricular nodes
- Pupil shape and reactivity and comparison between pupils

Often, evaluation of the affected eye requires fluorescein staining and a cobalt blue light using a slit lamp.


#### **Management**

- Urgent referral means within 12 hours, emergency referral is within 1-2 days
- Treatment of acute angle-closure glaucoma mandates prompt and rapid transfer to an eye specialist. In the Emergency Department, IV acetazolamide 500 mg and topical pilocarpine 2% should be given
- Patients with allergic conjunctivitis almost always present with itching and may or may not have associated watery eyes and rhinorrhea
- Keratitis must be suspected in any patient presenting with painful red eye who uses contact lenses

# 16. Acute visual loss

#### **Definition**

Loss of vision is considered acute if it develops within a few minutes to a couple of days and is classified as follows:

- Acute transient visual loss: sudden deficit in visual function in one or both eyes lasting less than 24 hours. It is
  caused by a temporary occlusion in the circulation to the eye or visual cortex, or by neuronal depression after
  a seizure or migraine
- Acute persistent visual loss: visual loss lasting more than 24 hours

#### Causes

Presence or absence of pain helps categorize acute loss of vision (Table 8.6).

# Salient points in the history

- A distinction must be made between sudden onset of visual loss and sudden discovery of visual loss
- Keratitis produces a sharp superficial pain, while acute glaucoma produces a deep brow ache with nausea and vomiting
- Patients with keratitis, acute glaucoma, and uveitis usually present with conjunctival hyperaemia (red eye)
- Optic neuritis typically causes eye pain, particularly with eye movements. The pupil looks normal, but pupil reaction is abnormal with a relative afferent pupillary defect
- Bilateral loss of vision often suggests a retro-chiasmal (posterior to optic chiasm) visual pathway disorder
- Urgent referral means within 12 hours; emergency referral is within 1–2 days

#### Table 8.6 Causes of acute visual loss



# 17. Hyperkalaemia

#### Introduction

True hyperkalaemia is rare in the presence of normal renal function.

# Causes of true hyperkalaemia

- Decreased renal excretion
  - Acute renal failure
  - Patients with chronic renal failure or on dialysis with potassium load
  - Potassium-sparing diuretics (e.g. spironolactone, amiloride)
- Cell injury
  - Crush injury and other causes of rhabdomyolysis
  - Burns
  - Tumour lysis syndrome
  - Massive or incompatible blood transfusions
- K+ cellular shifts (intracellular to extracellular)
  - Acidosis from any cause (e.g. DKA)
  - Drugs (suxamethonium, β-blockers, digoxin poisoning)
- Hypoaldosterone
  - Addison's disease
  - Drug induced (NSAIDs, ACE inhibitors, angiotensin II receptor blockers, heparin)
- Renal tubular acidosis type IV

# Degree of hyperkalaemia

- Mild: K+ 5.5–5.9 mmol/L
- Moderate: K+ 6.0–6.4 mmol/l
- Severe: K+ ≥6.5 mmol/L, or if ECG changes or symptoms occurring at any level ≥5.5 mmol/L

#### Signs and symptoms

Even extremely severe, life-threatening hyperkalaemia may be asymptomatic There may, however, be

- Muscle weakness and cramps
   Paraesthesia
   Hypotonia
   Focal neurological deficit
- Palpitations

### **ECG** changes

- Peaked, tall, 'tented' T waves
- Small/flattened, broad or absent P waves
- Widening of the QRS complex
- Sinusoidal ('sine wave' pattern) QRST leading to VT or VF
- Atrioventricular block or dissociation


#### **Treatment**

Both insulin/glucose combination and salbutamol work by shifting K+ from the extracellular compartment to the intracellular compartment, which in turn should minimize the effects of K+ on the electrical stability of the membranes. IV calcium stabilizes the membrane directly and reduces the arrhythmic threshold.

# 18. Rhabdomyolysis

Rhabdomyolysis is a syndrome characterised by muscle necrosis and release of intracellular muscle constituents into the circulation. Typically, CK levels are markedly elevated. Disease severity ranges from isolated CK rise to life-threatening disease with enzyme release, electrolyte disturbance, and acute kidney injury.

#### Causes

# Common causes of rhabdomyolysis can be summarised in table 8.7

### **Diagnostic tests**

See table 8.8.

#### Alkalinisation of urine

- This is said to enhance the solubility of myoglobin
- Usually effective in first 8 hours
- It can be achieved by 1 L 1.26% sodium bicarbonate over 2 hours and repeat as necessary to keep urinary pH >7.5
- Test urine regularly with pH strips to monitor



# 19. High INR

#### Warfarin

Warfarin is an oral anticoagulant that antagonizes the effect of vitamin K. It takes at least 48–72 hours for the anticoagulant effect to fully develop and anticoagulation can last for 4–5 days. Careful monitoring of PT, expressed as the INR, especially in the early stages of anticoagulation, is essential. Warfarin therapy is complicated by the delayed effect of dose alteration and because various medical conditions and other drugs modify warfarin activity.

# Factors that increase anticoagulant effect of warfarin

- Liver disease
- Infection/sepsis
- Thyrotoxicosis
- Alcohol/major dietary changes (consumption of cranberry and grapefruit juices)
- Drugs, e.g. ciprofloxacin, NSAIDs, salicylates, metronidazole, chloramphenicol, cephalosporins, amiodarone, antifungals (azoles)

# Factors that decrease anticoagulant effect of warfarin

- Pregnancy
- Anaemia
- Nephrotic syndrome
- Drugs, e.g. rifampicin, carbamazepine, griseofulvin, barbiturates, oral contraceptives, penicillins

# Life-/sight-/limb-threatening bleeding

Life-threatening bleeding includes intracranial, retroperitoneal, and significant GI bleeding and pericardial bleeding. Sight-threatening bleeding refers to intraocular and not conjunctival bleeding. Limb-threatening bleeding would include muscle bleeding leading to or threatening the development of compartment syndrome. A **strong** clinical suspicion of intracranial bleed following head injury should trigger administration of Beriplex® prior to the results of investigations.

#### Warfarin reversal

The anticoagulant effect of warfarin can be antagonized by administering vitamin K. This can be given orally or intravenously. Oral vitamin K is safe and adequate treatment for the majority of patients, but it can be given IV in life-, limb-, or sight-threatening bleed or in patients with significant bleeding or at high risk of bleeding or falls. IV vitamin K should be given as a slow bolus as it can cause anaphylaxis.

Full warfarin reversal can be achieved using human prothrombin complex (Beriplex) in combination with IV vitamin K. Depending on local guidelines, Beriplex often requires authorization for use by a consultant haematologist. Human prothrombin complex is prepared from human plasma and contains Factor IX together with Factors II, VII, and X. The standard dose is 30 units/kg rounded up to the nearest 500 units and is given over 10 minutes as a slow IV bolus injection.

Fresh frozen plasma (FFP) use is now largely limited to areas/situations where human prothrombin complex is not available.



# 1. Acute back pain

#### **Definition**

Most people will experience at least one episode of low back pain during their adult lifetime. Most of these are of short duration, lasting from days to a few weeks, and resolve with little if any therapeutic intervention. The challenge to the emergency physician is to identify those patients who may benefit from diagnostic interventions to further evaluate their pain.

# **Red flags**

For red flags in back pain see Table 9.1.

Table 9.1 Back pain red flags

# Cauda equina syndrome

Cauda equina syndrome is rare but catastrophic and requires urgent surgical consultation. All patients with back pain should be asked about urinary retention. Those reporting this symptom should be examined for bilateral leg weakness, depressed leg deep tendon reflexes, and perineal numbness. These patients may report bowel, bladder, and sexual dysfunction, and severe pain.

# **Malignancy**

Recurrent metastatic cancer must be considered in all cases of back pain in cancer survivors. Cancers frequently metastatic to the spine include breast, lung, gut, prostate, renal, and thyroid. Clues to the diagnosis include a gradual onset of symptoms and a history of cancer.

### **Non-spine causes**

AAA dissection or rupture should be suspected in any patients with lumbar pain who are known to have AAA or in those at risk of AAA.

# When to obtain plain radiography

Clinicians should not routinely obtain plain imaging in patients with low back pain; exposure to unnecessary ionizing radiation should be avoided. The amount of gonadal radiation from obtaining a single plain radiograph (two views) of the lumbar spine is equivalent to being exposed to a daily chest radiograph for more than 1 year.

Plain imaging is recommended in:


- Suspected fracture (trauma, prolonged steroid use, osteoporosis, etc.)
- Suspected cancer (new onset of low back pain with history of cancer, multiple risk factors for cancer, or strong clinical suspicion for cancer)
- Low back pain >6 weeks duration

# 2. Epistaxis

#### Introduction

- Most epistaxis is self-limiting and harmless; often a cause is not identified
- 80–90% of cases originate from Little's area on the anterior nasal septum
- Up to 60% of the population have experienced an episode of epistaxis

#### **Causes**

- Local causes include trauma, inflammation, nasal polyps, topical drugs, surgery, vascular causes, and tumours
- More general causes include hypertension, haematological disorders, environmental factors, systemic drugs, and excessive alcohol consumption

## **Complications**

 Complications of epistaxis are rare and include hypovolaemia, anaemia, and complications from nasal packing treatment

# **Management**

- A posterior bleed (bleeding is profuse, from both nostrils, and the bleeding site cannot be identified on examination) may require a Foley catheter and/or admission to ENT
- If bleeding does not stop after 10–15 minutes of pressure, nasal cautery or nasal packing may be used
- Consider nasal cautery if expertise and facilities are available:
  - Use topical local anaesthetic spray
  - Lightly apply the silver nitrate stick to the bleeding point for 3–10 seconds
  - Only cauterize one side of the septum to avoid nasal septal perforation
  - Avoid touching areas that do not need treatment
- If bleeding stops, a topical antiseptic such as Naseptin® cream may be applied to prevent rebleeding (qds for 10 days), particularly in children for whom cautery is not an option (beware peanut allergy)
- Consider nasal packing:
  - Anaesthetize the nasal cavity with topical local anaesthetic spray
  - Available products include:
    - Nasal tampons (e.g. Merocel®)— effective and easy to use
    - Inflatable packs (e.g. Rapid-Rhino®)— effective and more comfortable to insert and remove than nasal tampons
    - Ribbon gauze impregnated with Vaseline®—not recommended without specific training
  - Admit the person to hospital for observation, preferably to ENT

# Discharge self-care advice


- For 24 hours avoid activities that may increase the risk of rebleeding:
  - Blowing or picking the nose
  - Heavy lifting or strenuous exercise
  - Drinking alcohol or hot drinks
- If bleeding restarts and does not respond to first-aid measures, the person should seek medical advice

# 3. Falls

#### Introduction

Falls are increasingly common with advancing age, with 30% of over 65-year-olds and 50% of over 80-year-olds having at least one fall per year.

This algorithm should be applied to all patients presenting to Emergency Departments who are 65 years or over and any patient 50–64 years old if deemed to be at increased risk of falling due to an underlying condition. As part of the NICE guidance for prevention of falls, all such patients during any contact with health professionals should now routinely be asked if they have fallen in the past year and asked about the frequency, context, and characteristics of such fall(s).

#### **Assessment**

A multifactorial falls assessment may occur as an inpatient or in the setting of a falls clinic service. The focus of these may be slightly different, but in both cases the assessment should be carried out by a healthcare professional with appropriate skills and experience.

# Patients at risk of falling

It is important to identify patients at risk of falling as early as possible, and appropriate equipment and staffing levels should be provided during the patient's time in the Emergency Department. Ideally, an area of the Emergency Department could be designated for such patients with appropriate flooring, lighting, furniture, and fittings.

#### **Awareness**


All ED staff should undergo regular training in basic falls assessment and prevention and be aware of local pathways to refer to falls services. ED staff should have access to patient information leaflets regarding falls.

It is vitally important that ED staff are aware of the services available to them with regard to access to physiotherapy and occupational therapy (OT) assessment, access to short-term increase in social services, and referral pathways to falls services in their locality.

# 4. Non-traumatic limb pain and swelling

#### Introduction

This chapter focuses on acute pain/swelling (<3 months).

#### **D**-dimer

D-dimer is a fibrin degradation product. It is detectable at levels >500 ng/mL of fibrinogen equivalent units in nearly all patients with venous thromboembolism. It is a sensitive test but lacks specificity for the diagnosis of DVT and is therefore only useful when negative (value <500 ng/mL).

If DVT is not a diagnostic possibility, a D-dimer test should not be done, because a positive result may redirect a clinician away from investigating the true cause of the leg symptoms towards unnecessarily investigating for DVT

### **Revised Wells score**

A variety of clinical decision rules can be used to assess the clinical probability of having DVT. The Revised Wells score (RWS) is the most commonly used (Table 9.2).

Table 9.2 The Revised Wells Score—a commonly used clinical decision tool

| Symptom and risk factors  | Points            |
|---|-------------------|
| Active cancer, or cancer that's been treated within last 6 months                   | 1                 |

It is important to bear in mind that the RWS for DVT is not validated for use in patients with suspected DVT at sites other than the lower limb, in hospitalised patients, or in pregnant women.

Acute limb ischaemia should be thought of in patients presenting with acute non-traumatic limb pain and distal pulses should be assessed with or without the assistance of hand-held Doppler.

## **Ankle-brachial pressure index**

The resting systolic blood pressure at the ankle is compared with the systolic brachial pressure and the ratio of the two pressures defines the ankle-brachial pressure index (ABPI).

Claudication: 0.4 and 0.9
 Rest pain: 0.2–0.4
 Tissue loss (ulcer, gangrene): 0–0.4


#### **Notes**

- Stress fractures most frequently occur in weight-bearing bones, such as tibia. Initial plain imaging might look normal
- Be aware of compartment syndrome after heavy exercise like running. A high index of suspicion is crucial

# 5. Acute neck pain

# **Background**

Neck pain can be classified into acute (< 6 weeks), sub-acute (6 weeks-6 months) and chronic (>6 months). Acute neck pain can be further classified into traumatic and non-traumatic.

## Features suggestive of significant disease

The following signs and symptoms in patients presenting with non-traumatic neck pain suggest the potential for significant disease (see Table 9.3).

Although sinister causes of neck pain are rare, clinicians must be mindful of red flags that may indicate serious pathology. The clinical history, rather than the physical examination, remains the most critical step in determining the likely cause of cervical spine pain, whereas biochemical tests and imaging are not part of routine assessment.

## Traumatic neck pain

Patients with trauma presenting to the Emergency Departments with neck pain is not uncommon and fortunately most are soft tissue related however, very few of them have a cervical-spine fracture and must be managed appropriately to prevent spinal cord injuries and long term sequelae

# Which patient needs imaging?

There are 2 widely used clinical decision rules for C spine imaging, NEXUS rules and the Canadian C spine Rule (CCR). For the alert stable patient, the CCR seem to be superior to NEXUS rule with respect to sensitivity and specificity for cervical spine injuries.

#### **Salient points**


- A dangerous mechanism is considered to be a fall from an elevation ≥3 ft or 5 stairs; an axial load to the head (e.g., diving); a motor vehicle collision at high speed (>100 km/hr) or with rollover or ejection; a collision involving a motorized recreational vehicle; or a bicycle collision.
- No force should be used when assessing neck movements and the patient should be asked to actively
  movement their neck.
- To be able to assess neck movement, you would need a fully cooperative alert patient
- Adequate lateral spine X ray should show the entire 7 cervical spine vertebras and the top of the first thoracic vertebrae.

# 6. Painful ear (otalgia)

#### **Definitions**

Otalgia can be divided into primary and referred otalgia. Primary otalgia can be caused by disease in the external, middle, or inner ear, but the three are indistinguishable in terms of the pain experienced.

The general ear region has a sensory innervation provided by four cranial nerves (V, VII, IX, X) and two spinal segments (C2, C3). Hence, pathology in other 'non-ear' parts of the body innervated by these neural pathways may cause referred otalgia.

#### **Assessment**

- The history should be complete and specifically encompass a review of otologic symptomatology, swallowing disorders, sinus problems, and cervicofacial pain syndromes
- Physical examination should include otologic, head, and neck examination
- In primary otalgia, ear examination is usually abnormal, and vice versa
- The initial aim is to differentiate primary from referred otalgia

# Causes of primary otalgia

- Foreign body
- Otitis media
- Otitis externa.
- Trauma

Less common causes, which should not be overlooked, include:

- Necrotizing otitis externa (suspect in refractory otitis externa in patients with diabetes, older patients, and immunocompromised patients, and pain disproportionate to examination findings)
- Ramsay—Hunt syndrome (herpes zoster oticus)
- Mstoiditis (recent or concurrent otitis media, retroauricular pain, protrusion of auricle, and tender edematous mastoid on examination)
- Acute cholesteatoma (epidermal cysts composed of desquamating epithelium)

### Causes of referred otalgia

- Dental causes
- Pharyngitis or tonsillitis
- Temporomandibular joint (TMJ) syndrome
- Abscess

Less common causes, which should not be overlooked, include:


- Temporal arteritis (age >50, jaw claudication, diplopia, temporal arteries may be tender, prominent, or beaded, and ESR usually >50)
- Neuralgias (e.g. trigeminal, glossopharyngeal)
- Thoracic aneurysms (more common in older men and may have risk factors for atherosclerosis)
- Referred pain from angina pectoris or MI

# 7. Sore throat

#### The Centor criteria

The Centor criteria were developed to predict bacterial infection (group A beta-haemolytic streptococcus, GABHS) in people with acute sore throat.

- Presence of tonsillar exudate
- Presence of tender anterior cervical lymphadenopathy or lymphadenitis
- History of fever
- Absence of cough

>= of these criteria equates to a 40–60% chance of GABHS and therefore the patient may benefit from antibiotics. <3 of these criteria equates to an 80% chance that the patient does not have a bacterial infection and therefore antibiotics are unlikely to be necessary.

## Signs suggestive of acute epiglottitis

- Respiratory distress
- Drooling
- Systemically very unwell
- Painful swallowing
- Muffled voice

## Extra signs suggestive of quinsy

- Drooling
- Trismus
- Hot potato or muffled voice
- Asymmetric tonsillar hypertrophy
- Inferior and medial displacement of the tonsil
- Contralateral deviation of the uvular

# Patients at risk of immunosuppression

- Taking disease-modifying antirheumatic drugs (DMARDs)
- Taking carbimazole
- On or recent chemotherapy
- Known or suspected leukaemia, asplenia, aplastic anaemia, HIV/AIDs
- Taking immunosuppressive drugs post transplant


#### Glandular fever

Glandular fever is likely if the FBC has >20% atypical lymphocytes or >10% atypical lymphocytes and the lymphocyte count is >50% of the total WBC count.

# 8. Scrotal pain

#### **Definition**

The spectrum of conditions that affect the scrotum and its contents ranges from incidental findings that merely require patient reassurance to acute pathologic events that require immediate surgical intervention. Delayed surgical intervention can lead to loss of the testis and infertility.

The mainstay in assessing patients with scrotal pain is to differentiate between acute and chronic (>6 weeks) scrotal pain.

#### Causes

- Testicular torsion
- Epididymitis and epididymo-orchitis
- Fournier's gangrene (necrotizing fasciitis of the perineum caused by a mixed infection with aerobic/anaerobic bacteria)
- Torsion of the appendix testis
- Testicular cancer
- Trauma/surgery
- Others like inguinal hernia, Henoch-Schönlein purpura (IgA vasculitis), mumps, and referred pain

## **Management**

- The most sensitive physical finding in testicular torsion is absence of the cremasteric reflex (this reflex is
  elicited by stroking or pinching the medial thigh, causing contraction of the cremaster muscle, which elevates
  the testis)
- Normal lie testis (longitudinally) with normal cremasteric reflex makes testicular torsion highly unlikely
- False-negative results on Doppler ultrasonography may be caused by intermittent torsion or by early torsion
  when only venous outflow is occluded
- In epididymitis, the scrotal skin becomes oedematous and its appearance has been likened to an orange peel.
   This change occurs late in the course of the disease, however: Initially, the only sign may be tenderness of the epididymis and possibly pyuria
- When the appendix testis undergoes torsion, a hard, tender nodule 2–3 mm in diameter may be palpable on the upper pole of the testicle. A blue discoloration may be visible in this area ('blue dot sign')
- Fournier's gangrene, antibiotic therapy alone is usually associated with a 100% mortality rate, highlighting the need for immediate surgical debridement



# 9. Acute urinary retention

#### Introduction

- The most frequent aetiology is benign prostatic hyperplasia (BPH)
- Incidence in England is approximately 3/1000 men per annum
- Acute urinary retention (AUR) occurs in approximately 10% of men over the age of 70 in a 5-year period

#### **Causes**

- Most commonly secondary to an obstructive process including BPH, malignancy, urethral stricture, urolithiasis (stones), phimosis, and paraphimosis
- Other causes include the use of medications, trauma, neurologic disease, and infection

#### Risk factors

- Male gender—10 times more likely than in women
- Age >70 years carries a relative risk (RR) of 7.8
- Prostatic volumes >30 mL associated with an RR of 3.0
- Urinary flow rate of <12 mL/second carries an RR of 3.9

# History and examination

- Relevant history should include prior episodes of retention, prior urologic surgery, prior radiation, or trauma, haematuria, dysuria, fever, back pain, and a list of medications
- Palpation of the lower abdomen can reveal a palpable bladder
  - May contain over 500 mL
- Rectal examination: rectal masses, impaction of stool, and examination of the prostate gland to evaluate for malignancy or prostatitis should be performed
  - A prostate of normal consistency and size does not rule out obstructive pathology
- Urine should be sent for routine urinalysis and culture (usually after catheter placement)

### **Management**

- Initial management involves prompt bladder decompression
  - This can be accomplished with urethral or suprapubic (SP) catheterisation
- SP catheter may be necessary in patients with urethral stricture, severe BPH, or other anatomic abnormalities that preclude Foley catheter placement per urethra
  - SP catheters are preferred in patients who require long-term bladder drainage. SP catheters prevent urinary incontinence resulting from sphincter dysfunction, and avoid the risk of subsequent urethral stricture
- Partial drainage and clamping may increase the risk for urinary tract infection
- Hospitalisation is indicated for patients who are uroseptic or have obstruction related to malignancy or spinal cord compression
  - The majority of patients can be managed on an outpatient basis
- Prophylactic antibiotics are not routinely indicated unless suspicion exists for a urinary infection at the time of drainage or traumatic catheterisation
- Additional instructions regarding catheter and drainage bag management should be given prior to discharge



# 10. Per-vaginal bleeding

#### Introduction

- If the patient has collapsed, is in haemorrhagic shock, has heavy bleeding, or has severe abdominal pain, move
  to the resuscitation room and instigate resuscitation measures, as shown on the algorithm. Call for help early,
  e.g. senior obstetric, gynaecology, and anaesthetic teams
- Perform a urine or serum β-HCG to determine pregnancy status (consider catheter if the patient is unwell
  and urgent determination of pregnancy state is needed). If in doubt, treat the patient as if she is pregnant
- A PV examination may be lifesaving in the event of an open os during a miscarriage—ensure IV access and
  fluid resuscitation is ongoing. The aim is to remove products from the os to enable it to close to prevent
  further bleeding. If this fails, refer immediately for an examination under anaesthetic. During heavy PV loss due
  to a miscarriage, vagal stimulation may result in bradycardia as opposed to tachycardia. Consider the use of
  atropine in these patients

## Anti-D immunoglobulin use

Anti-D Ig is given to women who are D-negative and who have been exposed to a 'sensitizing event' (Box 9.1). It should be administered as soon as possible after the sensitizing event and within 72 hours (Table 9.4).

# Pelvic inflammatory disease

A full sexual history is needed in patients with a possible diagnosis of pelvic inflammatory disease (PID).

The collection of symptoms (fever, abdominal pain, PV discharge/bleeding) and signs (lower abdominal tenderness (usually bilateral), adnexal tenderness, cervical excitation, and fever >38°C) supports this diagnosis.

All patients should be discussed with the gynaecology team and have swabs taken for gonorrhoea and chlamydia. Inpatient vs outpatient treatment depends on many factors (see British Association for Sexual Health and HIV (BASHH) guidelines). All patients should be offered an HIV test.

Follow local hospital guidelines about antibiotic regimen.



# 1. Suicidal ideation

#### Introduction

Suicidal ideation and behaviour are among the most common psychiatric emergencies, and an estimated one million people die by suicide worldwide each year. Assessment of the patient exhibiting suicidal ideation is vital to try to prevent the patient going on to attempting self-harm or suicide.

#### Assessment of suicide risk

It can be challenging for clinicians in the Emergency Department to assess suicide risk in patients. The Modified SAD PERSONS Scale attempts to assist non-psychiatrists in assessing this risk by arranging a number of risk factors into a mnemonic that can be used to assess potentially suicidal patients (Table 10.1).

This score is then mapped onto a risk assessment scale as follows:

- 0–5: May be safe to discharge (depending upon circumstances)
- 6–8: Probably requires psychiatric consultation
- >8: Probably requires hospital admission

The Scale is helpful, but evidence suggests it is not reliable in isolation in assessing this group of patients. Other risk factors should also be taken into account.

#### Other risk factors

- Psychiatric disorders/diagnosis and physical health
- Hopelessness
- Occupation (e.g. military service)
- Family history

#### Who to refer

Patients scoring highly on the Modified SAD PERSONS Scale or with other worrying risk factors should be referred to mental health services. A low threshold should be maintained for discussion with mental health services for all suicidal patients as this enables information sharing and helps to ensure appropriate review and/or follow-up with mental health services.



## 2. Needlestick injury

#### Introduction

- Exposure to blood or bodily fluid may result in transmission of blood-borne viruses (BBVs)
  - These may include HIV and hepatitis B and C virus
- Risk is proportional to prevalence of the infection in the population served, and to a healthcare worker from an infective patient is approximately

## Transmission (significant exposures)

- Injury from hollow needles
- · Contamination of mucous membranes, eyes, mouth, or broken skin with infected blood or other infectious material
  - Risk is much lower after mucocutaneous exposure (<1 in 2000 for HIV)</li>
  - High-risk body fluids include blood, CSF, amniotic fluid, breast milk, peritoneal, pleural, pericardial, or synovial fluid, vaginal secretions, semen, and tissue fluid exudate
- Bites that break the skin of the person bitten

## **Testing**

- Source patient's consent to testing must always be obtained (cannot consent if unconscious)
  - By someone other than that who sustained the injury
  - A donor refusing consent is more likely HBsAg positive than those who consent

#### Risk factors

- IV drug abuse, blood transfusions (earlier than 1992), chronic liver disease, homosexual males, native of Sub-Saharan Africa or South East Asia, prostitute, multiple tattoos or piercings
- 'Window period' of 6–10 weeks from infection to detection of measurable antibodies

#### **Treatment**

- Post-exposure prophylaxis (PEP) reduces the risk of infection following an exposure
  - Rarely indicated following exposure to unknown source
  - Ideally commenced within 1 hour, certainly within 72 hours, and continued for 28 days
  - Standard regimen of 1Truvada® bd + 2Kaletra® bd
- Accelerated course of hepatitis B vaccine consists of doses at 0, 1, and 2 months (Table 10.2).



## 3. Pain management

### Introduction

Recognising and alleviating pain is vital in order to help relieve distress, aid patients in giving useful details of history, and help with cooperation with further investigations and treatment.

As clinicians we need to:

- Recognize that patients are in pain
- Be able to quantify and assess how much pain they are in
- Relieve the pain
- Reassess the pain in order to assess the effectiveness of the analgesia given
- Ensure that we have processes in place to audit the provision of analgesia

The Royal College of Emergency Medicine states that patients in severe pain should receive analgesia within 20 minutes and be reassessed within 30 minutes of that analgesia being given.

## Recognition and assessment of pain

There are various different mechanisms to quantify the level of pain a patient is in, including:

- Visual Analogue Scale: scale of 0–10. Severe pain is diagnosed with a score of 7 or more
- Wong-Baker FACES® Pain Rating Scale. This is a picture card of various faces that look happy (pain free), not so happy (moderate pain), or very tearful (severe pain). This is useful for children and those with language barriers

Table 10.3 is a guide from the Royal College of Emergency Medicine regarding assessment and treatment of pain in the Emergency Department.
