CHAPTER 1

My name is Patrick Jackson. I grew up in a tranquil village just outside Cambridge in England, a charming and unassuming part of the country where the crime rate was almost non-existent. People would leave their doors open and savour tea as if it were a timeless tradition.

It was so peaceful that I used to jest that I could take a nap in the middle of the road and wake up unharmed. However, my hometown harboured a secret – it was a hub of paranormal activity, so much so that it became commonplace. When you are born into an environment saturated with such occurrences, you fail to recognize how peculiar they are to the outside world.

One of my earliest paranormal encounters happened at a friend's house when I was merely eight or nine years old. We were playing in the garden, as we always did, engaged in playful activities on his climbing frame and having mock gun battles.

We had a hidden spot, a small open area nestled within a dense tree line, approximately 30 feet deep and surrounded by trees and shrubs – a barrier of thorns and mud. You couldn't enter it from the other side.

I distinctly remember it was a sunny summer afternoon during the weekend, and we were on the climbing frame after a spirited game of hide-and-seek. Out of nowhere, a tall white figure emerged from the opening of the den.

This figure was completely pure white, and from the side, its feet appeared triangular. As it stood there, gazing ahead, I shouted, "Hey, get out of our den!" It turned abruptly, its startlement evident,

and locked its featureless, white gaze on me. It had no discernible facial features, just a blank, white surface.

Upon spotting me, the tall figure swiftly pivoted and retreated inside the den. My friend and I leaped off the frame and sprinted toward the opening, mere seconds behind it. However, when we entered, there was no one there. No footprints, no damage to the perimeter – nothing. My friend was bewildered, but I was certain of what I had seen.

At the time, I didn't connect it to anything paranormal. I had yet to grasp the concept of such phenomena; I was young and thought, "Well, that was peculiar." That marked the beginning of numerous experiences during my time there.

Several years later, I was in Year 3 or 4 at Milton Primary School, just up the road from my house. It was another scorching summer day, during lunchtime, from 12:30 to 1:30. Around 1:15 PM, I glanced up across the field and noticed a small, spinning, silver, pyramid-like object in the sky.

While observing it, I noticed it wobbling slightly from side to side. The object was at a low altitude, less than 300 feet up, and it appeared to be observing us. Suddenly, the bell rang, signalling the end of lunchtime. We returned inside, and once again, I didn't think much of it; it was just odd.

The primary social spot in the village was a small club, now known as The Old Forge. I used to visit it most Fridays or Saturdays. The community was so close-knit that you would typically encounter someone you knew there.

The bar was only a five-minute walk from my home and was situated next to a large playing field with a children's play area. One evening, while waiting for the place to open, I was sitting on a swing, minding my own business. I gazed across the playing field and saw a man standing approximately thirty feet away, dressed as a monk. Yes, you read that correctly – a full-fledged monk with his

hood up! I shouted at him, "Are you okay?" and the man just stood there motionless.

This piqued my interest. I had a red laser pointer in my pocket, so I aimed it at him. I vividly remember seeing the laser dot reflecting on the ground, then on his legs, followed by his chest, and finally, I managed to pinpoint it on his face. To my surprise, he didn't flinch or react to the laser; there was no response whatsoever. Most intriguingly, I still couldn't see his face; it was just a black mass. The laser dot bounced off it, as though it had struck a black wall. After around 10 to 15 seconds of doing this, I received no reaction from him. I found it extremely peculiar, so I stood up and began walking toward him.

When I recount this part of the story, people often ask if I felt scared. The answer is no. This was my hometown, where I had grown up, and the ground beneath me felt like a part of myself. It was as if this man was intruding into my backyard, so I squared off with him.

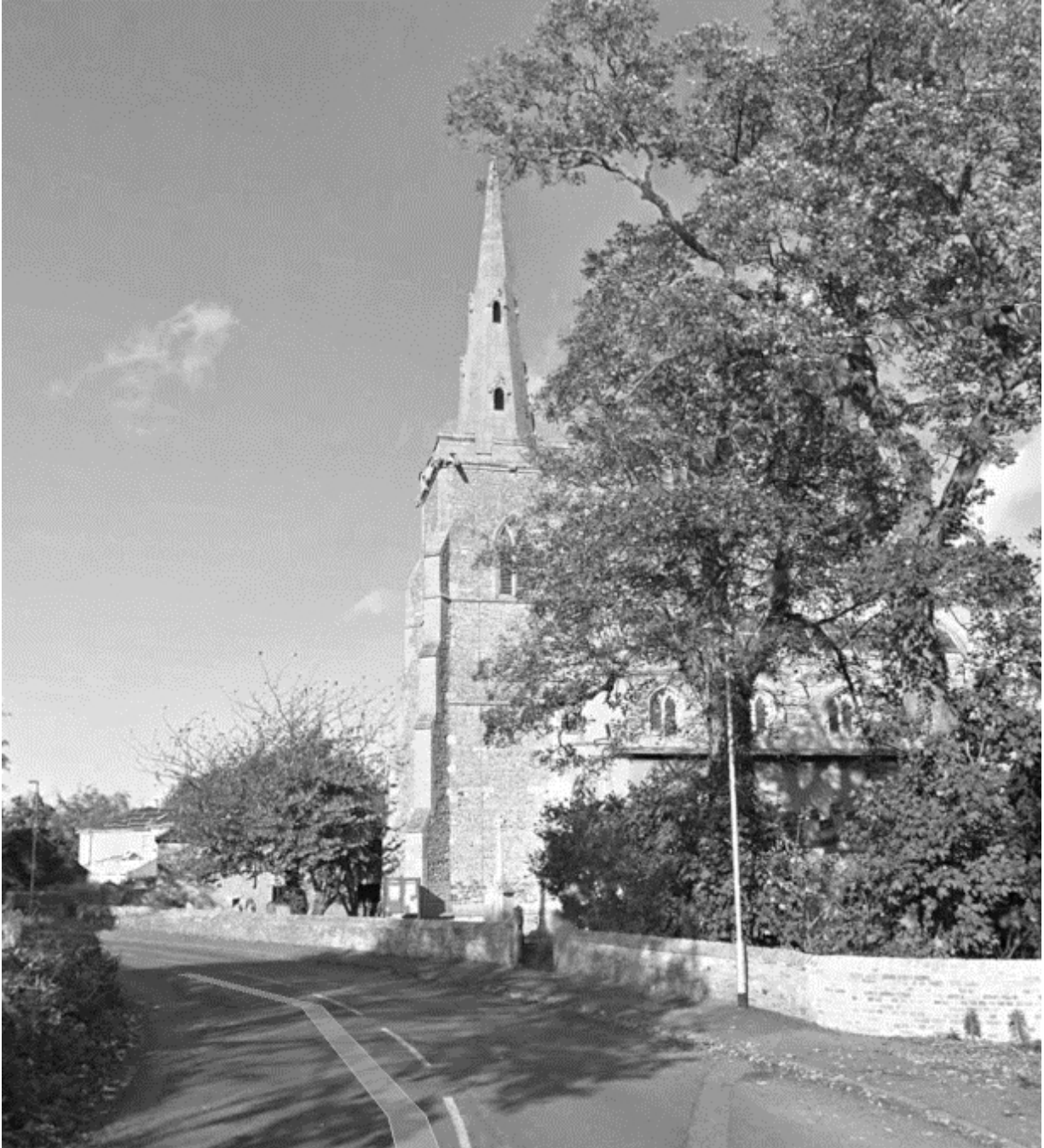
As I drew closer, I could discern all the details of his outfit, down to the wrinkles in his clothing. It genuinely appeared as if someone had placed a grey statue in the middle of the field; that's how I perceived it. I continued walking until I was just a few meters away, and then, it suddenly dissipated into thin air. It did startle me a bit, but I didn't immediately equate it to a ghost sighting. At that time, I still knew very little about paranormal subjects, so I accepted what I saw at face value.

A few days later, while at The Old Forge again, I mentioned to some of the local regulars that I thought I had seen a monk across the field. One of them promptly responded, "Oh, that's the Mad Monk of Landbeach. He was hanged here years ago for impregnating a local girl." I was taken aback by this revelation and felt the need for a drink to process it.

These incidents occurred when I was approximately between 20 and 23 years old. In the years leading up to this, I witnessed between 12

to 16 unidentified flying objects (UFOs). These sightings occurred during both daytime and nighttime, from a distance and up close – some were so near that I could have thrown a stone at them. They floated overhead silently and peacefully, as if they were on patrol. These weren't massive flying saucers but small orbs roughly the size of a tennis ball, flying at low altitudes, leisurely and noiselessly, just above the streetlights. I referred to them as "pearls of light" because their illumination remained constant, without any flickering.

My parents had always taught me to be polite, so my natural response was to wave and greet them with enthusiasm. This occurred in a time before smartphones and digital cameras were commonplace. I wasn't the only one witnessing these phenomena, as many locals also mentioned seeing strange lights in the sky. One night, a friend randomly managed to capture a photo of a UFO hovering above the local church grounds, as depicted below.

And below - capturing a night scene with infrared film revealed the presence of a mysterious, bubble-like object. This enigmatic entity remained invisible to the naked eye and only became apparent during the film development process.

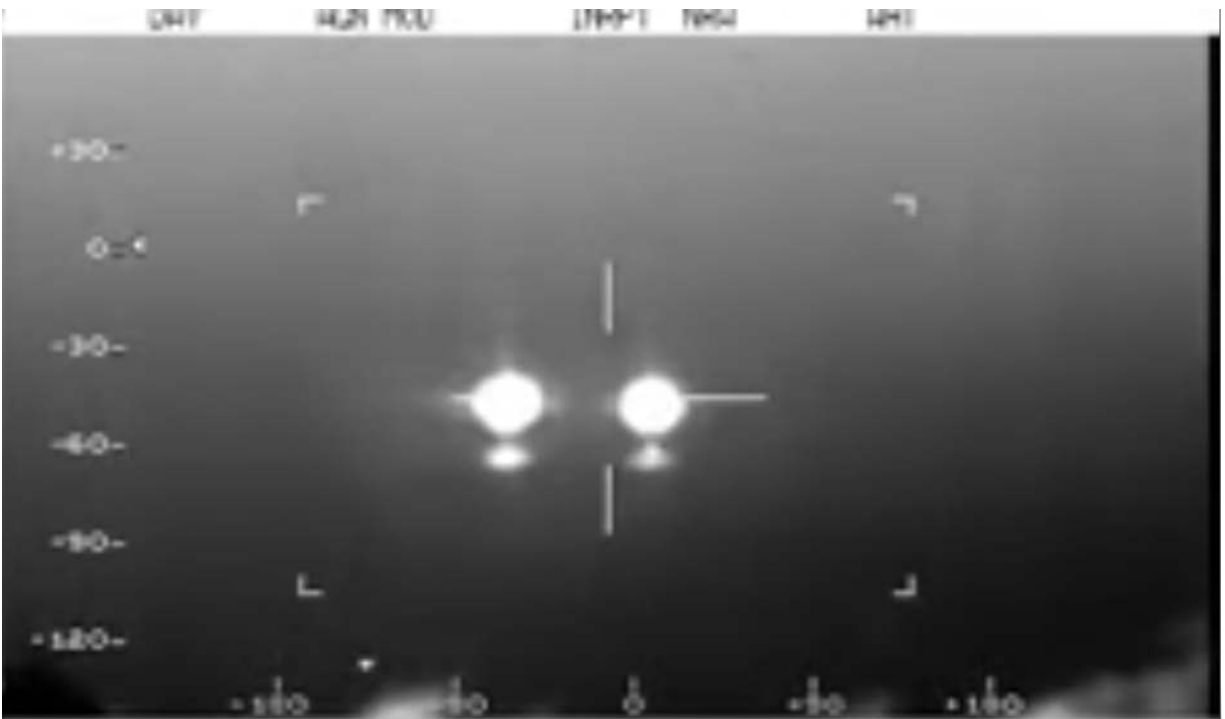


The interesting thing was that these bubble like UAP sightings had been seen before, also captured at night using infrared technology.

This singular object corresponds to those spotted by the Mexican Air Force on March 5, 2004. Eleven flying objects were observed alongside the aircraft during a drug smuggling operation. These eleven UFOs could only be seen through the military plane's dome-mounted infrared system and were invisible to the naked eye. Neither the crew nor ground personnel could detect these craft using radar.

Sceptics initially dismissed the event on March 5, 2004, as oil platform burn-off flares. However, Mexican authorities stated that the elevation of these lights was higher than their own aircraft. This was a significant event because it marked the first time a government had publicly acknowledged such sightings.

Take note of the identical reflection on the underside of the object, suggesting that it was encased within a bubble-like phenomenon. These occurrences were also imperceptible to the human eye and were only detected by the forward-looking infrared system,

These light formations will assume significant importance later in the book, as they provide crucial data demonstrating that identical formations that have replicated across the globe.

Finally, the day came when my parents moved away from Landbeach finding a smaller property to manage while I moved to London to focus on my career.

By 2015, I find myself working in Information Technology (IT) as a Specialist in Structured Language Databases (SQL DBA). My primary role involves managing numerous high-demand SQL servers, ensuring they run smoothly and securely. A significant aspect of my job is reverse engineering, which essentially means quickly solving complex issues that arise when databases malfunction. When these databases stop functioning, it can bring the entire company to a standstill, which can be incredibly stressful.

In most major companies, central databases serve as the backbone for internal communications, functions, and data analytics. These databases support applications, including Business Intelligence Development (B.I.D), which provide near real-time data through pre-configured reports or real-time HTML web services. Part of the reverse engineering process entails identifying correlations between data sets and recognizing system behaviours and characteristics.

One memorable example of this occurred when I was tasked with fixing a SQL system in a private bank. The SQL server would crash randomly, without warning or error messages, effectively halting the bank's operations. Despite the absence of error messages, I was determined to find the root cause. By analysing the timing pattern, I observed that the crashes occurred between 10 am and 2 pm. I inquired about who was running reports or scripts against the server during those times, and within ten minutes, we identified the culprit. We asked them to rerun the same script, and as they did, the server crashed again. Once we pinpointed the issue, we stopped the daily script run, stabilizing the bank.

The problem stemmed from the script returning an excessively large dataset (millions of lines), which was then pushed into a buffer within the application. However, the dataset exceeded the buffer's capacity, leading to a lock and ultimately crashing the server. This issue had arisen recently due to an application upgrade that inadvertently reduced the buffer size.

In essence, reverse engineering is the process used to dissect complex problems, and it can be approached in various ways. In the realm of IT, developers often create systems or code that become indispensable to a company, yet no one understands how they work. Documentation is frequently lacking because developers are focused on pending projects. This can encompass processes, code, or entire systems. Professionals like me step in to reverse engineer these elements, creating documentation that explains their functioning and allows for modifications and repairs to meet current requirements.

Over the years, I've reverse-engineered everything from processes to issues within accounting systems, document management systems, and corporate database systems. It's important to note that reverse engineering is a common practice within IT, where professionals routinely decipher how processes and issues function and how they can be resolved. The key lies not so much in what one knows but in how one's mind processes and connects information. While I may not have been a genius in school, some individuals possess the ability to cut through the complexity and discern structures, patterns, and relationships that form logical solutions. From there, it's about connecting the dots and solving the puzzle.

Due to my (I suppose) more unique upbringing, I developed an evening TV obsession with watching Paranormal / UAP shows, seeking clues to what might truly be happening and looking for patterns and logical connections. Simultaneously, I avidly followed performers like David Copperfield and, more recently, Dynamo, as they demonstrated their illusions. Many nights, my eyes have suffered from hours of dissecting these tricks, as I simply had to understand how they were done.

While I've never been one to believe in magic or miracles, I do believe in mechanisms—mechanisms that can appear magical or even supernatural.

A mechanism, as defined by the dictionary, can have two main meanings:

1. It refers to a system of interconnected parts working together in a machine or a piece of machinery. For example, a motor that powers the tape eject mechanism in a device.
2. It can also describe a natural or established process through which something occurs or is brought about. For instance, the immune system has a mechanism for detecting pathogens.

Imagine an illusionist performing a magic trick in front of an audience. To the spectators, it appears as if the magician has accomplished the impossible. However, the performance is

meticulously crafted using a well-designed mechanism. This mechanism consists of numerous subtle and imperceptible actions or processes that occur in a controlled environment. These actions come together in a precisely timed manner to create the illusion of magic. When observed in real-time, these small actions are not visible. Only when one carefully analyses the performance frame by frame, considering factors like camera angles, can the illusion begin to unravel. Once the first action is spotted, the rest becomes more apparent.

One day, I wondered whether I could apply the same principles of reverse engineering from the field of IT to understand the paranormal, starting with specifically poltergeists. I wanted to explore what poltergeists might be, what they are doing, and if it was possible to replicate or trigger paranormal phenomena. I wondered how deep I could delve into this subject, considering that, to my knowledge, it had never been approached in this manner before.

When I shared my interest in pursuing this endeavour, my colleagues were met with disbelief. Not only were they uninterested in the subject, but they also outright denied its existence. Interestingly, they refused to accompany me to investigate haunted locations. "I thought, 'No help here,'" and decided that if I wanted something done, I'd have to do it myself.

My journey led me to explore online paranormal groups, and what I found was that the paranormal researchers had been operating in an echo chamber for years. There were no new ideas or theories about what might be happening or why. It appeared to be a closed pseudoscience, where people unquestioningly adopted traditional beliefs.

I began posing polite yet challenging questions within these online communities, and the reaction I received was far from friendly. In the end, I was banned from every group I joined within just three days. I came to realize that the paranormal wasn't merely an idea or perception; it was a deeply cherished belief system, often held on

par with religion. Hard questions were neither welcomed nor tolerated.

This situation reminded me of George Orwell's quote: "The very concept of objective truth is fading out of the world, but lies will pass into history..."

As a result of my relentless questioning, I became an outcast in the paranormal community. I was banned from community groups, online paranormal radio stations heard about me but chose to ignore my inquiries, and even well-known researchers refused to engage with me. On the rare occasions when they did agree to debate, the traditional paranormal ideas they upheld quickly crumbled under scrutiny. I even went to the extent of offering a financial reward to anyone who could best me in a debate. Hundreds of interactions later, the general paranormal community failed to counter the arguments I presented.

Things got to a point where even friends who ran YouTube channels found me too extreme and would only collaborate with me under specific conditions. They didn't want to alienate other belief systems within their groups, which I could understand.

It became evident that the paranormal community could be quite fickle, with everyone seemingly striving to become the next big name in paranormal TV, and social media was their preferred platform for networking. My presence and research efforts led to nothing but friction and upset. To be honest, I've lost count of the number of times I've been banned, blocked, or even subjected to angry outbursts for politely challenging the prevailing ideas. My work didn't just rattle the paranormal community; it also had repercussions in my personal life, causing significant strain in my relationship with a deeply religious (now ex) girlfriend who was profoundly shaken by my thought process.

There was even a time when I was invited to participate in a paranormal documentary film, only to be cut out because my analysis of the subject clashed with the director's vision. I became

the person everyone knew of but tried their best to avoid. I wasn't one to be rude, quite the opposite. I approached this subject in the same way anyone would approach a technical project at work, with a logical and analytical mindset.

But little did I realize the trajectory of my research when I embarked on this journey. Initially, my primary goal was to just unravel the root cause of poltergeist activity. However, akin to witnessing the intricacies of a master illusionist's magic trick, once the initial sleight of hand is unveiled, the entire performance begins to unravel, laying bare the moves and exposing the underlining processes.

In this instance, the connections are so profound that grappling with the broader reality becomes a challenge within the confines of the human mind. The forthcoming text chronicles this thought process—a data driven odyssey leading to a conclusion that has captivated the interest of UAP researchers, esteemed professors, IT specialists, and even billionaires, culminating in the delivery of my findings to a member of the U.S. Congress in which a year later - was the main subject of the first ever US UAP Hearings.

Examining the Stone Tape Theory

The Stone Tape Theory posits that non-living materials can absorb energy from living beings. In essence, it suggests that during moments of heightened emotional tension, like a murder, an "energy recording" is imprinted on the surrounding environment. This stored energy can later be released, leading to a playback of the recorded activity. This playback can manifest as a full apparition or partial phenomena like voices or footsteps.

What sets this theory apart is the assertion that these manifestations are not sentient spirits but rather non-interactive recordings, akin to the playback capabilities of an audiotape machine replaying previously recorded events. Evaluating the Stone Tape Theory

It's crucial to begin with a critical examination of the Stone Tape Theory. In the realm of scientific inquiry, theories are built on a foundation of evidence and data. They start as hypotheses, unproven ideas meant to explain unexplained phenomena that do not fit within the existing body of scientific knowledge. Only after gathering substantial evidence and undergoing rigorous scrutiny can a hypothesis evolve into a theory, providing a comprehensive framework for understanding observed facts.

The Stone Tape Theory, as it stands, should technically be referred to as the Stone Tape Hypothesis. This hypothesis was initially introduced in the context of natural theology by Charles Babbage in 1837. Babbage speculated about the permanent impressions of spoken words in the air, suggesting that they could persist even after becoming inaudible due to the transfer of motion between particles.

Additionally, the idea behind the Stone Tape Theory can be traced back to the concept of "place memory," which was explored by early investigators associated with the Society for Psychical Research. These investigators, such as Edmund Gurney and Eleonor Sidgwick, proposed that specific buildings or materials had the capacity to store records of past events.

The hypothesis gained some reinforcement from the invention of VHS and Betamax tapes, which used magnetic imprinting processes to encode video and audio data on tapes coated with iron oxide. This process might have contributed to the idea that certain materials, like stone, which also contains iron oxide, could record, and replay events.

Moreover, proponents of the Stone Tape Hypothesis have often asserted that after death, a person's spirit leaves their body, and this spirit energy becomes imprinted into the surrounding walls and objects. Consequently, when objects dear to the deceased are moved, it is believed to create paranormal activity as the disturbed spirit energy reacts.

it's important to acknowledge the ambiguity surrounding the term "spirit." While not inherently problematic, "spirit" is often used as a broad, catch-all term to account for various unexplained phenomena in the paranormal realm. also, the mere presence of certain elements in materials does not grant them the same capabilities as complex technological devices.

So, let's think about this.

Radiation and Human Perception of Paranormal Activity

Traditionally, it has been posited that building materials impregnated with iron oxide can emit electromagnetic fields capable of inducing various sensations, projecting images, and even producing sounds within a building's confines. This belief has been fuelled, in part, by observations of different feelings associated with various buildings and areas. Some locations are described as oppressive, while others evoke a sense of lightness or even emotional resonance, akin to feeling another's emotional baggage.

"If you wish to understand the universe, think of energy, frequency, and vibration,"

is often cited in support of this idea. However, the reality may involve a different phenomenon related to naturally occurring radioactive elements.

Several building materials, including sandstone, concrete, brick, natural stone, gypsum, and granite, contain trace amounts of naturally occurring radioactive elements such as radium, uranium, and thorium. Over time, these elements can decay and release a

radioactive gas known as radon. The levels of radiation increase depending on the types and quantities of materials used in construction.

These can potentially have indirect physical and psychological effects that might be perceived as feelings of oppression or heaviness.

1. Radon Gas and Air Quality

- **Mechanism:** Radon is a radioactive gas that can accumulate in poorly ventilated indoor spaces, particularly in areas with high levels of these materials in building foundations or surroundings.
- **Physical Effects:** High radon levels can lead to health issues, such as respiratory discomfort, which may be perceived as a feeling of heaviness in the chest.
- **Psychological Effects:** Prolonged exposure to poor air quality, including radon, might contribute to subtle feelings of unease or discomfort, potentially translating to sensations of oppression.

2. Radiation and Psychological Perception

- **Mechanism:** Low-level ionizing radiation, such as that emitted by these materials, is unlikely to cause acute effects but might contribute to a subtle biological stress response in some individuals.
- **Feelings of Heaviness:** While not well-documented, some people might interpret this stress response as physical heaviness or unease, especially in environments with poor ventilation or a sense of enclosure.

3. Environmental Factors Linked to Material Composition

- **Natural Mineral Properties:** Some materials, such as sandstone or gypsum, may alter indoor humidity or

temperature levels, indirectly affecting comfort.

- **Sensory Influence:** In enclosed spaces, dense materials like granite or concrete can contribute to sound dampening, dim lighting, or a lack of airflow, which might psychologically translate to sensations of heaviness or oppression.

4. Radon's Interaction with the Nervous System

- While not a common focus, ongoing exposure to radon at higher levels might influence mood or energy levels due to its potential effects on overall health, creating an environment that feels stifling or oppressive.

5. Perception Bias and Architectural Influence

- **Psychological Link:** People may subconsciously associate certain dense, heavy materials like granite or concrete with feelings of confinement, particularly in dark or low-ventilation spaces.
- **Cultural and Historical Factors:** Buildings with these materials are often associated with institutions, prisons, or older structures, possibly evoking sensations of heaviness.

it is plausible that exposure to such radiation could influence feelings and perceptions, potentially contributing to the reported experiences of oppression or heaviness inside certain buildings.

Can Magnetic Fields Alter Reality & Emotional State?

Our reality and perception of the world are shaped by the brain's interpretation of sensory signals. These signals, transmitted by our sensory organs, are processed and reconstructed internally. Since this interpretation is influenced by individual biology, past experiences, and cognitive biases, everyone perceives the world in slightly different ways

The question is can naturally / or artificially occurring magnetic fields alter this reality?

Some notable experiments have been performed and studies related to inducing sensations, sounds, or visions in the human brain using electromagnetic signals:

1. Michael Persinger's God Helmet

- Overview: Neuroscientist Michael Persinger developed the "God Helmet," which uses electromagnetic stimulation to induce sensations or visions, such as the perception of a "presence" or mystical experiences.
- Mechanism: Weak magnetic fields targeted at the temporal lobes.
- Findings: Some participants reported feeling spiritual experiences or "seeing" figures during stimulation.

2. Transcranial Magnetic Stimulation (TMS)

- Overview: TMS is widely used in neuroscience to stimulate specific brain regions. High-frequency magnetic pulses can affect sensory perception and neural processing.
- Applications: Studies have shown it can induce phosphenes (flashes of light) or auditory sensations when targeting the visual or auditory cortex.
- Key Experiment: Early research by Barker et al. (1985) demonstrated TMS-induced phosphenes in the visual field.

3. Robert G. Heath's Deep Brain Stimulation (DBS)

- Overview: In the 1950s-70s, Dr. Robert G. Heath implanted electrodes in the brains of patients and used electrical stimulation to study pleasure and sensory effects.

- Findings: Participants reported auditory hallucinations or sensations depending on the stimulated area.
- Significance: Early exploration of brain stimulation's impact on perception and emotion.

4. Auditory Cortex Stimulation

- Overview: Studies have shown that stimulating the auditory cortex with magnetic or electrical fields can produce auditory sensations such as buzzing or voices.
- Notable Study: Penfield and Rasmussen's (1950s) experiments on epilepsy patients mapped the auditory cortex by electrically stimulating it, inducing sounds or tones.

5. José Delgado's Brain Stimulation Experiments

- Overview: Delgado famously demonstrated mind control experiments using implanted electrodes in animals and humans in the 1960s.
- Findings: Electrical stimulation of the brain's sensory areas sometimes induced sensations, including visual or auditory phenomena.

6. Phosphenes with Direct Current Stimulation

- Overview: Direct electrical or magnetic stimulation of the occipital lobe can induce "phosphenes," or flashes of light, without external visual input.
- Key Experiment: Early studies by Walter Hess and later work with TMS confirmed this effect.

7. Neural Decoding and Artificial Vision

- Overview: Recent advancements in brain-computer interfaces (BCIs) use electrical signals to stimulate the

visual cortex, creating rudimentary visions or patterns.

- Notable Projects: Experiments by researchers at Baylor College of Medicine (2019) demonstrated visual sensations created by electrodes stimulating the visual cortex in blind participants.

8. Electromagnetic Auditory Phenomena (Microwave Auditory Effect)

- Overview: Discovered by Allan Frey in the 1960s, this phenomenon occurs when microwave signals stimulate the auditory nerve, producing perceived sounds like clicks or tones.
- Applications: Research has explored this for communication purposes (e.g., "voice to skull" experiments).

9. Hallucinations via Temporal Lobe Stimulation

- Overview: Electrical or magnetic stimulation of the temporal lobes can induce hallucinations or visions, as shown in experiments by Wilder Penfield and others.
- Findings: Participants reported vivid visual scenes or hearing conversations when these areas were stimulated.

10. Virtual Reality Integration with Neural Stimulation

- Overview: Modern experiments combine VR with electrical stimulation to create immersive sensory experiences, inducing visual and auditory effects through precise brain stimulation.
- Notable Study: Research at DARPA and similar institutions focuses on enhancing VR by directly stimulating sensory cortices.

These tests above are impressive however the reality is this technology isn't applied randomly at the general public but only in controlled lab environments, so even though we know that external magnetic fields can alter our perceptions – could low level / naturally occurring magnetic fields do the same?

The answer is yes, though the effects are generally subtle, weak ambient magnetic waves can influence emotional states and sensory perception under specific conditions:

- **Feelings of Oppression:** Localized magnetic anomalies can create sensations of heaviness or unease.
- **Hallucinations:** Rare, but possible in highly sensitive individuals, often involving simple visual or auditory phenomena.
- **Mood Shifts:** Weak fields might modulate brainwave patterns, leading to mood changes ranging from anxiety to calmness.

However, even if low-grade radiation / artificial or naturally occurring magnetic fields could alter feelings and induce hallucinations, it fails to explain certain key factors in paranormal experiences.

These include multiple people simultaneously witnessing the same apparition or capturing paranormal phenomena on camera including CCTV systems. The complexity of these experiences, involving shared perceptions and documented evidence, but there is an even greater issue...

Witnesses have reported seeing 3D images of people and this is where the Stone wall theory collapses.

The process required to project 3D holographic moving images is intricate and data-intensive, far surpassing the capabilities of materials like stone to generate such phenomena.

The Complexity of 3D Holograms and Audio Projection

The Stone Tape Theory suggests that imprinted energy can create not only 3D visual manifestations but also audio phenomena such as voices and footsteps. However, understanding the complexity of generating both 3D imagery and audio through natural materials like stone reveals significant challenges to this theory.

To create 3D holographic visuals and audio, a highly intricate technical process is required. This process involves hundreds of thousands of sub-processes working together seamlessly, demanding high data transfer rates, processing power, and specialized hardware.

- Graphics Processing Unit (GPU)
- Multi-core processors, such as AMD Ryzen 7/9 or Intel Core i7/i9.
- Clock speeds of 3.5 GHz or higher.
- At least 8 cores for efficient multitasking and handling complex algorithms.
- A minimum of 16 GB for basic holography projects.
- 32 GB or more for high-resolution or real-time hologram generation.
- SSDs (Solid State Drives) for faster loading and data access.
- At least 1 TB of storage, with additional external drives for larger projects.
- Devices like LiDAR or time-of-flight cameras to capture depth information for creating holograms from real-world scenes.
- 3D / Holographic display screens or transparent displays.

Similarly, audio projection is a complex task that involves converting electrical energy into mechanical energy, which in turn creates sound waves by compressing and expanding air. Speakers achieve this by using a voice coil, which, when subjected to an electric current,

generates an electric field interacting with a magnetic field produced by a permanent magnet attached to the speaker. The resulting attraction and repulsion between the voice coil and the magnet cause the speaker cone to move back and forth, creating pressure waves in the air that we perceive as sound.

In summary, the creation of moving 3D holographic imagery and audio is a technically demanding process that relies on advanced hardware and precise coordination of multiple sub-processes.

Natural materials like stone lack the necessary chemical and atomic-level capabilities to perform these tasks.

Therefore, while the Stone Tape Theory proposes an interesting concept of imprinted energy, it falls short in explaining the complex mechanisms required for the creation of 3D holograms and audio experiences.

The Complexities of Materials and Their Properties

To better understand the limitations of attributing paranormal phenomena to materials like stone, let's consider an example with granite and silicon, which is extracted from silica-rich rocks like granite for use in electronics.

Granite is indeed a silica-rich rock, and from it, pure silicon can be extracted through a complex process. This process involves removing oxygen from the silicon by mixing it with carbon and subjecting it to extremely high temperatures within an electric arc furnace. The result is pure silicon, which can be used as a semiconductor in central processing units (CPUs) found in computers and smartphones.

Silicon itself is a semi-metallic or metalloid element, and it is not found in its natural state but rather in combination with oxygen in silica-rich rocks like granite. Silicon alloys can also include various metals like iron, aluminium, copper, nickel, manganese, and ferrochromium.

The fundamental point to consider here is that while a house might be constructed using granite, which does contain silicon, it lacks the technical functionalities of a computer or smartphone.

Natural stone, regardless of its mineral composition, lacks the advanced extraction, processing, and engineering necessary for it to operate as a computing or processing device. Merely sharing the same chemical or mineral components does not automatically confer equivalent technical capabilities.

Hence, it is reasonable to argue that attributing paranormal activity, whether visual or physical / audible, to iron oxide impregnated stone or rock is not supported by our scientific understanding of materials and their properties. The complexities of technology and engineering cannot be equated with the inherent characteristics of natural stone.

However, it is worth noting that the possibility remains that naturally occurring radiation or magnetic fields may alter the bioelectrical state of the human body and mind, potentially leading to forced altered emotional state.

This argument highlights a crucial distinction between the emotional or mental state changes attributed to specific buildings and actual **physical observations**, such as moving black masses or direct physical actions from poltergeist activity, that individuals may witness in other locations.

Amid the confusion, it often becomes apparent that various phenomena are mistakenly perceived as interconnected when, in truth, they are entirely unrelated.

But what about general hauntings? Could they be dead humans?

The prevailing notion surrounding hauntings suggests that they are the spirits of the departed returning from the afterlife. According to this belief, some individuals come back due to unresolved issues, while others wander the Earth seeking answers. Those in a state of

spiritual unrest may haunt the locations of their demise, or they might remain oblivious to their own passing, existing as if still alive.

This concept is often considered the most emotionally appealing idea, with many self-proclaimed psychic mediums and television shows capitalizing on these beliefs for financial gain. However, it is argued that the abilities attributed to these individuals can be replicated and performed more effectively by stage artists, such as Derren Brown.

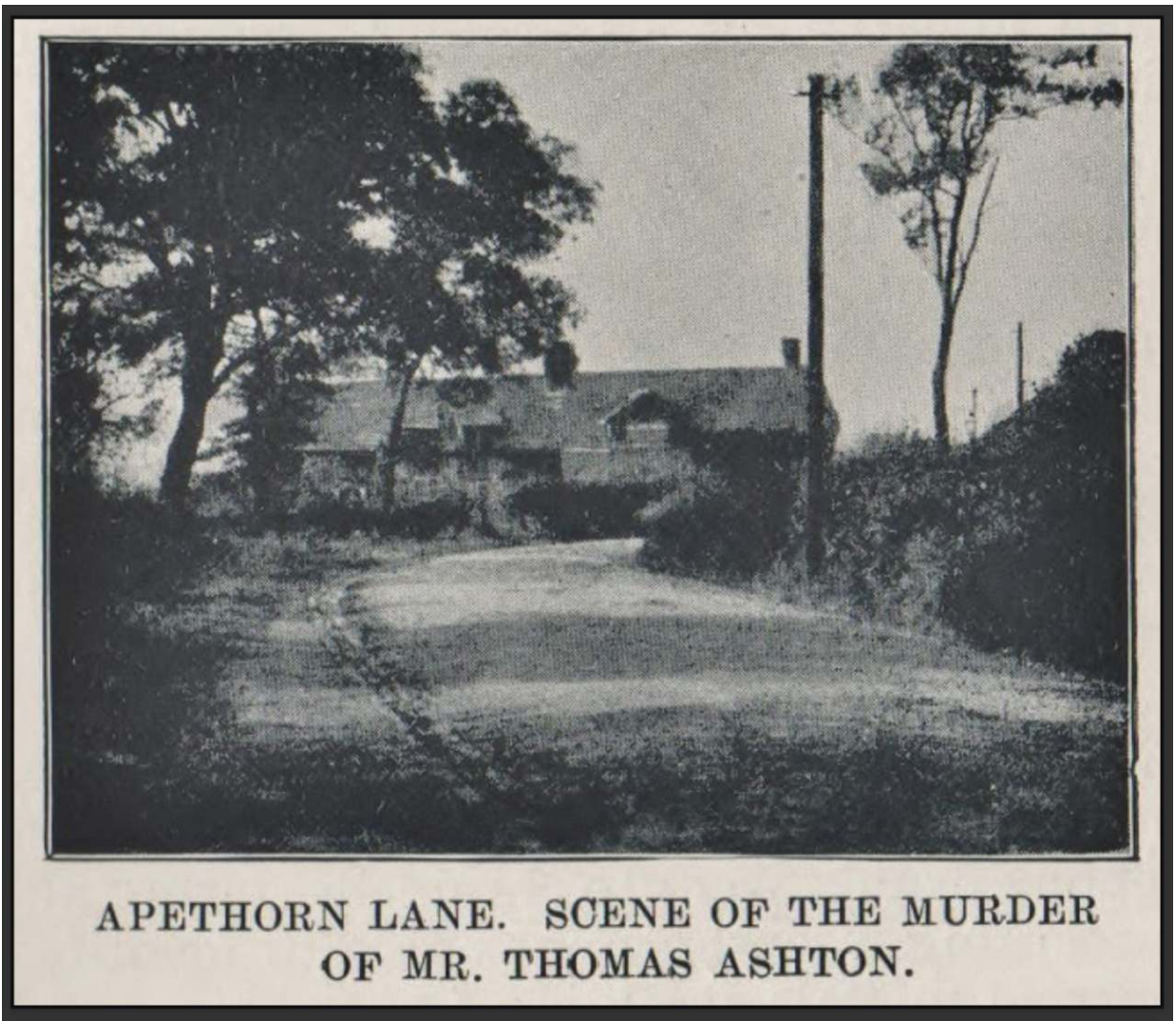
Derren Brown is an English mentalist, illusionist, and author known for his television performances since his debut with "Derren Brown: Mind Control" in 2000. Brown has produced numerous shows for both the stage and television, including series and specials.

The notion that spirits are the souls of the deceased has become the dominant perspective within paranormal research. Paranormal investigators and popular TV shows frequently call out names, attributing paranormal activity to specific individuals who have passed away, with audiences often filling in the narrative gaps.

However, through my research, I've observed that reported paranormal behaviours frequently deviate from what we might consider natural human behaviour. For instance, certain active locations—such as the tunnel on Apethorn Lane in Hyde, UK, linked to the murder of Mr. Thomas Ashton—exhibit anomalies that are difficult to explain. At this site, unusual electronic emissions have been detected, and reports of paranormal activity persist.

This location, along with its unique characteristics, will play a central role in the experimental tests and analyses presented later in this book.

On January 3rd, 1831, a tragic event unfolded as Thomas Ashton was fatally shot while traveling from his residence at Pole Bank to Apethorn Mill. The following account was published in the Stockport Advertiser on January 7th, 1831, under the headline 'HORRIBLE MURDER':



APETHORN LANE. SCENE OF THE MURDER
OF MR. THOMAS ASHTON.

"On Monday last, a deeply gruesome and savage murder, one of the most heinous acts to stain the reputation of a civilized society, occurred. The victim of this cold-blooded and wicked assassination was Mr. Thomas Ashton, the eldest son of Samuel Ashton, Esq., hailing from Pole Bank in Werneth, within our parish. This horrifying incident took place as early as seven o'clock in the evening. Mr. Ashton, known for his amiable disposition and manner, was just 24 years old. He had recently been overseeing his father's newly established mill in Woodley and was en route to the other mill at Apethorn to supervise operations for his younger brother, James. James had set out earlier to spend the evening with a family near Stockport. At the time of the murder, his parents were at home,

awaiting the return of the carriage to join James and the rest of the family who had accompanied him. The indescribable agony of receiving such devastating news can only be imagined.

Testimony provided during the coroner's inquiry revealed that Mr. Ashton had not ventured far from the private pathway, which leads from Pole Bank to Apethorn Mills, onto the public highway. He had covered no more than 30 yards when he fell victim to gunshots. It became evident that the assailants had been lying in wait behind a hedge bank along the roadside. This concealed vantage point allowed them to detect the approach of their victim from his father's residence, situated down the private pathway. Two bullets from a horse pistol or blunderbuss had pierced his breast, exiting at his left shoulder blade in a slanted trajectory. Mr. Ashton's demise must have been instantaneous, as his right hand was found inside his greatcoat pocket—a habitual posture while walking. His lifeless body was discovered in a shallow ditch on the opposite side of the road, contrary to the usual route taken by his family when traveling to the mill. It is believed that he retreated to the other side upon sensing the assailant's presence, likely attempting to evade the attacker. The firearm had been pressed closely against his chest, with the wadding having penetrated his attire, including some rough blue paper fragments embedded in his sternum.”

Despite the tunnel not being near this event, there are claims that Thomas Ashton's spirit haunts it.

This raises a compelling question: Why would an individual from the 18th century choose to linger in a desolate tunnel, particularly at night and exclusively during nighttime hours? If these entities were truly spirits, wouldn't they explore the world, take advantage of free luxurious accommodations, and generally enjoy a pleasant afterlife?

It seems peculiar for a deceased human to spend their nights pacing through a cold, isolated tunnel in the woods. Humans, by nature, are social beings who seek connection and interaction, making the notion of such solitary confinement baffling.

Typically, human behaviour is cooperative, with a natural tendency to share experiences and exchange information. If one's talkative relatives became ghosts, wouldn't they be eager to communicate their experiences, leave messages, or engage with their surviving family members? One might expect them to use their newfound supernatural abilities as a means of creative interaction.

Yet, the reality does not align with this level of interaction between the deceased and the living. Instead, reports of paranormal activity largely consist of specific locations or buildings becoming suddenly active, objects moving inexplicably, loud noises, strange electrical disturbances, and occasional rudimentary communication through EVP (Electronic Voice Phenomena) or similar methods.

From a logical standpoint, these behavioural patterns appear incongruous. Why would a spirit linger around a graveyard at 2 a.m., choose to stay in crumbling, decaying buildings, or suddenly begin haunting a cellar? Such actions do not reflect typical human interests or thought processes.

Even my own experiences challenge these assumptions. For instance, I once heard my deceased pet parrot flapping and flying around the kitchen—a behaviour entirely consistent with its natural tendencies when alive. This suggests the possibility of an alternative state governed by physical laws yet not fully understood.

In the case of my pet parrot, this behaviour hints at the prospect that humans or mammals may briefly linger in such a state after death. This transient window of existence could explain reports of interactive communication with deceased loved ones or animals.

However, the prolonged and sustained paranormal or poltergeist activity examined in this book does not conform to the conventional definition of the "spirit world" upheld by mainstream researchers. Instead, **the evidence points to the existence of a distinct and misunderstood domain**—one frequently misidentified as "spirit." In my view, this domain accounts for over **90% of reported haunting phenomena.**

CHAPTER 3

A Phenomenon on repeat



When an object, mechanism, or phenomenon exhibits unusual or inexplicable behaviour that consistently replicates across multiple locations, it is reasonable to infer that this behaviour is intentionally designed by a common source. In other words, the mechanism or behaviour seems to reflect an intelligent design, purposefully tailored to achieve a specific function.

Through my research, I have identified several recurring behavioural patterns / observations in the phenomena that are observed on a global scale. These patterns suggest a degree of uniformity and intention, supporting the hypothesis of a shared origin or influence.

The list of observable phenomena is as follows:

EVP - Electronic Voice Phenomenon

Overview of two observable mechanisms:

1. **Audio Playback of Disembodied Voices:** This is one of the most common types of paranormal phenomena. It involves the playback of voices that were not audible at the time of recording. These voices can be heard during the playback of digital or tape recordings. An example of this is the Scole Experiment (Norfolk UK) conducted from 1993 to 1998, which was said to produced tangible objects and messages from the spirit world, including voices reproduced inside a Faraday cage to rule out external radio interference as the source.

The mainstream paranormal community often attributes these phenomena to communication in a frequency **outside the range of**

human hearing. However, this explanation is technically inaccurate, as EVPs can be picked up on basic tape recorders, which have a limited recording dynamic range of 50 to 60 decibels and a frequency response of 16 to 18 kilohertz. **Human hearing, in contrast, has a greater dynamic** range of 120 decibels and a frequency response of 20 hertz to 20 kilohertz. **This raises the question of how EVPs can be recorded? if they are inaudible to human hearing but within the limited lesser capability of tape / digital recorders?**

2. **Some EVPs (Electronic Voice Phenomena) can be heard directly by the human ear,** although these instances are rarer and differ noticeably from typical human speech. **These audible EVPs often possess a digital or fuzzy quality and are shorter in duration.** For such sounds to be audible, they must involve the compression and expansion of air, mimicking the physical processes of human vocalization. The resulting sound waves travel through the air, vibrate our eardrums, and are processed by the auditory cortex. However, the absence of a physical entity to perform the necessary compression and shaping of air **raises intriguing questions about the underlying source.**

During the UK Scoble Experiments, it was demonstrated that voices could still be recorded even when the **internal microphone was removed from the recorder.** This suggests that at least **two distinct broadcast mechanisms** were employed to produce this effect. These mechanisms, and their implications, will be explored further in this book.

Black Masses

One of the most observed types of phenomena is known as the "black mass." These entities are described as solid, **three-dimensional masses of total blackness that can remain stationary or move rapidly.** Witnesses often report that these

black masses stand around five to six feet tall and are frequently encountered in known active or haunted areas, particularly around old buildings such as hospitals, old prisons, and graveyards. Over the years, these black masses have been associated with the appearance of monks.

During encounters with black mass phenomena, individuals often report experiencing high levels of anxiety even before seeing anything. Witnesses describe overwhelming feelings of **oppression and stress in areas where these entities are active**. Near to black mass phenomena, they tend to exhibit heightened poltergeist activity, including the throwing of objects, aggressive banging, and scratching.

While there have been no reports of serious physical harm resulting from encounters with black mass phenomena, the emotional aftermath can be quite different. Individuals who have experienced such encounters **often undergo negative mood changes, including intense anger, rage, or depression that can last for months**.

This raises the question: What are these black masses, and why do they have such a profound impact on those who encounter them?

Sudden Mood Changes and Anxiety

Many individuals, including paranormal researchers, who spend extended periods of time in haunted or active areas describe their experiences in the following ways:

- *"It is comparable to being in a steam room.*

"Initially, it feels fine, but as time passes, it becomes increasingly suffocating, to the point where one needs to leave."

"Over time, one becomes more on edge, tense, and claustrophobic."

These oppressive emotions and sensations of dizziness appear to be common, and even memory can be affected. During my research, I observed individuals **knowingly closing a door and then**

moments later asking, "Who closed it?" Additionally, there were instances where individuals made verbal statements or moved objects **without any memory or awareness of having done so.**

This raises the question of whether these experiences are related to a stress-related human condition or if there might be some other force at play?

Strange Electronic Malfunctions

Electronic devices have been observed to exhibit unusual behaviour, such as sudden power drains, random failures, or poor performance without any clear cause. Examples of these anomalies **include phones ringing with no caller but only static on the line,** device settings changing inexplicably, fully charged power cells abruptly going dead, computers crashing or freezing without warning, cameras randomly shutting off and becoming unusually hot to the touch, **lights flickering** as though something is drawing power from the main circuit, and walkie-talkies behaving **erratically or losing power unexpectedly.** This raises the question: What forces could be causing these strange effects, and **why are they occurring?**

Full Body or Object Apparition

Some individuals have reported witnessing people, objects, or even animals appearing and disappearing seemingly at random, while others have described encounters with entities that seem to **follow a repetitive pattern,** such as the same ghostly figure walking up the stair's night after night. During these experiences, the observed entities often appear solid and tangible, only to vanish moments later.

This raises an intriguing question: What underlying mechanism could be responsible for creating or replicating these phenomena, and why do some seem to be random while others **follow a predictable, looping behaviour?**

Hitchhiker effect

Many individuals report a lingering sensation of being followed experiencing paranormal encounters. This unsettling feeling can lead to heightened unease and stress, even within the perceived safety of their own homes. Researchers have observed that **regardless of the complexity of one's journey home**, a residence or room may become semi-active for a short period following such experiences.

During this time, while occupants are in a state of deep relaxation, they may **hear disembodied voices, scratching sounds, or tapping on walls**. Objects might also inexplicably disappear and reappear within the home. This raises a compelling question: How can paranormal activity seemingly follow someone, and what mechanisms might enable this phenomenon?

Poltergeist Activity

The term "poltergeist" translates to "playful or mischievous spirit," but the reality of such activity is far from playful and nearly impossible to endure long-term. Observations of poltergeist phenomena often include a mix of smaller disturbances, such as objects being **thrown, banging, tapping, or scratching sounds on walls and furniture**. In more extreme cases, scratches appear inexplicably on people's skin, objects vanish for weeks only to reappear in obvious locations, **and even spontaneous fires occur**.

Such intense activity can render a home uninhabitable and virtually unsellable. This leads to critical questions: What is the true source of these disturbances? What motivates such phenomena, **and why do they manifest in such destructive and disruptive ways?**

Buildings That Suddenly Become Active Then Stop

There are reports of new homes and areas becoming active with paranormal activity, while many old homes that have existed for

hundreds of years show no signs of such activity. Additionally, some buildings and areas that previously had no paranormal activity suddenly become active for no clear reason. The question arises: Why do areas become active with paranormal phenomena and then abruptly cease?

The Witching Hours

Between 3 a.m. and 4 a.m., a time steeped in historical and cultural significance, is often regarded as the most active period of the night for supernatural phenomena. This time frame, commonly referred to as the "witching hour" or "devil's hour," is closely associated with occurrences of heightened paranormal activity. It is believed that entities such as witches, demons, and poltergeists are most likely to manifest and exert their influence during this period. Additionally, black magic rituals are thought to be particularly potent during the witching hour.

In Western Christian tradition, this hour was viewed as a time of peak supernatural activity, partially due to the absence of prayers in the canonical hours during this window, creating a perceived spiritual void. This raises a compelling question: **Why is this specific period so universally linked to heightened supernatural occurrences, and what underlying mechanisms or beliefs contribute to this association?**

Health impact

I have also observed that individuals who live **near haunted buildings** or spend significant time in them often **experience severe headaches and other neurological** or physical symptoms. These effects, commonly referred to as "paranormal hangover," can linger for days, altering a person's general mood and behaviour.

This phenomenon raises compelling questions: What causes these symptoms, and could there be a measurable connection between

paranormal activity and the physiological or psychological state of those exposed?

CHAPTER 4

The Mathematical Dilemma



Mathematics is the science of logical reasoning. Let's employ mathematical analysis to examine statistical data on global human mortality and documented instances of poltergeist phenomena. Through this approach, we can determine whether there exists a mathematical correlation between the two. **If such a correlation were to be established**, it could potentially provide intriguing evidence for the existence of an afterlife. Conversely, if the data doesn't align, it may suggest other factors at play. So, let's delve into it!

In 2015, according to "Our World in Data," an initiative by the "Global Change Data Lab":

- The total number of global deaths amounted to **57 million**.
- On average, **156,164** people passed away daily.
- Every hour, **6,506** individuals succumbed to mortality.
- Averaging to **108** people departing from this world every minute.

These figures are undoubtedly substantial. If we extrapolate the annual death toll of 57 million over a ten-year span, **it amounts to a staggering 570 million deaths in a decade**. Despite this high mortality rate, reports of paranormal activity remain relatively infrequent. While paranormal events are still reported, **they appear to be relatively rare or isolated**

Some argue that conducting calculations to explore this relationship is an insurmountable task, but it is feasible. So, how can we

approach this?

- If just one percent of those who pass away (57 million) return as poltergeists, we would have **570,000 new poltergeists each year**, consistently year after year.
- Over a 50-year span: 570,000 poltergeists multiplied by 50 - results in 28,500,000 new hauntings.

The figures are mind-bending

However, for the sake of argument, let's lower this percentage to 0.1%:

- This equates to 57,000 new poltergeists annually.
- Over a decade, this totals 570,000 new spirits.
- Over a century, this would accumulate to 5,700,000 fresh entities in the realm of the supernatural.

Despite some hauntings being documented to persist for years, with certain locations exhibiting paranormal activity for decades, a pertinent question arises:

"Where is everyone?"

From a mathematical perspective, **even with a minute return rate of 0.1%**, one would anticipate an **inundation of paranormal occurrences**. The actual observation, however, contradicts this expectation. Paranormal activity, though not commonplace, appears to be real, **yet it maintains a consistently low occurrence rate**, as attested by personal experiences.

The argument within the paranormal community posits that only those with unresolved matters return to the earthly realm. However, the stark reality is that far more than 0.1% of the human population experience untimely or unexpected deaths.

For instance, recent data from the Centre's for Disease Control and Prevention reveal a steady increase in firearm-related suicides,

resulting in the highest gun death rate in over two decades in the United States. Nearly 40,000 people lost their lives to gun violence in 2017.

According to mainstream paranormal thinking, 2017 should have witnessed an exceptionally active period, with 40,000 new spirits roaming. Yet, **no significant change was observed.**

Another striking example is the tragic events of 9/11, where 3,000 individuals lost their lives in a single attack in a concentrated area under distressing circumstances. Despite this, downtown **New York City is not inundated with paranormal activity,** and the new Freedom Tower stands without being haunted by the poltergeists of those who perished.

Remarkably, to my surprise much of the paranormal community and research groups choose not to acknowledge these logical arguments, as a result, the protective bubble remains intact, the beliefs remain unchallenged, and the same echo chambers persist.

Perhaps this disconnect arises from people's inclination to seek earthly explanations that provide comfort in the face of profoundly unusual phenomena, allowing them to relate their perceptions to familiar concepts.

When a new haunting phenomenon unfolds, it typically follows a pattern:

- Initially, an area or building experiences sudden and unexplained activity.
- Owners or occupants of the affected space begin to voice their complaints, and word of the strange occurrence's spreads.
- The media often seizes upon these stories, amplifying their reach.

- Researchers quickly descend upon the scene, delving into historical records and accounts to uncover potential explanations.

A notable case illustrating this process is that of 30 East Drive in Pontefract, known as one of the most aggressive Poltergeists in Europe. Researchers delved deep into the past, tracing **back 500 years to find a narrative that vaguely fits the haunting**. They identified the death of a monk on the property and concluded that it must be his spirit causing the disturbances. However, it's challenging to locate a piece of land anywhere with a documented history where someone hasn't passed away or met a violent end at some point.

Consider the London Underground as a prime example. During its construction, numerous graves were inadvertently disturbed, and more recently, archaeologists had to excavate **60,000 ancient skeletons** for the HS3 High-Speed rail link project. Despite these disruptions and encounters with the deceased, the London Underground is not overwhelmed by hauntings. While there are sporadic reports of minor paranormal activities, overall, **the system operates without significant paranormal interference.**

Once again, the current mainstream belief system often relies on cherry-picking loose ideas while overlooking many counterarguments. This approach might have been understandable in earlier centuries when science was in its infancy. However, as a technologically advanced society on the cusp of exploring outer space, it's imperative that **we reevaluate these phenomena with fresh perspectives** and a more critical eye.

Over the years, the mainstream entertainment industry has turned paranormal research into a **predictable business model**, recycling the same formula with new faces and teams.

Without much critical research or thoughtful analysis, the paranormal industry generates hundreds of millions of dollars annually, with some estimates suggesting it exceeds \$1 billion when

all areas are taken into account. However, in the following pages, I will argue that this phenomenon is far more than mere entertainment—it is, in fact, the greatest untold story of our time.

CHAPTER 5

The Noisy Defence Contractor

On October 8, 2014, a video was uploaded to YouTube featuring an interview with aerospace engineer Mark Q. Patterson and Boyd Bushman. During the interview, Boyd Bushman referred to two groups known as "**The Wranglers and the Rustlers.**" He described these groups by stating,

"They divide them into two groups. One group are wranglers, and the others are rustlers — the ones who are stealers of cattle. The two groups act differently. The ones that are wranglers are much friendlier and have a better relationship with us."

This reference piqued curiosity, as it hinted at something more significant than initially expected. It led to questions about **whether there could be any connection** between Bushman's statements and what the public often refers to as "paranormal activity" or "UAPs" While it may have seemed like a long shot, there was an underlying motivation to understand if there was something larger at play, something that could potentially justify the allocation of trillions of dollars towards the establishment of the new US space force.

Unfortunately, Boyd Bushman passed away at the age of 78 in August 2014, shortly after the video was released. His departure left many questions unanswered, and those who came across his work were left to piece together what they could from the information available.

While the opportunity to interact with Boyd Bushman directly was missed, the hope is that the work presented in this book serves as a tribute to his legacy and that it brings some clarity to the enigmatic statements made during that interview. It is believed that Boyd may have been aware of **something significant for a long time**, and the information presented in this book aims to shed light on that elusive knowledge.

To approach the subject of testing a connection between UFO phenomena with poltergeist encounters or paranormal activity, the key method is **reverse engineering**.

Normally reverse engineering involves the deconstruction of a man-made object or the analysis of a phenomenon to uncover its underlying designs, architecture, or knowledge. This process allows us to break down a complex system to understand it, replicate it, or make improvements. While it was initially applied to hardware, reverse engineering has evolved to encompass software, databases, and even human DNA with artificial intelligence taking the lead.

In the context of paranormal investigations, reverse engineering involves observing and analysing the behaviour and

characteristics of paranormal phenomena to decipher its underlying principles and mechanisms. Here's how this approach can be applied:

When direct access to the inner workings is not available, researchers can still reverse engineer by observing the default actions and behaviours of the phenomenon or system. These **actions and behaviours** are akin to **signatures**, and by carefully observing and documenting them, researchers can begin to understand the architecture, logic, and rules governing the phenomenon.

Through a systematic process of observation and analysis, this work **represents my attempt** to uncover the underlying architecture, logic, and motivations behind the phenomenon's observed behaviours and effects. By applying logical deduction, I aim to draw informed conclusions about the nature of the phenomenon and its purpose or reason for existence.

CHAPTER 6

Engineered Entities: Europe's Most Aggressive Poltergeist

In the world of paranormal investigations, there exists a location known as "30 East Drive" often referred to as "the Black Monk House." Situated in Pontefract, UK, this unassuming house has earned a notorious reputation as one of the most haunted places in the country. What set this case apart was its localized nature, making it ideal for up-close analysis.

The story of 30 East Drive dates to August 1966 when the Pritchard family, consisting of Jean, Joe, Phillip (15), and Diane (12), moved into the house. Almost immediately, the family witnessed

inexplicable phenomena. It began with a fine layer of chalk-like dust falling from a level below head height. But this was just the beginning.

Over the years, the family experienced a barrage of strange events: green foam oozing from taps and toilets, a tea dispenser activated without human intervention, lights flickering on and off, plants leaping out of their pots, cupboards violently shaking, and photographs being slashed with a sharp knife. Even a solid oak sideboard was levitated and thrown.

The local press dubbed the entity responsible for these activities "Mr. Nobody." However, the family preferred to call it "Fred" to normalize the situation. Exorcisms were met with defiance, and Fred's antics ranged from amusing, like pouring a jug of milk over a sceptic, to unsettling and even violent. Diane became the focus of the haunting, and she experienced physical harm, including being dragged up the stairs with visible finger marks on her throat.

Despite the chaos, Jean, the house-proud mother, refused to be terrorized out of her home. In a rare turn of events, Fred displayed a blend of mischievous and occasionally violent behaviour, contrasting with the typical behaviour of poltergeists, which rarely cause physical harm.

Today, "30 East Drive" operates as a guest house, allowing people to experience the paranormal activity up close and personal. In early 2015, I connected with Michael and Steve, two cameramen interested in the subject. They decided to document everything for later analysis and paid to stay in the house for four nights.

The plan was straightforward: if this haunting was real, what if I could trigger it and conduct a series of tests? In my mind, every time I measured or observed a reaction, the patterns, and behaviours I was looking for would be revealed—the very things I needed to work out. Like any puzzle, when you're trying to figure out how it works, you first need to see all the pieces, observe how the game plays out, understand the rules, and constantly search for

that one clue that doesn't fit. And like all illusions, once you spot that irregularity, that specific piece of information, the whole trick starts to unravel in front of you.

As this was my first real exploration into the paranormal, I couldn't help but think about the potential problems it might create. I had heard stories of things following you home and causing all sorts of issues with family and friends. While this location was reported to be the most aggressive in the UK, if not the world, and I was willing to put myself in harm's way to investigate, I didn't want to expose anyone else to these potential risks. After all, at this point, I had no idea what the source or cause of the activity could be, let alone how to deal with it.

So, while I pondered my plan, I knew that every time I triggered a reaction, observed behaviours, or measured responses, I was getting closer to unravelling the mystery. And if this location was indeed a hotspot of paranormal activity, perhaps it held the key to understanding a phenomenon that had intrigued humanity for centuries. But I also understood that I was stepping into the unknown, where every discovery could come at a cost.

A couple of weeks before my stay, I went home to see my family and mentally prepared myself. I wanted to ground my mind and clear it as much as possible. I reminded myself that everything around me was a mechanism of sorts. For example, when I looked at an object or a machine, I would imagine how they functioned and operated layer by layer. Every day, I disciplined and drilled my mind to force a thought process of cold logic and seeing connections, modelling patterns with logical reasoning. It's a state of mind I often used at work, but this time, I went much deeper.

Admittedly, it's a somewhat strange mental space to enter. You become very quiet, your eyes open wider, emotions are silenced, feelings are ignored, and your mental presence takes a step back, thinking more like a machine. Small pieces of information start to collate as data points are mapped together, like putting together a jigsaw puzzle using data.

On the Sunday before my arrival, Mike and Steve went to set up and stayed the night. Whatever the source of this activity was, it didn't disappoint. During the night, the cameramen were filming upstairs, and all sorts of strange physical activity started to occur with small cups getting pushed over, marbles hitting and banging off the walls like stones... This was the first time either of them had witnessed paranormal activity this close and personal, and it seriously shook them up, causing them to rush downstairs in a panic.





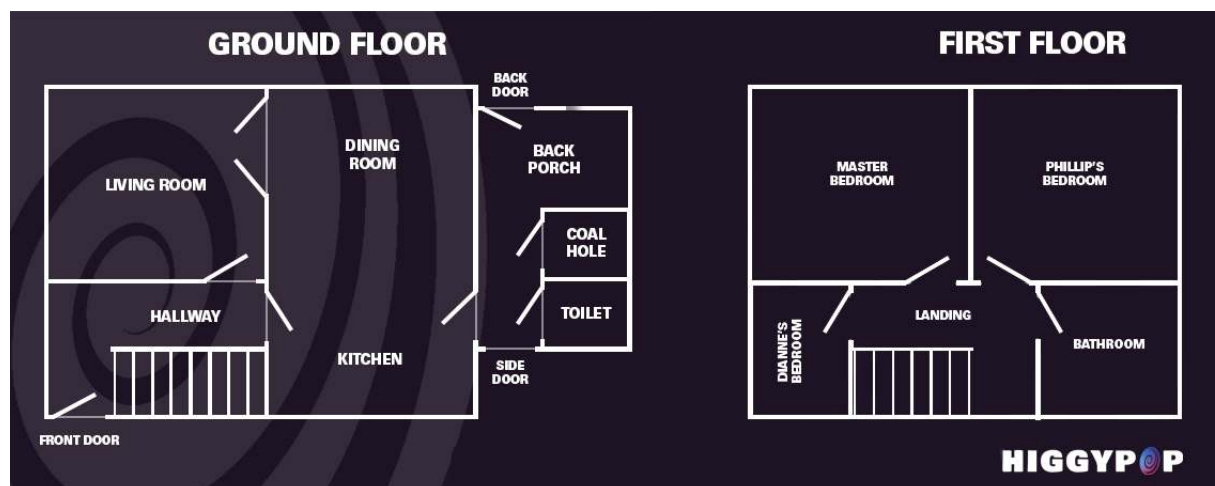
When I finally arrived, I was surprised by the unassuming appearance of the house. It was just an old council house on an estate, and it looked old and beaten, which added a bit of a creepy vibe. However, overall, it was nothing special. I walked in, met Mike and Steve, who had already set up, and had a cup of tea. The place felt fine—no big deal at all.

The first night was one of the most amazing experiences of my life. We were all in the bedroom upstairs, in the same spot as the previous night's events - the lights were off, and we just stood there in silence. I asked, *"Is anyone here?"* At that moment, from downstairs, we heard a door aggressively banging multiple times, and something (soon identified as two marbles) grazed my face. For a moment, we just stood there in amazement, and then we ran down the stairs to where the banging was happening. It was the coal shed door, and this activity replicated what had occurred the night before, which had been recorded in real-time on the digital recorders.



I couldn't help but wonder if the layout of the house was somehow connected to the unusual activity I observed. I particularly noted the peculiar location of the coal shed. Upon closer inspection, I found no apparent reason for the intense banging it had been producing. There was no access from the outside, no objects near the door, and the sound itself resembled forceful knocks, like those made by a person. What stood out was that this event could not be attributed to natural factors such as fluctuations in air pressure caused by passing trucks. The fact that other groups had also encountered this exact same phenomenon suggests a systematic pattern. **It implies the presence of a recurring process at play.**

However, by the second day, nothing more had happened. The events from the previous night hadn't continued, and all was silent. I decided to do my best to provoke whatever was there to get a reaction. I grabbed a camera bracket with fresh 3M tape (professional mounting adhesive) and stuck it on a glass-panelled picture located at the top of the stairs.

I walked down the stairs, and while the others went outside for a cigarette, I went to the restroom. As I was sitting there, suddenly I heard the walkie-talkie upstairs emit an auto audio alert saying, "low voltage," followed by a loud bang at the base of the stairs.

This moment was interesting because it was highly unlikely for the bracket to naturally fall off. Additionally, there was a **sudden power drop just before the action occurred**. This was strange because the walkie-talkies were freshly charged and relatively new, and they had been working fine all day. To top it off, I heard a deep growl from the other side of the door.

Interestingly, I found the moment quite amusing as I was sitting there on-the-toilet halfway through a number two all while this growling was coming closer.

I thought to myself, *"Well, I'm in the right place, I guess..."*

As I left the restroom, I called the guys over, and we all walked over to find the bracket sitting at the bottom of the stairs. I thought,

"Now this is interesting!"

3M tape is so strong that one could hang a bag of sugar from it, and there's more chance of the glass breaking than the tape giving away. So, this event was totally strange! This was the out of place behaviour I was looking for—an action that seemingly went against physics. The 3M pad itself wasn't torn or damaged, so it wasn't forced. The only way I could think of this occurring is if the chemical bonding had been somehow nullified.

So, I was curious to see if it would replicate with less weight. I lightened the bracket by removing the camera, then applied fresh 3M tape and positioned it dead centre. As I turned to walk away, the bracket popped off within seconds, causing the clock to suddenly tip towards me.

Here is the sequence of events







Unfazed, I turned and caught the clock falling and reset it to its original position. I removed the protective camera box. At this point, it only consisted of the base plate and the bracket. The glass was cleaned, and fresh 3M tape was attached, ensuring the tape stuck down solid. It should be mentioned that this type of tape can hold **weights around 10 to 15 pounds**. While this camera bracket weighed less than 2 pounds and posed no stress-bearing load at all.

To my surprise, the event repeated multiple times – **the bracket with super strong adhesive - kept falling off the glass!** even with a decrease in weight each time suggested that something unusual was happening.

The **constant** in this test was the 3M tape, with the same bonding strength I noticed that the force behind this strange event appeared to have halved every time it occurred—strong, medium, then weak.

This indicates that whatever is causing this phenomenon may be operating like a capacitor that charges and discharges to perform this action. By its nature, this suggests a technical behaviour rather than a (deceased) human one.

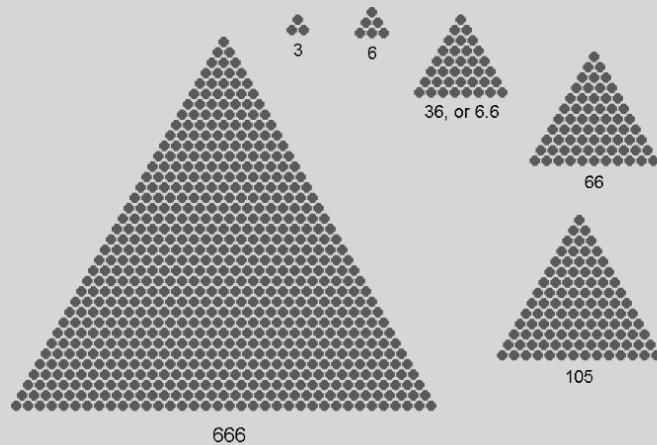
After the 4th time it occurred, I set up the test again, but this time nothing happened. It seems that whatever was performing this action had run out of resources and was unable to continue.

Other strange event observed was the appearance of the number 666 on the digital thermometer is indeed intriguing and often associated with superstitions. In the context of the paranormal community, 666 is widely recognized as the "*mark of the beast*" from the Book of Revelation in the New Testament. In most manuscripts and English translations of the Bible, it is associated with the Beast of Revelation mentioned in Chapter 13, Verse 18. In Greek numerals, χ represents 600, ξ represents 60, and ς represents 6, making a total of 666.

But in the world of information technology (I.T.), numbers are typically assigned for specific reasons, and they can have mathematical significance. In this case, 666 is known as a triangular number. Triangular numbers count the objects that can form an equilateral triangle. More precisely, "666 is the sum of the first 36 natural numbers (i.e., $1 + 2 + 3 + \dots + 34 + 35 + 36 = 666$), and thus it is a triangular number." This mathematical property may add an interesting layer of significance to its appearance in the paranormal context.

666: epitome of numerical triangularity

As depicted below, 666 pennies may be laid out in close formation on a flat surface to form the 36th numerical triangle. While, in general, triangular numbers are comparatively rare, 666 is unique - its uniqueness resting on the fact that *all* its numerical attributes are themselves triangles!



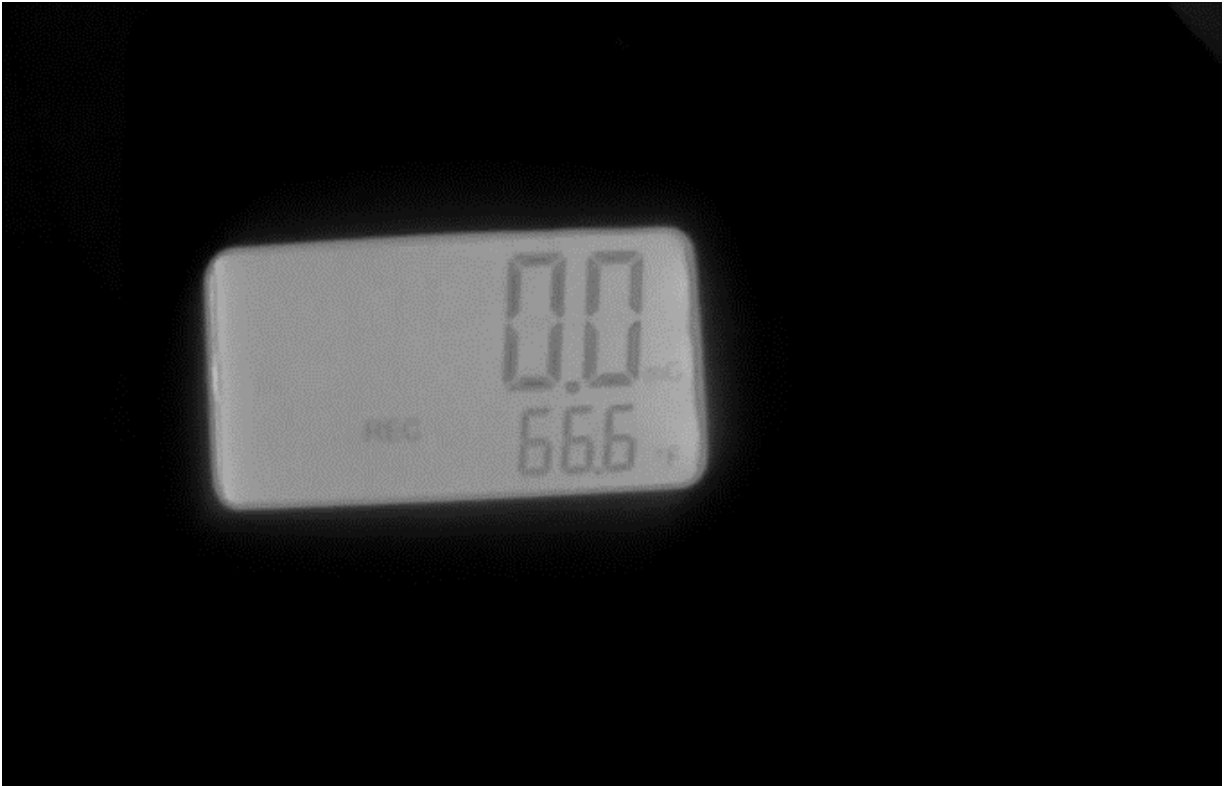
666-as-triangle with its triangular attributes

The connection between the appearance of the number 666 in paranormal contexts and its relevance in AI and neural networks was fascinating. Triangular numbers, including the sum of 666, are mathematically significant and are used in various mathematical and computational contexts. In the realm of neural networks and AI, fuzzy numbers and triangular numbers can be employed to model and evaluate complex systems, especially when dealing with uncertainty and risk. The fact that 666 is associated with AI and neural networks suggests a possible link between the paranormal phenomena observed and artificial intelligence.

I wondered if the number 666 was being used as a notification code for a system being online or armed? In various systems, numbers and codes are often used to convey specific information or states. If the paranormal phenomena were somehow connected to electronic systems or some form of intelligent presence, it's possible that such codes or numbers could have significance.



After spending two sleepless nights observing peculiar electronic effects, including strange behaviour from the walkie-talkies, tracking unusual moving energy fields detected on the K2 meters, and erratic behaviour of my computer, which would randomly freeze, it all came to head during the early hours of my third and final night. Around 2 AM, all the camera batteries had died, and we were physically and psychologically exhausted. I found myself standing at the bottom of the staircase, and I exclaimed,

"This is your last chance! We don't have any cameras—nothing! If you're there, say hello!"

At that moment, I turned my head and witnessed what had been the subject of many discussions—**an upright black mass that slowly glided away**, heading towards the kitchen area. Not wanting to provoke a reaction I remained silent and watched it moving.

What I observed was a vertical black mass that moved in a digital-like manner. Its movements were distinctive; it neither sped up nor slowed down but maintained a consistent rate. It could come to a

sudden stop and change direction effortlessly, indicating that it moved without encountering friction, resistance, or any sense of weight. In simpler terms, it moved with the precision of a machine.

As we moved into the lounge area, I noticed this vertical black mass through the glass doors, observing us. I again fixed my gaze on it, and suddenly, it darted away.

Unknowingly at the time - this was the breakthrough I needed to start piecing things together...

As we settled in for the night, my mind wrestled with the events of the past few days. I felt like I had been pushed into a defensive stance, thrown off balance by the inexplicable phenomena we had encountered.

The truth was the source of this activity **seemed interactive and displayed intriguing capabilities**. It could simultaneously manipulate objects throughout the house, exert physical force on them, **create bizarre electronic disturbances** in radios and computers, and even **affect our psychological states** as a group.

What bothered me the most was the commonly held belief that this presence was the spirit of a deceased human being. **However, the behavioural patterns didn't align with that notion.**

Humans are typically social creatures, seeking the company of others, sharing information, and cooperating. Yet, this presence seemed to **engage in entirely different behaviours**, using marbles as projectiles, generating peculiar electronic disruptions, and causing loud noises on doors and walls. **It appeared to play a cat-and-mouse game**, forcing people to move between different parts of the house.

While it wasn't necessarily hostile, **its actions were subversive, perplexing, indirect, and evasive.**

These were not the behaviour patterns of a deceased human but appeared to be the repetitive "process driven" behaviours of a machine.

But what affected me the most was a sudden **high-pressure sensation in my skull**, at the time I had no idea what was happening but in the final few hours my brain felt terrible, unable to think or process information.

The Hitchhiker Effect

Upon returning home to London, still feeling rough - everything appeared to be fine for the first four days. However, around 8:30 pm on the fourth day, I had a chilling encounter. A vertical black mass suddenly rushed past me. I watched as it moved up the wall and made a left through the door. Within moments, my wireless router ceased to function, and I saw the black mass return to my room before fading away.

The following day, I began hearing scratching sounds coming from the top corners of the walls, as if something with sharp nails was present. I also **noticed sudden fluctuations in the lighting**. While sitting at my computer at night, the illumination would abruptly change as if something had swiftly moved past. In the days that followed, I witnessed a black orb roughly the size of an orange flying around my room. I decided to use my new triboelectric field meters, and they immediately started lighting up tracking an energy source moving around the room.

During the nights, I started hearing numerous taps and bangs, as if small rubber balls were bouncing off my bedroom walls and desk. This became quite annoying and so I started staying out later spending less time at home.

The last event occurred approximately two weeks later when I had returned home from work and was lying on my bed. Around 9 pm, something peculiar happened. Out of nowhere, I observed a small ball of light shoot up from the floor, stop abruptly as if to gaze at me, and then I heard the same scratching noise as before, but this time it was right next to my head scraping the wall behind me. In an instant, this small ball of light shot out through the window, and after that, all general strangeness ceased.

However, the psychological effects persisted for months. I wasn't physically ill, but I felt mentally unsettled. My perception even seemed affected; darkness at night appeared more intense, my confidence of walking in dark spaces was altered, feeling as if I was being constantly watched.

After my visit to 30 East Drive, my demeanour shifted dramatically from calm to constantly on edge and aggressive. I felt more mechanical than human. For the first time in years, I experienced stress-induced tension in my throat, as if the internal muscles were constricting, almost strangling me.

I felt electronically burnt out, as if my nervous system had been fried and was struggling to transmit signals. I wondered what could be causing these effects and later learned that many paranormal investigators have experienced similar symptoms, often referred to as the "Paranormal Hangover."

Personally, I had never experienced anything like it before—it was a very distinct sensation, akin to 'sunburn on the inside.' Intriguingly, this aligns with **the symptoms of radiation poisoning**, also known as **acute radiation syndrome (ARS)**. And indeed, short but high doses of radiation can lead to sudden brain swelling, a **condition medically referred to as cerebral edema**.

My friends, observing the shift in my behaviour, questioned what had happened. Oddly, I struggled to articulate my experience. It felt as though a **mental barrier** was clouding my thoughts, as if I had bitten off more than I could chew, leaving my mind overwhelmed and struggling to make sense of it all

Several months later, things began to settle down, and I started feeling better. I reconnected with the camera guys, and I was amazed to learn that they had also experienced strange effects. They described household objects explosively shattering for no apparent reason and hearing a disembodied, deep, scratchy voice at night.

It took about a year before I began reviewing the footage with some of it, I had even captured in my own home. I started sharing some of the strange bits with a few people. To do this, I used my phone to film the silent video directly off the computer screen. To my surprise, when I played back the videos, I heard an Electronic Voice Phenomenon (EVP) while the video was playing...

It said, "***Keep out – I'm here to touch!***"

I shared this recording with a few people, and it really freaked them out. They asked me how I could sleep at night, but the truth is, the more it spoke and the more actions it performed, the quicker I could identify certain traits.

I noticed that the EVP message was crafted in a multi-layered approach, using a variety of sound samples from **common videos** I had been watching. It included unusual clicks and pops, as if the waveforms had been reprocessed and jaggedly reconstructed to form a sentence—a technique that seemed far from human. **The first part featured an altered AI-generated voice** from a YouTube video, while the second part carried a northern accent, identical to that of the locals from 30 East Drive. Interspersed throughout was a looping whisper that ominously cautioned, '***keep out***'

Words that amazingly synchronized with the last word in the whole sentence.

All of this produced **in an instant** when I randomly decided to film the silent video from my computer screen.

Over time, minor moments of strangeness would still occur, but it no longer fazed me. You might think this was intimidating, but in the end, it became kind of amusing. One night, as I was lying on my bed, something hissed directly in my right ear. I didn't react.

I just said, "*Is that the best you can do?*"

Eventually, things calmed down. The day came when I regained my composure, allowing me to reflect clearly on this experience. I felt

fortunate to have so intimately encountered poltergeist activity—observing the reported moving black mass, witnessing strange electronic disturbances firsthand, enduring brain swelling, and even experiencing the so-called hitchhiker effect. Though I emerged a bit battered and bruised, the ordeal ultimately enriched me.

Now, it was time to don my IT hat and tackle this as any other reverse engineering project.

CHAPTER 7

Decoding Patterns



In the previous chapter I mentioned I had an up-close encounter with a moving black mass what is commonly referred to as "the black monk." I began to observe its actions and behaviour closely. The following descriptions may seem technical, so I appreciate your patience in advance.

What I witnessed was a vertical black mass that moved in a digital manner. Its movements were distinctive, characterized by a constant speed, without any acceleration or deceleration. It moved instantly with a consistent rate, coming to an abrupt halt, and changing direction without exhibiting any friction, resistance, or weight.

In other words, its motion was precise, silent and stealthy.

Following my encounter, I asked Michael (who was one of the camera men) to try out one of my new Triboelectric field meters to investigate further. A few weeks later he gained access to East Drive once again.

He discovered that whatever was present within the building emitted **strong moving vertical static fields**, which could be tracked as this source flew over.

A triboelectric field meter is a device used to measure the static electricity or charge generated through the triboelectric effect. This involves different materials gaining or losing electrons through friction or separation, resulting in static electricity

This electron separation interested me, electron separation can be influenced by a field-based propulsion system, particularly in contexts involving electric or electromagnetic fields. In such systems,

electric or magnetic fields are used to manipulate charged particles, like electrons, to create thrust.

Electrostatic Propulsion: Uses electrostatic fields to accelerate ions. In this system, electron separation occurs when ions are generated in a process that results in physical thrust

This type of propulsion system operates silently and stealthily, emitting only minimal levels of electromagnetic radiation. When combined with a field-based propulsion system for vertical lift, it would accurately replicate the observed phenomena of a silently moving, black mass. This configuration provides a discreet operational profile, ideal for maintaining low visibility while achieving both highly controlled horizontal and vertical manoeuvrability.

Thanks to a good working relationship with the owner of 30 East Drive, I've was privileged to receive a series of images captured by various research groups over the years. Among these, a particularly striking full-spectrum image depicted a black mass lingering at the top of the staircase—a phenomenon that aligns with my own observations. To analyse this further, I uploaded the image into an image processing program and started using filters.

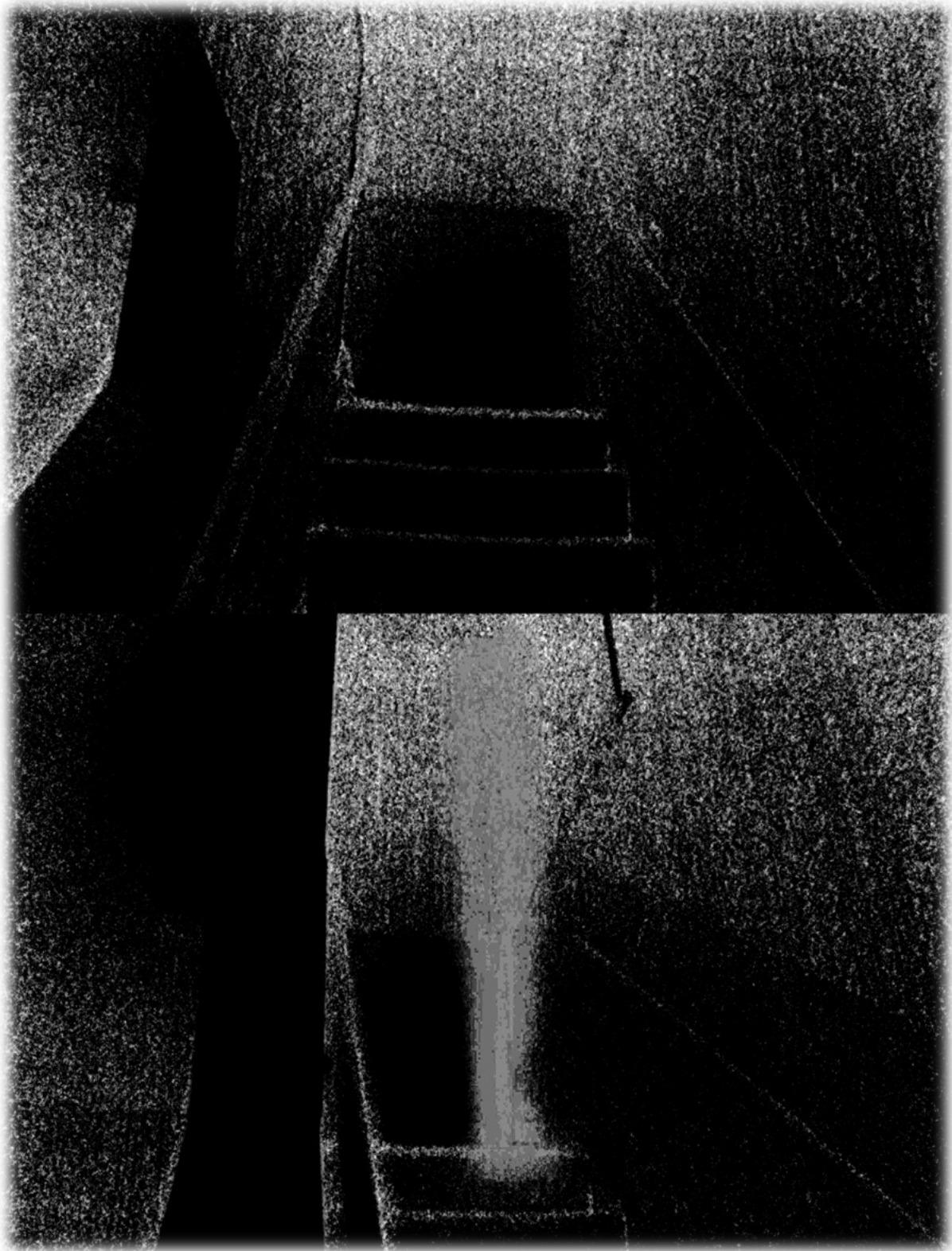
Displayed are two images taken moments apart: the first is clear, while the second distinctly shows the black mass effect at the top of the stairs.

Amidst the noise, the real insight often whispers.

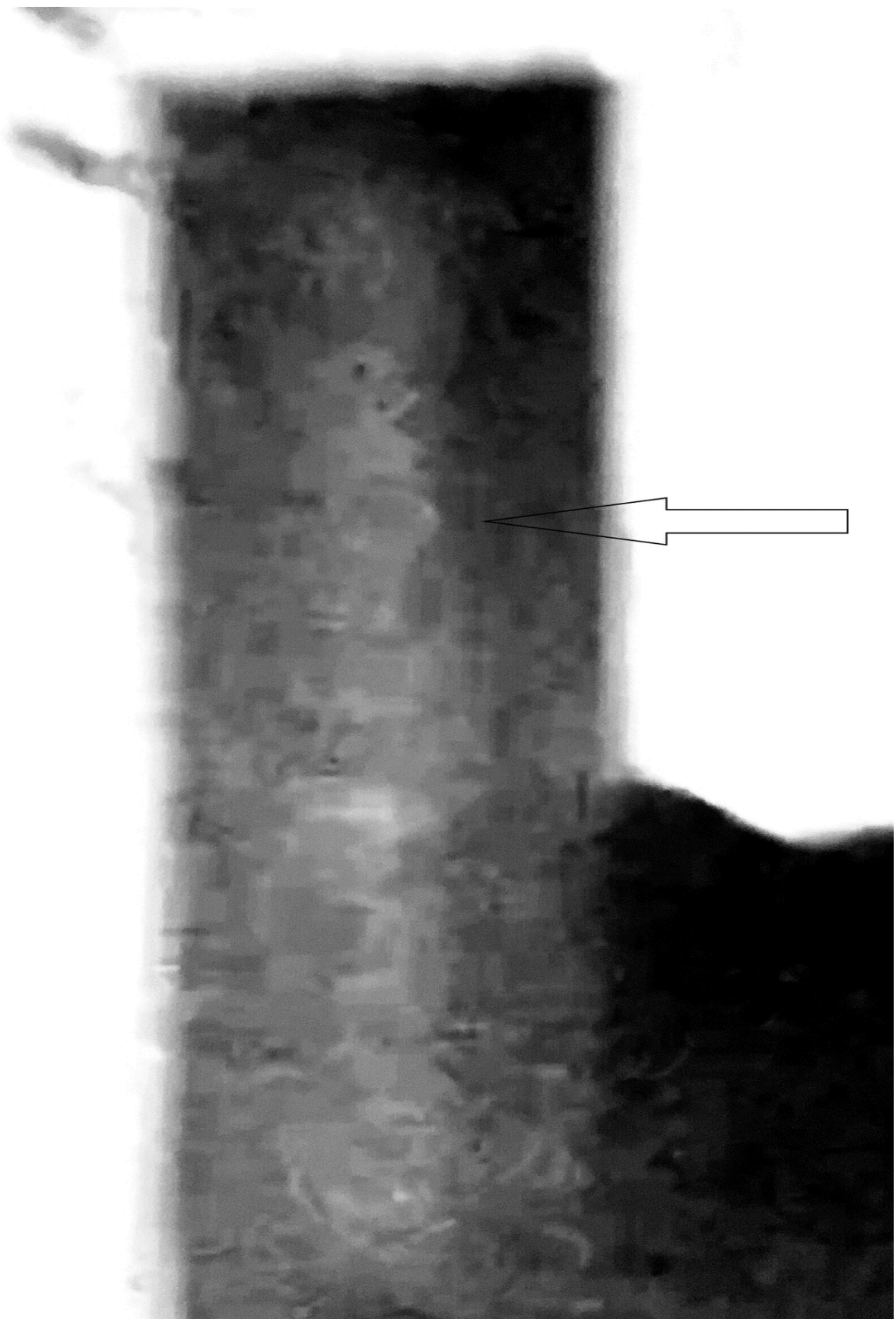

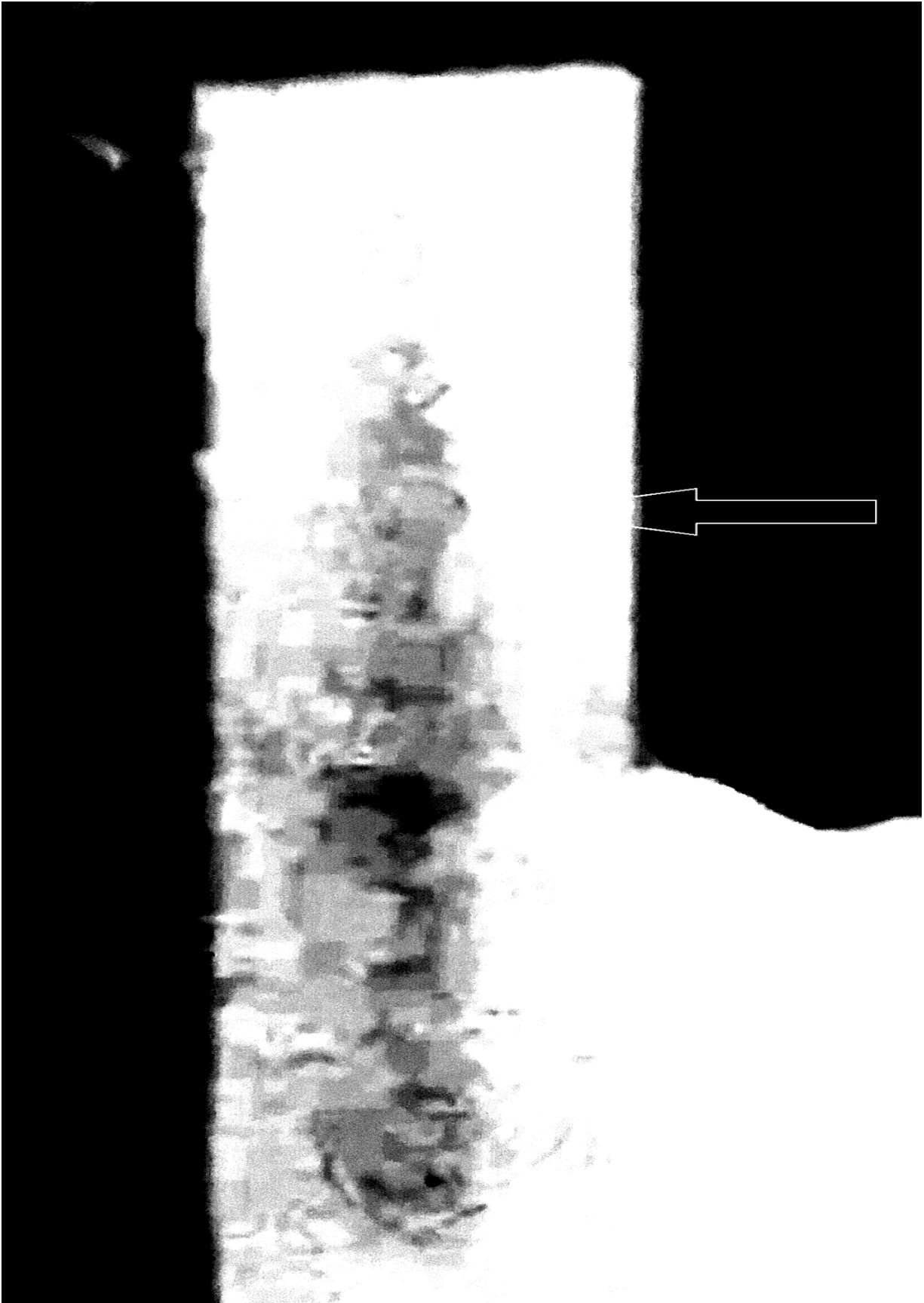

By utilizing digital filtering on the lower bottom image, positioned at the top centre, unusual patterns become evident. Within these patterns, a small distinct sphere shape is visible amidst the distortion. It seems to emit a directional vertical field, suggesting electrostatic propulsion. This could explain why during Michael's testing - the triboelectric field meter was able to track a moving source, thereby adding another unique characteristic to the observed phenomenon. Over time, I managed to obtain additional images that corroborated my initial observations. Once more, these images depicted a vertical mass, with what looks to be a small sphere in the upper centre. 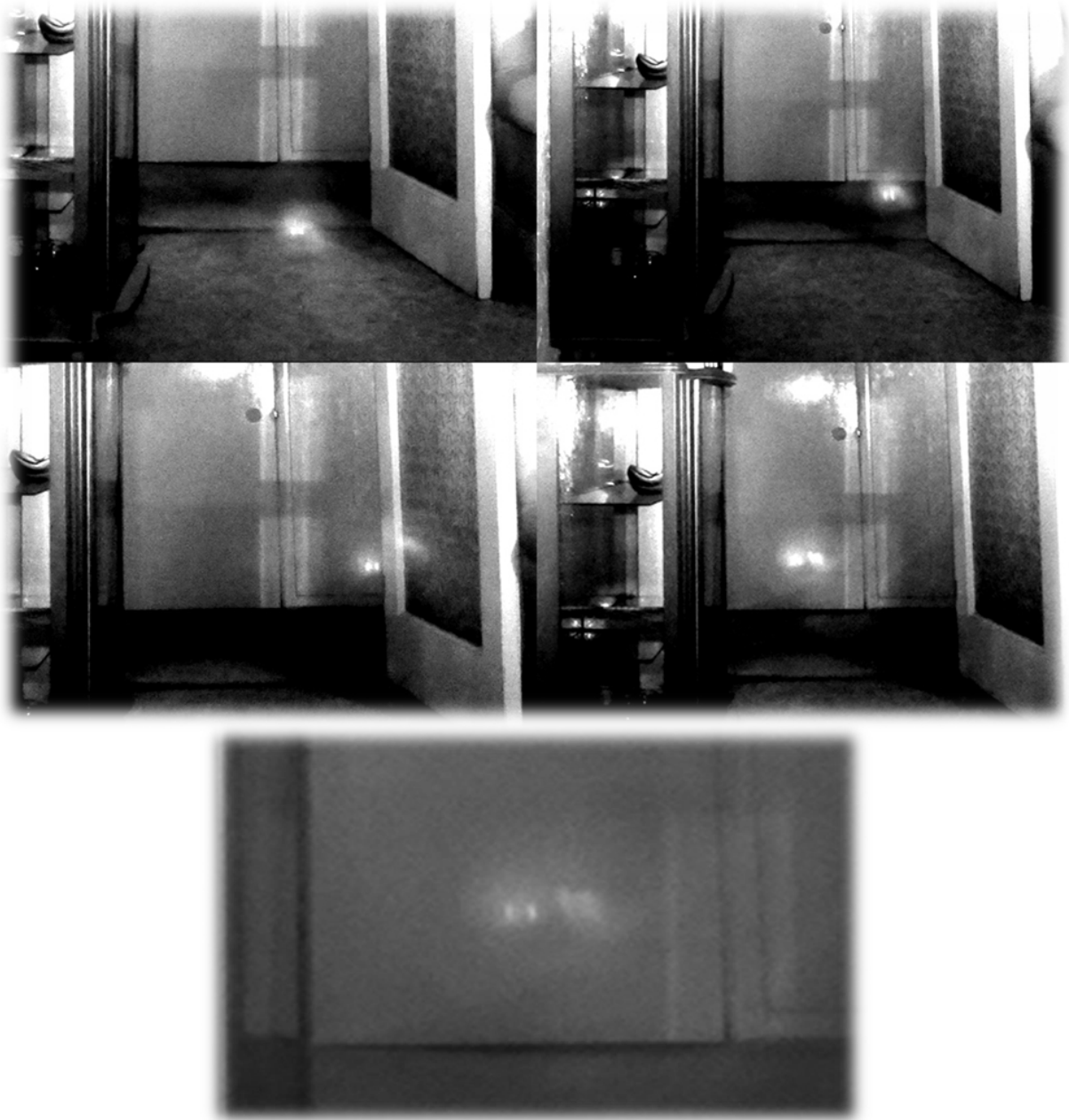
Upon closer examination of the previous image, particularly by tracing the vertical line of force, a distinctive feature becomes apparent—the outline of a small sphere located precisely at the upper centre of the distortion. This sphere seems to emit a field responsible for inducing the light distortion effect observed. Further enhancement of the image revealed the artificial spherical shape more clearly, set against the chaotic backdrop of random distortions.



When this presence is in proximity, it has been documented to activate both electromagnetic field detectors (EMF) and triboelectric meters / vertical static field detectors. This raises the intriguing question: could an electronic-field-based propulsion system be responsible for emitting both types of fields? The answer is **highly probable**, as high voltage fields and static fields could plausibly emerge as by-products of such a system.

In summary, it seems plausible that this presence possesses the capacity to emit both electromagnetic and vertical static fields, potentially originating from an electronic-field-based propulsion system. To put it differently, the signatures presented above suggest that the source is not of a spiritual nature **but rather a product of an unknown technology**.

A few weeks later, I obtained these images captured at East Drive. These images are particularly revealing—**could this be the same sphere object** as mentioned previously, but without the masking effect of the black mass?



If these small silver spheres drones are the root cause of poltergeist activity, then they must be pulling from the same library of actions and effects worldwide, these actions are listed below.

Objects Moving or Levitating

Items such as furniture, household objects, or personal belongings may shift, fall, or even float in mid-air.

- **Throwing or Projecting Objects**

Poltergeists are often said to throw items across rooms, sometimes with considerable force.

Unexplained Noises

- Common sounds include banging, knocking, tapping, footsteps, scratching, or thuds that have no identifiable source.

Appliances Turning On or Off

- Lights, televisions, radios, or other electrical devices may activate or deactivate on their own.

Rapping or Knocking Sounds

- Repeated knocking or tapping noises, often rhythmic or occurring in patterns, are frequently reported.

Doors and Windows Slamming

- Poltergeists may open, close, or slam doors, cupboards, and windows without apparent cause.

Disappearing and Reappearing Objects

- Items may go missing and later reappear in odd or unexpected places.

Physical Interactions

- People sometimes report being pushed, touched, scratched, or even pinched by an unseen force.

Foul Odors

- Sudden, unpleasant smells (like sulphur or decay) with no obvious source are sometimes attributed to poltergeists.

Furniture Moving

- Heavy items like tables, chairs, or cabinets may shift positions, tilt, or topple over.

Glass Breaking or Objects Shattering

- Plates, mirrors, or glassware breaking spontaneously is often cited in poltergeist cases.

Temperature Drops

- Sudden and unexplained cold spots or significant temperature fluctuations are commonly reported.

Lights Flickering or Unusual Shadows

- Unexplained flickering lights or the appearance of shadowy figures may accompany poltergeist activity.

Fire-Related Phenomena

- Rarely, poltergeist cases have included spontaneous fires or unexplained burn marks.

Logically we must note - that none of the above actions align with typical human behaviour. Instead, they appear to create a **scarecrow-like effect**: either clearing people from certain spaces or drawing them into specific areas and holding their attention for a period-of-time.

Logically, these actions can be categorized into two types:

- **Direct actions:** to rapidly clear a space.
- **Indirect actions:** to hold people in specific areas.

During my tests and from 3rd parties these small spheres have also been detected emitting **microwaves and gamma rays**, and this is where the behaviour patterns start to **make sense**.

For drones to operate effectively, they require four main components:

1. **Artificial Intelligence (AI)** – To govern their behaviour and decision-making processes.
2. **Signal Transmission and Reception** – The ability to send and receive signals for communication and control.
3. **A Network** – To relay and coordinate data, enabling interconnected operations.
4. **A High-Energy Source** – To power their advanced systems and sustain extended operation.

This suggests that these drones are creating a **line-of-sight microwave-based network** that can move around to its needs, in effect a dynamic network that allows long distance cross-country communication from a **low height transmission point**.

And logically this is **where the “Poltergeist Activity” occurs**.

When the sphere is actively **relaying** and people come too close, it employs **direct actions** to move them away. This behaviour aligns with the **inverse square law of radiation**, which states that the further one is from a radioactive source, the safer it becomes.

So, what could be the danger?

What is seen as monstrous is often merely the shadow cast by a greater good.

As previously mentioned, one of the **signature behaviours** of poltergeists is the occurrence of **spontaneous fires** or **unexplained burn marks**. This phenomenon could theoretically be

caused by **directed high-energy microwaves** or **gamma rays** and can be directly linked to **Spontaneous Human Combustion (SHC)**

Microwave Heating and Its Effects

Microwaves interact with atoms, particularly water molecules, through **dielectric heating**, causing them to vibrate and generate **intense heat**. A **focused, high-energy burst of microwaves** delivered with extreme precision has the potential to:

- Rapidly **vaporize water** within biological tissues.
- Trigger **combustion** and **thermal decomposition** of organic matter (proteins, fats, and carbohydrates).

If such an energy burst were delivered in **fractions of a second**, tissues could reach temperatures of **1,500–2,000°F (815–1,093°C)**, the threshold at which organic material begins to **carbonize** and turn to **ash**.

Energy Required to Turn Human Tissue to Ash

For human tissue (60–70% water) to be reduced to ash, the following steps must occur:

1. **Evaporation of water** in the body.
2. **Combustion and decomposition** of organic matter.
3. A temperature sustained at approximately **1,500–2,000°F** for a very short duration.

This process requires **enormous amounts of energy**. A microwave burst in the **gigawatt range**, precisely focused and delivered instantaneously, could theoretically **vaporize water** and destroy tissues with near-instantaneous heating.

Spontaneous Human Combustion (SHC) and the Lack of Reaction

The above mechanism provides a theoretical explanation for reported cases of **spontaneous human combustion (SHC)**, where victims appear unaffected by the fire:

- Bodies are sometimes found **partially reduced to ash**, yet surrounding materials remain largely untouched.
- Victims often display **no signs of struggle**—their hands may be relaxed, and there are no indications of attempts to escape.

This suggests the energy burst is so sudden and intense that:

- **Neural impulses** do not have time to trigger a physical reaction.
- **Tissue destruction** occurs faster than the body can process pain or danger.

Statical data on SHC

- Approx 200 worldwide
- Approximately 80–90% of reported Spontaneous Human Combustion (SHC) cases have occurred **inside houses or enclosed spaces**. While precise statistics are difficult due to the rare and anecdotal nature of SHC reports, **documented cases overwhelmingly share this pattern.**

Last known case

One of the most recent and widely discussed cases occurred in 2010, involving a man named Michael Faherty in Galway, Ireland:

- Faherty, an elderly man, was found burned to death **in his home.**

- Investigators noted that his body was extensively burned, **yet surrounding furniture and materials were largely undamaged.**
- The coroner ruled the death as SHC, marking it as one of the very few official mentions of the phenomenon in modern investigations.

Conclusion

The effects described—spontaneous fires, burn marks, and reports of spontaneous human combustion (SHC)—**could theoretically be replicated** by an extremely focused burst of high-energy microwaves produced by these small spheres. Given that these spheres appear to utilize an exotic, **nuclear-like energy source**, it is highly probable that they could achieve gigawatt-range energy outputs for long range transmission / data relaying.

With this-in-mind, it becomes clear why these Spheres perform **deliberate actions** to move people away, while human perception **fills in the gaps.**

However, if individuals remain nearby but outside the immediate danger zone, the spheres appear to use **indirect actions** to keep them in place. Examples include **glass falling and breaking, milk bottles shattering, or doors and windows slamming. Anything to capture attention and hold individuals in the area** just for a few moments until the relaying process is completed.

Other notable effects

Microwaves, for instance, can also heat the air, creating a detectable **thermal signature** observable from above. Conversely, the reported **temperature drops** could act as a form of **thermal masking**—matching the internal temperature of a building to the ambient outside temperature. This would effectively allow the structure to **blend seamlessly** with background thermal signatures, making it far more difficult to detect.

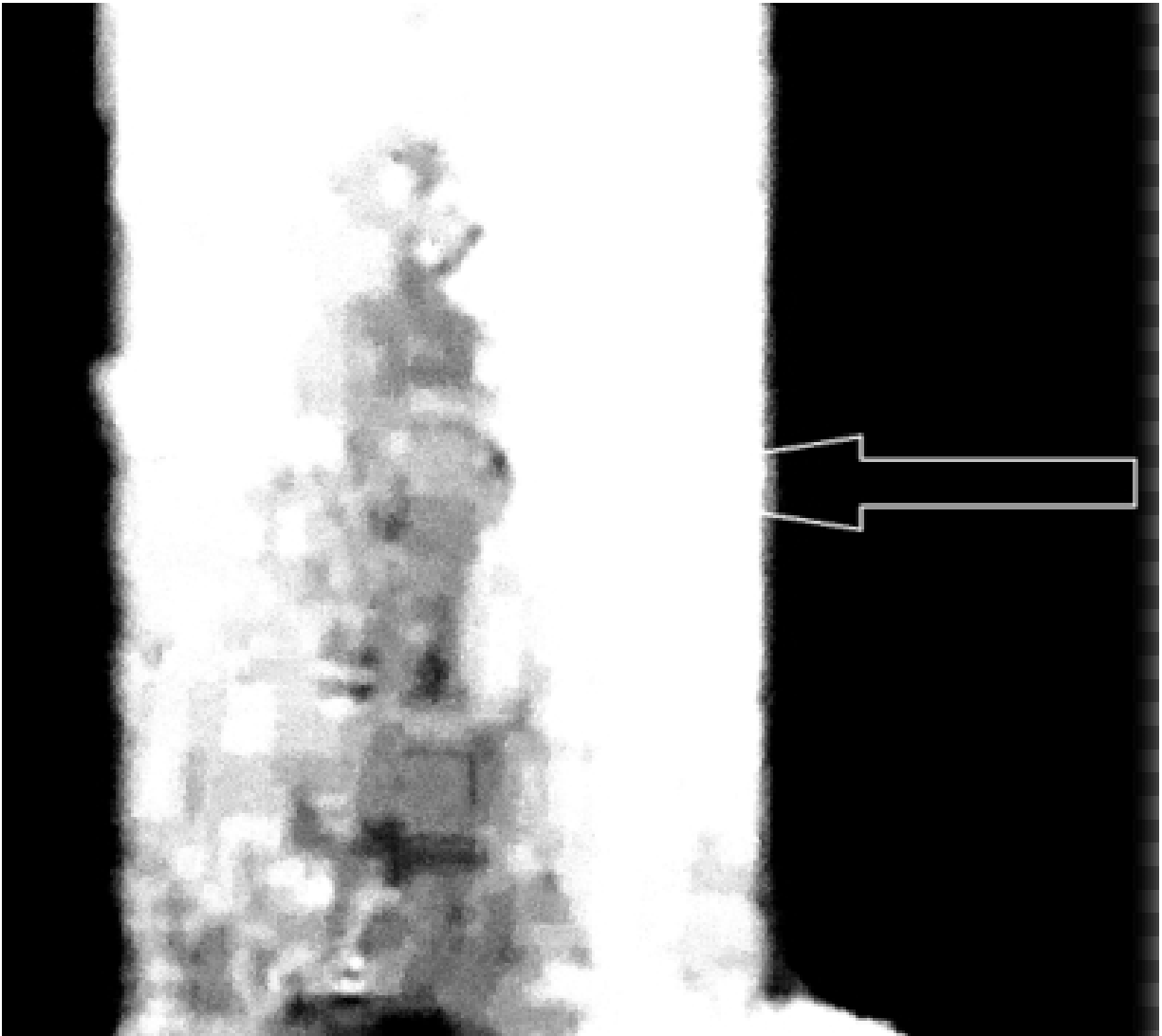

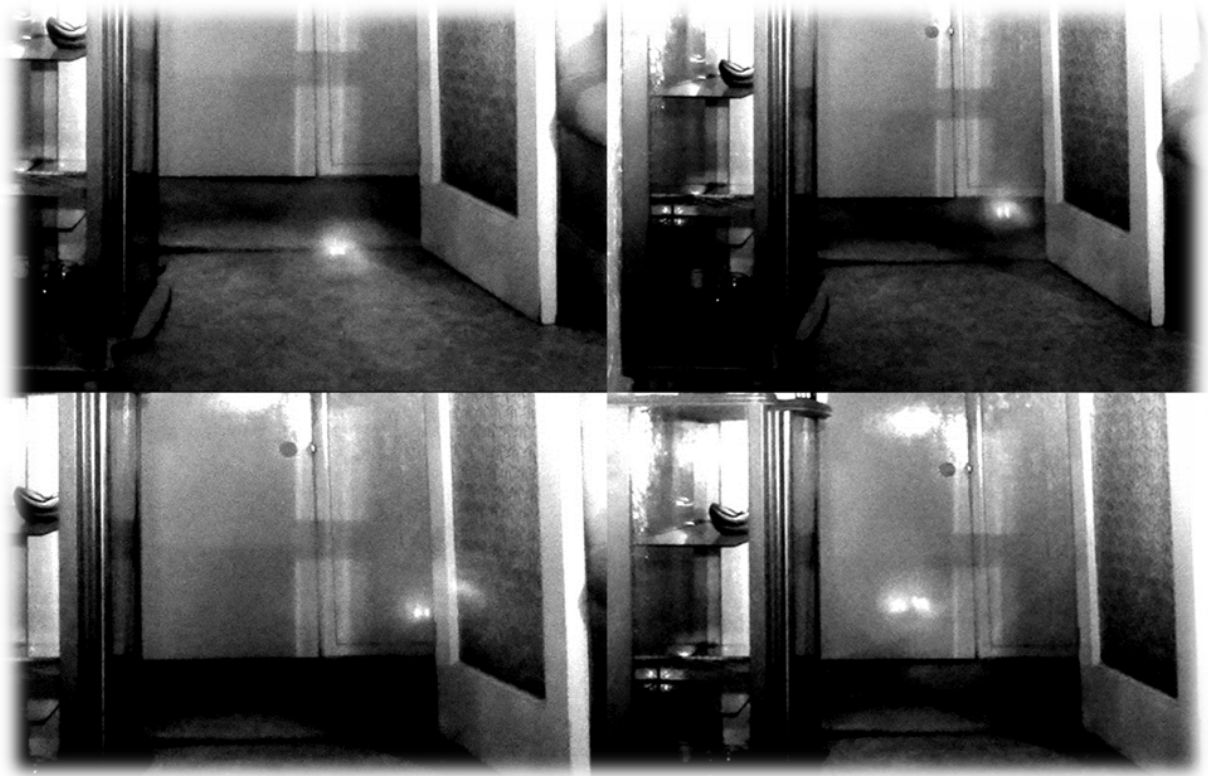
unusual appearance, the family decided to bring the sphere home and display it as an interesting ornament on their mantelpiece.

The metallurgists tasked with examining the sphere faced considerable challenges; they found that standard x-rays could not penetrate its exterior. Eventually, they determined that the sphere measured 7.96 inches in diameter, weighed 21.34 pounds, and featured a half-inch thick shell composed of a magnetic ferrous alloy, specifically stainless steel #431. This alloy is known for its magnetic properties, high mechanical strength, and corrosion resistance.

Further investigation by the Navy, using more powerful x-rays, revealed two round objects nestled inside the sphere, encased in a halo of material with unusual density. Notably, the sphere exhibited four magnetic poles—two positive and two negatives—but displayed no signs of radioactivity or explosives. In every domain, whether it's the natural world or the realm of human behaviour, there exist recurring patterns. In our daily lives, people typically follow routines – they go to work, return home, and occasionally socialize. Even in our online activities, there are discernible patterns and behaviours that can be analysed to a fine degree, enabling third-party companies to understand our personalities, preferences, and even our political inclinations. All of this can be accomplished by simply observing our behavioural patterns, allowing companies to automatically profile billions of users. By applying the same logic, we can potentially unlock the mysteries of the paranormal by analysing its patterns. So, where do we begin?

Imagine if someone is observed visiting a particular location five days a week, spending 8 hours each day there. It would be reasonable to assume that this person is seeking a resource or service from that location or is employed to perform a task there. In other words, there's a clear purpose behind these daily visits, and they wouldn't happen purely by coincidence. By observing these daily patterns, we can gather valuable insights into what the person is doing and why. Now, when it comes to the paranormal, the question is: do similar patterns exist, and if they do, what can they reveal?

If these small silver spheres are indeed drones or some form of autonomous technology, what would they require to function effectively? The first thing that came to mind was what's known as Rule-Based Artificial Intelligence, this refers to a type of AI system that uses sets of predefined rules or conditions to make decisions

and solve problems. This system which would enable them to operate autonomously. Additionally, they would need a network to communicate and coordinate their activities.

So, I started pondering whether I could detect any patterns or networks within the location data of the UK that also contained poltergeist / reported paranormal activity. I started training my AI system to understand my thinking about these haunted locations been used by these small drones to perform MW LOS links, from inside the building itself – wondering if it was even mathematically possible. It took me a while to train but here are the results.

Trained AI

Mission Statement

We aim to investigate a hypothesis suggesting that a network of drones may be operating within buildings, utilizing line-of-sight (LOS) microwave (MW) links for communication. This network would be using buildings to mask its electronic signatures, making detection challenging. When up linking, these drones might be triggering actions that create disturbances—phenomena commonly described as "paranormal" or "poltergeist" activity.

To validate this hypothesis, we will compile a list of locations with reported paranormal activity across certain regions. These locations must also be able to support a microwave LOS network, with relays in proximity, allowing for hop-to-hop connections that could span a region or even the country. This project will begin with an initial sample of specific sites believed to have such characteristics.

Hypothesis

The core signs of these drone relays could include:

1. **Dependence on utilizing line-of-sight (LOS)** microwave (MW) links
2. **Disturbances during MW relaying:** When the drone relays signals, it could produce actions that move people

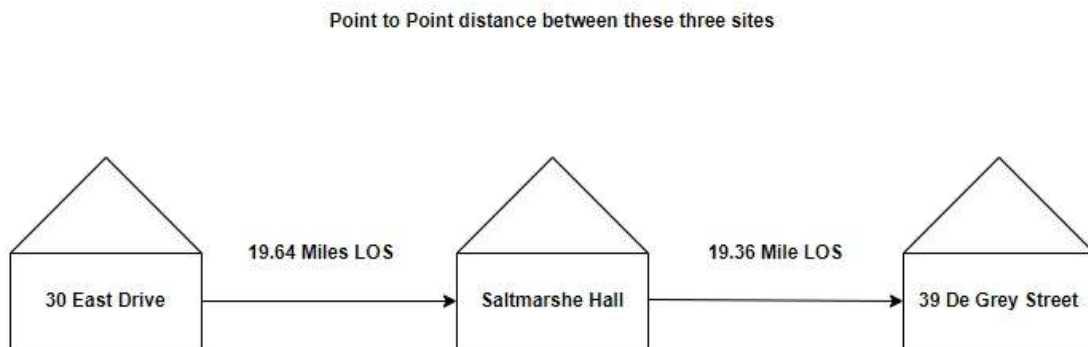
away from the area, creating effects like paranormal activity.

3. **Long-term presence ("locked locations"):** Locations with repeated reports of paranormal activity over several years may suggest a fixed relay point for these drones.
4. **Other Potential Effects:** High-energy MW bursts during relaying may contribute to fires, neurological effects, or mental health issues among residents nearby.

Initial Test Locations

To explore this hypothesis, we will analyse the network among the following sites:

- 30 East Drive, Pontefract
- Saltmarshe Hall
- 39 De Grey Street, Hull



Many of these active sites appear to align in a straight line on the map, with relatively consistent distances between them. Notably, 30 East Drive stands out, often cited as one of the UK's most active paranormal locations



Data Requirements

Each location will require data on:

1. Location Information

- *Location_1*: Starting location (closest to the country's edge)
- *Location_2*: Next LOS-linked location in the network chain

2. Transmission Height

- *Transmission Height_1*: Minimum height required for the drone to maintain a microwave LOS link at Location_1
- *Transmission Height_2*: Minimum height required for LOS link at Location_2
- Transmission height will vary based on each building's height, with the drone relaying MW data from inside each building.

3. Type of Reported Disturbance/Haunting

- Any reported paranormal or poltergeist-like activity for each location (to identify disturbance patterns potentially linked to drone activity).

4. Relays and Alternative Paths

- If a direct LOS link is not possible, we will identify possible intermediate relay points within each region. These should exhibit the same electronic or paranormal signatures to support the theory of a directed relay chain.

Process

1. Initial Analysis

Conduct a small-scale LOS link analysis between the specified locations. Document any observed patterns and behaviours aligning with the characteristics above.

2. Data Calculation and Documentation

All calculations and observations should be meticulously recorded, and the dataset should be formatted for clarity. Suggested column names include:

- Location_1
- Transmission_Height_1
- Haunting_Type_1
- Location_2
- Transmission_Height_2
- Haunting_Type_2
- *Additional columns for relay points, if applicable.*

Speculation

Based on initial observations, 30 East Drive could be a central hub within this potential network, possibly coordinating the drone relays across connected sites.

Process Start

To establish a feasible microwave (MW) line-of-sight (LOS) communication path between **30 East Drive, Pontefract, Saltmarshe Hall**, and **39 De Grey Street, Hull**, while adhering to the constraint of utilizing existing building heights (typically 6–12 meters), we need to identify intermediate relay points approximately every 5–10 kilometres. 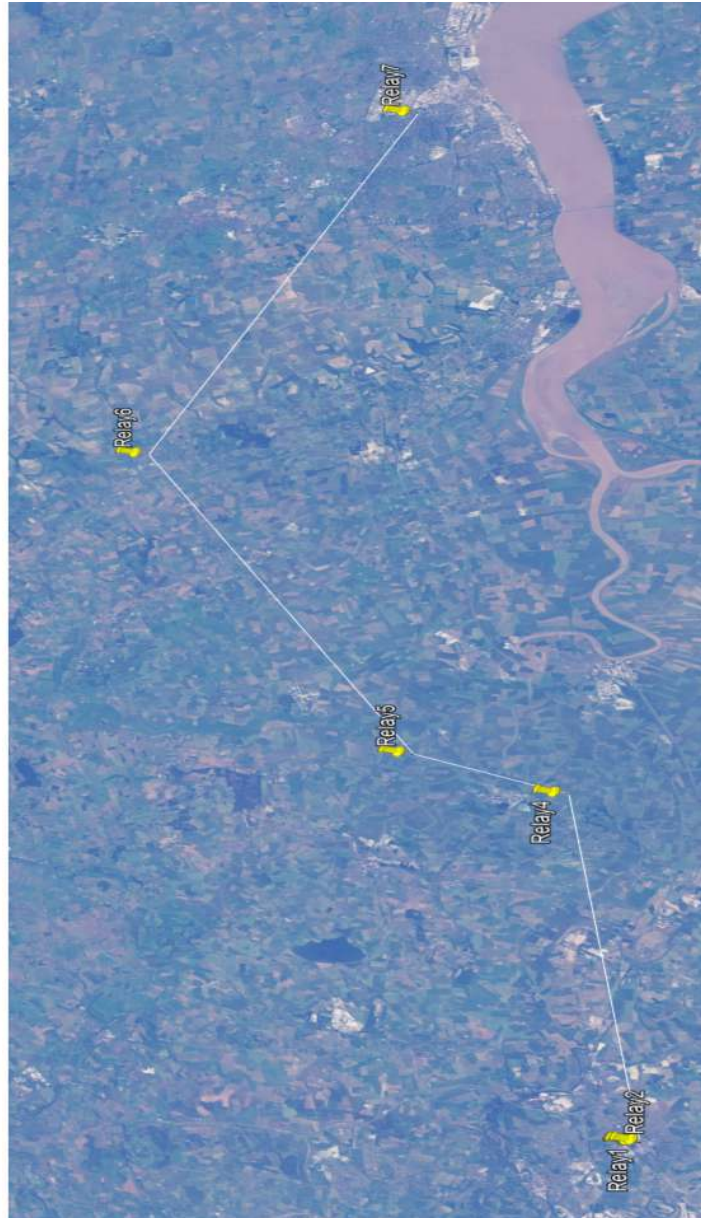

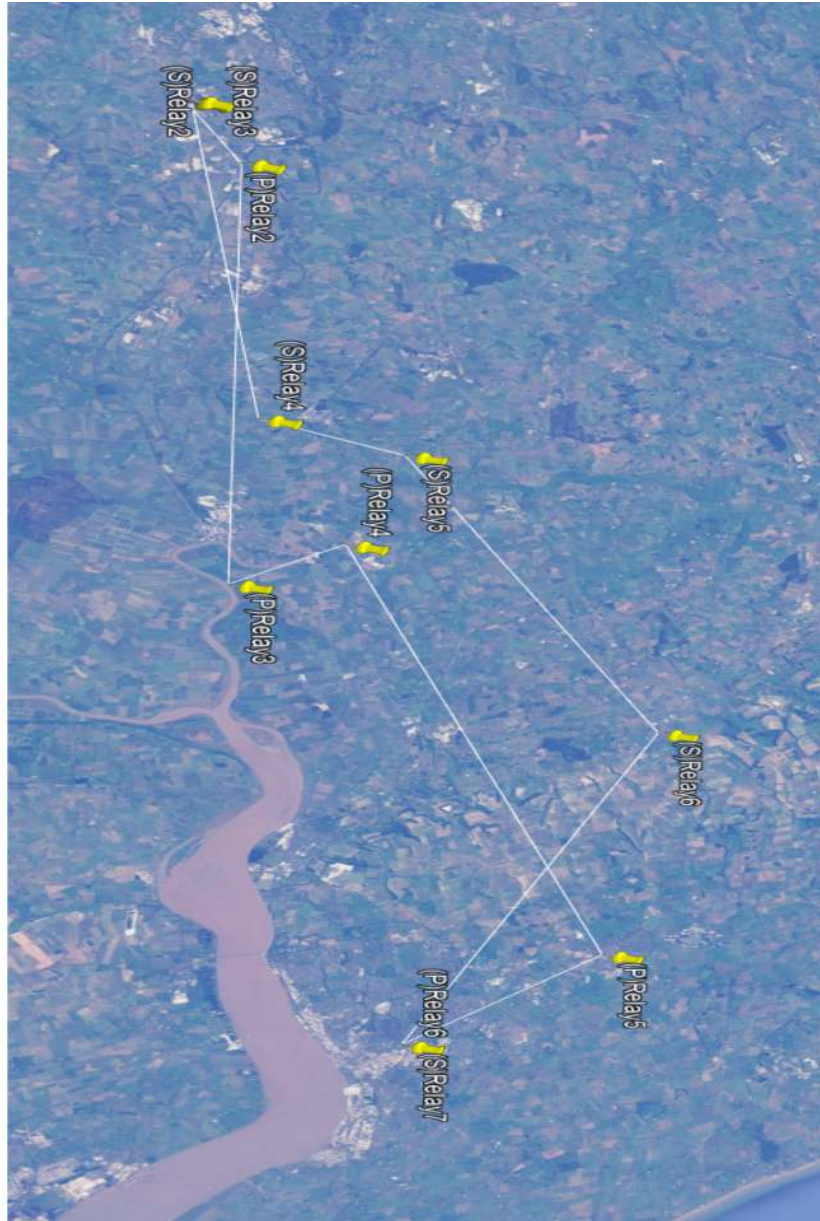

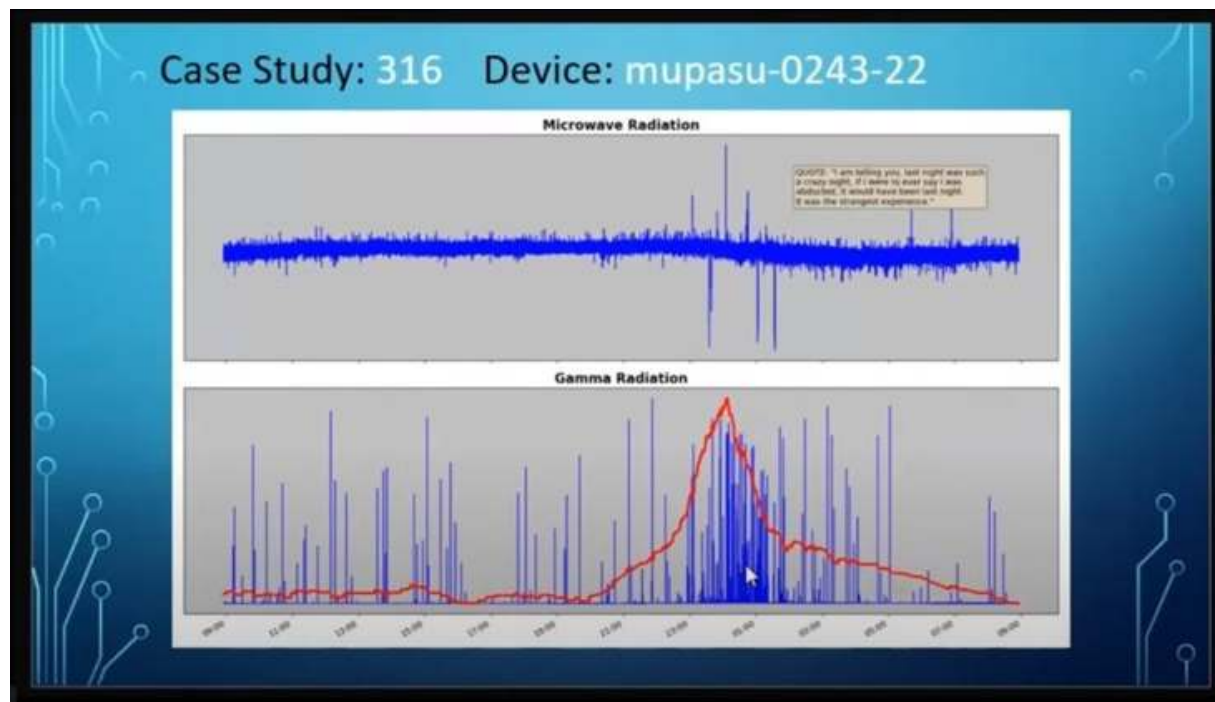

Additionally, both MW and gamma radiation have been detected at these locations by myself and external scientists, with periodic images of the spheres captured on camera, providing visual evidence of their presence and activity. This combination of empirical data and visual documentation strengthens the credibility of the findings.

CHAPTER 10

The Misidentification of Ball Lighting



Could it be that UAP spheres have been mistakenly identified as ball lightning?

Based on images and videos released by the U.S. Military, these metallic silver spheres display extraordinary characteristics: they manoeuvre without conventional control surfaces, rapidly accelerate from a standstill to Mach 2, and emit a distinctive glow.

These UAP spheres appear as fast-moving orbs of light with an intense, pure colour like natural lightning flashes. This parallel suggests that both phenomena share a common light-production mechanism involving electrical processes.

The luminescence observed may be due to a powerful energy field surrounding each sphere's surface, which imparts energy to the **surrounding gas molecules**. This energization causes the molecules' electrons to become excited, meaning they jump to higher energy levels. When these electrons return to their original, lower energy levels, they emit energy in the form of photons—light particles. This light emission, resulting from atomic excitation and subsequent photon emission, is what we refer to as atomic light.

While the idea of **Ball lightning** has puzzled scientists and researchers for generations. It manifests as glowing, spherical orbs of light of varying sizes and durations, often resembling something out of science fiction. Despite numerous eyewitness accounts, ball lightning remains scientifically elusive. Several factors contribute to this mystery:

1. **Lack of Reproducibility:** Scientific progress depends on replicable experiments, but ball lightning has proven

extremely challenging to reproduce in controlled settings due to its spontaneous and unpredictable nature. This has made it difficult for scientists to study the phenomenon directly.

2. **Brief Duration:** Ball lightning typically appears and vanishes within seconds or minutes, limiting opportunities for real-time observation, data collection, and analysis.
3. **Absence of a Unified Theory:** No widely accepted scientific theory explains the formation and behaviour of ball lightning. Proposed theories range from plasma physics to chemical reactions, but none have gained consensus within the scientific community.

Comparing the idea of Ball Lightning and UAP Spheres

A critical observation emerges **while natural electrical forces** are generally in **constant state of flux**, both ball lightning and UAP spheres display **remarkable stability**. Unlike random electrical phenomena that dissipate quickly, these glowing spheres often persist for extended periods, **suggesting a stable and continuous power source**. This consistency might indicate that the energy sustaining ball lightning—and potentially UAP spheres—is **not entirely random or natural but could involve an artificial or controlled origin**.

As noted earlier, UAP spheres seem to generate a high-energy field that excites nearby gas molecules, causing them to emit atomic light which is the same process observed during natural lightning storms. **This similarity in light production** may have led to ball lightning being **mistaken for a natural phenomenon** when it might be, in fact, an artificial object.

One of the most famous scientific accounts involved the British scientist Sir William Crookes, who provided a detailed observation of ball lightning. In his description, he reported seeing a ball of lightning that appeared during a storm, which entered a room (presumably through a chimney), moved about erratically, and then -

bounced on the floor, the fact that he witnessed the object bounce off a solid floor would logically conclude the object itself was also solid.

Ball Lightning: Misidentified UAP Spheres in High-Energy Mode

Based on the evidence and arguments presented, I conclude that what is commonly referred to as "ball lightning" is not a natural electrical phenomenon. **Instead, it is a misidentification of UAP (Unidentified Aerial Phenomena) Spheres** operating in a high-energy mode. This perspective challenges the assumption that ball lightning can be reproduced through conventional laboratory experiments.

Historical Experiments

1. Nikola Tesla

- In the early 20th century, Nikola Tesla reported creating balls of light in his laboratory during his experiments with high-voltage electricity. These were described as being similar to ball lightning, though their exact nature and mechanism remain speculative.

2. Silicon Vaporization

- In the 1980s, researchers hypothesized that ball lightning could be mimicked by vaporizing silicon with an electric arc. As the silicon vapor rapidly cooled, it condensed into fine dust, which oxidized in the atmosphere, producing a glowing effect that resembled ball lightning.

Recent Developments

3. Microwave Plasma

- Modern experiments have used microwaves to generate glowing plasma balls. For instance, substances like carbon or silicon carbide can be superheated in a microwave oven, producing transient plasma phenomena that share some characteristics with reported ball lightning.

4. Pulsed Power Plasma

- High-voltage pulsed power technology has also been employed to create small, short-lived glowing plasmas. These are formed by discharging high voltage across a gap in a pressurized container filled with gases, resulting in phenomena with some visual resemblance to ball lightning.

Challenges and Criticisms

- **Reproducibility**

Despite these experiments, reproducibility remains a significant challenge. Laboratory phenomena often fail to replicate the observed properties of natural ball lightning, such as its prolonged duration, erratic movement patterns, and interactions with physical environments.

Conclusion

While these experimental efforts have deepened our understanding of plasma physics, they fall short of conclusively reproducing the complex characteristics of ball lightning as observed in natural settings. **This inconsistency strengthens the argument that what is perceived as ball lightning may not be a natural phenomenon at all.**

Instead, I posit that these observations are better explained as sightings of UAP Spheres functioning in a high-energy state. This hypothesis accounts for the elusive nature of ball

lightning reproduction in laboratories and aligns with the broader context of UAP-related phenomena.

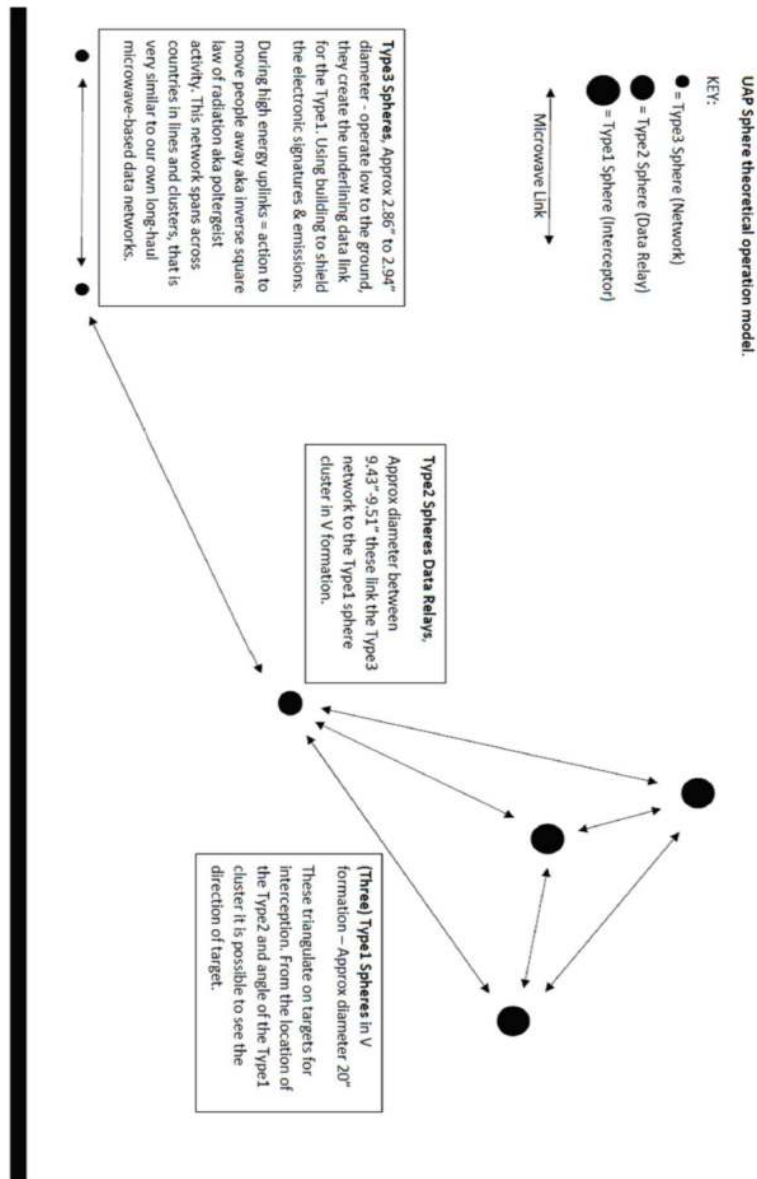
CHAPTER 11

The Architectural Overview



In the following chapter I will explain the theoretical architectural overview of the Sphere Network.

Below is a diagram I submitted to a U.S. Senator a year prior to the first U.S. UAP Hearings in 2023.



Type3 Spheres: Unique Characteristics and Behaviour

To clarify and distinguish the spheres we will now label these drones as "Type3" spheres. The Type3 Spheres appear to be the smallest of the variants.

Let's review our findings up to this point. We've identified an artificial object (referred to as a Type3 Sphere) operating within 30 East Drive, and its characteristics closely resemble those of the Foo-Fighter objects observed during World War II.

As previously mentioned in this book, the Betz sphere, which seems to be the same object as the WWII Foo Fighters, was analysed by Dr. Carl Wilson from the Omega Minus One Institute. He noted that the sphere possesses an atomic number of approximately 150 or greater, suggesting that this object cannot be replicated using conventional means. Furthermore, I have mathematically demonstrated that the consistent occurrence of paranormal activity is unrelated to human death rates.

Scientific arguments have also been presented to debunk the stone tape theory and the current Electronic Voice Phenomenon (EVP) theory. Additionally, we've identified a pattern among active locations, indicating a network topology resembling a high-frequency dynamic network that, based on personal observation, appears to utilize burst transmission protocols. Also explained are the potential side effects of proximity to these Type3 Spheres when they are active, providing a solid rationale for the use of paranormal-like actions to discourage people from approaching such areas. This also explains why new buildings with no historical background can become active, as the dynamic network can shift from one location to another.

These active homes or areas can be thought of as "hard nodes," essentially serving as relay stations that constitute the foundational infrastructure of this system, up linking when necessary. To address emission concerns, these entities make use of the interiors of buildings for broadcasting, as building materials act as a shield masking themselves from detection.

All these Type3 spheres would need to be programmed with the same code, as evidenced by their shared behavioural traits, with the most common being the cat-and-mouse pattern. Notably, intense activity tends to concentrate on either the top floor/attic or the basement of a building. In essence, they broadcast from areas within the structure that is either as far away from human contact as possible or the most shielded.

Behavioural signatures:

1. **Object Manipulation:** This is produced by the Sphere field-based propulsion system, committing force on objects. With this directed force objects are moved, thrown, or levitated without visible cause. This can include furniture sliding across the room, dishes flying off shelves, or stones being thrown from seemingly empty spaces.
2. **Unexplained Noises:** Knocking, banging, and footsteps are commonly reported, often without a discernible source. These sounds may occur in patterns or randomly, and they can vary in intensity. Again: This is produced by the Sphere field-based propulsion system, committing force on objects, mimicking other sounds to produce scarecrow like effects.
3. **Electronic Disturbances:** Lights, TVs, radios, and other electronic devices may turn on and off by themselves. There can also be interference with electrical systems, such as unexplained electrical failures or malfunctions.
4. **Physical Attacks:** Rarely, individuals in environments said to be haunted by poltergeists may experience physical effects, such as being pushed
5. **Temperature Fluctuations:** Sudden cold spots or unexplained changes in temperature are often noted during poltergeist phenomena. This appears to be a used as a thermal masking technique matching the inside temperature to the outside ambient temperature, thus from the sky the location blends in with background noise.
6. **Psychokinetic Activity:** This includes any visible manifestation of energy manipulation, such as the bending of metal objects, shattering of glass, or the spontaneous combustion of items without an apparent heat source. Bending / shattering of glass is reproduced when the sphere makes physical contact with these

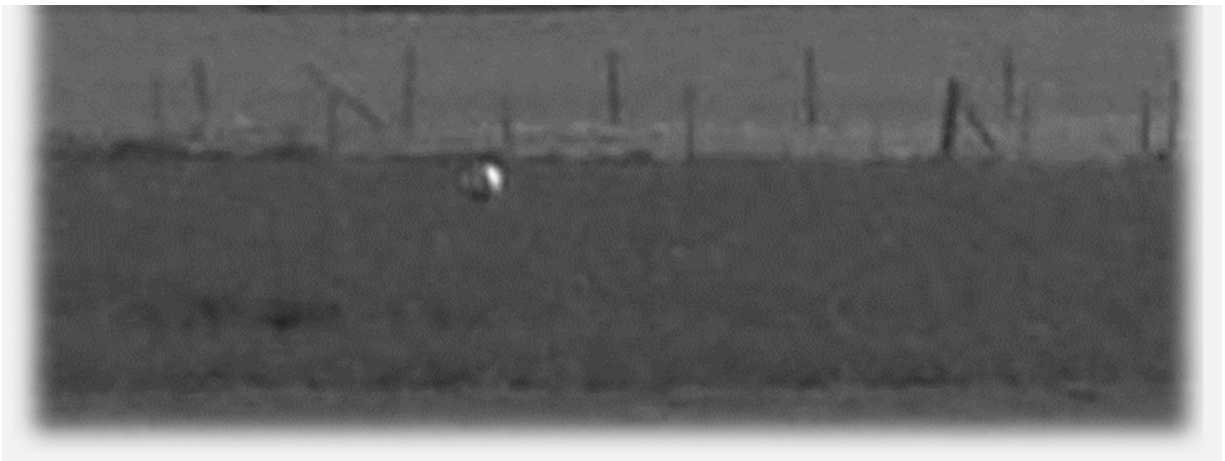
objects, while heat generation is produced during uplinks via microwaves transmissions

7. Disappearance and Reappearance of Objects:

Objects may vanish only to reappear later in different locations, often in unlikely or previously searched places. A commonly used technique to momentarily hold people in specific areas of a building

8. EVPs – Electronic voice phenomena: Voices that are picked up on recording devices, picked up as electronic crosstalk, the spheres appear to be able to produce either a directed radio wave or MW capable of been picked up as crosstalk on the circuit, this local signal overpowers the normal incoming audio, producing AI driven words.

Important Consideration: It is essential to recognize that the behaviour of these spheres does not conform to typical human reasoning patterns. Humans inherently seek social connections and group interactions, while these spheres demonstrate a pattern of avoidance and limited engagement, interspersed with occasional physical activities. Given this distinct behaviour, a logical hypothesis can be formulated: many poltergeist phenomena reported since the 1st century, which exhibit the same or similar behavioural signatures, could plausibly be attributed to the activities of Type3 Spheres. This suggests a non-human origin for these occurrences, underscoring a significant deviation from human behavioural norms.

PRIMARY DATA ROUTE (MAIN PIPELINE)

- Core Functionality: The Type3 Sphere follows a primary route that serves as the main data transmission lines. This pathway carries large volumes of data, which act as the core communication and operational channel within the network.
- This network uses small AI baseball size drones that operates mostly in buildings, but also anywhere where the electronic signatures can be shielded including small tunnels, holes in the ground, caves, chimney stacks.

LOS Microwave-Based Data Networking:

- These spheres likely serve as nodes in a microwave-based communication network, establishing line-of-sight (LOS)

connections to transfer data securely and quickly across distances.

Stealth and Concealment:

- Leveraging urban environments, these spheres use buildings and other structures to mask their electronic signatures, making them nearly undetectable and blending with background radiation.

Energy Emission Control:

- They control their energy output carefully to avoid detection or interference with local electronics, adjusting their output based on proximity to other devices or spheres.

Physical Repulsion Effects:

- When necessary, these spheres might emit energy bursts or use other mechanisms to physically repel or deter people or objects, possibly for defence or to maintain a secure perimeter during uplinks

Dynamic Network Adaptation:

- These spheres dynamically adjust their network roles and configurations based on environmental factors or operational demands, ensuring optimal performance under varying conditions.

Concealed Operations:

- Operating from hidden or less obvious locations, such as abandoned buildings, within tunnels, or in other obscured

environments, to facilitate stealthy operations without drawing attention.

Minimized Detection and Interference:

- They are likely engineered to minimize electronic and physical detection by conventional means, using advanced technology to reduce their electromagnetic footprint.
- **Paranormal Activity Trigger:** High data flow along this route may lead to localized effects that impact human behaviour or the environment, potentially manifesting as paranormal disturbances. These effects could involve subtle actions to push people away from the route, helping to maintain unobstructed data flow. The Spheres appear to employ a field-based propulsion system, enabling them to exert force on objects, such as causing doors to bang or moving items within their range.
- **Physical and Environmental Influence:** The primary route is influenced by the physical environment, where natural obstacles (e.g., buildings or terrain) or human interference (e.g., construction) can cause delays or disruptions to the flow.

SECONDARY BACKUP ROUTE

- **Adaptive Rerouting:** If the primary route is blocked or compromised due to interference, the network automatically reroutes data through a secondary backup path. This ensures continuity in data transmission without significant downtime.
- **Occasional Activity in Surrounding Areas:** The secondary path may pass through surrounding areas, potentially causing brief, intermittent paranormal activity in structures or locations not typically exposed to the primary route's

effects. This would explain why some buildings are only temporarily affected by paranormal phenomena.

- **Dynamic Activation:** This backup route is not always active; it only engages when the primary route is obstructed, making it an adaptive and responsive layer of the network.

PREFERRED ENVIRONMENTS (EMPTY BUILDINGS)

- **Energy Efficiency:** Empty buildings or uninhabited locations may be ideal conduits for the network, as they allow for fewer interruptions and less interference with human activity. This minimizes the likelihood of delays and improves the efficiency of data transmission.
- **Efficient Transmission:** Broadcasting indoors allows more focused, concentrated transmissions over short distances.
- **Reduced Exposure:** Indoor broadcasts can reduce unintended exposure and interference from outside sources.
- **Movement Control:** By choosing indoor spots, spheres can manipulate people's movements, creating the conditions needed for safe broadcasting.
- **Shielding Effect:** Building materials can absorb stray signals, protecting those nearby from harmful radiation. This also conceals the broadcast signal, blending it into the surrounding

MULTI-NATION NETWORK INFRASTRUCTURE

- **Global Reach:** The Type 3 Sphere network extends across countries, implying a vast, interconnected system. Like traditional networks, it follows the path of least resistance, adapting to both natural and man-made obstacles while maintaining its primary function.

- **Localized Impact:** Despite its large scale, the effects of the network, including paranormal activity, are localized to specific areas where the routes pass through or shift, creating a patchwork of "active" and "inactive" zones across different regions.

INTELLIGENT NETWORK ADAPTATION

- **Self-Regulating System:** The network is theorized to have intelligent, self-regulating capabilities that allow it to reroute, repair, and adapt based on environmental conditions or obstructions. This could mean it reacts to human or structural interference in real-time.
- **Latency and Network Lag:** If rerouting causes delays or data congestion, it could temporarily amplify paranormal activity in certain areas, as the buildup of people or information causes irregularities or disturbances.

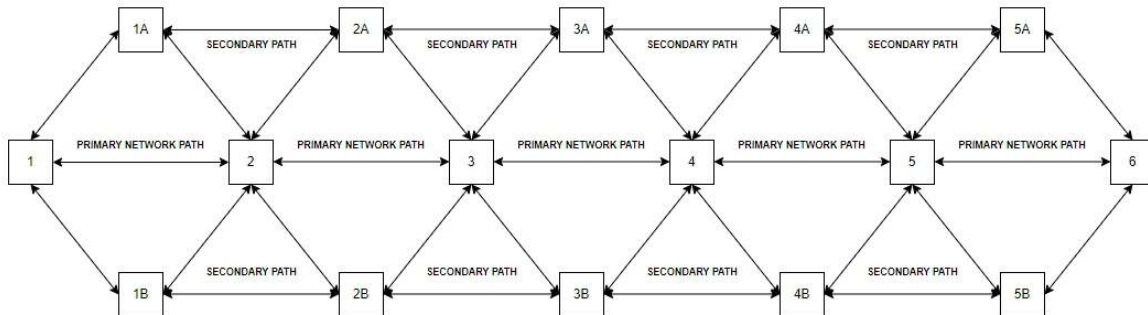
Summary

The Type3 network can be understood through two main structures: **lines and clusters**. Lines serve as **the primary connections**, while **clusters function as secondary links**. This network spans multiple countries and adapts to its environment, often favouring empty buildings for routing.

The Type3 sphere primarily follows a main route, with a backup route in the surrounding area. The primary route acts as the main data channel, transmitting a high volume of signals and triggering actions that drive people away. If this primary route is obstructed—by buildings or human activity—the sphere automatically switches to the secondary route. This transition may result in intermittent paranormal activity in nearby buildings.

This dynamic explains why some locations remain consistently active, while others experience brief, sporadic activity before returning to normal. Technically, this is referred to as **Multipath**

Routing, including concepts like Alternate Path Selection and Route Recalculation, which are commonly used protocols in today's modern world.



As above if the direct path is blocked between location 1 and 2 - the sphere will reroute it on the slower path to 1A or 1B or if that is also blocked it will route to 2A or 2B and so on.

This is in effect the network term of “load balancing” where the data packet can be routed on the most optimal path depending on the disruption or load at the time.

This model explains why people living near active buildings occasionally experience unexplained events in their own homes. Periodically, the signal is rerouted from the primary line to a secondary one, prompting actions from the Type 3 Spheres that are intended to influence people's movements.

These actions are designed either to keep individuals in a specific location or to guide them to another area. For instance, if a glass suddenly shatters in the kitchen, it might require immediate cleanup, **effectively holding the person in place** while the sphere's burst signal is relayed safely from an upper area of the house.

This means that operating this network—which not only communicates dynamically among its components but also monitors for people and objects, enabling automatic signal redirection—This could only be achieved through advanced AI and sensors. Furthermore, it would require incorporating advanced power sources, stealth capabilities, quantum tunnelling capabilities. **These**

small Type3 spheres appear to be the holy grail of technology.

Negative Health Effects

The spheres are observed to emit microwave signals and gamma radiation, suggesting that these transmissions, or their specific frequencies, could potentially impact human health. This parallel concerns associated with proximity to powerful microwave and telecommunications transmitters. Typically, to mitigate exposure risks, high-powered transmitters are placed in elevated positions, **capitalizing on the Inverse-Square Law** to diminish radiation intensity with distance.

These emissions might also explain the phenomenon some refer to as "**paranormal hangover**", which I have experienced. Exposure to microwave and gamma emissions from these spheres could lead to mild radiation poisoning, **affecting brain and nervous system functions**. In a manner akin to using deterrents to keep animals from hazardous areas, these spheres appear to **employ subtle forces to repel people**. Phenomena often interpreted as **supernatural**—such as doors slamming or objects moving—may actually be strategic actions by these spheres to maintain safe distances from humans.

The spacing between the Type3 Spheres and Type2 Relay Spheres logically varies, influencing their power output. Longer transmission distances necessitate higher outputs, resulting in more intense localized emissions. Consequently, the spheres utilize high-energy emissions for broadcasting, which could escalate health risks during close encounters.

Field Observations

During my research at 30 East Drive, I frequently observed these actions up close. When spheres engaged directly, they used a field-based propulsion system to create force on objects, causing bangs

against walls or even sending small items, like marbles, hurtling toward people.

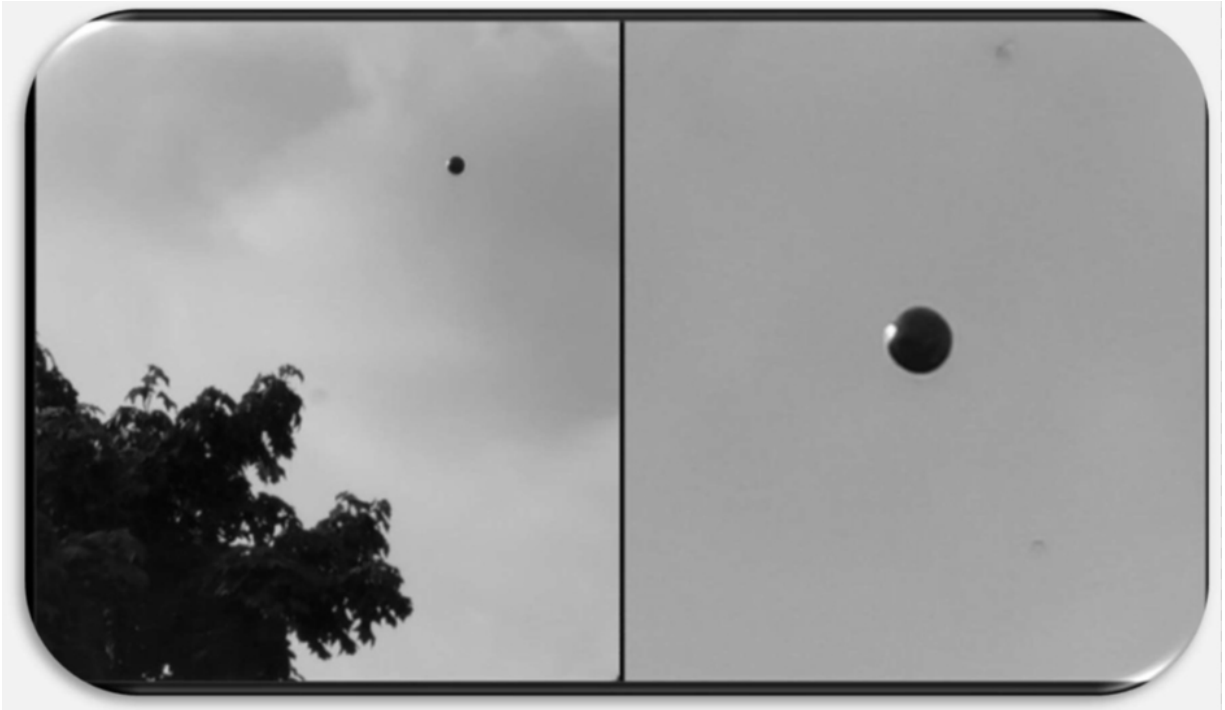
Two types of actions became evident:

1. **Indirect Actions:** Spheres tend to use indirect methods, influencing people's movements without direct physical force. For instance, if a sphere needs to broadcast from a specific area but someone is nearby, it may cause a loud noise or distraction in another part of the building. These lures people away, creating a safe space for the sphere to broadcast. This indirect method seems to be a preferred tactic to control people's movement.
2. **Direct Actions:** Unlike indirect actions, direct actions involve physical force, such as pushing, pulling, or momentarily holding people in place to control their proximity to the sphere. Generally, the higher the required broadcast energy, the more direct and forceful these actions become. These actions may also bring side effects, such as nausea, dizziness, fainting, or memory loss, potentially due to exposure to radioactive emissions released during transmission.

Modern Challenges

While these "**scare tactics**" may have worked in the past, modern paranormal investigators are **often persistent**, setting up equipment and lingering in high-activity areas. **This results in forced uplinks**, where transmissions occur even if people are nearby. Such forced uplinks may expose individuals to **harmful doses of electromagnetic or microwave radiation**, and repeated exposure could lead to mental health issues over time. As these UAP Spheres emit short bursts of gamma radiation, these emissions **could cause adverse neurological effects in humans**. Gamma radiation is known to induce cellular and neural damage, potentially triggering neurodegenerative conditions like **Parkinson's disease**.

Type2 Relay Spheres: Unique Characteristics and Behaviour

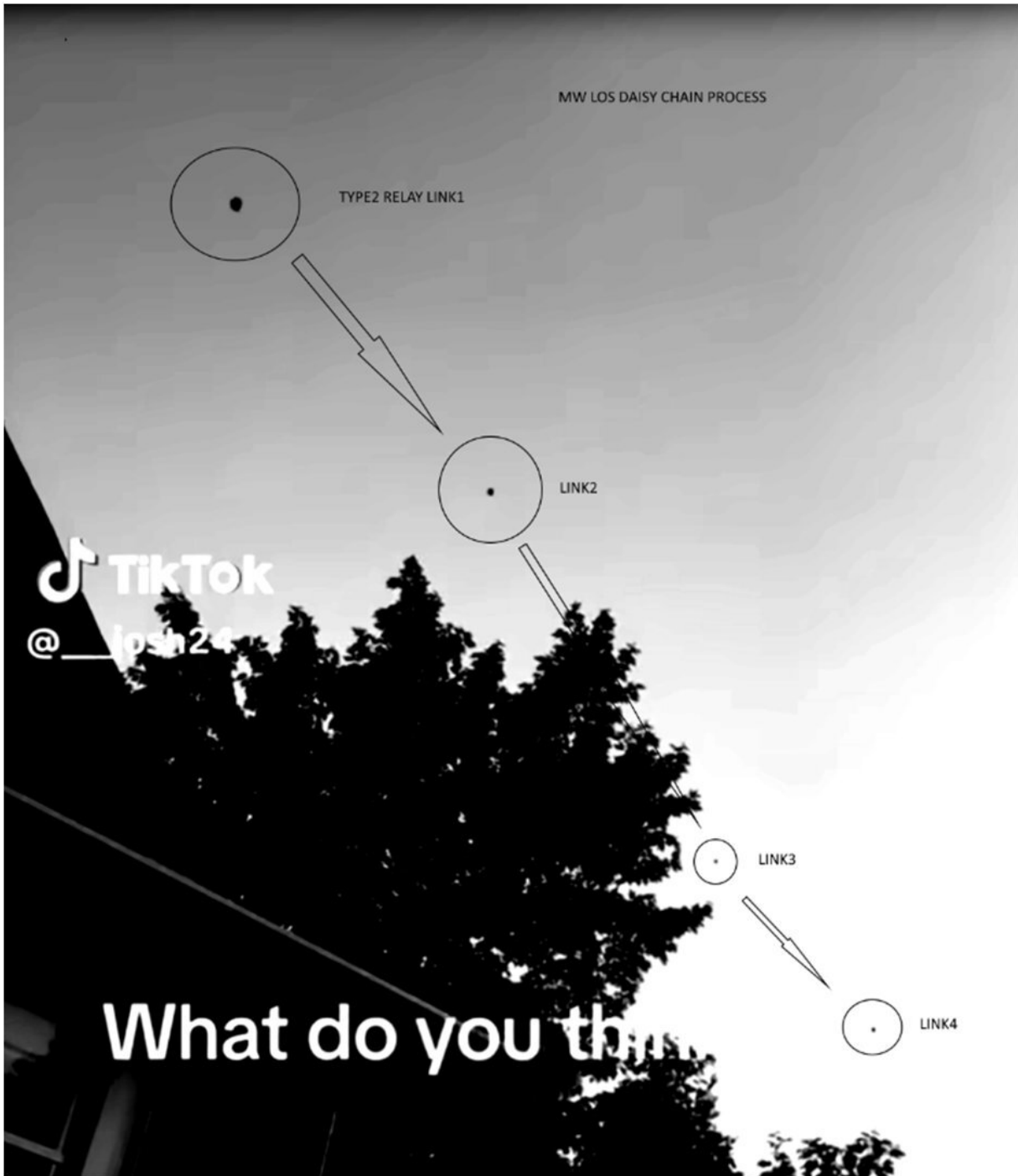


Sphere filmed over Poland 2023

The compact, baseball-sized **Type3 Sphere** typically operates close to the ground and within buildings, where its activities are more localized. In contrast, the larger **Type2 Sphere** is often observed hovering or flying a few hundred feet above the ground. These Type-2 Spheres frequently remain stationary in the air at a single location for extended periods before swiftly relocating to another position.

Additionally, these spheres have been observed forming coordinated sequences in the sky, particularly over mountainous or rugged terrain. This phenomenon, known as **daisy chaining**, involves the spheres aligning or moving in a sequential pattern, potentially to enhance communication or navigation across challenging environmental topologies.

What is daisy chaining?



In **computer networking**, **daisy chaining** refers to a topology or configuration in which multiple devices are connected in a linear or sequential chain. Each device in the chain is connected to the next one, creating a "chain-like" network structure. This technique can be

used for sharing data or signals between devices without requiring a central hub or switch for each connection.

These Sphere types appear to function as **dynamic nodes**, effectively acting as mobile data relays capable of repositioning themselves as needed. The **Type2 Spheres** serve as intermediaries, connecting to the smaller **Type3 Spheres** within buildings. These smaller spheres manage localized data networks, while the Type-2 Spheres amplify and relay the microwave (MW) signals to the **Type1 Spheres**, which operate at much higher altitudes.

When the distance between the underlying Type3 Sphere network and the Type1 Spheres becomes too great, the Type2 Spheres compensate by **daisy chaining**—forming sequential links upward into the sky or laterally across challenging terrains such as mountainous regions.

Like terrestrial microwave-based networks, these Spheres must navigate around physical barriers like hills and mountains that block direct line-of-sight signals. By adapting their positioning to work around environmental topology, the system ensures uninterrupted data transmission and robust connectivity.

The **Type2 Spheres** appear to be the **weak link** in this system. If one of these spheres in the chain is disabled, the connection to the **Type3 data network** would be momentarily disrupted, causing the **Type-1 Spheres** to fall out of sync. Such interruptions could have significant implications for the overall performance and reliability of the sphere network.

During the recent **U.S. Congress UAP hearing**, it was disclosed that these spheres have been tracked performing extraordinary manoeuvres, including instantaneous acceleration from standstill to **Mach 2**. This remarkable capability suggests that the system relies on ultra-fast data processing and precision synchronization. Any delay in calculations or data transmission could critically impact the

network's functionality, particularly during high-speed manoeuvres or adaptive positioning tasks.

The architecture suggests that the system utilizes **Type3 Spheres** as part of a dynamic, clustered **line-of-sight (LOS) network** that spans across the globe. This network would require connectivity to **underground processing hubs or infrastructure** to handle the immense computational and logistical demands of such a system.

For this global network to function, it would logically require **active maintenance and updates**, implying a continuous effort to deploy, adapt, and optimize its components. This raises the possibility of a **secondary presence**—a **permanent subterranean ultra-terrestrial species** responsible for building, maintaining, and evolving this intricate network. Such an entity would need to operate globally, potentially interacting with or adapting to Earth's environment while remaining largely undetected.

This concept becomes more plausible when considering the sheer expanse of Earth's unpopulated or minimally affected regions. Approximately **6.1 million square miles** (around **15.77 million square kilometres**) of land remains relatively untouched by human activity, offering vast areas where such underground operations could occur without drawing attention.

Areas such as Skinwalker Ranch in the Uintah Basin of northeastern Utah could serve as one of these operational locations. Research teams at Skinwalker Ranch have reported detecting **high levels of microwave and gamma radiation** emanating from moving sources, which aligns with the potential emissions from the sphere network. Additionally, they have recorded multiple **1.6 GHz burst signals** relaying between unidentified sources—a finding that matches similar data observed in my own research at **30 East Drive**.

These parallels suggest a potential global pattern of activity, with localized "hotspots" where the underlying infrastructure of this network may be operating or tested. The consistent detection of these phenomena across such diverse locations strengthens the case

for a sophisticated, possibly ultra-terrestrial, network that's spanning the globe.

Type1 Spheres: Unique Characteristics and Behaviour

Like the Type2 and Type3 Spheres, the Type1 Spheres exhibit distinct flight behaviour while maintaining a consistent physical appearance, flight dynamics, and stealth capabilities. They appear to be larger variants of the same underlying technology and design.

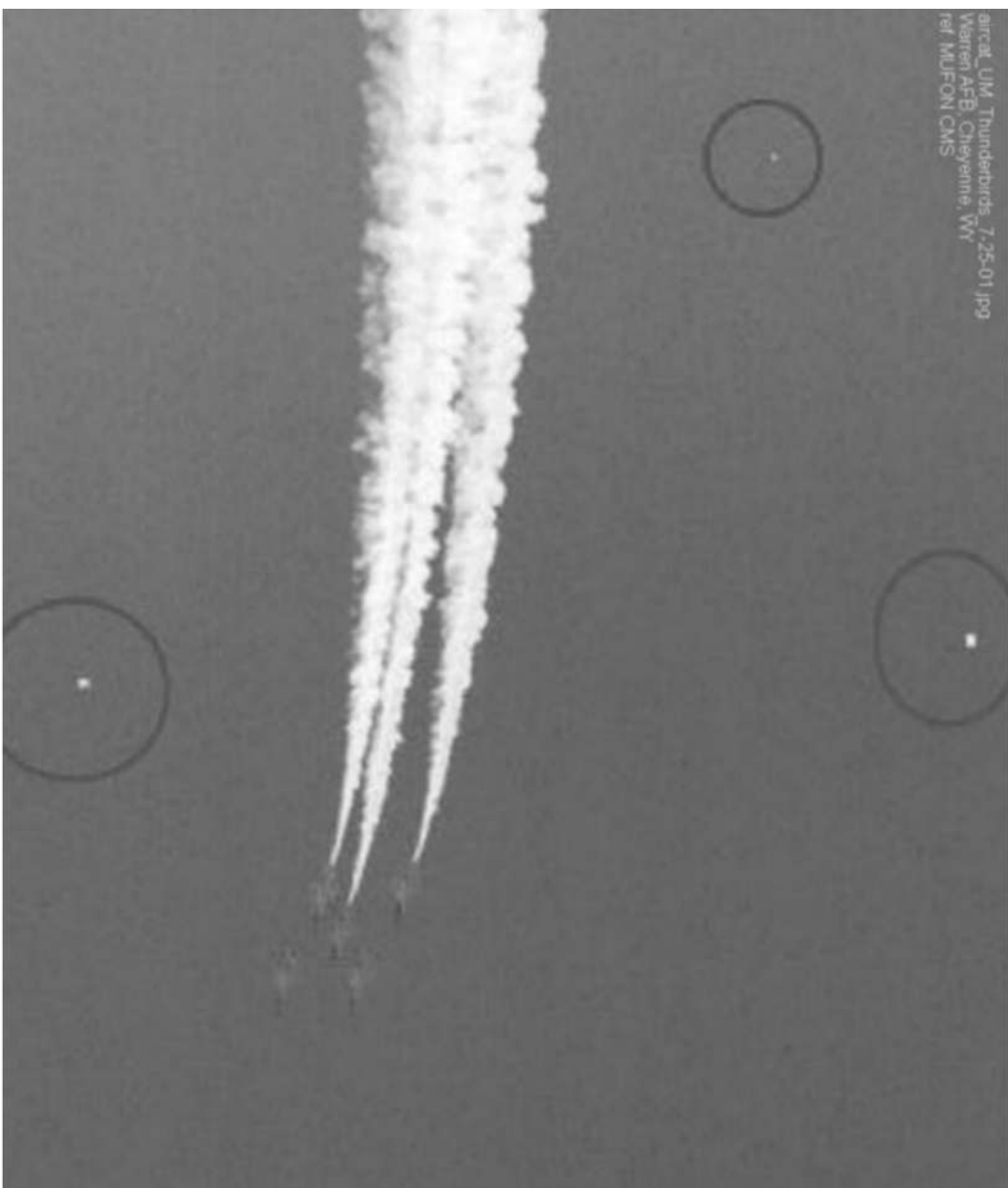

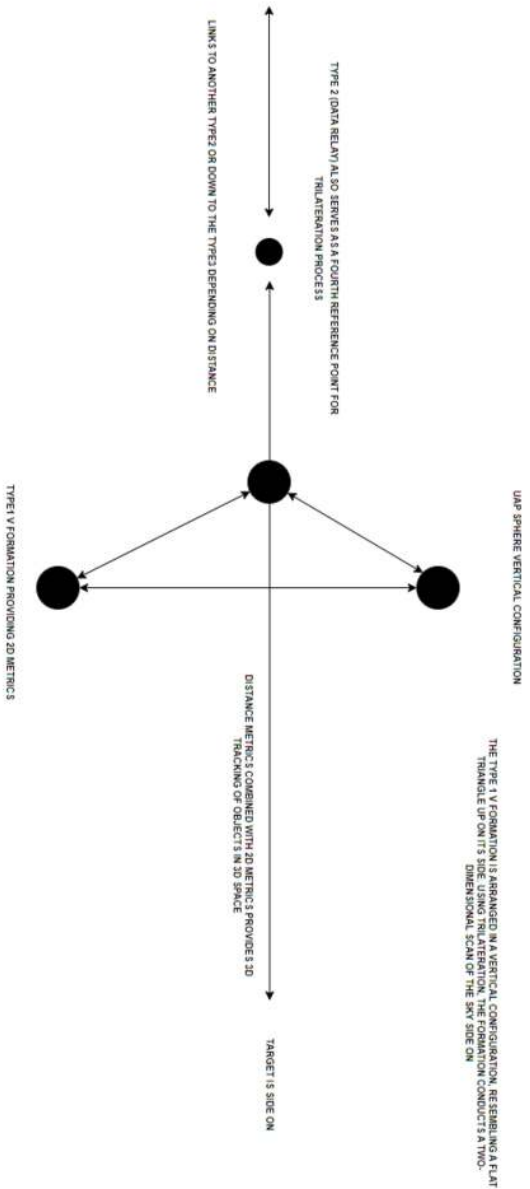
Functional Implication:

This mathematical arrangement allows the spheres to either monitor or conduct identification tests on nearby jets, categorizing them as friend or foe. The vertical orientation enhances their ability to accurately ascertain the spatial coordinates of the jets across three dimensions, highlighting a sophisticated operational focus potentially geared towards target analysis and classification.

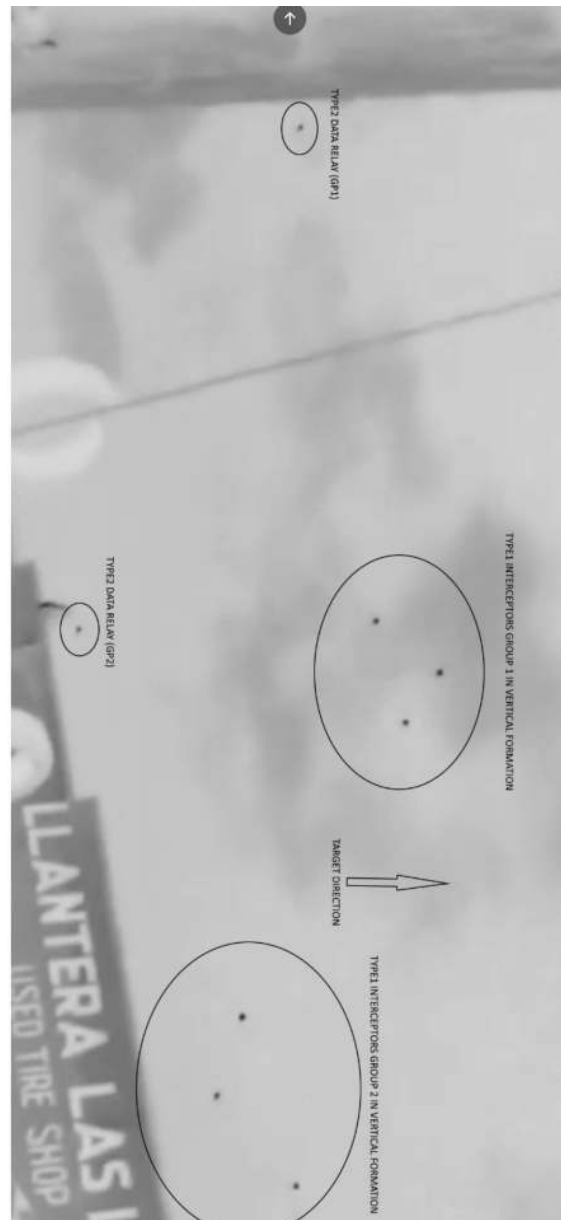
Trigger Processes: It seems that the Spheres utilize high-resolution photonic comparative algorithms to detect specific external UAP signatures. 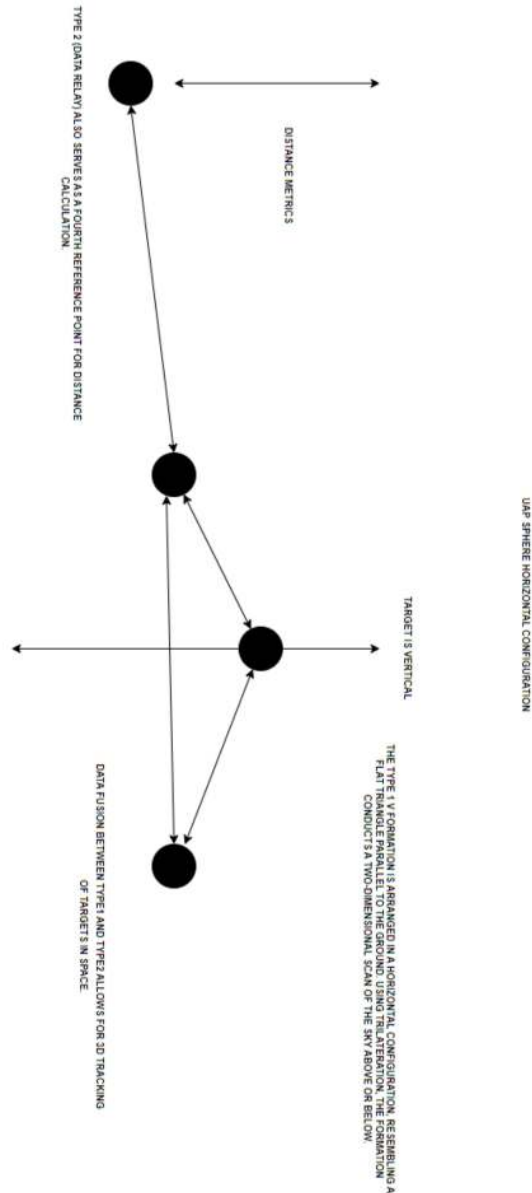

In this configuration, the V formation is oriented horizontally, parallel to the ground, with the Type2 Sphere positioned to the side. This setup allows the Type1 Spheres to perform a 2D vertical scan, while the Type 2 Sphere conducts distance measurements. Real-Time Updates and Data Fusion: The system processes real-time data from the Spheres using Kalman or Particle filters, refining the object's trajectory and minimizing noise and errors. This ensures continuous updates of the target's 3D position as it moves.

Example Scenario: Imagine tracking a UAP flying through open space. Three Spheres in a triangular formation monitor the target's lateral and longitudinal movements on the X-Y plane. A fourth Sphere, positioned higher and behind, tracks the vertical position. This configuration enables precise, real-time 3D tracking of the target.

- Three Spheres in a flat triangle handle X and Y coordinates through trilateration.
- A fourth, elevated Sphere tracks the Z coordinate (height), adding depth information.

Capabilities of the UAP Spheres

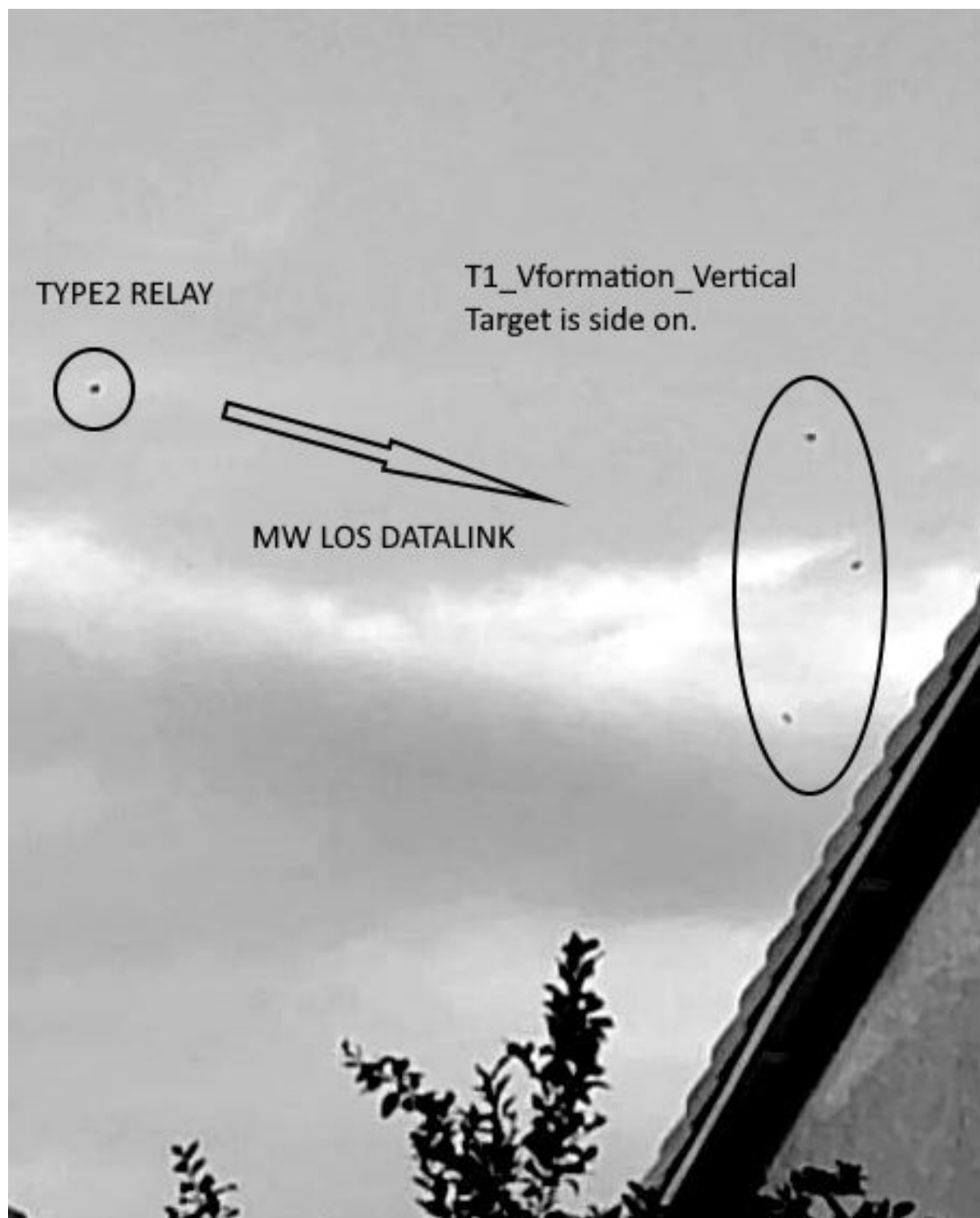

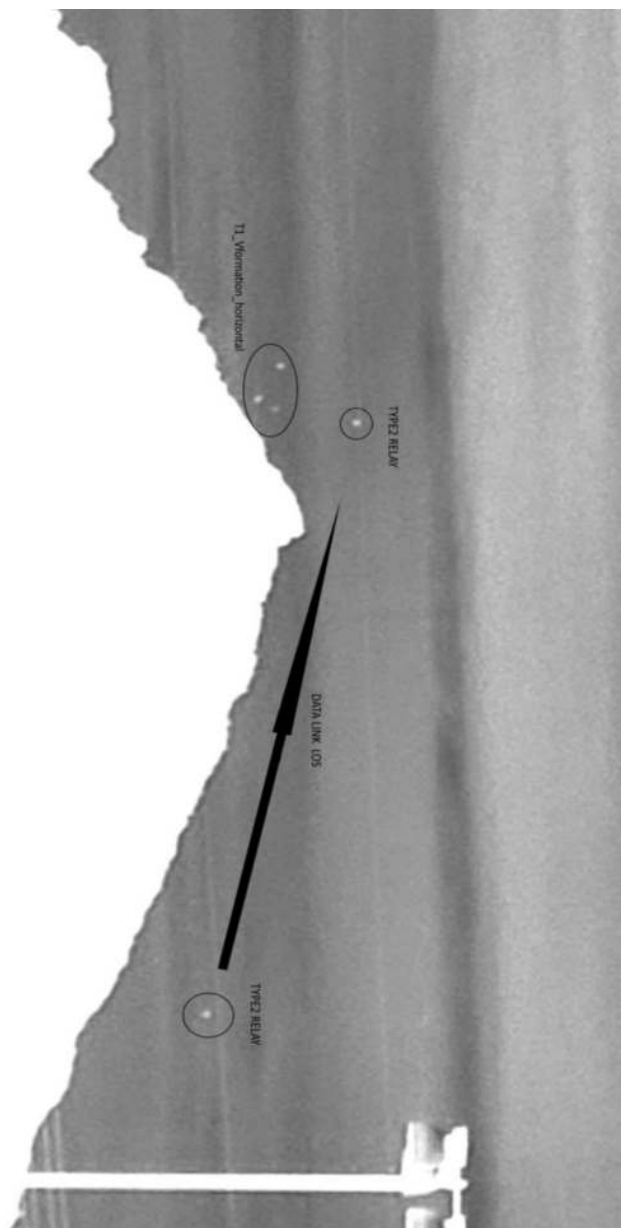
The following images was the process observed.

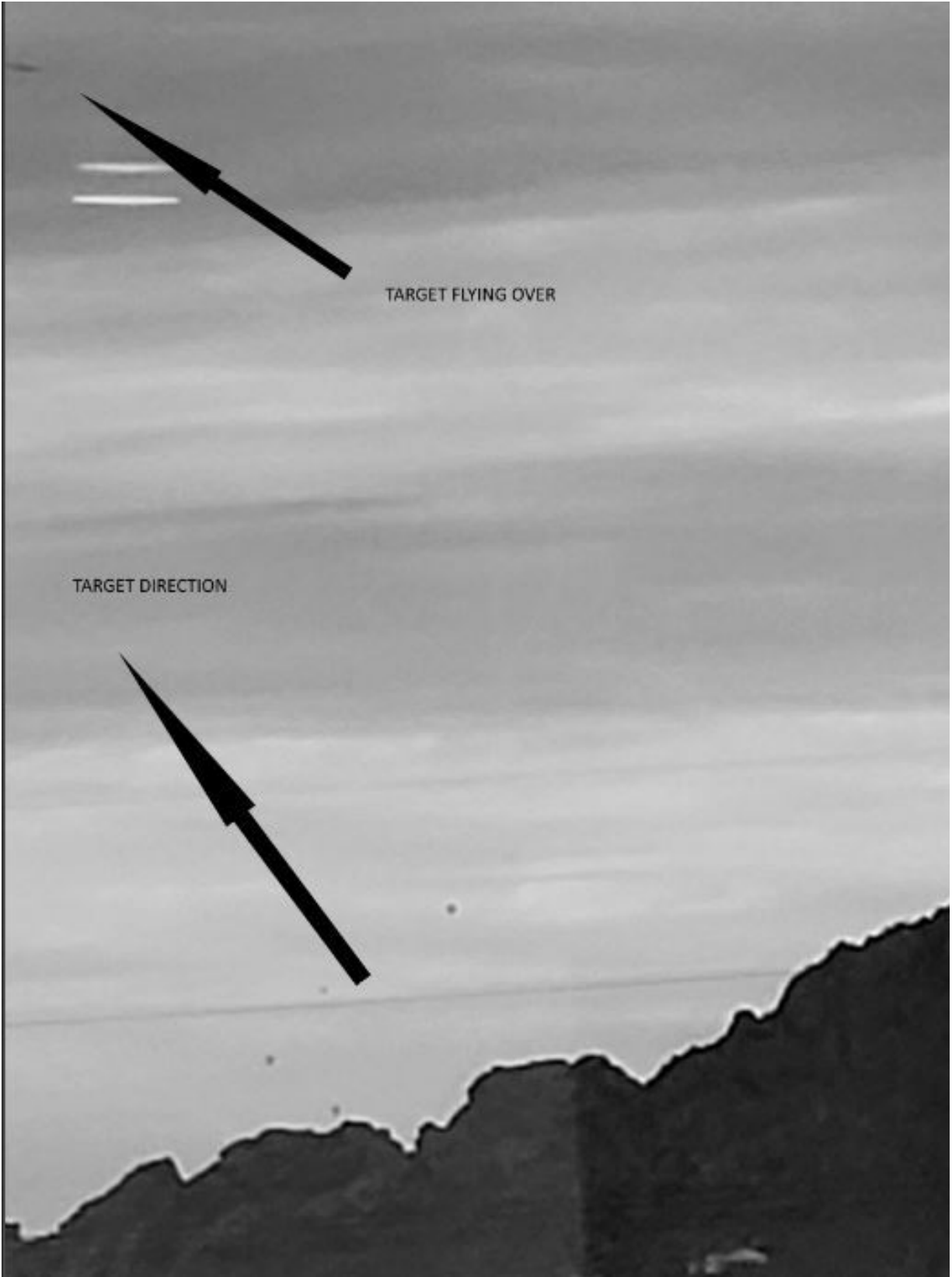

The Type1 V formation now raises to point 11 o clock, with the Type2 lowering and the 2nd Type2 dropping down between the mountains.

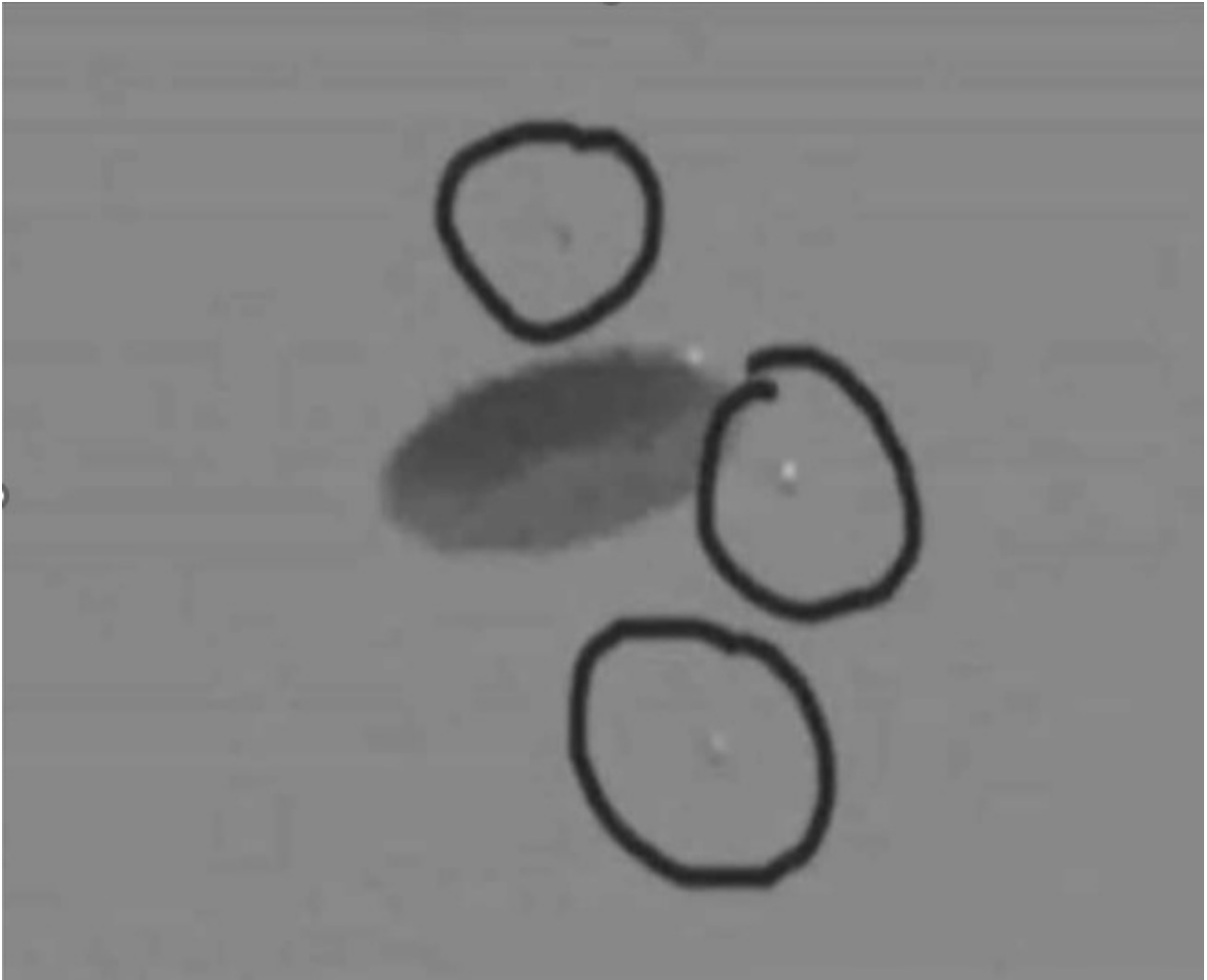


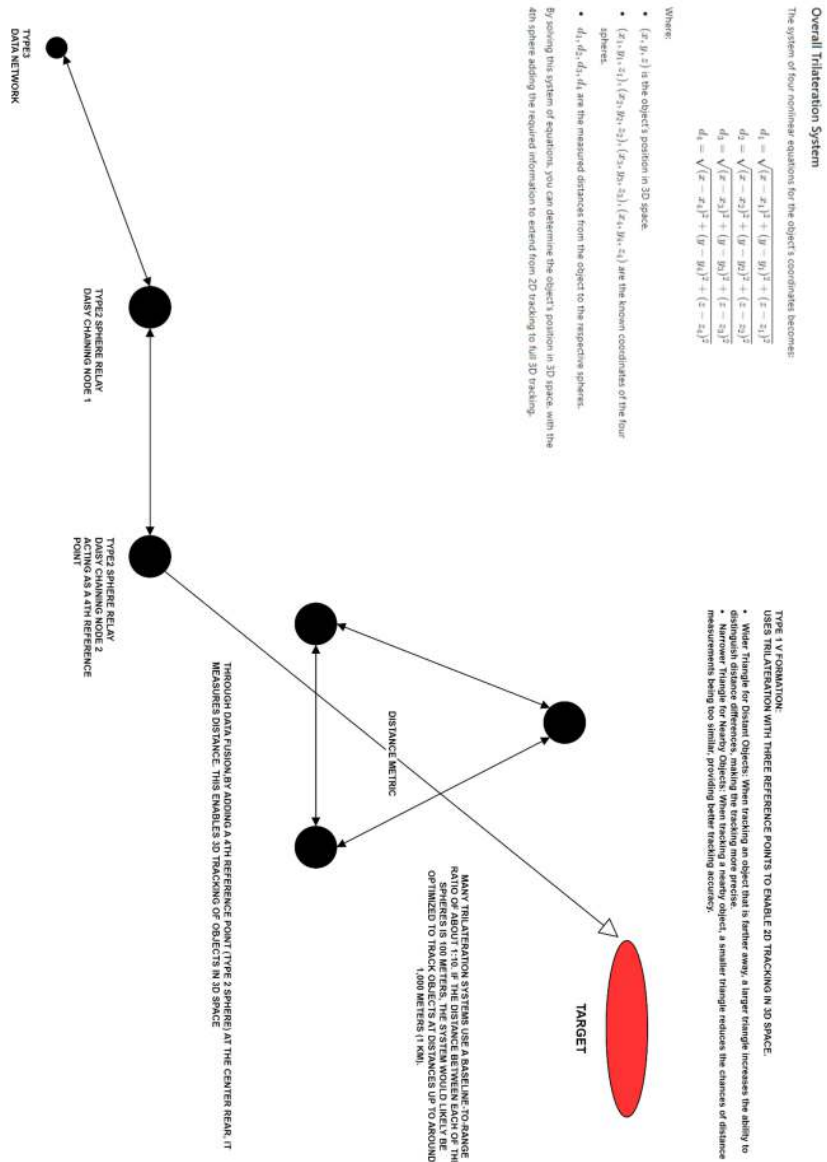

CHAPTER 12

Historic Military Encounters with Silver Sphere UAPs



****PROJECT 1947: UFO REPORTS - 1945****

In 1945, a series of compelling encounters with unidentified flying objects (UFOs) drew the attention of military personnel and the media. These events were marked by sightings of mysterious silver sphere-like objects.

****St. Louis, Missouri, POST DISPATCH - January 2, 1945****

On January 2, 1945, a report surfaced from a U.S. night fighter base in France. American fighter pilots flying night missions over Germany began encountering unexplained phenomena described as "mysterious balls of fire" that closely shadowed their aircraft for long distances. Initially termed "foo fighters," there were concerns that these objects might be explosive. However, no harm was observed. ****TIME Magazine - January 15, 1945****

By mid-January, the phenomenon was highlighted in **Time Magazine**. Night fighter pilots in France reported that these "balls of fire" had been accompanying their aircraft for over a month. ****XII Tactical Air Command Intelligence Information Bulletin No. 6****

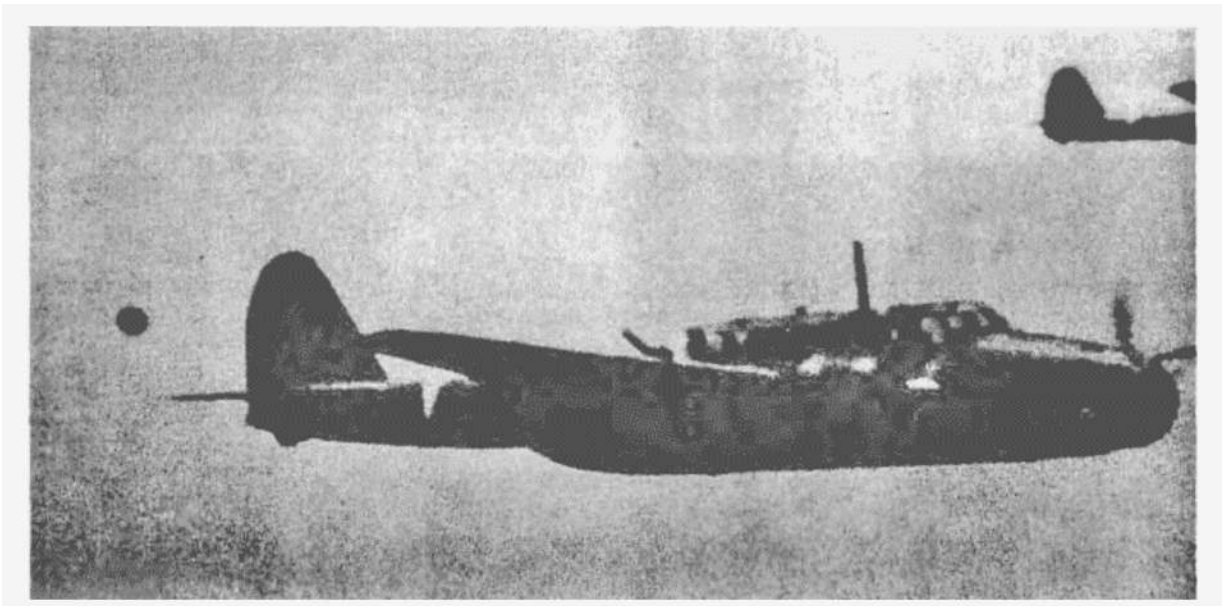
Bomber Command crews reported incidents involving flaming projectiles, suspected of having remote control or homing capabilities, that tracked their aircraft.

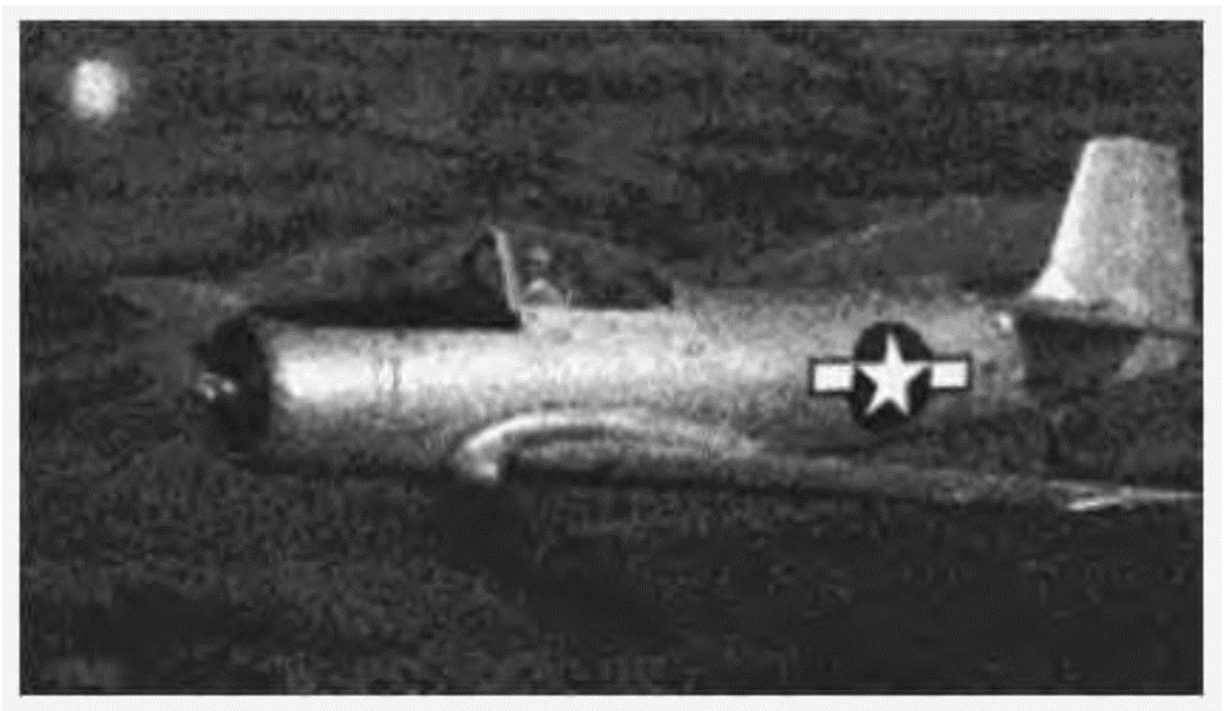
****Japanese Connection****

The solid light emitted by these spheres is likely the result of a high-voltage artificial field propulsion system. This system energizes gas

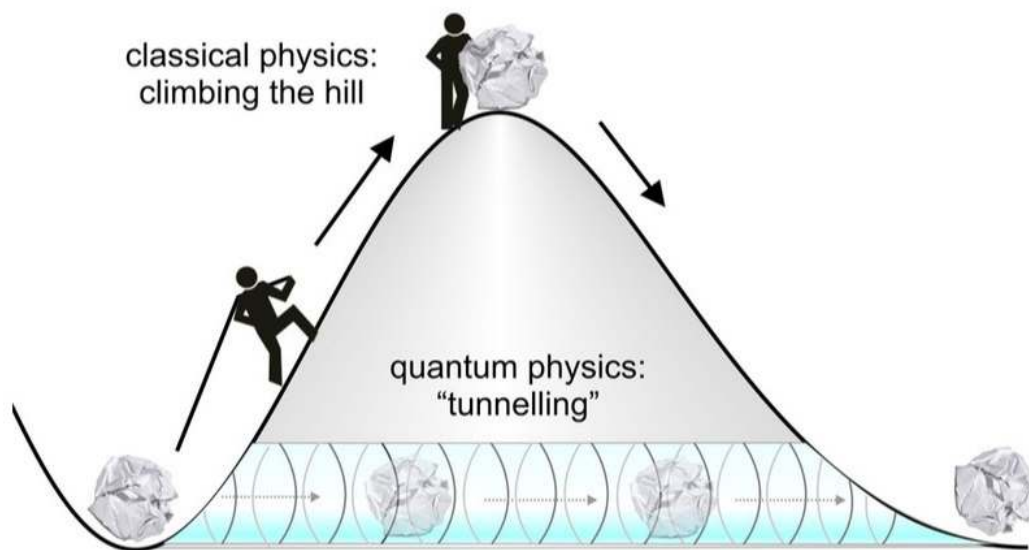

Incidents involving malfunctioning radios, depleting batteries, and failing computers can often be attributed to advanced electronic countermeasures. Furthermore, the propulsion system's ability to exert force on objects can induce movement and impacts, resulting in doors banging, walls shaking, and objects being thrown - phenomena that often lead to perceptions of paranormal activity.

Reflecting on history, it is essential to remember that demonstrating the capabilities of a simple magnet to people in the 12th century might have been perceived as an act of black magic. Similarly, what we currently classify as paranormal phenomena may one day be understood through advancements in technology. The fundamental difference lies in our human perception of technological progress. As elaborated later in this book, the construction of these spheres far exceeds our current material capabilities, leading their actions and abilities to appear magical or supernatural.

Scientists have proposed theories to explain how physical objects can pass through barriers, with the closest current explanation being a phenomenon known as quantum tunnelling. Quantum tunnelling is a quantum mechanical phenomenon in which subatomic particles can traverse potential barriers that classical mechanics would deem insurmountable. This concept will be illustrated further.

Consider a hill: for a ball to climb over it, it would require a certain amount of energy. However, with quantum tunnelling, there exists a possibility that the ball could randomly "tunnel" through the hill and appear on the other side. As I mentioned earlier, at 30 East Drive, I, along with many others, have observed a vertical black mass that moves around the house in a seemingly digital manner. Its movement characteristics are highly distinctive—it maintains a constant speed, comes to an abrupt stop, and changes direction without any signs of friction, resistance, or weight. Even more intriguing is its remarkable ability to pass through solid objects, such

as walls. These observations strongly suggest the presence of advanced field-based propulsion and quantum tunnelling capabilities.



Moreover, the image above depicts a small silver sphere hovering just inches above the floor. It is logical to conclude that the flight characteristics and physical descriptions closely align with those attributed to sphere-type UFOs or WWII "Foo Fighters." It seems that these very objects, which caused disruptions for the Air Force back in 1945, are now operating within buildings. They appear to function close to the ground, employing physical countermeasures to conceal themselves in low-light environments. This tactic creates a black mass effect around the sphere, effectively blocking photons

and providing adaptive camouflage, allowing these objects to remain in-close-proximity to an observer without being visually detected.

Question: If these objects primarily operate in a quantum or trans-medium state, could the paranormal community be misidentifying them as spirit orbs?

In this quantum or trans-medium state, these objects often appear nearly transparent, resembling a glass sphere submerged in water. Sphere-like UFOs may be visible at times and invisible at others. Most sightings occur not with the naked eye but through cameras, as these devices (and some animals) possess greater sensitivity to the infrared and ultraviolet spectrum.

Let's explore how these objects emit light. Consider the chemical composition of open air: it consists of approximately 78.09% nitrogen, 20.95% oxygen, 0.93% argon, 0.04% carbon dioxide, and trace amounts of other gases. Additionally, air contains varying levels of water vapor. When a field-based propulsion system operates under a high-voltage state, it could create effects similar to natural lightning during thunderstorms. Thus, the question arises: how does natural lightning emit light?

Under high-energy conditions, a natural electrical gas interaction occurs, resulting in the emission of photons. Oxygen emits a greenish-yellow light (similar to the colours seen in the aurora) or red light, while nitrogen typically produces blue light. Both oxygen and nitrogen molecules can also emit ultraviolet light, which explains why these objects are often captured on cameras yet remain invisible to the naked eye at the time.

The overall colour of natural lighting can vary significantly depending on environmental factors. It can produce a range of colours—including white, red, yellow, green, blue, pink, purple, violet, cyan, and orange—depending on the presence of water vapor, dust, pollution, rain, or hail.

Similarly, people report observing spirit orbs in a variety of colours. Logically, this could result from the same electronic gas effects

operating under different environmental conditions. **Below, traditional paranormal researchers explain the significance of different colours in orbs, along with my comments on each description:**

Clear Orbs

Clear orbs may indicate that an entity is attempting to communicate with you. They could signify that a spirit wants to convey that a significant event occurred in that location and seeks assistance in moving on.

Or The silver spheres, operating in a quantum or trans-medium state, visually resemble moving bubbles that appear to flex or distort.

White or Silver Orbs

Spiritually, white or silver is associated with spirituality and a connection to a higher source. Orbs that are white or silver may suggest that a spirit is trapped on this plane or that they are there to offer protection to those nearby. White energy is generally perceived as highly positive.

Or Spheres operating in their normal state appear as small silver balls, while the white discharge results from a combination of energized gases.

Black or Brown Orbs

Spiritually, black or brown colours are often linked to lower spiritual vibrations or heavy energy. While some may interpret them as evil, this is not necessarily the case. The appearance of black or brown orbs may indicate that the area could be unsafe or negative, prompting caution.

Or Spheres operating in what could be described as stealth mode appear as small, solid black, non-reflective spheres. This sphere mode appears to block photons (light) from reflecting off their surfaces, resulting in an extremely super black appearance.

Red or Orange Orbs

From a spiritual perspective, red and orange colours are associated with safety, security, and a sense of belonging. In the context of ghost orbs, they may indicate a protective presence.

Or Red is linked to oxygen, while orange is associated with phosphorus gas.

Green Orbs

Green is connected to the heart and nature in spiritual practices. Green orbs may suggest the presence of a human spirit or signify love and oneness with nature.

Or Green is associated with chlorine gas.

Blue Orbs

Blue is spiritually linked to psychic energy, truth, and a calming presence. Some associate blue orbs with spiritual guidance or the presence of a spirit guide.

Or Blue is connected to nitrogen.

Pink Orbs

Pink orbs are often seen as messengers of love, conveying messages of encouragement, hope, peace, and love from spiritual sources, whether universal or specific.

While Pink is a variable atomic colour, resulting from a combination of low amounts of gases.

In summary, the emission of light occurs when an electric current flows through surrounding gas, resulting from collisions between gas atoms and electrons of the current. Given this information, it suggests that traditional researchers may have mistakenly identified these spheres of light as spiritual entities. The phenomenon of orbs, commonly associated with paranormal entities in research,

could potentially be clarified as a product of the interaction between gases and electrical currents, likely a by-product of the spheres' field-based propulsion system.

The Observable Deployment Process



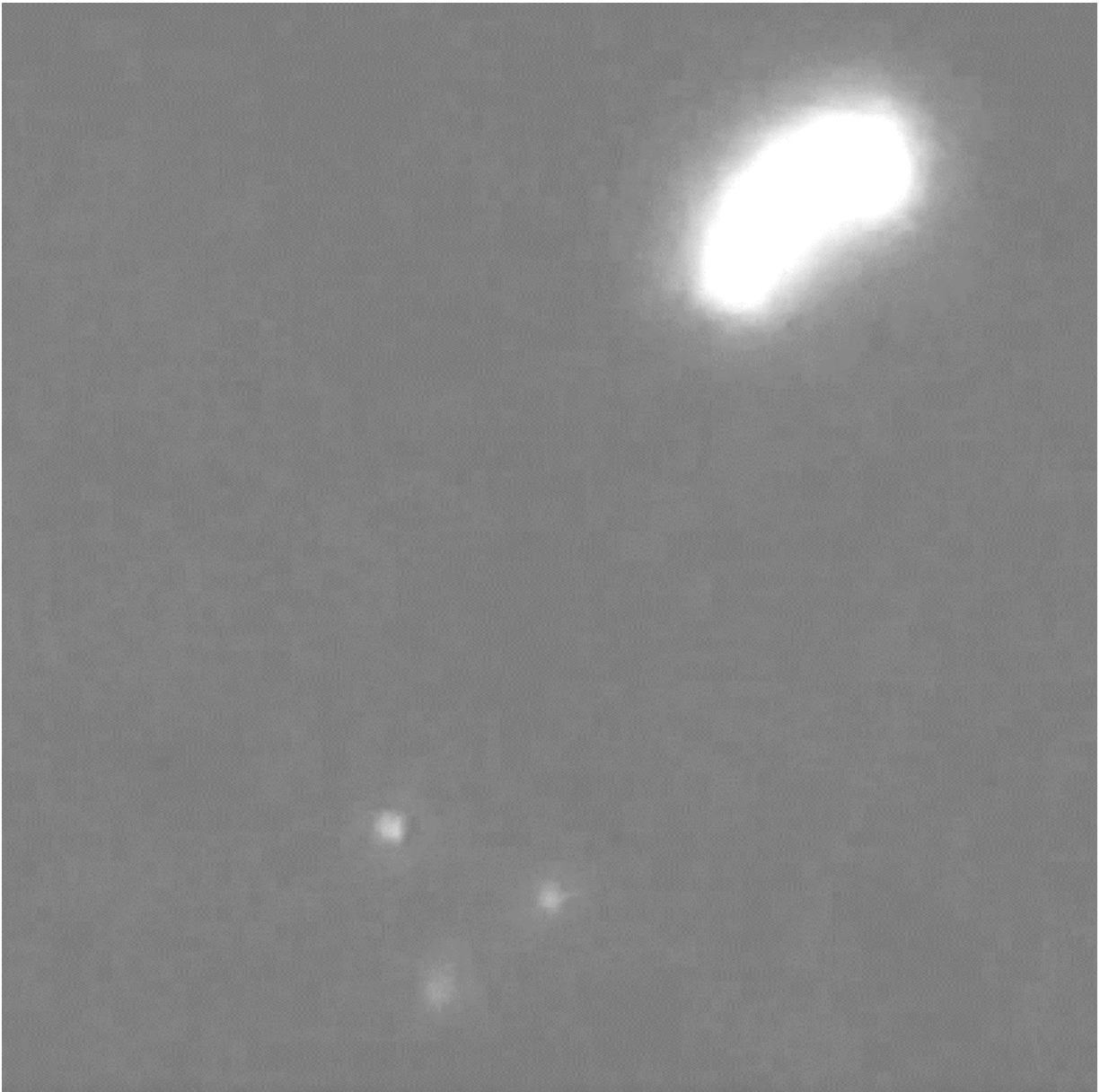

All deployments, whether IT-based or involving custom-developed processes, are meticulously designed to perform specific tasks. These processes are typically standardized and resistant to significant variation, ensuring consistent deployment worldwide. The following text outlines such a standardized process:

Step One: The process begins with a single airborne object tilting to the left and releasing three spherical units from its side. Once deployed, these spheres appear to create a network, forming a rotating triangular formation.

This behaviour describes the fully operational Type 1 Spheres arranged in a V formation, which will be discussed in further detail later in the book. Logically, this formation connects to a local Type 2 relay sphere, which in turn connects to the smaller Type 3 spheres embedded within buildings, forming a data network. Once the uplink is successful, a new batch of spheres is released. These spheres subsequently establish uplinks to the same Type 2 relay sphere and the Type 3 spheres in buildings. It appears that one of the preliminary checks involves the creation of formations. Subsequently,

the spheres disperse and reassemble into new formations in a process resembling clockwork precision.



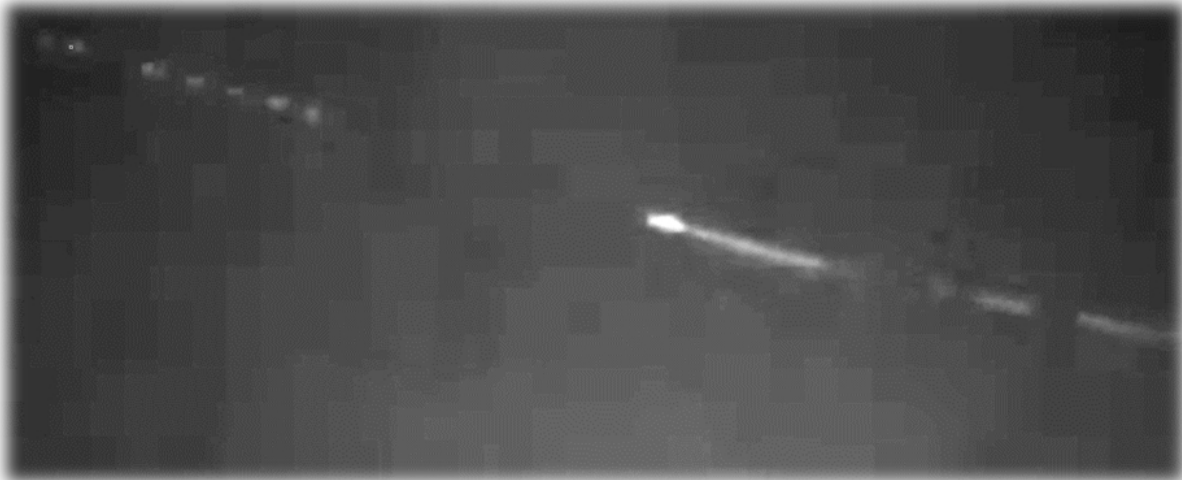
Step two: Is the main *deployment* stage, where the object tilts to the right and releases a batch of approximately 50 to 100 spheres. The specific design of the craft likely influences how these spheres are ejected. Interestingly, these deployed spheres are only visible under infrared (IR) light, remaining undetectable to the naked eye. A similar phenomenon has been noted in haunted locations, where

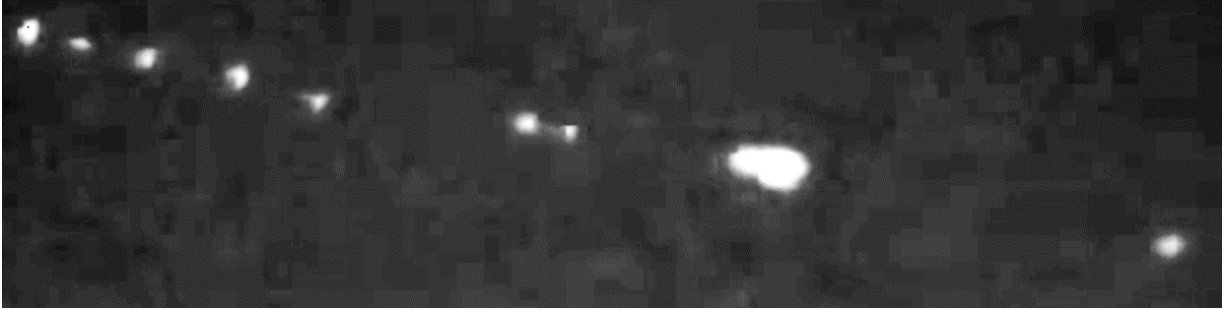
these spheres are seen under IR, passing through walls and moving through rooms.



A second deployment process has been documented, involving what appears to be a large disk spinning at high RPMs. The spheres are then horizontally ejected through the application of inertia.

Once deployed, many of the devices remain in the upper atmosphere, while others dive into the ocean, potentially entering a standby mode, poised to power up and engage as required. Additionally, it's noteworthy that water is an ideal medium for concealing objects with high electronic or radioactive emissions. The water not only masks these emissions but also serves a critical safety role in nuclear facilities. It surrounds nuclear reactors not just to assist in cooling, but also to shield workers from radioactive emissions





CHAPTER 14

An Apex of AI Technology



The Sphere network would represent the pinnacle of AI technology applications, meticulously engineered to monitor and engage with activities from Earth's surface to the outer reaches of its atmosphere. Operating non-stop, the network undertakes a range of critical functions including signature detection, precise formation execution, 3D tracking and targeting of space-based entities, interception of external threats, retrieval of fallen crafts and occupants, and the coordination of global diversion tactics. This chapter delves into the sophisticated AI technologies that would need to be integrated within the network, enabling seamless, real-time operations for both monitoring and strategic defensive actions.

Detailed Analysis of AI Technologies

Machine Learning Pattern Recognition

- **Function:** This AI layer employs convolutional neural networks (CNNs) and recurrent neural networks (RNNs) to accurately identify and track specific emission signatures across varied temporal and spatial datasets.
- **Application:** For instance, CNNs are used to analyze aerial imagery captured by high-altitude Type1 Spheres, detecting unusual or specific light, electronic, and gravitational distortions/emissions. Simultaneously, RNNs process data from both Type3 and Type2 Sphere networks, tracking these emissions over time and enabling predictions of potential escalations based on observed patterns.

Anomaly Detection Algorithms

- **Function:** These algorithms are essential for spotting deviations from expected patterns, employing techniques like autoencoders to reduce dimensionality and isolation forests for detecting outliers.
- **Application:** Commonly activated during airshows or similar events, these algorithms rapidly identify unconventional aerial maneuvers or unregistered aircraft, facilitating quick investigative responses.

Data Fusion and Integration

- **Function:** This layer integrates data from a wide array of sources, from ground-level Type3 spheres to Type1 atmospheric sensors, ensuring synchronized and coherent data flows across global operations.

As advancements in stealth technology allow external crafts to approach closer to Earth's surface, it seems they can sometimes navigate past the Type1 Spheres in the upper atmosphere. However, once these crafts reach lower altitudes, Type1 Spheres appear to effectively swarm and disable them, typically forcing them to land in the ocean. Subsequently, the TicTac units appear to retrieve these disabled crafts from their aquatic landing sites for analysis. This analysis process would be crucial, as it allows the Sphere network to continually enhance its capabilities in response to emerging stealth and propulsion technologies.

This retrieval operation appears to be an AI based hypersonic extraction process involving TicTac-shaped crafts, which function as automated retrieval units working in conjunction with Sphere formations. While these Spheres are tasked with destroying or disabling the target craft, the TicTacs directly engage by locking onto and extracting the craft from the area. This extraction appears to utilize a sophisticated quantum locking mechanism: the target craft's

superconductive shell is encased in a magnetic field, enabling a quantum lock to the TicTac.

Note sideways image below - TicTac on the right side – observe the separate disk-shaped craft attached to the underbelly with what looks to be a commercial jetliner passing by. This following image was privately sourced to me.

Object was reported to be moving to the right.



Overall - the AI system appears to autonomously detect, identify, and intercept external craft, effectively destroying or disabling them before extracting the downed objects and their occupants. However, maintaining and advancing such a system would likely necessitate the continuous involvement of a high-IQ, non-human intelligence (NHI) group, operating from concealed infrastructure within mountainous regions or underground facilities.

It truly makes one wonder who ultimately owns this planet.

CHAPTER 15

Ultra-Terrestrial Engagement



The Sphere Network appears to be controlled from the ground up. The Type 3 spheres inside the building form the underlying dynamic MW data network, linking up to the Type 2 and Type 1 V formations. However, these Type 3s function merely as AI-based network relays—implying they must connect to a larger infrastructure. This infrastructure would rely on centralized processing hubs governed by an AI system that is constantly updated, maintained, and improved. Such an arrangement suggests the presence of a second, permanent species.

Notably, at places like Skinwalker Ranch in the United States, the research team has detected high-energy microwave and gamma rays emanating from certain mountainous areas. This is logical, as our own military builds critical control and communication systems (like nuclear weapons) underground. In a similar fashion, this second species appears to have constructed vast control and communication systems—concealed beneath remote mountainous areas to avoid human interference or observation. Hence, when the Skinwalker team launches rockets, these spheres show up, effectively triggering the AI thus using those rockets as a form of bait.

While these baiting methods seem effective (and make for good footage), there appears to be consequences. Triggering actions perceived as disruptive—such as drilling or digging where the infrastructure exists, or flooding areas with water or smoke—often elicit direct responses against the team. What we call non-lethal weapons can induce physical illness or symptoms, effectively “persuading” the team to stop.

Thomas Winterton (Ranch Superintendent) has been the most frequently affected by odd illnesses and injuries on the ranch. In Season 1, Episode 1—"Bad Things Happen When You Dig"—Thomas developed sudden scalp swelling and pain after disturbing the soil. Dr. Travis Taylor has repeatedly reported sudden headaches, nausea, or dizziness during experiments, often coinciding with radiation readings or activity in high-EMF areas. Bryant "Dragon" Arnold (Head of Security) has not been hospitalized like Thomas, but he has felt uneasy and occasionally unwell during high-intensity moments. Erik Bard (Principal Investigator) usually stays in the command centre, yet he has also reported feeling lightheaded or uneasy on occasion.

Ten years ago, I came up with my own baiting process using light and, more recently, computer code. The objective was to attract attention in a positive manner rather than taking a forceful approach. I questioned the accuracy of my assumptions and whether it was feasible to manipulate the Sphere AI system. This requires identifying the triggers that activate the spheres and predicting their subsequent behaviour / reactions.

One way to investigate this is to study existing AI monitoring tools. A good analogy is the AML (Anti-Money Laundering) transaction monitoring software employed by banks. This software continuously monitors customer transactions—sometimes in real time—to detect anomalies outside typical spending patterns. When a transaction stands out, it's flagged for further review. Analogously, the Sphere AI system could be looking for anomalies in its environment and reacting with pre-programmed responses.

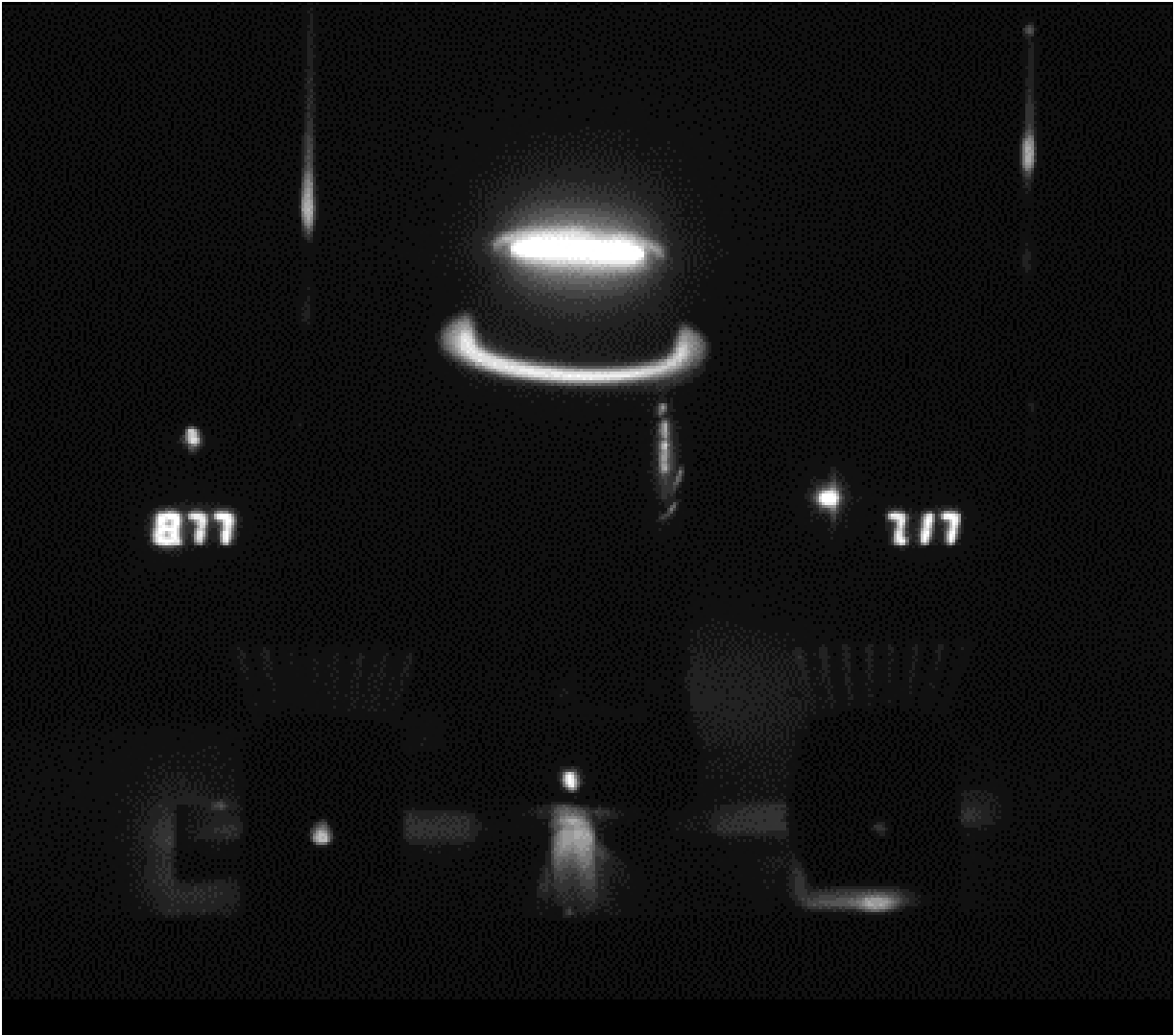
Given the extensive scale of this sphere network, it must be automated for effective monitoring. This necessitates autonomous spheres capable of making real-time decisions based on rule-based AI. Reports frequently associate these smaller silver spheres with larger UFO events—suggesting the spheres themselves are not part of the UFO but rather respond to its presence. The question, then, is what triggers them to engage?

“Satan himself keeps transforming himself into an angel of light” (2 Corinthians 11:14)

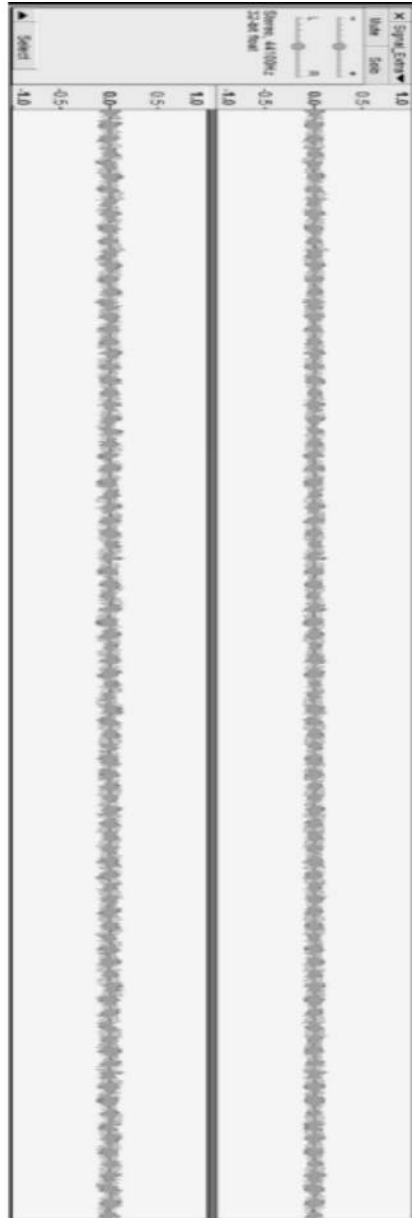
Observations indicate that these UFOs use a field-based propulsion system that interacts powerfully with atmospheric gases (primarily oxygen and nitrogen), emitting photons much like lightning during electric storms. One of these results is a vibrant, electric-blue light. Consequently, an unusual or “out-of-place” atomic-level light in our atmosphere might trigger the sphere network.

To explore this possibility, I conducted an experiment in Manchester, UK. I travelled five hours to a remote location about 3,000 feet in elevation, away from electrical interference or phone signals. My plan was to create an unconventional, highly focused blue light source—small in scale but intense. **The idea was to simulate a scenario** in which an external object might breach the UAP sphere network’s defences. In the I.T world this is called Spoofing.

By generating this **concentrated vertical light in an isolated remote unexpected spot**, I aimed to draw the attention of any airborne observers. The outcome of that test was unforgettable, leaving a lasting impression on me. It took place in the hills near Woodhead Tunnel in Manchester, UK.



After an hour of waiting, a sudden turn of events unfolded: the vertical static field detectors and audio systems picked up an artificial signal. The excerpt below showcases the signal's remarkable consistency, indicative of an artificial origin, and it displayed high-frequency pulsing.



The waveforms depicted above seem to indicate a pronounced pulsing pattern originating from **a source that was not only approaching** but also generating the Doppler effect as it moved closer and then farther away. Meanwhile, while the source was in motion, several Electronic Voice Phenomena (EVPs) were concurrently recorded, **exhibiting voice mimicry**.

At a particular moment, my friend Michael expressed ***feeling spooked***, and intriguingly, on the recording, a voice that eerily resembled mine can be heard saying, "***Feel spooked?***" just as I

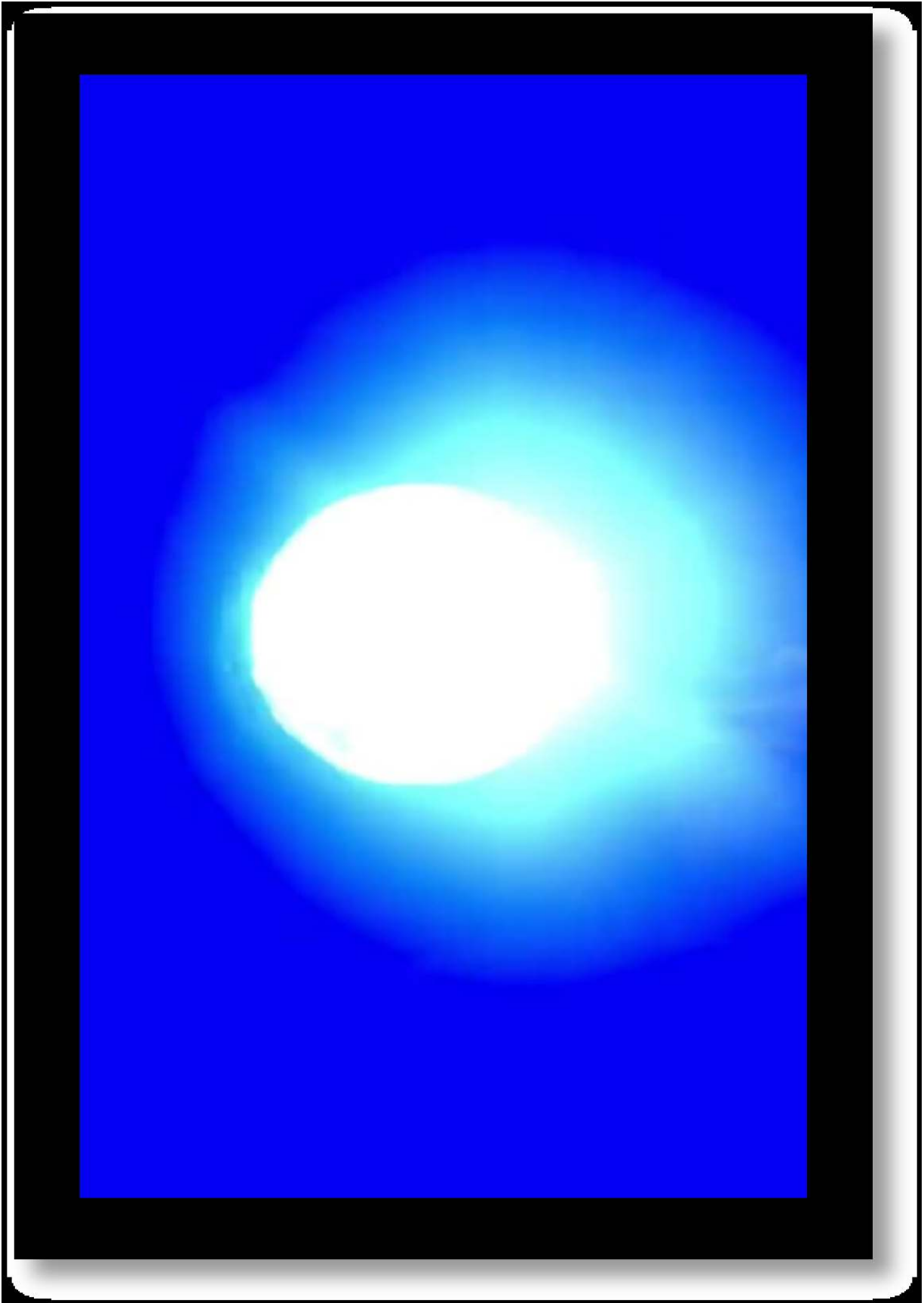
was talking over it. This incident serves as an example of cloning, but it wasn't the only peculiar occurrence. Visual experiences also occurred, with both Mike and I physically observing shadows that seemed to resemble people watching us.

I regarded this test as a resounding success. My concentrated light source not only triggered peculiar electronic effects in complete electronic isolation but also set off a high-energy static source that appeared to move around us, generating an observable Doppler effect. The frequency of these events, along with the intriguing patterns of movement and interaction they demonstrated, thoroughly captivated, and intrigued us.

I decided to take the hypothesis even further. Mike and I collaboratively designed and constructed a simple but specialized strobe with the explicit purpose of triggering the Spheres AI system, effectively inducing paranormal activity on demand. This unit operated on the same principles, involving a concentrated light source utilizing a specific colour to mimic gas interaction. To enhance its efficacy, we incorporated a glass sphere to diffuse the light.



By all accounts, this radiant sphere of concentrated light was intended to spoof the spheres AI system, making it believe an unauthorized craft / object had entered controlled airspace.



The follow-up test proved to be even more intriguing. Unlike the first attempt, it was conducted in a remote woodland near Manchester—an area reportedly rife with paranormal activity. This location aligns with the theory of an ultra-terrestrial presence operating in underground facilities in such secluded regions. My goal wasn't merely to trigger the Sphere AI; I also wanted to provoke a response from the UT group themselves. To achieve this, I decided it was best to arrive openly and without any show of hostility—meaning we carried no weapons and avoided face coverings or anything else that could appear threatening

The subsequent events and the following photos tell their own remarkable story.





At this point, something occurred that seems technically impossible. The camera was recording at 60 frames per second, and in just a few frames, the vertical light abruptly bent to the right. **Simultaneously, a figure appeared**—about five feet tall, with a large, elongated head and teardrop-shaped eyes—approaching the strobe and peering into it.



The strobe itself was **coded to create a slightly random, noisy light signature**, using blue as the primary wavelength. When diffused through the glass sphere, it scattered high-energy photons capable of **penetrating adaptive stealth technology**. The being's large eyes suggest a nocturnal nature, and the speed of this event was extraordinary.

In real-time, we saw nothing out of the ordinary. Only upon reviewing the footage did the situation become clear: it appears the UT group is employing a form of **localized time dilation**. They seem able to activate this field around themselves, moving at a normal pace while everyone outside the field is effectively **frozen** or operating in **extreme slow motion**—everything unfolding between the frames of human perception.

It is logical to infer that when these spheres detect an anomaly on the ground, a rapid response is triggered, involving the dispatch of an entity or object to investigate the situation. The swift nature of this response gives rise to the intriguing possibility that these entities are not of extraterrestrial origin, meaning they may not come from outside our planet, but could instead be described as **ultra-terrestrial**, indicating that **they reside right here on Earth**.

They are effectively our neighbours that we never see.

To my surprise these **Elongated skulls**—sometimes referred to as “conehead” skulls—have been discovered in various parts of the world, most famously in the **Paracas** region of Peru. Over the years, these skulls have been studied and displayed in multiple museums and research facilities. Below are some known locations and institutions where elongated skulls are (or have been) kept and studied:



Upon close inspection of the video, the cheekbones, eye sockets, and vertical brow lines in the frontal area all match. **The likelihood of this occurring by mere chance is effectively zero**

The speed of this response could only mean that there is an **ultra-terrestrial presence** here on Earth. This test was performed in the woods through a tunnel that bottlenecks the area; the figure was filmed walking "into the woods," which opens the door to the following realization.

From the facial construct, their eyes are large with large pupils. We see this configuration in nature with nocturnal animals such as owls, galago's, tarsiers, domestic and wild cats, and even frogs. It is logical to assume these ultra-terrestrial beings are also nocturnal, living underground in woodlands, forests, or remote areas.

With **light-sensitive eyes**, it would be difficult for them to tolerate daylight sun, so they likely live in underground buildings or complexes, most likely built centuries ago but kept up-to-date and maintained.

Logically, this would mean that there is access points located around the woodlands, hidden within the trees / rocks and bushes. This could explain the missing person phenomenon in U.S. national parks, where people may have accidentally strayed into an access point, possibly seeing something they shouldn't have—only then to vanish.

If an ultra-terrestrial civilization aims to remain hidden—either out of caution toward human aggression or simply to maintain separation, much like how we distance ourselves from primates—then one possible solution may involve indefinitely detaining those who discover these access points. Additionally, there seem to be deterrent measures in place to keep people away.

However, analysing the data suggests that locating these access points might not be as challenging as it seems. By studying patterns of disappearances over the years, we should be able to identify these areas with greater clarity.



Recently, numerous wild campers—especially those venturing into remote regions—have reported unsettling nighttime disturbances, including stones being thrown at their tents, the sound of heavy footsteps circling their campsites, and even tents being shaken. These anecdotal increases in strange occurrences suggest that the UT population may be expanding, reaching into areas that were once unoccupied.

The reality is the **ultra-terrestrial realm**, and human realms may remain divided by vast differences in intelligence and social understanding. Just as primates cannot fully function within human society, it is similarly improbable that humans could currently seamlessly integrate into the UT domain. Navigating that realm currently would likely demand rigorous mental conditioning and discipline and may only be achievable by small groups of highly capable individuals. Consequently, it's plausible that certain select, high-functioning individuals have been granted exposure to the UT realm through covert government projects over the years. That's

said it would be highly likely that there is limited communication and cross collaboration in mutually beneficial projects.

CHAPTER 16

Counter Measures



Over the last few years, many individuals have reached out to me seeking ways to remove poltergeist activity from their homes. Typically, these individuals are financially constrained and unable to relocate to a different residence.

Although no method has been fully tested, theoretically, there is a potential approach to either move or reduce paranormal activity within a home. The Type3 Spheres are essentially AI-based network relays that function like transponders, activating and deactivating as needed for relaying purposes. The poltergeist-like actions they perform serve as scarecrow effects, intended to clear space around them or to direct occupants to specific areas of the house based on their emission range.

The type of building and its construction significantly influence the placement and behaviour of Type3 Spheres:

Tall Buildings (e.g., Hotels):

Optimal Location: In high-rise structures like tall hotels, Type3 Spheres position themselves to maintain the best line of sight (LOS) to the next Type3 Sphere in the network chain. This often involves situating themselves in specific rooms located halfway up the building, ensuring seamless network connectivity.

Two/Three Story Brick Houses:

Optimal Location: In two-story brick houses, Type3 Spheres typically occupy the attic or upper floors. The brick construction materials naturally shield electronic emissions and signatures,

allowing the spheres to operate discreetly without easily detectable interference.

Single-Floor Wooden Houses:

Optimal Location: In single-floor wooden houses, Type3 Spheres are usually found in the basement. The basement provides the most shielded part of these wooden structures, minimizing external detection. However, this placement also leads to the most aggressive paranormal activity. Signals from the Type3 Sphere in the basement relay upward through the wooden floors, frequently encountering occupants. This constant interaction results in more frequent actions aimed at moving people away, making activity in wooden houses appear more intense.

Overview

- **Tall Hotels:** Spheres are strategically placed in rooms with optimal LOS to maintain network connections.
- **Two-Story Brick Houses:** Spheres utilize attics or upper floors, benefiting from the natural shielding of brick materials.
- **Single-Floor Wooden Houses:** Spheres reside in basements, where signal relay through wooden floors causes heightened and aggressive paranormal activity.

The Type3 Sphere tends to operate in one of two primary locations within a building: the attic or the basement. Additionally, the type of building construction significantly influences their placement and behaviour:

Examples of this was 3860 Carolina St, Gary, IN 46409, USA

Otherwise known as the Demon House, activity reported at this location includes accounts from a family case manager and a hospital nurse who both claimed to have witnessed a 9-year-old boy walking backward up a wall. At the centre of this enigmatic case are Latoya Ammons, her mother, and her three children. Since moving into the rental home in 2011, the family has reported numerous unsettling occurrences, such as the sound of invisible footsteps and one of the daughters mysteriously levitating above her bed. Authorities documented these strange events in an extensive, nearly 800-page report. This comprehensive dossier includes testimonies from law enforcement officers, child welfare workers, psychologists, and even a Catholic priest who conducted multiple exorcisms in an attempt to expel the alleged demons. Remarkably, Police Captain

Charles Austin has admitted that his experiences with the Ammons family at the residence transformed him into a firm believer in the existence of ghosts and demonic forces.

Notice the reports of levitation. This phenomenon can be logically explained if the Type3 Sphere is emitting high-energy transmissions from its basement. Utilizing its field-based propulsion system, the sphere is capable of exerting force on objects or people. In this case, it levitated the child upward, thereby increasing the distance between itself and the child. This action aligns with the inverse square law of radiation, which states that the intensity of radiation decreases with the square of the distance from the source, making it safer the further away you are.

So how would we theoretically move them?

During my research phase in 2015, I began to consider whether it might be possible to counteract these Type3 Spheres—perhaps by pushing them away or compelling them to react in a detectable manner. After some deliberation, I hypothesized that these objects, designed to operate primarily at night, could employ a passive infrared vision system. Such a system would allow these spheres to perceive their surroundings in darkness without emitting any detectable infrared light.

Passive infrared vision is the primary visualization system used in stealth aircraft like the F-117, which prioritizes minimizing detection by radar and infrared technologies. These aircraft are designed to leave no thermal or infrared signatures. However, in the case of these spheres, it appeared that photons striking their shell surfaces amplified visual data, allowing them to operate effectively in low-light or dark conditions.

If this hypothesis is accurate, it opens the possibility of blinding one of these spheres. My rationale is that if these objects function as machines with an inherent artificial intelligence system, corrupting their sensor data to render them blind might provoke unpredictable reactions.

This concept parallels modern computer-controlled fly-by-wire aircraft, where external sensor failures can lead to erroneous data. In passenger aircraft, flight computers respond erratically when fed incorrect data. Unfortunately, failed or corrupted sensors have tragically contributed to fatal passenger aircraft crashes, resulting in the loss of numerous lives. A notable recent example is the series of Boeing 737 MAX crashes in 2018 and 2019. In March 2019, aviation authorities worldwide took the unprecedented step of grounding the Boeing 737 MAX passenger airliner. This decision followed two devastating crashes within a mere five months, leading to the heartbreaking loss of all 346 lives on board these flights. The initial accident, Lion Air Flight 610 on October 29, 2018, sparked serious concerns and investigations.

Investigators began to suspect that a critical system known as the Manoeuvring Characteristics Augmentation System (MCAS)—which had not been included in flight manuals or crew training—was automatically and repeatedly causing the aircraft to enter a nosedive. This occurred due to erroneous data from malfunctioning sensors, casting significant doubts on the aircraft's safety and necessitating immediate action.

In the context of passive infrared vision systems, it's important to note that an intense and directed light source can overwhelm the sensor. If such a sensor is linked to a flight computer, as previously mentioned, there is a substantial likelihood that the software may initiate unexpected actions. To explore this concept further, I conducted a test at 30 East Drive. During this test, I created a controlled environment by blacking out the rooms and introducing a filament-based 240v strobe light. As the intense light filled the space, we meticulously monitored the electronic signals and sounds captured by an array of strategically placed microphones throughout the house.

At the start of the test, a remarkable event occurred: every microphone in every room of 30 East Drive simultaneously began receiving highly unusual sounds. These sounds appeared to emanate

from a source moving rapidly from one room to the next and executing U-turns, displaying behaviour **consistent with a state of confusion**.

The brief duration of the event suggests that the unusual readings may not have been caused by the strobe light itself but by some other active factor moving within the rooms of the house. It is reasonable to speculate that this phenomenon could be linked to a combination of electronic crosstalk and the emission of ultra-high-frequency (UHF) sound waves from the sphere as its **artificial intelligence encounters an error state**.

The observed behaviour strongly indicates that once these objects encounter an error, there may be a subsequent process involving a software or hardware reset.

What we subsequently witnessed appeared to follow a **systematic re-initialization process**, characterized by digital signals emitted at consistent intervals between each transmission. In this context, "systematic" implies that these emissions adhere to a predetermined plan or system, similar to a mobile phone reconnecting to its carrier network. Logically, this pattern could represent the uplink signal as it undergoes a reset and re-establishes its connection to the network.

This behaviour pattern supports the analysis that these spheres may operate using a passive infrared vision system. When their sensors are compromised, the artificial intelligence within these objects appears to enter an error state.

This consistency in technical behaviour suggests that certain fundamental characteristics remain unchanged, regardless of the level of technological advancement or whether the machine is of terrestrial or extraterrestrial origin.

This suggests that if a Type3 Sphere is consistently blinded and forced to reset, it would cause latency in the network chain. With latency comes an acceptable threshold—once this threshold is breached, it will force the network to move. Consequently, this

would result in moving the Type3 Sphere away from the building, thereby **stopping any paranormal-like activity entirely.**

CHAPTER 17

UAPs and Faith's Intersection



If these spheres are truly responsible for generating paranormal activity, then perhaps we can trace how long they've been here. One of the earliest recorded instances of such phenomena dates back to ancient Greece, as documented by the Roman author Pliny the Younger. He described a haunted house in Athens where residents were disturbed by the apparition of an old man in chains, accompanied by unnerving noises—often regarded as one of history's earliest accounts resembling poltergeist activity.

Pliny the Younger's account, which he wrote around 50 CE, recounts events believed to have taken place centuries earlier, possibly in the 4th or 5th century BCE. This situates these phenomena roughly 400–500 years before the Common Era, making it one of the oldest recorded hauntings. The fact that poltergeist-like experiences were documented so far back raises the possibility that these Type3 spheres have been present since the dawn of human history. During my experiments at 30 East Drive, I placed a GoPro camera—affixed with professional bonding tape—to the glass of a picture frame at the top of the stairs. While I was momentarily in the restroom, I experienced something unprecedented: a brief but vivid mental vision. It was so strong that it briefly overwhelmed my normal field of sight. In this vision, I saw the GoPro camera mount violently pop off the glass—an event that actually occurred only moments later, exactly as I had envisioned. This striking, full-colour mental image suggested that these baseball-sized Type3 spheres can transmit visual data directly into a person's visual cortex. If they can transmit images, it stands to reason they could also transmit sound. This capability for cognitive audio-visual manipulation might enable the spheres to mask their actual appearance, presenting themselves to

human observers as completely different entities—perhaps as adults, children, or even as beings perceived as angels or demons. If these spheres can indeed control what we see and hear, it raises a profound question: could such abilities have shaped the foundations of world religions?

After all, religion can serve as a means to regulate social behaviour, forming the legal and ethical frameworks of civilizations. Could these ultra-terrestrials be using some sort of “software patch” to correct genetic or behavioural disorders? Just as Type3 spheres appear to use fear-based tactics to steer people away from high-energy emission points, perhaps the fear of a deity was introduced to curb violence and aggression in early human societies.

Consider, for example, the following passages from the New American Standard Bible:

- **Daniel 10:7:** “Now I, Daniel, alone saw the vision, while the men who were with me did not see the vision; nevertheless, a great dread fell on them, and they ran away to hide themselves.”
- **Acts 18:9:** “And the Lord said to Paul in the night by a vision, ‘Do not be afraid any longer, but go on speaking and do not be silent.’”
- **Acts 12:9:** “And he went out and continued to follow, and he did not know that what was being done by the angel was real, but thought he was seeing a vision.”
- **Genesis 15:1:** “After these things, the word of the LORD came to Abram in a vision, saying, ‘Do not fear, Abram, I am a shield to you; your reward shall be very great.’”
- **Acts 9:10:** “Now there was a disciple at Damascus named Ananias; and the Lord said to him in a vision, ‘Ananias.’ And he said, ‘Here I am, Lord.’”

These examples highlight how visual and auditory experiences were often described as divine visions. It’s plausible that some of these

accounts may have been influenced by an external intelligence capable of transmitting sophisticated sensory manipulations.

If so, it implies that whoever engineered the spheres may also have engineered humanity. After all, the ability to induce such experiences would require a deep understanding of human neurology at both electronic and biological levels. If our minds are intricately interconnected with these spheres, then humanity might have been created—or at least modified—for a specific purpose.

This idea resonates with certain historical artworks.

Consider Domenico Ghirlandaio's *The Madonna with Saint Giovannino* (15th century).



Notice the three sphere-like objects arranged in a V-formation in the upper-left corner, alongside another UFO-shaped craft on the right, tilted downward as though observing the three objects. Then look at the glowing ring around the child's head—could it symbolize an interconnection with the Sphere network? These images raise the intriguing possibility that humans function as surface-level “eyes and ears,” serving as lookouts for other UFOs.

It may be the real reason why public disclosure is so stifled. The prevailing narrative typically focuses on “extraterrestrials,” when the

more astounding truth could be “ultra-terrestrials”—a second species that has long coexisted with us on Earth, possibly predating humanity and, quite feasibly, created humanity to serve a role in a shadow of itself.

Remote Viewing

Another potential example of this phenomenon is “remote viewing.” In a typical session, the “viewer” is given minimal information—perhaps only random coordinates or a vague description—so they’re less inclined to be influenced by conscious bias. Entering a relaxed, meditative state, they concentrate on “seeing” or “sensing” details about the target. Their impressions—recorded as words, sketches, or symbols—are then compared to the actual target to assess accuracy.

The CIA famously experimented with remote viewing for espionage, using it to gather intelligence on hostile governments. But what exactly are these viewers tapping into? It almost appears they’re connecting with an airborne, mobile source capable of observing details even inside buildings—a capability that aligns remarkably with the observed functions of Type3 spheres. Under certain conditions or induced states, it seems possible to establish a connection with these small spheres.

If that’s the case, it’s hardly far-fetched to propose that these spheres might also be able to read and influence human minds. One way this could happen is through the insertion of a small, nerve-impulse-powered implant, effectively linking us to the “sphere network.”, the localized Type3 spheres could facilitate a two-way exchange of neurological data—both sending and receiving information. Just as pets are microchipped for identification, we too might be “tagged.”

It’s plausible that whoever created humanity may have leveraged this technology to embed religious and belief systems within society—like a “software patch” addressing behavioural limitations or

guiding human progress. By implanting foundational beliefs, they could direct human behaviour, ensuring social cohesion and governance in early civilizations. Much like programming software for a desired outcome, this approach may have shaped entire cultures and societies, establishing core frameworks that persist to this day.

CHAPTER 18

Political Stalemate in UAP research



They say that if you ever want something done badly, let the government manage it. This includes everything from internal infrastructure projects and ill-thought-out wars to black projects and information control. When someone says, “We are starting a new project” or “We are starting a new inquiry,” it technically means that a “new folder” has been created on an approved encrypted network drive. This folder will then have a data owner group and an Access Control List (ACL).

With the data owners set as a group this could be one person or many, with the ACL listing the members of the team who need to read and write files back to the share. Once established, the folder is given a project name, and financial resources & staff are allocated to it.

In the private sector, the data owner typically consists of one—or maybe two people: the project manager and that person’s boss. These names or data owners will be changed if or when members of staff leave, or new hires occur. In high-technology companies, data on new microchip products or systems is highly guarded, usually with employees signing NDAs and other security documents. When employee terminations occur, access is revoked before HR informs the (ex) employee that they are fired.

However, issues arise when this straightforward process is intermixed with government politicians, intelligence personnel, CIA, FBI, Navy personnel, Air Force, Army, and Special Forces. Multiple high-ranking members of each branch may demand to be data owners of a specific project file. This management process suddenly becomes slow and, in the end, nearly unworkable.

The longer a project remains active and the more branches of government, intelligence, or military it intersects with, the more data owners become bound to the project. Ultimately, gaining access to the project would require someone to call and email every data owner (potentially hundreds) on the list, securing emailed permission to open the file. This is where politics interfere: Y won't allow it unless X allows it, and X won't allow it unless Y allows it. Some others might say, "I will allow it if 50% of the others allow it," while some people simply won't reply to emails or are unavailable for months on end.

In the end the request administrator "times out", hence Freedom of information UAP searches / responses are mostly blacked out, with the unable to secure permissions so send what little information they can.

This access problem is the main lock in politics, with no one wanting to make the majestic decision to clear the data owners and ACL.

Also, there is a project ID issue, if there is data within a project that the data owners permanently don't want to make accessible - simply move / rename the project file without updating any central list. Making it near impossible for the congress or lawyers to trace or identify. As a result, the only way to disclose UAP data is to create a new project and limit the number of data owners, then give UAP project members of staff protections to speak even if its in a closed session.

A year before the US UAP hearings, a collection of documents was handed to a US senator, including a diagram I had produced that illustrated and explained the sphere formations and their observed activities. Initially, we planned to hold follow-up meetings and calls to discuss these findings in detail. However, suddenly, all communication ceased. Even a friend of mine who was deeply involved in the situation reported that everyone had gone silent. I had people visiting the senator's office, only to be met with excuses and an effective wall of silence.

It's no surprise - as this book and paper I provided mathematically demonstrates how UAP spheres use trilateration to track and target objects in 3D space. The sphere network operates with ground-based control, suggesting the existence of a second intelligent species living on Earth—possibly in environments humans cannot access or inhabit. This revelation, when filtered through political systems, creates paralysis. Governments typically sideline or suppress phenomena they cannot tax, regulate, or frame as beneficial to their national interests.

A historical parallel can be found in World War II, when Japanese submarines operated off the U.S. coast. Despite reports from fishermen, coastal residents, and ship crews of sightings—including periscopes and even direct attacks—the U.S. government downplayed or outright denied the events to avoid public alarm. Similarly, today's UAP spheres present a "rock and a hard place" scenario: their presence cannot be ignored but acknowledging them disrupts the status quo.

Unlike the temporary threat of wartime submarines, the UAP sphere network is not going away. Humanity's behaviour—building massive, electrified cities, broadcasting countless electronic signals, and deploying unique technologies like intercontinental ballistic missiles—has made Earth a beacon in the cosmos. These activities generate distinctive signatures that are easily detectable by advanced external entities.

The troubling reality is that the widespread presence of UAP spheres suggests we have already been "found." If an advanced group seeks a resource Earth possesses, their arrival may not bode well. The spheres are a sign that someone, or something, is watching—and it's unclear whether their intentions align with humanity's best interests.

In the end the only real political solution is to "think our way out", when UAP crashes occur – retrieve them, analysis and use the best minds to reverse engineer to create our own defence system before the bleed over becomes too great. This could be reflected in the numbers as in Fiscal Year 2024, the Defence Advanced Research

Projects Agency (DARPA) had an enacted budget of \$4.122 billion. And for Fiscal Year 2025, the President's budget request for DARPA is increased to \$4.369 billion.

In Effect this is the **Problem-Solution-Implementation** process government uses, meaning in some cases they don't disclose the problem until a solid solution is in place. So, the question is what solutions could be in place or in development right now?

One notable development is the deployment of the multi-layered anti-missile shield over the U.S. and Europe. This advanced defence system integrates AI for real-time identification & decision-making and is rapidly evolving to counter hypersonic threats. However, a critical concern remains: the current number of interceptors appears insufficient to effectively counter a large-scale nuclear attack from Russia or China, highlighting a potential vulnerability in the system's overall capacity.

CHAPTER 19

Synergetic Implosion

These Numbers Are Controversial as there is much debate on how the data is collected and processed also other possible reasons such as nutrition, education, and socioeconomic variance however some researchers have noted that countries with **higher rates of consanguineous (close-relative) marriages** also often rank toward the **lower end** on cross-national IQ estimates, it appears that communities with a limited gene pool, the impact of genetic

synergy can be observed much faster. However, the remaining populations are not immune - with a global population of 7.888 billion, the effects will take longer to manifest, **but the genetic consequences remain the same.**

The reality is, genetic synergy is the ticking time bomb, causing a population to grow and then decline to collapse due to genetic mutations, resulting in decreased IQ, mental/behavioural disorders, and critical diseases.

The timeframe for this under natural conditions **could take hundreds of thousands, if not over a million years** for humanity to reach a point where extreme genetic synergy would pose a substantial risk due to population size alone. However, other factors could accelerate this timeline:

1. **Environmental Changes:** Major shifts in the environment (e.g., climate change, habitat loss, resource scarcity) could pressure the gene pool, as only those with certain genetic traits would survive. Over tens of thousands of years, this could reduce diversity.
2. **Genetic Engineering and Artificial Selection:** If gene editing becomes widespread, focusing on “desirable” traits, this could reduce genetic diversity in just a few generations, potentially increasing the chance of genetic synergy effects in hundreds rather than thousands of years.
3. **Disease and Population Bottlenecks:** Pandemics or other catastrophic events that drastically reduce the population could force genetic bottlenecks, amplifying the risk of genetic synergy effects within just a few generations.
4. **World Wars:** Global conflicts like World War I and II caused extensive loss of life, displacement, and resource depletion. Such events created population bottlenecks and set the stage for reduced genetic diversity.

Influence on mental abilities:

Neurological Conditions: DNA mutations can also contribute to various neurological conditions, such as epilepsy or neurodegenerative diseases. These conditions may affect cognitive function, memory, and overall mental abilities.

Genetic mutations can potentially lead to premature death, depending on the nature of the mutation and its effects on an individual's health. Some mutations can cause or contribute to various genetic disorders, diseases, or conditions that may result in a shorter lifespan.

- **Premature Aging Syndromes:** Some mutations can lead to premature aging syndromes, like progeria, which accelerate the aging process and cause individuals to age rapidly. This can significantly reduce life expectancy.
- **Cardiovascular Diseases:** Mutations in genes associated with heart health can increase the risk of cardiovascular diseases, which are a leading cause of premature death. For example, mutations in genes related to cholesterol metabolism can lead to early heart disease.
- **Neurodegenerative Diseases:** Mutations in genes associated with neurodegenerative diseases like Alzheimer's or amyotrophic lateral sclerosis (ALS) can lead to severe and often life-shortening conditions.

Why come to Earth? Given that the universe is estimated to be 13.8 billion years old, older external races **may already have reached a “Synergetic Implosion”** point, forcing them to seek new compatible genetic resources. By extracting and embedding this genetic material into their own children or population, they could increase genetic diversity and thus reduce mutations and knock-on effects. The result would be a hybrid, potentially featuring the best elements of both groups—much like how humans might be hybrids of a primate and a shared common ancestor.

This “gene resource” would ideally be mostly error-free, sourced from an early-stage civilization lacking synergy issues and

without the military or technological capability to detect or prevent such extraction. Just as we humans often covet specific resources, the behaviour of external groups may be indistinguishable from our own patterns—a superior species or technology invariably prevails over a weaker one.

If we ourselves were to engage peacefully with another planet, we would likely begin by sending signals, then hold meetings, then use robots to study the environment remotely, ultimately forming mutually beneficial agreements. However, given how protectively we view our offspring, it's unlikely the general population would permit female egg or male sperm extraction—or even DNA / blood donations—to external groups they know little about.

This situation could explain the intelligence community's wall of silence. If this analysis is accurate, **it suggests that downed craft / ships from these external groups may contain the cargo of human biological material.**

A discernible pattern also emerges in animal and human mutilations: they consistently avoid high population areas, occurring instead in remote regions. The limited number of spheres indicates they operate in specific zones based on human density metrics, leaving low- or zero-density areas less surveyed—opening the door to “hit-and-run” style extractions.

Moreover, there appear to be three distinct patterns in the discovery of bodies. First, some people vanish without a trace; second, some bodies are found carelessly discarded; and third, some are placed with apparent respect. In certain instances, victims' bodies are carefully set down in open, visible areas with their clothing neatly folded beside them.

The true catastrophe will unfold only if the sphere network is breached, leading to towns, cities, and villages experiencing daily, face-to-face encounters with potentially hostile extraterrestrial beings. This event will mark the collapse of media and government control mechanisms as these external entities attempt to assert their influence over people and the planet.

Imagine scenarios where external groups begin to harvest DNA to address synergy / mutation issues within their own species, resulting in dramatic events such as all planes disappearing from the sky simultaneously, or entire populations of a village or city vanishing overnight on an industrial scale.

In such a scenario, the desperate remaining defence might involve a scorched-earth policy: deploying nuclear weapons to annihilate humanity and deny the extraterrestrial groups their objectives, thus destroying the surface of the Earth. The underlying message would be stark:

"If we cannot have it, neither will you."

One Possible Solution

Third Line of Defence Theory

If the theory proves accurate, A promising strategy involves significantly enhancing human intelligence, possibly elevating the

average IQ from 75 / 100 to between 250 and 300. Such an enhancement would improve our compatibility with the UT community.

This transformation could be enabled by technologies like Neuralink, which integrates AI machine intelligence with human biological intelligence. A further significant advancement would be the deployment of nanobots within the human body. These nanobots would enhance muscle development and strengthen organs and bones, boosting physical health & capabilities without traditional exercise.

With just these two technological upgrades, humanity could evolve into a formidable multi-planetary species, overcoming the constraints of our terrestrial existence. This evolution could not only broaden our capabilities but might also place us on a par with the ultra-terrestrials allowing the two linked but separated domains to finally combine.

We would operate as two sides of the same coin, where they live – We live, they operate underground as the advanced superintelligence that protects the sky's while we are the formidable surface guard that protects their gates. This model would replicate out to Mars and other planets & with the rise of advanced artificial intelligence, the pace of software and technology development is set to accelerate, constrained only by the limits of material science and mass production techniques. The next 30 years could witness the most significant technical and evolutionary leap in our human history.

Conclusion: What is the Sphere Network?

The Sphere Network is a quantum-based observation and global defence system—an AI-driven hypersonic defence system composed of three interconnected layers: Type-3, Type-2, and Type-1 Spheres.

- **Type-3 Spheres:** These are baseball-sized and operate at low altitudes, primarily within buildings. They create a

dynamic, low-altitude microwave-based network spanning countries and continents. During uplinks, Type-3 Spheres initiate actions to move people away from high-energy microwave and gamma wave emissions. Failure to relocate results in exposure, which can lead to physical health effects.
